**International Visitor Attestation
For Travel and Incidental Expense Reimbursement Only**

To USC International Support for Faculty and Staff:

I understand that under the U.S. Immigration and Naturalization Act, I may accept payment of incidental expenses associated with my academic activity at the University of South Carolina, pursuant to my admission into the United States. If I am present in the U.S. in a visa status other than B-1, W/B, F-1, J-1 or H-1B, I understand that reimbursement of my expenses may require prior approval from USCIS (Immigration), or may not be possible at all. NOTE: Individuals in the U.S. in a status other than the above should contact International Support for Faculty and Staff in advance of the visit for guidance. To document my U.S. immigration status, I have checked the appropriate blocks and attached copies of all relevant documents listed below:

- I am a **B-1/WB visitor**. Attached is my I-94 or I-94W Arrival/Departure Record (*small white or green card stamped by a U.S. immigration officer at the U.S. Port of Entry*) indicating that I hold B-1 or W/B status. **OR, I am from a Visa Waiver country and was not given Form I-94W; attached is my approved ESTA travel authorization and the U.S. entry stamp from my passport.**
- I am a **J-1 professor, research scholar, short-term scholar or student on Academic Training**. Attached is a copy of my DS-2019, my I-94 and a letter from my J-1 Responsible Officer authorizing my visit to USC.
- I am an **F-1 Student**. Attached is a copy of my Employment Authorization card (I-766), *or* my I-20 and my I-94.
- I am an **H-1B Temporary Worker**. Attached is a copy of my I-94 and I-797 Approval Notice.
