## **Courses taught:**

## Management 371 Principles of Management: 1998 to present

Course covers principles of management theory from scientific management to TQM and six-sigma. Students learn different theories on planning, leadership, organization and control. Students learn about theories of motivation and leadership.

## Management 478 Strategic Management: 1998 to present

Course is the capstone course for all business majors. Students need to integrate all of the skills they have developed while at the Moore School of Business. Students will present a minimum of six times during the semester using cases covering a wide range of different business situations. Students are required to work together in teams and develop presentations that last between ten and thirty minutes and be prepared to answer questions about their presentations.

## MBAD 701 Business Simulation and Case Competition: 2000 to present

Course develops analytical and presentation skills in preparation for case competitions. Students also work on developing team building skills. Students must be able to integrate all parts of business operations including finance, marketing, management, MIS and supply chain management into solving business problems. Students also learn to recognize potential issues involving the different cultures and business practices in different countries throughout the world.

# **BADM 780B Development a Business Plans for New or Existing Ventures: 2003 to** present

Course works with students to develop business plans from the thought process to the actual establishment of operations. Students are required to develop timelines, pro-forma financial statements, marketing budgets and campaigns and identify potential customers. Students who develop strong business plans will enter business plan competitions in hopes of potentially gaining support for their plans.

## Management 479 Entrepreneurship in China: Maymester 2007

Taught course on business practices and entrepreneurship practices in China. Visited companies in Beijing and Shanghai including software developers, medical supply companies and the worlds' largest outsourcer Li and Fung.

# **Management 490 Integration of Sustainability into Organizations**: Fall 2013, 2014, 2015

Course focuses on how sustainable technology can be integrated into organizations. Technology exists that is not only cost effective, but also increases the efficiency of organizations. Too often the technology is not used because of lack of awareness. To be competitive organizations must be aware of what new technologies and services are available and be willing to use it when they are cost effective. Many of these new technologies use less energy and resources making them more environmentally sensitive.

# **Case Writing:**

**Langfan Case Competition:** Undergraduate Case Competition on constitutional issues.

<u>Whiteside Manufacturing</u>: May 2006 Case involved invasion of privacy of employees and the violation of privacy during the hiring process. The case required the students to develop an understanding of what is and is not permissible in the hiring process. Students also needed to understand the federal bidding process on contracts.

<u>The Right to Be Stupid</u>: October 2006 Case involved the argument by many motorcycle riders that they had the right to not wear helmets regardless of the potential consequences. Students were asked to weigh the costs to society and the individuals against the potential restrictions of the rights of the motorcycle riders. The students needed to review laws across the country and also develop plans to address potential resistance of motorcycle riders.

<u>Airline Passengers Bill of Rights</u>: November 2007 Case involved the potential development of an airline passenger bill of rights. The students were required to look at the potential costs and effect on corporate reputation of enacting or not enacting a passenger bill of rights.

<u>Cyclops</u>: October 2009 Case involved the use of a specialized piece of equipment to be used in Haiti after its' devastating earthquake. Students were required to look at the potential loss of a federal contract due to using the machinery in Haiti rather than in a mine area in Pennsylvania.

<u>Gutka</u>: February 2011 Case involved the sale of a tobacco related product in India. Students were faced with the potential threats of the product to it users versus the fact that gutka represented the third highest single source of taxes in India

<u>Eptix Electronics</u>: February 2015 Case involved the use of inventory control models that assisted smaller companies in limiting the inventory holding risks in an industry with shortening production cycles.

<u>The Importance of Provenance</u>: February 2016 Case involved the discovery of artworks that had potentially be acquired at prices well below actual market due to pressure of the German government.

## **Cases written for other competitions:**

<u>Uber: Just Another Corporate Suit</u>: January 2016 Written for the University of Denver ethics case competition. Case involved practice and behaviors of company with respect to determining whether drivers were employees or independent contractors.

**Showcase Weekend**: Cases written to give potential students the opportunity to see what types of business problems they may foresee in the IMBA program

<u>Equine Development Camps</u>: Fall 2004 Case looked into situation where company was locating camps for teenage sexual predators within proximity to cities and towns without

fully disclosing nature of camp to local government. Case taken from camps developed in North Carolina and Colorado. Case asked students to evaluate responsibilities of local government.

Sponge Bob on Ice: Fall 2005 City of Columbia ballet was looking at putting on a non traditional ballet due to the lack of interest among local schools. Students had to develop a plan for the ballet, set a schedule and ticket prices and come up with a marketing campaign. Worked with director of ballet to identify potential fundraising and overall financial impact of departure from standard productions.

Olives and Wine: Spring 2007 Students were to come up with a potential acquisition and development strategy for a vineyard in the United States. Students also had to develop an operating budget and decide what types of wines they wished to grow. Consulted with several developers in California to identify key success factors in wine industry. Introduced potential of using olive trees as a way to eliminate water usage and run-off of fertilizers by vineyards.

<u>What's Not To Like Company</u>: Spring 2005 Company sells products to use as fundraiser for schools. The market is changing and students are asked to look over a group of new products and choose which ones to keep and which ones to replace.

<u>Gel Tyme</u>: Spring 2006 Fertilizer company makes product that works best in arid regions. It is ideal for Iraq. Unfortunately the fertilizer is very stable and is ideal to be used in car bombs. The potential profits are very high and the government is encouraging the company to bid because the fertilizer does not make strong bombs and tracer elements in the fertilizer can be easily tracked back to their source.

<u>Diamond Pet Foods</u>: Spring 2007 Company with plant in central South Carolina accidentally allows mold to grow in pet food harming a number of pets. Students are asked how to address situation. Case based on actual real time events with input from company.
