**A RECOMMENDATION**  
**-TO-**  
STANDARDIZE A STUDENT SURVEY AFTER EVERY  
ACADEMIC ADVISING APPOINTMENT

**WHEREAS**, excellence in advising was part of former President Pastides' Carolina 2025 plan and he announced in 2015 that advising is an institutional priority; and

**WHEREAS**, even though academic advising is not a goal stated in the Strategic Plan, excellent and equitable advising would help accomplish Strategic Priority #1 to “retain and graduate high-achieving students” and to “provide a student -centric educational experience to all students” ; and

**WHEREAS**, academic advising is a requirement for every student at the University of South Carolina in order to register for classes. Advising is the only required and structured service on campus that involves one on one contact with a concerned representative of the institution; and

**WHEREAS**, academic advising is the single most powerful predictor of satisfaction within a campus environment for students at four year schools; and

**WHEREAS**, undergraduate students have regularly recognized inequitable advising experiences across all colleges and schools. It is the goal of the university and University Advising Center (UAC) to promote equity and excellence in academic advising; and

**WHEREAS**, the central goal for the UAC is standardization in academic advising, so that all students have the opportunity for enhanced and equitable advising experiences;

**WHEREAS**, the University Advising Center conducts university wide surveys to receive overarching feedback about the advising process, but not specific to each college, school, department, or academic program; and

**WHEREAS**, a more specific survey would provide more comprehensive feedback about each advisor and advising experience. Students would then be able to help shape the future of advising models and practices in their program. Advisors would also know about their strengths and areas to improve; and

**NOW, THEREFORE,**

**BE IT RECOMMENDED** by the 112th Student Senate

**THAT**, each advisor across every college, school, or academic program send a simple feedback survey to assess student satisfaction and the student's remaining questions or comments; and

**THAT**, this survey has uniform questions across all of campus in order to have university wide metrics for advisors. There should also be questions unique to that area of study or academic program; and

**THAT**, survey reports are created and published online in order to provide transparency about that program's advising experiences. Any areas of improvement or challenges should be addressed by and worked on with the University Advising Center and that department's group of advisors, dean, and other related faculty or staff; and

**THAT**, student advisory boards, program ambassadors, or other representative student bodies should help organize this data and assess ways that this student feedback translates into tangible changes within the advising model at their program; and

**THAT**, by conducting such surveys and working towards understanding advising improvements and challenges over time, a more excellent, standardized, and equitable advising model becomes an overarching institutional priority and goal.
