- Recap of 2024:

- Freshmen profile
  - 4.1-4.7 HS GPA; 1100-1320 SAT-SC; 22-30 ACT-SC
  - o 1260-1410 SAT Non-SC; 27-32 ACT Non-SC
  - o SCHC 4.5-5.1 HS GPA; 1430-1530 SAT; 1%- 5% Class rank; 32-35 ACT
- Top 10 states for our applicants NY, NJ, NC, VA, PA, GA, MD, MASS, ILL, OH
- Fall 24 Transfer 3000 applications but admitted 900-1000
- Approximately 600 Female and 500 Male

- Registrar and Admissions have a new software called Highland to assist in dual credit reporting software for incoming students to help with having their dual credit showing immediate course articulations.
- Push on getting all transcripts prior to orientation. All work must be in for the roll over to Registrar.
- Questions concerning class size Admissions talks with Faculty Senate to discuss classroom space, availability of classes, and staffing issues along with parking
- Early decision and regular decisions- question if there is competition for who will be accepted.
- The most competitive students are admitted first
- The cliff trend is not necessarily affecting USC as it is the rest of the country

#### **First Gen Initiatives**

LaNae Budden Melissa Kupfer

- The agenda was to discuss the definition of first generation- USC uses the TRIO definition of First Generation which recognizes any individual whose parents did not complete a baccalaureate degree.
- There is an attribute placed on their record.
- The office does extend their services to students whose parents earned a degree in a foreign country. They do not have an attribute on their record.
- 1/3 of all college students identify nationally but at USC 20% of our students identify as first generation.
- First generation office has become a member of the Network Leader. Membership is by invitation with the required participation of the President and two cabinet members. It is a national model for a holistic student
- Fall 2024 class statistics
  - o 20% of the undergraduates are First Generation.
  - o 77% are SC residents.
  - o 52% are Pell Grant recipients
  - o 137 are residents in the First-Generation residence
  - o 11.5% are participating in study abroad
  - o 55% have the Magellan Journey Grant
- Breakdown of 1<sup>st</sup> Gen in the colleges:

## International Students Support/IAP

- Regulatory imperatives
  - o 12 hours are mandatory (IAP office will be checking the first 60 days of the semester)
  - Reduced course load can be allowed for extreme circumstances such illness, diagnosed depression/anxiety, difficulty with English language or last semester of academic program which must be approved by advisor/college
  - o Graduation in the International world is a party
- Employment authorization must be academically relevant and directly relevant to the academic endeavor
  - Must be on the USC transcript
  - o Must be academically authorized by a USC authority
  - o Must not disrupt or delay program completion
  - o If there is no internship or experiential learning requirement embedded in the program, then the Carolina Internship program may be an option for the student.
  - o Students may not "volunteer" in an employment like opportunity.
