Methodology for Emergency Financial Aid Grants Under Section 314(a)(1) of the ARP Act

- Pell Grant recipients currently enrolled full-time will be awarded \$1250
- Pell Grant recipients currently enrolled less than full-time will be awarded \$1075. All other currently enrolled full-time eligible students will receive \$650.
- All other currently enrolled less than full-time will be awarded \$550.
 - USC-Salkehatchie has received an official FAFSA as of April 12, 2021
 - Meet the **Title IV Federal eligibility** requirements
 - Be a degree-seeking student enrolled for Spring 2021 term as of April 12, 2021
 - Meet the **Satisfactory Academic Progress** requirements

The award notice sent to each will explain the purpose of the ARP funds awarded to them and the process by which they can accept or decline them.

Awards will be made to students via the already-established aid awarding process. These awards will be refunded regardless of any balance on the students' account, per statute. Refunds will be sent via direct deposit or paper check, depending upon the student's already-chosen method with the Bursar's Office.

In early June, any HEERF II funding that had been declined by awardees was reallocated to students who accepted an initial HEERF II award and maintained eligibility for Title IV federal student financial aid. This additional award was \$28.00 per recipient. Students will have the option to sign a consent form to pay any current balance.
