

MINUTES OF USC LANCASTER FACULTY MEETING ON APRIL 1, 2011

Approval of Minutes

The minutes of the March 4, 2011 faculty meeting were approved.

Reports of Officers

Dean Catalano: A written report was submitted (See Appendix I). Dean Catalano answered couple of questions posed by faculty members:

- The Palmetto Program tuition split will help offset the budget for the upcoming year since the number of students enrolled in the 4 year degree programs (i.e. nursing and BLS) is increasing rapidly and should continue to raise in the upcoming year.
- Mass distribution of emails rules should be followed. The most important involves sending emails to ALL students. In order to send emails to ALL students, you must gain approval from Barbara Blaney and the Registrar's office in Columbia. For other mass distribution (faculty and staff) emails, you must go through the HR department in Columbia. Chris Plyler's office is looking into this matter.

Dean Cox: A written report was submitted (See Appendix II). Dean Cox reminded the faculty about the dos and don'ts for the last week of classes and final exam week. Also, he asked that each division chair select two members from their division to on a faculty advisory committee for the new classroom building. Please contact your division chair if you are interested in serving on this committee.

Student Affairs (Collins): A written report was submitted (See Appendix III). Dean Collins announced one correction in the report involving the baseball team. The baseball takes on Louisburg Community College away on Saturday and Sunday. The tentative schedule for orientation has been sent out by email. Please feel free to send any comments/suggestions to Dean Collins by email.

Admissions (English): Mrs. Amanda English submitted a written report (See Appendix IV) regarding One Carolina. Mrs. English announced that admissions will "go live" to Banner (program substituting IMS) August 1, 2011 for processing Fall 2012 applications. In addition, Mrs. English requested accommodations for the schedules for Spring, Summer and Fall 2012. Schedules must be submitted by October 1, 2011 for Fall 2012 in order to meet the deadline for entering the information in the presence of Banner administrators. Please feel free to contact Mrs. English with questions/concerns.

Gregory Health and Wellness Center (Sellhorst): Dr. Sarah Hunt Sellhorst announced that Zumba classes will be offered this Summer Tuesday and Thursday from 10am until 11am. Each cycle runs over a 2 year period so we are at the end of one cycle at this time and gearing up for a new cycle. Rubrics are currently being developed for the 8 learning outcomes, and samples should be going out soon for scoring. So far this year, the committee has collected and analyzed 687 samples.

Appendix I (page 1 of 2) Dean Catalano's Report, 4-01-11**USC Lancaster Dean's Report to the USCL Faculty, April 1, 2011**

Financial update: The SC House and Senate budgets are nearly complete and USCL will probably be short \$359,000 from last year (that includes the loss of stimulus funding). At the same time there is talk among legislators of holding tuition increases to the higher education price index, or HEPI (this year < 1%). That means that just to stay even with last year (one of the worst budget years on record), we will have to increase generated funds by approximately 6% (whether by tuition or enrollment increases). We intend to budget conservatively using flat enrollment numbers, and so the tuition increase is extremely important. Fortunately, several factors will help:

- Increased enrollments have been an annual blessing (See attachment)
- Palmetto Programs tuition split continues to increase each year
- Millage increases from the Lancaster County Council have been extremely important

We also had a modest budget carryover of \$429,000 last year and we are working hard to increase that amount this year. We have hired an additional admissions counselor/ recruiter this spring. We will move forward with faculty hires and building plans. We will avoid furloughs and layoffs.

Personal Note:

This spring semester concludes my tenth year serving as the Dean of USCL. I have spent far too much of that time worrying about declining finances, the lack of parity funding, and the inability of the University to secure much needed and much deserved pay raises.

But, I would like to think that we have made great strides during those ten years. Our enrollments have doubled. We have added many student events, including athletics. We have added square footage and acreage. We have upgraded safety and security. We have improved the look of campus. We have emphasized planning (the blueprint, a long range strategic plan, a facilities master plan, and a safety and security plan). We will soon build a new classroom building and add dorms and food service to the campus. But I am most proud of the changes to the faculty. We now have a young (sorry, Van Hall) and talented faculty that is more than double the number of ten years ago. It is clear that they have embraced the culture of helping our students to succeed and then to compete after moving on. The new faculty has become a part of our University community and of the Lancaster community. We will add at least four new members to our faculty this year and I hope that they are as committed to USCL as the faculty we are now blessed to have. Please know that in the few remaining years that I have left as your Dean I will work as hard as I can to stabilize our finances, follow the plans that are in place, and try to secure those much needed raises. Thank you for all that you do for our students and for USCL and for making my time as Dean so rewarding.

01 April, A.D. 2011**

Thank you to everyone for helping USCL prepare for its **SACS Reaccreditation Visit** this past Monday. Dean Catalano reported hearing many positive things being said about the Lancaster visit during a recent meeting he attended in Columbia, and we are very appreciative to all faculty, staff, and students for their efforts. The committee should release its findings later today, although the official report on USC's reaccreditation report will not be given until the annual SACS meeting in December.

Faculty Searches for 2011-2012 – Faculty searches for CRJU, HIST, MATH, and SOCY are proceeding according to schedule. The MATH committee has already made its recommendation, and the other committees are scheduled to meet with candidates over the next couple of weeks. My sincere thanks to the committee members, chairs, and the HR office for their hard work.

NOTICE TO ACADEMIC ADVISORS – USC Columbia is currently considering changes to the pre-requisites for MATH courses. The most notable change would be that all students would be required to take a MATH placement test, and enrollment in all courses (even MATH 111i) would require a certain score. (For us, this will probably mean that students not scoring into MATH 111i would be required to take RCAM 105 before registering in any MATH course.)

This will also be a great way to make it easier for you to keep track of your service activities for purposes of annual review, tenure/promotion, and post-tenure review.

- In any course or laboratory which meets two or three times per week, no quiz, test, or examination may be given during the last two class meetings prior to the regularly scheduled examination period.
- In any course or laboratory which meets once a week, no quiz, test, or examination may be given during the last class meeting prior to the regular examination period.
- If an instructor teaches more than one section of the same course, students may transfer from one examination section to another with the instructor's permission.
- Students who are absent from any final examination will be given the grade of **F** on the course if they have not offered an excuse acceptable to the instructor. If excused, they will be assigned a grade of **I** (see "I" entry under "Grading System"), and may complete the course through a deferred examination (see below).
- Re-examinations for the purpose of removing an **F** or raising a grade are not permitted.

Report to Faculty Meeting, April 1, 2011

Topics:

One Carolina: I am traveling to Columbia for training and discussion on implementation in areas of Admissions, Records and Registration.

- Again, admissions will “go live” to Banner August 1, 2011 for processing Fall 2012 applications. This means any student who has to submit an application to attend USC Lancaster for the Fall 2012 semester will be entered on the new Banner system.
- *There were some previous concerns about the transferability of our current section numbers to Banner, I thought that this had been resolved; however, I have since received information that we will not be able to use our current section system. I will get more information to you as I know.*
- Request for your accommodations for the schedules for Spring 2012, Summer I 2012, Summer II 2012 and Fall 2012. Schedules for Spring and Summer 2012 will be done on IMS. The schedule for Fall 2012 will be entered on Banner. I have discussed with Ron and the Division Chairs to work with you to get the Fall 2012 schedule to me by October 1, 2011. This request comes from intensive sessions with Banner representatives and USC officials that will take place in October 2011. During these sessions, I will be entering USC Lancaster’s Fall 2012 schedule under those administrators watchful eyes. This is to help ensure a seamless transition to Banner for the Fall 2012 semester. The schedule will be available to me and how it is determined to send to faculty for review, it will not go live to students until March 12, 2012. We just want plenty of time to enter the information and make sure the system works properly.
- Additionally, students will register for the Spring and Summer 2012 semesters on vip.sc.edu. For the Fall 2012 semester, the students will register on the new Banner system. It has been proposed by USC Columbia officials that we separate pre-registration for Summer and Fall 2012 for this ONE TIME ONLY. This is because the students will have to log onto a separate transitional web terminal to obtain their brand new Banner ID, so they can then log onto Banner and register for Fall 2012. I can just envision the large influx of student phone calls and traffic to both the Admissions and Records Office, and to the faculty about why they cannot register for Fall 2012 on vip.sc.edu. This would mean offering Summer 2012 pre-registration at an earlier time than Spring Break. We would still have Fall 2012 pre-registration the Monday after Spring Break, March 12, 2012
- Spring 2012 schedule is normally available after Fall Break that would be October 24, 2011. I would encourage that Summer I and II 2012 be included in that pre-registration period.

Please feel free to contact me about any concerns, or if you want to talk shop about One Carolina. I do ask that as I bring various suggestions and/or USC mandates to Dr. Cox, Division Chairs, faculty and staff, that you take the information with an open mind and willingness to compromise on certain areas. As soon as I am trained, I will be in contact about several training sessions!!

The committee discussed the John J. Duffy Teaching in Excellence Award system that we currently have in place back in Fall 2010 when we only received 3 nominee names. The committee decided that each division will nominate one individual for this award during the first division meetings of the year in August/September. We have the option of submitting 5 nominee names forward to the RCFS Welfare Committee by December 1st and would like the other 2 nominees to be nominated by the rest of the faculty and to be voted on in an October/November faculty meeting next academic year.

This changes the timeline significantly for our nominees. Previously, nominations were due to the committee mid-September, with complete files (similar to what is due for RCFS Welfare Committee) due from the nominees by October 31st. The committee then reviews these files and determines which of the nominees names will be put forth to the RCFS Welfare Committee; however, due to low nomination numbers in the past, we have never had to judge the files, just give feedback to better the files.

The low nomination number may be due to having a complete file due so early. The final file is not due until January 31st to the RCFS Welfare Committee. By changing the format of who decides the nominees from our campus and the timeline, the committee has less responsibility in determining our nominees and the nominee has more time to complete their file. We are hoping that we will have more nominees in the future due to these changes.
