USC Lancaster Faculty Meeting Minutes
April 7, 2023

CALL TO ORDER: 12:30 PM B. Taylor-Driggers

CORRECTION/APPROVAL OF MINUTES:

The minutes of the March 3, 2023, faculty organization meeting were approved.

Special Report presentation: Faculty Welfare Survey – Dr. Katie Klik (PCFS Welfare Committee Chair)

Dr. Klik spoke to faculty about the Faculty Welfare survey and invited faculty members to participate.

Questions and/or Comments:

C. Heinemann-Priest (in chat) - I'm a little confused by the first 4 questions.

K. Klik: Those questions may look a bit strange because they are intentionally random. The intent is to track returning respondents while keeping information confidential through a combination of characters from these unique supplied answers.

REPORTS OF OFFICERS:

Dean of the Campus – Dr. Walter Collins, report submitted (Appendix 1).

- Page 1: Updates on enrollment. Zoe Byrd has accepted a permanent full-time position with our Office of Academic and Student Affairs. Ongoing searches are going well and we anticipate offers soon. Thanks to this year's outgoing Executive Committee and to all faculty serving in many roles.
- Page 2: Relaunch of our Indian Land Business Advisory Group (and thanks to Anthony Brockington for his work in organizing it). Upcoming Town Gown Advisory Group meeting will discuss a potential community health education initiative that USCL could be involved with. USCL's 65th anniversary is coming up in 2024. Inviting faculty to attend April drop-in meetings and/or participate in a survey regarding the City of Lancaster Comprehensive Plan. Legislature updates, including pay increases and workforce development bill.
- Page 3: Reminder to Give for Garnet; Commencement speaker will be Mary Ann Claud

Questions and/or Comments:

E. Moon-Kelly (in chat) - Questions in chat about pay raises [A: The raise will be for full-time state employees]

C. Judge (in chat) - Shared a link/commentary about the different increases proposed in the House versus the Senate.

Associate Dean for Academic and Student Affairs – Dr. Todd Lekan, report submitted (Appendix 2).

- Page 1: There were 13 academic integrity violations reported this year with all sanctions requested by professors applied or enforced. While some faculty exercise their own discretion in these cases, it can be useful for the Academic and Student Affairs office to receive reports so they can spot other incidents on file, etc. The Admissions Petitions Grade Change (APGC) Committee did great work this year so thanks to them and Chair, Jerrod Yarosh, for the work done to streamline processes. There were 15 hardship withdrawals and about half were approved (see report for specific breakdown).
- Page 2: Updates on end-of-year events like Spring Fling and awards luncheon; thanks to Jeff Rammage for his work as Student Life Director, and to Victoria Hollings. Call for participation in commencement. Request to give students class time to complete course evaluations. Academic calendar reminders including last day of class and exams schedule.
- Page 3 – 6: Listing faculty accomplishments (please see report for the many USCL faculty accomplishments).
- Page 7: Upcoming events, including *Grease* and NASC's Lunch and Learn.

Questions and/or Comments:

K. Holland – Will faculty have the option of completing evaluation forms in different format, as in the past ?(paper forms versus online)

T. Lekan – This needs to be discussed further, and I think that the evaluation committee would be the committee to take the lead on evaluating pros and cons.

S. Sellhorst – When we had paper evaluations, it was difficult to evaluate faculty due to issues like forms being filled out inconsistently or incorrectly, which created a significant burden on Pam Ellis to correct/manage.

L. Martek (in chat) - Geology students presenting and Earth Day Open House April 18th - doors open 1:20 to 2:20 in Bradley 110.

A. Golonka – Comments acknowledging that many disciplines will be participating in Discover USC day. This year shows an impressive Magellan group.

Math Placement Coordinator – Dr. Shemsi Alhaddad.

- Updates on the math placement test: Columbia has given our campus more control over how the test is administered. Students will now fill out a form to

request access to the test. The test closes and the beginning of fall and reopens around October. This process should be easier and present fewer issues going forward.

Director of Human Resources – Tracey Mobley-Chavous (**Appendix 3**)

- Reminder to check course offerings and sessions for the summer to ensure proper pay, updates coming soon regarding the allowable earnings for summer.
- Reminder to submit documentation regarding summer grants, plus reminder to work with Ken Cole and complete personnel forms using pink paper when hiring student assistants through grant funding
- Update regarding supplemental benefits enrollment period
- Reminder about upcoming holiday closures

UNIV 101 Coordinator – Tracey Mobley-Chavous (**Appendix 4**)

- Also shared updates to UNIV 101 offerings, as UNIV 101 Coordinator. USCL has added an additional instructor and is offering different times

Questions and/or Comments:

C. Heinemann-Priest (in chat) - Are we closed for Juneteenth?

T. Mobley-Chavous – No. After Memorial Day, the next holiday closure is for Independence Day on July 4.

APGC Committee (Admissions, Petitions, and Grade Change Committee) – Dr.

Jerrod Yarosh

- It has been brought to our attention that there is no formal procedure for Satisfactory Academic Progress appeals, and we have been handling this with an ad hoc approach.
- In the fall, faculty can expect a motion to formally add this new charge to the APGC Committee.

Welfare Committee – Dr. Dana Lawrence

- Vote via Teams poll to update the campus description that is sent to external reviewers for tenure and promotion. The vote passed and the motion carried.

UNFINISHED BUSINESS:

2023-2024 elections – B. Taylor Driggers, FO Chair

Faculty discussion, then a vote on the proposed slate was administered through Faculty Organization Blackboard. See **Appendix 5** for results.

Questions and/or Comments:

C. Bundrick – I've removed my name from consideration not because I don't want to serve, but because the announcement of a stipend [for Executive Committee] is a significant change to the way things have been done and I don't want it to appear that I'm in support of a decision I had no part in. I think that that decision should have been discussed by the entire faculty organization before it was made.

S. Criswell – I wanted to share my support of the stipends. This office requires a great deal of work and I appreciate the administration's recognition and support through financial support. I do understand Chris' concern about a lack of procedure or faculty approval. However, the FO does not approve matters related to compensation. I hope that this change will encourage more faculty to run for leadership positions.

S. Penuel – I understand Stephen's point that this is not necessarily a faculty decision, but it is our privilege and perhaps responsibility to weigh in on these things. It does seem that faculty should be paid more for doing additional work, and in that case, we should consider why the chair of the T&P committee, for example, should not also receive a stipend. It would also be nice to see tenured faculty taking turns as Chair (with options for non-tenured faculty, as well).

S. Alhaddad – I am also in favor of the stipend for the Executive Committee. I also think that the Chair should receive a course release, given the additional workload. I agree with Suzanne's point that other labor-intensive roles should also be fairly compensated, but do not feel that denying this to the Executive Committee because of this is the right move – we should treat it as an opportunity to continue the discussion.

B. Taylor-Driggers – I wanted to make a statement about the stipends. After the silence during the Executive Committee part of the elections last meeting, I approached Walt and Todd about the stipend as a way of encouraging faculty to run without feeling too much of a burden. I don't want to appear like I was voting for a stipend for myself or anyone else.

J. Yarosh – I had been considering volunteering for various roles and/or scaffolding up into higher positions progressively, but am still debating.

D. Lawrence – Phillip noted in the chat that this was also discussed with Division Chairs, not just the Deans. I also think the idea of rotating through positions (like Jerrod

mentioned) is good and Senate has used a similar model [A. Yingst pointed out that this is no longer the case in Senate]. I have been at USCL for 10 years and have not seen an instance where we actually hold an election for the Executive committee. There is usually silence and the same 5 or so faculty members volunteer each time. The stipends may or may not alleviate this issue, but something needs to be done.

S. Criswell – [Regarding the rotation model, where the Vice Chair is expected to be Chair the following year, and the notion that participation would be mandatory] Would a course release sway [Jerrod's] consideration of serving? If this service were mandatory, there is concern that an individual's name would come up during a time when they have too many responsibilities and their service would not be satisfactory.

N. Lawrence – My comment is neither in support nor against the stipend, but rather to emphasize Brittany and Dana's point about the silence during the Executive Committee election, and the same names coming up every year. I also want to share some ambivalence about the notion of mandatory service. I am glad that we're having this conversation, and it is because Brittany volunteered last year. I also appreciate the faculty who volunteered after Chris, and I removed our names from the ballot. I think some gratitude is an order either way, no matter how people feel about it.

S. Penuel – Further discussion of the concept of the rotation, perhaps allowing people with mitigating circumstances to trade with faculty of equal or higher rank.

J. Yarosh – [Answering Stephen's question regarding course release] I'm not sure if a course release would impact my decision to volunteer. There are many factors to consider.

A. Yingst - [In answer to the rotation model] I think that requiring someone to Chair that does not want to is a bad idea, given how much work is required. As one of the people whose name comes up regularly, I think that it is ok for us to specialize in self-governance.

P. Lawrence – I agree with Andy's position but do see potential merit to a rotation schedule like Jerrod proposed – if I knew that I would be Chair in 2-3 years, I could make space in my schedule to give it proper attention. If we were to implement it right now, there would be challenges, but if your name went into the queue when tenure was awarded, there would be some years before you were called to serve. Everyone is making good points.

S. Sellhorst – It is worth considering officially putting more presence on service via the faculty manual, given the issue of volunteerism. I don't necessarily believe that stipends are the solution to the issue, but I am not against them. Course releases could cause issues with the schedule so I think I would favor compensation over course release, but the real crux of the issue is how do we value service.

C. Bundrick – I think that the issue is less about the stipends themselves and more, like Sarah said, ways to value this service and of getting faculty to buy in.

A. Yingst – I think that money and course releases are a good way to buy investment. There is a lot of work that goes unrecognized on our campus. For example, a number of advisees taken on by a faculty member might equate to a course release. Someone posed a stipend for the T&P committee and having served on both T&P and Executive committees, I don't think they are equal amounts of work. I do favor a small stipend for T&P. Course releases also help allow important, time-consuming work to happen. I think that reducing number of advisees for big service should also be considered in this conversation, since good advising encourages student retention.

New motion from March meeting by the PCFS executive committee – Dr. Andrew Yingst

- Vote to approve the proposed changes to capitalization in USC Lancaster's local tenure and promotion procedures in the faculty manual. The vote passed and the motion carried.

Legislative Update

UPDATE on the House budget. At the March meeting of the Faculty Organization, I reported on updates related to the state budget from the House. Since then the House has added raises for state employees to its budget. **Here is the proposal: Anyone making less than \$83,000 a year will get a \$2,500 raise. Anyone making over \$83,000 a year will get a 3% raise.** Remember that this is a very preliminary look at what next

year's situation might be as the Senate is still working on its budget. In any case, there will be no tuition increase for USC Lancaster students again next year.

There is a **workforce development bill with higher education implications** coming from the SC House of Representatives (H. 4060) that you might have interest in watching. Here is the link to the bill as it currently stands:

REPORT TO THE FACULTY ORGANIZATION
April 7, 2023

1. **Academic Integrity Violations.** Since summer term 2022, 13 academic integrity violations have been reported to my office (compared to 10 this time last year). Five professors made the reports. In all cases, professor recommended sanctions were implemented. No student requested informal or formal hearings.
2. **Hardship Withdrawal Requests.** Thanks to the APGC committee for very good work this year. Special thanks to committee chair Jerrod Yarosh for streamlining processes that make the committee's work more efficient. Some 22-23 data:
 - a. Hardship Withdrawal Petitions reviewed: 15
 - b. Approved: 8 (53% approval rate)
 - c. Disapproved: 7 (46% disapproval rate)
 - d. Academic Suspension Appeals reviewed: 3
 - e. Approve: 1 (33% approval rate)
 - f. Disapproved: 2 (66% disapproval rate)
 - g. Total approval rate for both: 50%
3. **APGC Committee Description Change.** Ken Cole brought a request to the committee to change its description to include review of SAP (Satisfactory Academic Progress) appeals pertaining to financial aid eligibility. Mr. Cole mentioned that the government would like to see standing committees that handle these appeals. To date, we have used an ad hoc committee. Building this function into APGC makes sense since the committee's hardship withdrawal and suspension appeal petitions often have ramifications for satisfactory academic progress. The committee unanimously agreed to recommend a change to its description adding "this committee will function as the

University's SAP appeals committee." A formal motion to change the FO bylaws will come to the FO at the first fall 2023 meeting.

4. **2023 Spring Fling** will be held April 17th - 20th to provide the USCL campus with a fun and engaging event, celebrating the end of the Spring 2023 semester. Students, staff, and faculty can expect fun games, good food, and memorable takeaways throughout the week. Due to its timing, Spring Fling will also help address student stress and anxiety concerns while also helping to prepare for end-of-term finals. A mix of new and established events will be held during Spring Fling including goat yoga, awards, and an evening student social.
5. **Banquet Award Ceremony for Teacher of the Year and Servant Heart Awards.** During the evening of Tuesday, April 18th from 5:30-7:30 PM all faculty, staff, and students are invited to an awards banquet. Long-standing awards such as Teacher of the Year and Servant Heart will be awarded along with new awards like Student Club of the Year and Most Spirited Lancer. Immediately following the awards banquet will be a highly-request student social/dance. Food will be served throughout the evening and we look forward to seeing you all there!" 6. **Call for Commencement Participation.** USC Lancaster will hold its annual Commencement Exercises at 11:00 a.m. on SATURDAY, April 29 in the Starr-Hubbard Parking area near the Rose Garden. On behalf of our graduates, I want to thank you for attending. Student-faculty connections at commencement are a vital part of its emotional core.
7. **Course Evaluations.** This is a reminder that all course evaluations for Spring 2023 semester will be given between Monday, April 10 and close on Monday, April 24 at 11:59PM (the last regular class day of the semester). Students will be prompted with reminders periodically during this time period. If you are teaching in a synchronous format, consider taking time during your class to have students access and complete the course evaluations.
8. **Finishing the Semester.** The last day of class for the 16-week semester is April 24. Final exam week begins April 26 and ends May 3. Final exams begin on April 28. Final grades are due by noon on May 6 at noon.

1) Summer Courses

If you are scheduled to teach a course during one of the 2023 summer sessions, please be sure that your course appears on the summer schedule. If the course does not appear or a correction needs to be made, please share the information with your Division Chair so that it may be given to the Academic and Student Affairs Department and our Campus Registrar. Once it appears on the schedule the Division Chairs and Academic Affairs Department will include the course in the Compensation Report.

2) Summer Compensation

The Division of Human Resources has not released the information about summer compensation for 2023. The Human Resources Summer Compensation Webinar is scheduled for Wednesday April 12, 2023. During the webinar I will confirm the earnings percentage and verify if the Palmetto College Summer Compensation Offer Letters are still needed. I will share an update via email following the webinar.

For planning purposes please use 33.33% of the faculty member's preceding academic year salary as the total compensation that may be earned from state entities during the summer months (beginning May 16 and ending August 15). The percentage includes compensation for instruction and extra compensation (ECOM). ECOM includes compensation earned through grants and other duties not related to teaching during the summer months.

Any faculty member who expects to exceed the compensation cap should meet with Dr. Lekan prior to the start of the summer session to ensure that either approval is obtained from Chancellor Elkins or arrangements are made for compensation to be equal to or less than the cap.

3) Internal and External Grants

Any faculty member who needs to receive compensation from an internal or external grant source should complete a Personnel Request Form and receive proper approvals prior to it being sent to the Human Resources Department for processing. Please be sure to include the number of hours per week because they are needed to be able to successfully process the request.

Personnel Request Forms should also be completed to hire student assistants who will be paid through grant funds. The only exception to this is for student assistants who are funded from Palmetto Undergraduate Research Experience (PURE) grants. Students funded through PURE grants will be awarded their compensation through the Financial Aid Department.

Turnout was excellent for Dr. Holland's talk on pandemic-related student challenges. We had over 25 people in attendance, which produced a very robust Q&A. Thanks to everyone who came to the talk and to Dr. Holland for sharing her insights and providing the opportunity for these discussions.

April is the final month of regular-schedule tutoring at the ASC, but we will continue to serve students enrolled in USCL courses through all five summer sessions. As always, this will include both virtual and in-person tutoring, with our coverage tailored to the courses being offered. Please anticipate receiving a summer tutoring schedule soon.

Summary of Tutoring Data

Year-to-year trends: Session data from March confirms that the Center has been considerably slower than comparable periods in past years. Circumstances related to specific courses appear to have played a role (see distribution trends below). We are reassured knowing that Center use thus far this semester (140 visits) exceeds the previous period in 2022 (125), but there is still cause for concern in the decline, and we are working to understand and reverse the trend.

Session distribution trends: Student preference for in-person tutoring remains steady at about 75%. Distribution of courses has shifted significantly away from Math in the past several weeks. This and a steep drop in Studio visits accounts for the decline in tutoring sessions. This suggests we should seek solutions to lower demand for these specific offerings, rather than to overall Center use.





I. COURSE DESCRIPTION

This PCAM 299 independent study course is a three-credit hour supervised exploration of the South Carolina Leadership Education in Neurodevelopmental and Related Disabilities (SC LEND) program. LEND provides long-term interdisciplinary training that is designed to improve the health of infants, children, and adolescents with disabilities. Funded by the Bureau of Maternal and Child Health in the U.S. Department of Health and Human Service, it is a nationwide program with 52 sites in 44 states. The South Carolina program is a state-wide program that represents the Medical University of South Carolina, the Children's Hospital of Prisma Health Upstate, and the University of South Carolina. Outside of USC Lancaster, most of the other trainees in the program are graduate students and professionals from a wide range of fields related to health and education. This PCAM 299 independent study course requires a contract approved by the instructor, advisor, and academic dean and it may be taken for elective credit only. This course can contribute to one of the Graduation with Leadership Distinction (GLD) pathways. Students should discuss this option with the instructor and a GLD advisor early in the course.

II. GOALS AND LEARNING OUTCOMES

Upon completion of this course, the student should specifically be able to:

1. Understand many of the developmental disorders that affect children and the role of interprofessional care for these individuals.
2. Advance the knowledge and skills of all child health professionals to improve health care delivery systems for children with developmental disabilities.
3. Participate in interprofessional education emphasizing the integration of services from state and local agencies, organizations, private providers, and communities.
4. Promote innovative practices to enhance cultural competency, family-centered care, and interprofessional partnerships.

III. TEXTBOOKS, READINGS, AND OTHER MATERIALS

There is no required textbook for this course; however, most of the online lectures will have supplemental reading materials that will be provided.

IV. OVERALL STRUCTURE OF THE COURSE

You will complete 7 two-week online modules through Medical University of South Carolina (MUSC) that cover clinical and leadership topics related to autism spectrum disorders (ASD) and neurodevelopmental disabilities (ND). You will write a short reflection on each module.

Throughout the semester you will complete 4 clinical or educational experiences designed to give you a glimpse into treatment, education, and healthcare. You will write a reflection for each of these experiences.

You will attend 1 statewide meeting in Columbia or Greenville, South Carolina. The meeting will include guest speakers who work with or research this population, as well as family members and self-advocates who will discuss their experiences with disability. If you are not able to attend the meeting, an alternate assignment will be provided. You will write a paper summarizing your experience.

Through these course activities, you will have access to leaders in the field of neurodevelopmental disabilities in South Carolina. Use the connections you make to learn about possible career paths, seek the advice of new mentors, and develop relationships with others interested in developmental disabilities.

V. COURSE REQUIREMENTS

- You need a 2.5 or higher GPA to enroll in this course. There are no pre-requisites; however, this course is most relevant to students majoring in healthcare or education related fields.
- You will need a computer or other device for access to Blackboard, the online modules, and your USCL student email.
- Register for the online MUSC course modules 2 weeks before the semester begins, and be ready to start them when the semester begins.
- Attend an in-person conference or complete an alternate assignment specified by the instructor.
- Keep track of course grades in Blackboard. If you are failing (< 69 average), speak to the instructor and your advisor about dropping the class before the withdrawal date.
- Conduct yourself with professionalism. Email communication should be proofread and have a professional tone. Clothing at SC LEND activities is business casual.
- Don't cheat or plagiarize on any assignment. Follow the academic integrity policy of the university.

Our very own DJ **Antonio Mackey** will be providing music.

Upward Bound

- 22 Upward Bound participants just completed a successful **Spring Break Trip to Charleston, SC**. This served as the first overnight trip for the project since well before the COVID-19 pandemic began. During their time away, participants toured **Charleston Southern University**, the **College of Charleston**, and the **University of South Carolina** main campus in Columbia. Our group also visited the historic **Charleston City Market** and **Fort Sumter and Fort Moultrie National Historical Park**.
- 29 participants attended the **Charlotte Hornets** NBA game versus the Chicago Bulls at the Spectrum Center in Charlotte, NC on March 31, 2023.
- We had a wonderful time with **South Middle School** students who visited the USCL campus on March 15, 2023. Special thanks to **Nick Jones** and **Kanisha Rollings** for arranging this session.



A Regional Palmetto College

- Our next session will be a hybrid **Personal Productivity Workshop** with **Iris Reading** at 10:00 a.m. on Saturday, April 15, 2023. The goal will be to help participants maximize study habits by helping them better their reading comprehension skills.
- A **Parent and Participant Session** will be held in the TRiO LRC on the evening of Thursday, April 27, 2023. We will discuss the upcoming **2023 Upward Bound Summer Experience**, our summer **Internship Academy**, as well as final college admission preparations for our high school seniors.
- This year's Summer Experience will take place at USCL from June 12 – July 21, 2023. We plan to offer supplemental instruction courses in English Composition and Literature, Mathematics, Spanish, and STEM and Lab Science. The Internship Academy, our summer work-study program designed to expose participants to careers requiring four-year college degrees, will take place over the course of nine (9) weeks, beginning in mid-June and ending in mid-August.

Student Organizations

- The **USCL Rotaract Club** held its first meeting of the semester on March 14, 2023. New club members learned about the history of **Rotary International**, one of the world's largest service organizations, and its mission of providing service to others, promoting integrity, and advancing goodwill, peace, and understanding through the fellowship of business, community, and professional leaders.
- The **D.E.F.I.N.E.** organization held its last meeting on March 29, 2023. In addition to planning their next community service project detailed below, group members watched a TED Talk about stepping out of comfort zones and growing as individuals.
- **Gary Robinson** of **Engaging Men & Boys**, a local organization whose mission is transforming men and boys in changing the narrative of domestic violence and sexual assault, will present to members of the **G.E.N.T.S.** organization at their next meeting on Monday, April 10, 2023.

Data Management and Performance Reporting

- Last month, independent auditor CliftonLarsonAllen LLP completed their Single Audit of federal funds for the University of South Carolina. This included all TRiO grant projects in the USC system. For four (4) months, we worked with USC's Director of Financial Reporting on documenting core curriculum instruction, expense allowability, participant eligibility, performance reporting, and services provided. We're pleased to report that our Federal TRiO Programs at the Lancaster campus were found to be compliant with no audit findings.
- The Annual Performance Report (APR) for the OSP project was submitted to our sponsor, the federal Department of Education (ED) on March 28, 2023. The report measured the performance of the project for the second year of its five-year grant cycle, which covered the reporting period September 1, 2021, through August 31, 2022. We were pleased that we received at or above the approved rate for our performance objectives, allowing us to achieve the maximum amount of prior experience (PE) points. These points will be applied toward the next grant competition for this project in 2027. We appreciate the hard work of the OSP project team, and especially **Ken Cole** and the **Office of Financial Aid and Veteran Affairs** for making this successful submission possible.



- The APR for our Upward Bound project opened on March 28, 2023. This report will measure the performance of the project for the final year of its previous five-year grant cycle, covering the period June 1, 2021, through May 31, 2022. The final report is due to ED by April 28, 2023.

Community Service

- USCL's **G.E.N.T.S.** organization, under the leadership of OSP students **Christian Cochran** (President) and **Scott Meadows** (Vice President), held a **Charity Basketball Tournament** on March 24, 2023. Concessions were provided by **D.E.F.I.N.E.** \$250.00 was raised to benefit the **United Way of Lancaster County**. We greatly appreciate **Jeff Rammage** for his support of this event. Special thanks also to **Caroline Poovey** and the staff of the **Gregory Family YMCA** for hosting our fundraiser.
- At their meeting on March 29, **D.E.F.I.N.E.** members began collecting spare change as part of a **Baby Bottle Fundraiser** to support the **Women's Enrichment Center** on Main Street in Lancaster. This non-profit agency supplies vital care, counseling, education, and workforce initiatives and referrals for expectant mothers in our local community.

Legislative Updates

- According to the **Council for Opportunity in Education** (COE), 457 Capitol Hill meetings with 85 Senators and 372 Representatives and Delegates were held during their recent Policy Seminar. In these meetings, 46% said they will support a \$107 million increase for the Federal TRiO Programs in Fiscal Year 2024. In addition, 57% said they will oppose cuts to education funding.
- Last week, several members of the House of Representatives sent the FY24 TRiO Funding Letter to the House Appropriations Labor, HHS, and Education Subcommittee. The letter received 186 signers, requesting that this subcommittee continue to prioritize TRiO grant projects nationwide – more than 3,000 projects in every state and several federated territories. An increase in TRiO funding will allow more students to prepare for, persist in, and graduate from college. This, in turn, will yield greater gains for our economy as research demonstrates that college graduates have lower rates of unemployment, pay more in federal taxes, and earn a million dollars more over the course of their working lives than non-college graduates.

The Athletics Advisory Committee met on Friday, March 31. Topics of discussion included:

1. Discussion of the Athlete Progress Reports based on Faculty, Coach, and Student Feedback

- a. We had a great conversation about updating the progress reports
 - i. Background: The progress reports came about because faculty were reporting that they were not sure who the athletes were and wanted to make sure athletes were communicating about their absences and make up work
- b. General thoughts of the current system (based on committee discussion and faculty feedback):
 - i. While the progress forms seem to be a good idea in theory, many faculty are not receiving the form and the student-athletes are unsure about the process
 - ii. The committee has decided that these reports may not be necessary since issues are coming to light with the established Early Alert system
 - iii. We still want a process that is simple, streamlined, and little burden to the faculty
- c. Proposed method:
 - i. Printed calendar of dates provided to the faculty at the beginning of the semester from athlete
 - ii. Student-athlete should contact the professor one week in advance of missing class to arrange make-up work
 - iii. Faculty should encourage all students to speak to them in advance if there is a conflict with days
 - iv. Early alert system should continue to be used for students struggling with course work or not attending class

2. Time management video/speaker series

- a. Dr. Sarah Sellhorst has proposed mandatory time-management sessions for our student-athletes
 - i. We discussed incorporating times that representatives from Student Affairs Office, ASC, Counseling Services, etc could speak to athletes about resources on campus, time management, and soft skill development
