# **GENERAL INFORMATION AND QUESTIONS ANSWERED**

- 1. Pre-Bid Meeting: A non-mandatory pre-bid meeting was held on May 19, 2015. A list of attendees is attached.
- 2. Last Day for questions is May 28, 2015 at 5pm. Questions must be submitted in writing (email) to Chris Smith, CHA Sports at <a href="mailto:csmith@chacompanies.com">csmith@chacompanies.com</a>.
- Clarification: The soccer contractor shall access the site from South Marion Street, through the track site. Track contractor will install and maintain the stabilized construction entrance. Soccer contractor shall maintain the temporary access path through the track site and restore to acceptable grade when finished.
- 4. Clarification: Excess soil may be stockpiled in the former Roundhouse building pad and left there for future use by track contractor. Haul off is not necessary.
- Clarification: Specification section 014000 Quality Requirements subsection 1.4.C calls for a Certified Field Builder to construct certain parts of the project. A list of certified field builders can be found at the following website: http://www.sportsbuilders.org/fields/cfb.cfm

# 1.1 WORK COVERED BY CONTRACT DOCUMENTS

    - c. Furnishing and installing new sod.
    - d. New perimeter chain link fencing and ball netting system.
    - e. New irrigation system.

# 1.3 WORK SEQUENCE


A. The Work shall be conducted in 1 phase.

### 1.4 USE OF PREMISES

A. General: Contractor shall have full use of premises for construction operations, including use of Project site, during construction period. Contractor's use of premises is limited only by Owner's right to perform work or to retain other contractors on portions of Project.

# 1.5 WORK UNDER OTHER CONTRACTS

- A. Separate Contract: Owner will award a separate contract for performance of certain construction operations at Project site. Those operations are scheduled to be performed at the same time as this Contract. The separate contract will include the following:
  - Athletic Village Improvements, Track and Field Upgrades: A separate contract will be awarded to a contractor for construction of a new track and field facility adjacent to the Project. Access to this Project will be through a portion of the track and field project site. Contractor for the soccer project shall provide access as shown to this Project during construction. Soccer contractor shall maintain the stabilized construction entrance on South
