The following Questions were received from Vendor A

Question #1

Submission issue: The RFQ states to submit one electronic copy on a "compact disc." Is a USB drive acceptable?

Question #3

Question on number of students: Would all of the students at Lancaster, Salkehatchie, Sumter and Union as well as the USC Ft. Jackson Associate Degree program be candidates for online tutoring (e.g., does the 4300 noted include all on-ground students)?
