The sites visits and deadlines for receipt of bids (bid openings) and deadlines for receipt of quotes for solicitations that are scheduled between today (3/16/20) and March 31, 2020 are suspended effective immediately. The President of the University of South Carolina System, Bob Caslen, on (3/15/20), announced in response to the public health crisis posed by the coronavirus and in accordance with yesterday's order from the South Carolina Governor's Office, the University of South Carolina will close all system institutions March 16 through March 31, 2020. Our first priority remains the health, welfare, and safety of our students, faculty, and staff. Initiating these additional mitigation measures, to include reducing large groups of people on our campuses, will reduce the risk to our communities further. Therefore, the site visits and deadlines for receipt of bids (bid openings) and deadlines for receipt of quotes for solicitations scheduled between today (3/16/20) and March 31, 2020 are suspended indefinitely and will be rescheduled after the University of South Carolina System institutions are reopened.
