Q1. Please provide average weights to use for compactor and roll off pricing calculations. The bid-pricing schedule lumps transportation and disposal into the same number. Please consider separating these two costs on the bid-pricing schedule. Doing so would provide the best value to USCU.

A. **Weights vary per container on what is disposed.**

**CLC and Palmetto House compactors are on will call and generally contain 5-8 tons monthly. Could be more or less and actual may vary.**

**Roll-off weights can be 1-6 tons depending on materials.**

**Separating costs of weight fee, haul fee, and if any standard service fees would be good.**

Q2. Please clarify and identify the containers needed for the event move in and move out services. This service is not identified in the scope or the bid-pricing schedule

A. **Typically we need 4-6 8yd containers fall and spring during Housing moves.**

**Empty daily or as needed during this time. Duration is 1-2 weeks.**

Q3. During the site visit, we ran across additional 8 CY Front End containers for cardboard recycling. Should these be included in the bid?

A. **Yes, Lot 2 is changed as follows:**
