This addendum modifies the Contract Documents only in the manner and to the extent stated herein and shown on any accompanying drawings and will become a part of the Contract Documents. Except as specified or otherwise indicated by this addendum, all work shall be in accordance with the basic requirements of the Contract Documents.

GENERAL:

1. Attached is the sign-in sheet for the Pre-Bid meeting held Thursday, May 17, 2012 listing the attendees.

DRAWINGS:

1. Plans General: New aluminum checker plate sizes shall match existing thicknesses and style.
2. Sheet A301 at Ramp: Add a section cut 5/A701 at the step side (outside edge) of the ramp. This section shall be similar to 5/A701 and shall include the 2 x 2 x 3/16 aluminum angle.
3. Sheet A301 at Ramp: The revised ramp structure shall match the existing 3" x 3" aluminum structural system at 16" on center. Connections may be bolted using stainless steel angles and bolts as noted elsewhere on the plans or may be welded at the contractors' option.
4. Sheet A701 Section 1: Omit painting on new aluminum face panel.
5. Sheet A701 Section 5: Provide a 2" x 2" x 3/16" aluminum edge angle at the perimeter similar to Section 1 on this sheet.
