6. Final wording for the monument text will be provided to the selected contractor by February 24.
7. The contractor will be responsible for protecting existing hardscapes to remain; refer to Item #17 in 'USC Supplementary General Conditions for Construction Projects' in the project manual.
8. A laydown area will be provided consisting of 2 concrete staff parking spaces at the rear of Osborne, and one staff parking space at the adjacent asphalt lot.
