- f. Concrete trucks will be able to drive close to the first base side seating area and to the gates located near the third base side seating area. Concrete can be pumped from these locations up to the elevated seating areas at both locations.
- g. Owner will furnish and install new seating at new concrete platforms.
- h. Owner will furnish and install traffic coating on new concrete platforms.
- i. Owner will be responsible for all work related to wall mounted electrical outlets at both seating locations.
- All pipe and tube railings and guardrails shall be galvanized steel and shall have powder coated finish.

B. CHANGES TO TECHNICAL SPECIFICATIONS AND DRAWINGS:

SPECIFICATIONS

- 1. Reference Section 055213, Pipe and Tube Railings. At paragraph 2.7, add the following:
 - "F. Powder-Coat Finish: Prepare, treat, and coat galvanized metal to comply with resin manufacturer's written instructions and as follows:
 - 1) Prepare galvanized metal by thoroughly removing grease, dirt, oil, flux, and other foreign matter.
 - 2) Treat prepared metal with zinc-phosphate pretreatment, rinse, and seal surfaces.
 - 3) Apply thermosetting polyester or acrylic urethane powder coating with cured-film thickness not less than 1.5 mils (0.04 mm).
 - 4) Color: Match Owner's color sample."


