D1 Pre-Bid Conference Vendor question: Are there Owner provided doors? Answer: Yes, that is correct. The Owner is enlarging a door and adding a door. Please see notes on Drawing E11G for details.

Pre-Bid Conference Vendor Question: Please confirm the Substantial Completion and Liquidated Damages.

Answer: Substantial Completion and Liquidated Damages remain as stated on the SE-330 and for reference are as follows:

\S 9. TIME OF CONTRACT PERFORMANCE AND LIQUIDATED DAMAGES a) CONTRACT TIME

Bidder agrees that the Date of Commencement of the Work shall be established in a Notice to Proceed to be issued by the Owner. Bidder agrees to substantially complete the Work within **85** Calendar Days from the Date of Commencement, subject to adjustments as provided in the Contract Documents.

b) LIQUIDATED DAMAGES

Bidder further agrees that from the compensation to be paid, the Owner shall retain as Liquidated Damages the amount of \$ 250.00 for each Calendar Day the actual construction time required to achieve Substantial Completion exceeds the specified or adjusted time for Substantial Completion as provided in the Contract Documents. This amount is intended by the parties as the predetermined measure of compensation for actual damages, not as a penalty for nonperformance.
