1. STANDARD SUPPLEMENTAL INSTRUCTIONS TO BIDDERS

- **1.1.** These Standard Supplemental Instructions To Bidders amend or supplement Instructions To Bidders (AIA Document A701-1997) and other provisions of Bidding and Contract Documents as indicated below.
- **1.2.** Compliance with these Standard Supplemental Instructions is required by the Office of State Engineer (OSE) for all State projects when competitive sealed bidding is used as the method of procurement.
- 1.3. All provisions of A701-1997, which are not so amended or supplemented, remain in full force and effect.
- **1.4.** Bidders are cautioned to carefully examine the Bidding and Contract Documents for additional instructions or requirements.

2. MODIFICATIONS TO A701-1997

- **2.1.** *Delete Section 1.1 and insert the following:*
 - 1.1 Bidding Documents, collectively referred to as the Invitation for Bids, include the Bidding Requirements and the proposed Contract Documents. The Bidding Requirements consist of the Advertisement, Instructions to Bidders (A-701), Supplementary Instructions to Bidders, the bid form (SE-330), the Intent to Award Notice (SE-370), and other sample bidding and contract forms. The proposed Contract Documents consist of the form of Agreement between the Owner and Contractor, Conditions of the Contract (General, Supplementary and other Conditions), Drawings, Specifications, all Addenda issued prior to execution of the Contract, and other documents set forth in the Bidding Documents. Any reference in this document to the Agreement between the Owner and Contractor, AIA Document A101, or some abbreviated reference thereof, shall mean the AIA A101, 2007 Edition as modified by OSE Form 00501 Standard Modification to Agreement Between Owner and Contractor. Any reference in this document to the General Conditions of the Contract for Construction, AIA Document A201, or some abbreviated reference thereof, shall mean the AIA A201, 2007 Edition as modified by OSE Form 00811 Standard Supplementary Conditions.
- **2.2.** In Section 1.8, delete the words "and who meets the requirements set forth in the Bidding Documents".
- **2.3.** In Section 2.1, delete the word "making" and substitute the word "submitting."
- **2.4.** *In Section 2.1.1:*

After the words "Bidding Documents," delete the word "or" and substitute the word "and."

Insert the following at the end of this section:

Bidders are expected to examine the Bidding Documents and Contract Documents thoroughly and should request an explanation of any ambiguities, discrepancies, errors, omissions, or conflicting statements. Failure to do so will be at the Bidder's risk. Bidder assumes responsibility for any patent ambiguity that Bidder does not bring to the Owner's attention prior to bid opening.

2.5. In Section 2.1.3, insert the following after the term "Contract Documents" and before the period: and accepts full responsibility for any pre-bid existing conditions that would affect the Bid that could have been ascertained by a site visit. As provided in Regulation 19-445.2042(B), A bidder's failure to attend an advertised pre-bid conference will not excuse its responsibility for estimating properly the difficulty and cost of successfully performing the work, or for proceeding to successfully perform the work without additional expense to the State.

2.6. *Insert the following Sections* 2.2 *through* 2.6:

2.2 CERTIFICATION OF INDEPENDENT PRICE DETERMINATION

GIVING FALSE, MISLEADING, OR INCOMPLETE INFORMATION ON THIS CERTIFICATION MAY RENDER YOU SUBJECT TO PROSECUTION UNDER SECTION 16-9-10 OF THE SOUTH CAROLINA CODE OF LAWS AND OTHER APPLICABLE LAWS.

- (a) By submitting an bid, the bidder certifies that—
 - (1) The prices in this bid have been arrived at independently, without, for the purpose of restricting competition, any consultation, communication, or agreement with any other bidder or competitor relating to—
 - (i) Those prices;
 - (ii) The intention to submit an bid; or
 - (iii) The methods or factors used to calculate the prices offered.
 - (2) The prices in this bid have not been and will not be knowingly disclosed by the bidder, directly or indirectly, to any other bidder or competitor before bid opening (in the case of a sealed bid solicitation) or contract award (in the case of a negotiated solicitation) unless otherwise required by law; and
 - (3) No attempt has been made or will be made by the bidder to induce any other concern to submit or not to submit an bid for the purpose of restricting competition.
- (b) Each signature on the bid is considered to be a certification by the signatory that the signatory—
 - (1) Is the person in the bidder's organization responsible for determining the prices being offered in this bid, and that the signatory has not participated and will not participate in any action contrary to paragraphs (a)(1) through (a)(3) of this certification; or
 - (2)(i) Has been authorized, in writing, to act as agent for the bidder's principals in certifying that those principals have not participated, and will not participate in any action contrary to paragraphs (a)(1) through (a)(3) of this certification [As used in this subdivision (b)(2)(i), the term "principals" means the person(s) in the bidder's organization responsible for determining the prices offered in this bid];
 - (ii) As an authorized agent, does certify that the principals referenced in subdivision (b)(2)(i) of this certification have not participated, and will not participate, in any action contrary to paragraphs (a)(1) through (a)(3) of this certification; and
 - (iii) As an agent, has not personally participated, and will not participate, in any action contrary to paragraphs (a)(1) through (a)(3) of this certification.
- (c) If the bidder deletes or modifies paragraph (a)(2) of this certification, the bidder must furnish with its offer a signed statement setting forth in detail the circumstances of the disclosure.

2.3 DRUG FREE WORKPLACE

By submitting a bid, the Bidder certifies that Bidder will maintain a drug free workplace in accordance with the requirements of Title 44, Chapter 107 of South Carolina Code of Laws, as amended.

2.4 CERTIFICATION REGARDING DEBARMENT AND OTHER RESPONSIBILITY MATTERS

- (a) (1) By submitting an Bid, Bidder certifies, to the best of its knowledge and belief, that-
 - (i) Bidder and/or any of its Principals-
 - (A) Are not presently debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any state or federal agency;
 - (B) Have not, within a three-year period preceding this bid, been convicted of or had a civil judgment rendered against them for: commission of fraud or a criminal offense in

connection with obtaining, attempting to obtain, or performing a public (Federal, state, or local) contract or subcontract; violation of Federal or state antitrust statutes relating to the submission of bids; or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, tax evasion, or receiving stolen property; and

- (C) Are not presently indicted for, or otherwise criminally or civilly charged by a governmental entity with, commission of any of the offenses enumerated in paragraph (a)(1)(i)(B) of this provision.
- (ii) Bidder has not, within a three-year period preceding this bid, had one or more contracts terminated for default by any public (Federal, state, or local) entity.
- (2) "Principals," for the purposes of this certification, means officers; directors; owners; partners; and, persons having primary management or supervisory responsibilities within a business entity (e.g., general manager; plant manager; head of a subsidiary, division, or business segment, and similar positions).
- (b) Bidder shall provide immediate written notice to the Procurement Officer if, at any time prior to contract award, Bidder learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
- (c) If Bidder is unable to certify the representations stated in paragraphs (a)(1), Bid must submit a written explanation regarding its inability to make the certification. The certification will be considered in connection with a review of the Bidder's responsibility. Failure of the Bidder to furnish additional information as requested by the Procurement Officer may render the Bidder nonresponsible.
- (d) Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render, in good faith, the certification required by paragraph (a) of this provision. The knowledge and information of an Bidder is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
- (e) The certification in paragraph (a) of this provision is a material representation of fact upon which reliance was placed when making award. If it is later determined that the Bidder knowingly or in bad faith rendered an erroneous certification, in addition to other remedies available to the State, the Procurement Officer may terminate the contract resulting from this solicitation for default.

2.5 ETHICS CERTIFICATE

By submitting a bid, the bidder certifies that the bidder has and will comply with, and has not, and will not, induce a person to violate Title 8, Chapter 13 of the South Carolina Code of Laws, as amended (ethics act). The following statutes require special attention: Section 8-13-700, regarding use of official position for financial gain; Section 8-13-705, regarding gifts to influence action of public official; Section 8-13-720, regarding offering money for advice or assistance of public official; Sections 8-13-755 and 8-13-760, regarding restrictions on employment by former public official; Section 8-13-775, prohibiting public official with economic interests from acting on contracts; Section 8-13-790, regarding recovery of kickbacks; Section 8-13-1150, regarding statements to be filed by consultants; and Section 8-13-1342, regarding restrictions on contributions by contractor to candidate who participated in awarding of contract. The state may rescind any contract and recover all amounts expended as a result of any action taken in violation of this provision. If contractor participates, directly or indirectly, in the evaluation or award of public contracts, including without limitation, change orders or task orders regarding a public contract, contractor shall, if required by law to file such a statement, provide the statement required by Section 8-13-1150 to the procurement officer at the same time the law requires the statement to be filed.

2.6 RESTRICTIONS APPLICABLE TO BIDDERS & GIFTS

Violation of these restrictions may result in disqualification of your bid, suspension or debarment, and may constitute a violation of the state Ethics Act. (a) After issuance of the solicitation, bidder agrees not to discuss this procurement activity in any way with the Owner or its employees, agents or officials. All communications must be solely with the Procurement Officer. This restriction may be lifted by express written permission from the Procurement Officer. This restriction expires once a contract has been formed. (b) Unless otherwise approved in writing by the Procurement

Officer, bidder agrees not to give anything to the Owner, any affiliated organizations, or the employees, agents or officials of either, prior to award. (c) Bidder acknowledges that the policy of the State is that a governmental body should not accept or solicit a gift, directly or indirectly, from a donor if the governmental body has reason to believe the donor has or is seeking to obtain contractual or other business or financial relationships with the governmental body. Regulation 19-445.2165(C) broadly defines the term donor.

2.7. *Delete Section 3.1.1 and substitute the following:*

3.1.1 Bidders may obtain complete sets of the Bidding Documents from the issuing office designated in the Advertisement in the number and for the deposit sum, if any, stated therein. If so provided in the Advertisement, the deposit will be refunded to all plan holders who return the Bidding Documents in good condition within ten days after receipt of Bids. The cost of replacement of missing or damaged documents will be deducted from the deposit. A Bidder receiving a Contract award may retain the Bidding Documents and the Bidder's deposit will be refunded.

- **2.8.** Delete the language of Section 3.1.2 and insert the word "Reserved."
- 2.9. In Section 3.1.4, delete the words "and Architect may make" and substitute the words "has made."
- **2.10.** *Insert the following Section 3.1.5*

3.1.5 All persons obtaining Bidding Documents from the issuing office designated in the Advertisement shall provide that office with Bidder's contact information to include the Bidder's name, telephone number, mailing address, and email address.

2.11. *In Section 3.2.2:*

Delete the words "and Sub-bidders"

Delete the word "seven" and substitute the word "ten"

2.12. *In Section 3.2.3*:

In the first Sentence, insert the word "written" before the word "Addendum."

Insert the following at the end of the section:

As provided in Regulation 19-445.2042(B), nothing stated at the pre-bid conference shall change the Bidding Documents unless a change is made by written Addendum.

2.13. *Insert the following at the end of Section 3.3.1:*

Reference in the Bidding Documents to a designated material, product, thing, or service by specific brand or trade name followed by the words "or equal" and "or approved equal" shall be interpreted as establishing a standard of quality and shall not be construed as limiting competition.

2.14. *Delete Section 3.3.2 and substitute the following:*

3.3.2 No request to substitute materials, products, or equipment for materials, products, or equipment described in the Bidding Documents and no request for addition of a manufacturer or supplier to a list of approved manufacturers or suppliers in the Bidding Documents will be considered prior to receipt of Bids unless written request for approval has been received by the Architect at least ten days prior to the date for receipt of Bids established in the Invitation for Bids. Any subsequent extension of the date for receipt of Bids by addendum shall not extend the date for receipt of such requests unless the addendum so specifies. Such requests shall include the name of the material or equipment for which it is to be substituted and a complete description of the proposed substitution including drawings, performance and test data, and other information necessary for an evaluation. A statement setting forth changes in other materials, equipment or other portions of the Work, including changes in the work of other contracts that incorporation of the proposed substitution would require, shall be included. The burden of proof of the merit of the proposed substitution is upon the proposer. The Architect's decision of approval or disapproval of a proposed substitution shall be final.

2.15. *Delete Section 3.4.3 and substitute the following:*

3.4.3 Addenda will be issued no later than 120 hours prior to the time for receipt of Bids except an Addendum withdrawing the request for Bids or one which includes postponement of the date for receipt of Bids.

STANDARD SUPPLEMENTAL INSTRUCTIONS TO BIDDERS

2.16. *Insert the following Sections 3.4.5 and 3.4.6:*

- **3.4.5** When the date for receipt of Bids is to be postponed and there is insufficient time to issue a written Addendum prior to the original Bid Date, Owner will notify prospective Bidders by telephone or other appropriate means with immediate follow up with a written Addendum. This Addendum will verify the postponement of the original Bid Date and establish a new Bid Date. The new Bid Date will be no earlier than the fifth (5th) calendar day after the date of issuance of the Addendum postponing the original Bid Date.
- **3.4.6.** If an emergency or unanticipated event interrupts normal government processes so that bids cannot be received at the government office designated for receipt of bids by the exact time specified in the solicitation, the time specified for receipt of bids will be deemed to be extended to the same time of day specified in the solicitation on the first work day on which normal government processes resume. In lieu of an automatic extension, an Addendum may be issued to reschedule bid opening. If state offices are closed at the time a pre-bid or pre-proposal conference is scheduled, an Addendum will be issued to reschedule the conference. - **2.17.** In Section 4.1.1, delete the word "forms" and substitute the words "SE-330 Bid Form."
- **2.18.** *Delete Section 4.1.2 and substitute the following:*
 - **4.1.2** Any blanks on the bid form to be filled in by the Bidder shall be legibly executed in a non-erasable medium. Bids shall be signed in ink or other indelible media.
- **2.19.** *Delete Section 4.1.3 and substitute the following:*
 - **4.1.3** Sums shall be expressed in figures.
- **2.20.** *Insert the following at the end of Section 4.1.4:*

Bidder shall not make stipulations or qualify his bid in any manner not permitted on the bid form. An incomplete Bid or information not requested that is written on or attached to the Bid Form that could be considered a qualification of the Bid, may be cause for rejection of the Bid.

- **2.21.** *Delete Section 4.1.5 and substitute the following:*
 - **4.1.5** All requested Alternates shall be bid. The failure of the bidder to indicate a price for an Alternate shall render the Bid non-responsive. Indicate the change to the Base Bid by entering the dollar amount and marking, as appropriate, the box for "ADD TO" or "DEDUCT FROM". If no change in the Base Bid is required, enter "ZERO" or "No Change." For add alternates to the base bid, Subcontractor(s) listed on page BF-2 of the Bid Form to perform Alternate Work may be used for both Alternates and Base Bid Work if Alternates are accepted.
- **2.22.** *Delete Section 4.1.6 and substitute the following:*
 - **4.1.6** Pursuant to Title 11, Chapter 35, Section 3020(b)(i) of the South Carolina Code of Laws, as amended, Section 7 of the Bid Form sets forth a list of subcontractor specialties for which Bidder is required to list only the subcontractors Bidder will use to perform the work of each listed specialty. Bidder must follow the Instructions in the Bid Form for filling out this section of the Bid Form. Failure to properly fill out Section 7 may result in rejection of Bidder's bid as non-responsive.
- **2.23.** Delete Section 4.1.7 and substitute the following:
 - **4.1.7** Each copy of the Bid shall state the legal name of the Bidder and the nature of legal form of the Bidder. Each copy shall be signed by the person or persons legally authorized to bind the Bidder to a contract. A Bid submitted by an agent shall have a current power of attorney attached certifying the agent's authority to bind the Bidder.
- **2.24.** *Delete Section 4.2.1 and substitute the following:*
 - **4.2.1** If required by the Invitation for Bids, each Bid shall be accompanied by a bid security in an amount of not less than five percent of the Base Bid. The bid security shall be a bid bond or a certified cashier's check. The Bidder pledges to enter into a Contract with the Owner on the terms stated in the Bid and will, if required, furnish bonds covering the faithful performance of the Contract and payment of all obligations arising thereunder. Should the Bidder refuse to enter into such Contract or fail to furnish such bonds if required, the amount of the bid security shall be forfeited to the Owner as liquidated damages, not as a penalty.

2.25. *Delete Section 4.2.2 and substitute the following:*

Bidder acknowledges and agrees that this list is provided for purposes of determining responsibility and not pursuant to the subcontractor listing requirements of SC Code Ann § 11-35-3020(b)(i).

§ 9. TIME OF CONTRACT PERFORMANCE AND LIQUIDATED DAMAGES

- a. CONTRACT TIME: Bidder agrees that the Date of Commencement of the Work shall be established in a Notice to Proceed to be issued by the Owner. Bidder agrees to substantially complete the Work within <u>90</u> calendar days from the Date of Commencement, subject to adjustments as provided in the Contract Documents.
- b. LIQUIDATED DAMAGES: Bidder further agrees that from the compensation to be paid, the Owner shall retain as Liquidated Damages the sum of \$250.00 for each calendar day the actual construction time required to achieve Substantial Completion exceeds the specified or adjusted time for Substantial Completion as provided in the Contract Documents. This sum is intended by the parties as the predetermined measure of compensation for actual damages, not as a penalty for nonperformance.

§ 10. AGREEMENTS

1 GENERAL CONDITIONS

The *General Conditions of the Contract for Construction*, AIA Document A201, 2007 Edition, Articles 1 through 15 inclusive, is a part of this Contract and is incorporated as fully as if herein set forth. For brevity, AIA Document A201 is also referred to in the Contract Documents collectively as the "General Conditions."

2 STANDARD SUPPLEMENTARY CONDITIONS

- 2.1 The following supplements modify, delete and/or add to the General Conditions. Where any portion of the General Conditions is modified or any paragraph, Section or clause thereof is modified or deleted by these Supplementary Conditions, the unaltered provisions of the General Conditions shall remain in effect.
- 2.2 Unless otherwise stated, the terms used in these Standard Supplementary Conditions which are defined in the General Conditions have the meanings assigned to them in the General Conditions.

3 MODIFICATIONS TO A201-2007

Any reference in this document to the Agreement between the Owner and Contractor, AIA Document A101, or some abbreviated reference thereof, shall mean the AIA A101, 2007 Edition as modified by OSE Form 00501 – Standard Modification to Agreement Between Owner and Contractor. Any reference in this document to the General Conditions of the Contract for Construction, AIA Document A201, or some abbreviated reference thereof, shall mean the AIA A201, 2007 Edition as modified by OSE Form 00811 – Standard Supplementary Conditions.

 - **2.4** If the Contractor defaults or neglects to carry out the Work in accordance with the Contract Documents and fails within a ten-day period after receipt of written notice from the Owner to commence and continue correction of such default or neglect, including but not limited to providing necessary resources, with diligence and promptness, the Owner may, without prejudice to other remedies the Owner may have, correct such deficiencies. In such case an appropriate Change Directive shall be issued deducting from payments then or thereafter due the Contractor the reasonable cost of correcting such deficiencies, including Owner's expenses and compensation for the Architect's additional services made necessary by such default, neglect or failure. If payments then or thereafter due the Contractor are not sufficient to cover such amounts, the Contractor shall pay the difference to the Owner.

3.13 *Insert the following at the end of Section 3.2.1:*

The Contractor acknowledges that it has investigated and satisfied itself as to the general and local conditions which can affect the work or its cost, including but not limited to (1) conditions bearing upon transportation, disposal, handling, and storage of materials; (2) the availability of labor, water, electric power, and roads; (3) uncertainties of weather, river stages, tides, or similar physical conditions at the site; (4) the conformation and conditions of the ground; and (5) the character of equipment and facilities needed preliminary to and during work performance. The Contractor also acknowledges that it has satisfied itself as to the character, quality, and quantity of surface and subsurface materials or obstacles to be encountered insofar as this information is reasonably ascertainable from an inspection of the site, including all exploratory work done by the Owner, as well as from the drawings and specifications made a part of this contract. Any failure of the Contractor to take the actions described and acknowledged in this paragraph will not relieve the Contractor from responsibility for estimating properly the difficulty and cost of successfully performing the work, or for proceeding to successfully perform the work without additional expense to the Owner.

- 3.14 In the third sentence of Section 3.2.4, insert the word "latent" before the word "errors."

In no event shall any progress report constitute an adjustment in the Contract Time, any Milestone Date, or the Contract Sum unless any such adjustment is agreed to by the Owner and authorized pursuant to Change Order.

The Architect will visit the site as necessary to fulfill its obligation to the Owner for inspection services, if any, and, at a minimum, to assure conformance with the Architect's design as shown in the Contract Documents and to observe the progress and quality of the various components of the Contractor's Work, and to determine if the Work observed is being performed in a manner indicating that the Work, when fully completed, will be in accordance with the Contract Documents.

3.34 *Delete the first sentence of Section 4.2.3 and substitute the following:*

On the basis of the site visits, the Architect will keep the Owner informed about the progress and quality of the portion of the Work completed, and report to the Owner (1) deviations from the Contract Documents and from the most recent construction schedule submitted by the Contractor, and (2) defects and deficiencies observed in the Work.

3.35 In Section 4.2.5, after the words "evaluations of the" and before the word "Contractor's," insert the following:

Work completed and correlated with the

- **3.36** *Delete the first sentence of Section 4.2.11 and substitute the following:*
 - **4.2.11** The Architect will, in the first instance, interpret and decide matters concerning performance under, and requirements of, the Contract Documents on written request of either the Owner or Contractor. Upon receipt of such request, the Architect will promptly provide the non-requesting party with a copy of the request.

STANDARD SUPPLEMENTARY CONDITIONS

3.37 *Insert the following at the end of Section 4.2.12:*

If either party disputes the Architects interpretation or decision, that party may proceed as provided in Article 15. The Architect's interpretations and decisions may be, but need not be, accorded any deference in any review conducted pursuant to law or the Contract Documents.

3.38 *Delete Section 4.2.14 and substitute the following:*

The Architect will review and respond to requests for information about the Contract Documents so as to avoid delay to the construction of the Project. The Architect's response to such requests will be made in writing with reasonable promptness. If appropriate, the Architect will prepare and issue supplemental Drawings and Specifications in response to the requests for information. Any response to a request for information must be consistent with the intent of, and reasonably inferable from, the Contract Documents and will be in writing or in the form of drawings. Unless issued pursuant to a Modification, supplemental Drawings or Specifications will not involve an adjustment to the Contract Sum or Contract Time.

- **3.39** *Delete Section 5.2.1 and substitute the following:*
 - **5.2.1** Unless otherwise stated in the Contract Documents or the bidding requirements, the Contractor, within fourteen days after posting of the Notice of Intent to Award the Contract, shall furnish in writing to the Owner through the Architect the names of persons or entities (excluding Listed Subcontractors but including those who are to furnish materials or equipment fabricated to a special design) proposed for each principal portion of the Work. The Owner may reply within 14 days to the Contractor in writing stating (1) whether the Owner has reasonable objection to any such proposed person or entity. Failure of the Owner to reply within the 14 day period shall constitute notice of no reasonable objection.
- **3.40** *Delete Section 5.2.2 and substitute the following:*
 - **5.2.2** The Contractor shall not contract with a proposed person or entity to whom the Owner has made reasonable and timely objection. The Owner shall not direct the Contractor to contract with any specific individual or entity for supplies or services unless such supplies and services are necessary for completion of the Work and the specified individual or entity is the only source of such supply or services.
- 3.41 In the first sentence of Section 5.2.3, delete the words "...or Architect..." in the two places they appear.
- 3.42 Delete the words "...or Architect..." in the in the first sentence of Section 5.2.4 and insert the following sentence at the end of Section 5.2.4:

The Contractor's request for substitution must be made to the Owner in writing accompanied by supporting information.

- **3.43** *Add the following Section 5.2.5:*
 - **5.2.5** A Subcontractor identified in the Contractor's Bid in response the specialty subcontractor listing requirements of Section 7 of the Bid Form (SE-330) may only be substituted in accordance with and as permitted by the provisions of Title 11, Chapter 35, Section 3021 of the South Carolina Code of Laws, as amended. A proposed substitute for a Listed Subcontractor shall be subject to the Owner's approval as set forth is Section 5.2.3.
- 3.44 In Section 5.3, delete everything following the heading "SUBCONTRACTUAL RELATIONS" and insert the following Sections 5.3.1, 5.3.2, 5.3.3, and 5.3.4:
 - **5.3.1** By appropriate written agreement, the Contractor shall require each Subcontractor, to the extent of the Work to be performed by the Subcontractor, to be bound to the Contractor by terms of the Contract Documents, and to assume toward the Contractor all the obligations and responsibilities, including the responsibility for safety of the Subcontractor's Work, which the Contractor, by these Documents, assumes toward the Owner and Architect. Each subcontract agreement shall preserve and protect the rights of the Owner and Architect under the Contract Documents with respect to the Work to be performed by the Subcontractor so that subcontracting thereof will not

STANDARD SUPPLEMENTARY CONDITIONS

prejudice such rights, and shall allow to the Subcontractor, unless specifically provided otherwise herein or in the subcontract agreement, the benefit of all rights, remedies and redress against the Contractor that the Contractor, by the Contract Documents, has against the Owner. Where appropriate, the Contractor shall require each Subcontractor to enter into similar agreements with Sub-subcontractors. The Contractor shall make available to each proposed Subcontractor, prior to the execution of the subcontract agreement, copies of the Contract Documents to which the Subcontractor will be bound, and, upon written request of the Subcontractor, identify to the Subcontractor terms and conditions of the proposed subcontract agreement that may be at variance with the Contract Documents. Subcontractors will similarly make copies of applicable portions of such documents available to their respective proposed Sub-subcontractors.

- § 5.3.2 Without limitation on the generality of Section 5.3.1, each Subcontract agreement and each Sub-subcontract agreement shall include, and shall be deemed to include, the following Sections of these General Conditions: 3.2, 3.5, 3.18, 5.3, 5.4, 6.2.2, 7.3.3, 7.5, 7.6, 13.1, 13.12, 14.3, 14.4, and 15.1.6.
- § 5.3.3 Each Subcontract Agreement and each Sub-subcontract agreement shall exclude, and shall be deemed to exclude, Sections 13.2.1 and 13.6 and all of Article 15, except Section 15.1.6, of these General Conditions. In the place of these excluded sections of the General Conditions, each Subcontract Agreement and each Sub-subcontract may include Sections 13.2.1 and 13.6 and all of Article 15, except Section 15.1.6, of AIA Document A201-2007, Conditions of the Contract, as originally issued by the American Institute of Architects.
- § 5.3.4 The Contractor shall assure the Owner that all agreements between the Contractor and its Subcontractor incorporate the provisions of Subparagraph 5.3.1 as necessary to preserve and protect the rights of the Owner and the Architect under the Contract Documents with respect to the work to be performed by Subcontractors so that the subcontracting thereof will not prejudice such rights. The Contractor's assurance shall be in the form of an affidavit or in such other form as the Owner may approve. Upon request, the Contractor shall provide the Owner or Architect with copies of any or all subcontracts or purchase orders.
- **3.45** *Delete the last sentence of Section 5.4.1.*
- **3.46** *Add the following Sections 5.4.4, 5.4.5 and 5.4.6:*
 - § 5.4.4 Each subcontract shall specifically provide that the Owner shall only be responsible to the subcontractor for those obligations of the Contractor that accrue subsequent to the Owner's exercise of any rights under this conditional assignment.
 - § 5.4.5 Each subcontract shall specifically provide that the Subcontractor agrees to perform portions of the Work assigned to the Owner in accordance with the Contract Documents.
 - § 5.4.6 Nothing in this Section 5.4 shall act to reduce or discharge the Contractor's payment bond surety's obligations to claims arising prior to the Owner's exercise of any rights under this conditional assignment.
- 3.47 Delete the language of Section 6.1.4 and substitute the word "Reserved."
- **3.48** *Insert the following at the end of Section 7.1.2:*

If the amount of a Modification exceeds the limits of the Owner's Construction Change Order Certification (reference Section 9.1.7.2 of the Agreement), then the Owner's agreement is not effective, and Work may not proceed, until approved in writing by the Office of State Engineer.

- **3.49** *Delete Section 7.2.1 and substitute the following:*
 - **7.2.1** A Change Order is a written instrument prepared by the Architect (using State Form SE-480 "Construction Change Order") and signed by the Owner, Contractor and Architect stating their agreement upon all of the following:
 - .1 The change in the Work;

- .2 The amount of the adjustment, if any, in the Contract Sum; and
- .3 The extent of the adjustment, if any, in the Contract Time.
- **3.50** *Add the following Sections* 7.2.2, 7.2.3, 7.2.4, *and* 7.2.5:
 - **7.2.2** If a Change Order provides for an adjustment to the Contract Sum, the adjustment must be calculated in accordance with Section 7.3.3.
 - **7.2.3** At the Owner's request, the Contractor shall prepare a proposal to perform the work of a proposed Change Order setting forth the amount of the proposed adjustment, if any, in the Contract Sum; and the extent of the proposed adjustment, if any, in the Contract Time. Any proposed adjustment in the Contract sum shall be prepared in accordance with Section 7.2.2. The Owner's request shall include any revisions to the Drawings or Specifications necessary to define any changes in the Work. Within fifteen days of receiving the request, the Contractor shall submit the proposal to the Owner and Architect along with all documentation required by Section 7.6.
 - **7.2.4** If the Contractor requests a Change Order, the request shall set forth the proposed change in the Work and shall be prepared in accordance with Section 7.2.3. If the Contractor requests a change to the Work that involves a revision to either the Drawings or Specifications, the Contractor shall reimburse the Owner for any expenditures associated with the Architects' review of the proposed revisions, except to the extent the revisions are accepted by execution of a Change Order.
 - **7.2.5** Agreement on any Change Order shall constitute a final settlement of all matters relating to the change in the Work that is the subject of the Change Order, including, but not limited to, any adjustments to the Contract Sum or the Contract Time.
- **3.51** *Delete 7.3.3 and substitute the following:*

7.3.3 PRICE ADJUSTMENTS

- § 7.3.3.1 If any Modification, including a Construction Change Directive, provides for an adjustment to the Contract Sum, the adjustment shall be based on whichever of the following methods is the most valid approximation of the actual cost to the contractor, with overhead and profit as allowed by Section 7.5:
 - .1 Mutual acceptance of a lump sum;
 - **.2** Unit prices stated in the Contract Documents, except as provided in Section 7.3.4, or subsequently agreed upon;
 - .3 Cost attributable to the events or situations under applicable clauses with adjustment of profits or fee, all as specified in the contract, or subsequently agreed upon by the parties, or by some other method as the parties may agree; or
 - **.4** As provided in Section 7.3.7.
- § 7.3.3.2Consistent with Section 7.6, costs must be properly itemized and supported by substantiating data sufficient to permit evaluation before commencement of the pertinent performance or as soon after that as practicable. All costs incurred by the Contractor must be justifiably compared with prevailing industry standards. Except as provided in Section 7.5, all adjustments to the Contract Price shall be limited to job specific costs and shall not include indirect costs, overhead, home office overhead, or profit.
- **3.52** *Delete Section 7.3.7 and substitute the following:*
 - **7.3.7** If the Contractor does not respond promptly or disagrees with the method for adjustment in the Contract Sum, the Architect shall make an initial determination, consistent with Section 7.3.3, of the method and the adjustment on the basis of reasonable expenditures and savings of those performing the Work attributable to the change, including, in case of an increase in the Contract Sum, an amount for overhead and profit as set forth in Section 7.5. In such case, and also under Section 7.3.3.1.3, the Contractor shall keep and present, in such form as the Architect may prescribe, an itemized accounting together with appropriate supporting data. Unless otherwise provided in the Contract Documents, costs for the purposes of this Section 7.3.7 shall be limited to the following:

- .1 Costs of labor, including social security, old age and unemployment insurance, fringe benefits required by agreement or custom, and workers' compensation insurance;
- .2 Costs of materials, supplies and equipment, including cost of transportation, whether incorporated or consumed;
- .3 Rental costs of machinery and equipment, exclusive of hand tools, whether rented from the Contractor or others; and
- .4 Costs of premiums for all bonds and insurance, permit fees, and sales, use or similar taxes related to the Work.
- **3.53** *Delete Section 7.3.8 and substitute the following:*
 - **7.3.8** Using the percentages stated in Section 7.5, any adjustment to the Contract Sum for deleted work shall include any overhead and profit attributable to the cost for the deleted Work.
- **3.54** *Add the following Sections 7.5 and 7.6:*

7.5 AGREED OVERHEAD AND PROFIT RATES

- **7.5.1** For any adjustment to the Contract Sum for which overhead and profit may be recovered, other than those made pursuant to Unit Prices stated in the Contract Documents, the Contractor agrees to charge and accept, as full payment for overhead and profit, the following percentages of costs attributable to the change in the Work. The percentages cited below shall be considered to include all indirect costs including, but not limited to: field and office managers, supervisors and assistants, incidental job burdens, small tools, and general overhead allocations. The allowable percentages for overhead and profit are as follows:
 - .1 To the Contractor for work performed by the Contractor's own forces, 17% of the Contractor's actual costs.
 - .2 To each Subcontractor for work performed by the Subcontractor's own forces, 17% of the subcontractor's actual costs.
 - .3 To the Contractor for work performed by a subcontractor, 10% of the subcontractor's actual costs (not including the subcontractor's overhead and profit).

7.6 PRICING DATA AND AUDIT

§ 7.6.1 Cost or Pricing Data.

Upon request of the Owner or Architect, Contractor shall submit cost or pricing data prior to execution of a Modification which exceeds \$500,000. Contractor shall certify that, to the best of its knowledge and belief, the cost or pricing data submitted is accurate, complete, and current as of a mutually determined specified date prior to the date of pricing the Modification. Contractor's price, including profit, shall be adjusted to exclude any significant sums by which such price was increased because Contractor furnished cost or pricing data that was inaccurate, incomplete, or not current as of the date specified by the parties. Notwithstanding Subparagraph 9.10.4, such adjustments may be made after final payment to the Contractor.

§ 7.6.2 Cost or pricing data means all facts that, as of the date specified by the parties, prudent buyers and sellers would reasonably expect to affect price negotiations significantly. Cost or pricing data are factual, not judgmental; and are verifiable. While they do not indicate the accuracy of the prospective contractor's judgment about estimated future costs or projections, they do include the data forming the basis for that judgment. Cost or pricing data are more than historical accounting data; they are all the facts that can be reasonably expected to contribute to the soundness of estimates of future costs and to the validity of determinations of costs already incurred.

§ 7.6.3 Records Retention.

As used in Section 7.6, the term "records" means any books or records that relate to cost or pricing data that Contractor is required to submit pursuant to Section 7.6.1. Contractor shall maintain records for three years from the date of final payment, or longer if requested by the chief procurement officer. The Owner may audit Contractor's records at reasonable times and places.

STANDARD SUPPLEMENTARY CONDITIONS

- **3.55** Delete Section 8.2.2 and substitute the following:
 - **8.2.2** The Contractor shall not knowingly commence operations on the site or elsewhere prior to the effective date of surety bonds and insurance required by Article 11 to be furnished by the Contractor and Owner. The date of commencement of the Work shall not be changed by the effective date of such surety bonds or insurance.
- **3.56** *Delete Section 8.3.1 and substitute the following:*
 - **8.3.1** If the Contractor is delayed at any time in the commencement or progress of the Work by an act or neglect of the Owner or Architect, or of an employee of either, or of a separate contractor employed by the Owner; or by changes ordered in the Work; or by labor disputes, fire, unusual delay in deliveries, unavoidable casualties or other causes beyond the control of the Contractor and any subcontractor at any tier; or by delay authorized by the Owner pending dispute resolution; or by other causes that the Architect determines may justify delay, then to the extent such delay will prevent the Contractor from achieving Substantial Completion within the Contract Time and provided the delay (1) is not caused by the fault or negligence of the Contractor or a subcontractor at any tier and (2) is not due to unusual delay in the delivery of supplies, machinery, equipment, or services when such supplies, machinery, equipment, or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery, the Contract Time shall be extended by Change Order for such reasonable time as the Architect may determine.
- 3.57 *Insert the following at the end of Section 9.1:*

All changes to the Contract Sum shall be adjusted in accordance with Section 7.3.3.

3.58 *Delete Section 9.2 and substitute the following:*

9.2 SCHEDULE OF VALUES

- **9.2.1** The Contractor shall submit to the Architect, within ten days of full execution of the Agreement, a schedule of values allocating the entire Contract Sum to the various portions of the Work and prepared in such form and supported by such data to substantiate its accuracy as the Architect may require. This schedule, unless objected to by the Architect, shall be used as a basis for reviewing the Contractor's Applications for Payment. As requested by the Architect, the Contractor and each Subcontractor shall prepare a trade payment breakdown for the Work for which each is responsible, such breakdown being submitted on a uniform standardized format approved by the Architect and Owner. The breakdown shall be divided in detail, using convenient units, sufficient to accurately determine the value of completed Work during the course of the Project. The Contractor shall update the schedule of values as required by either the Architect or Owner as necessary to reflect:
 - .1 the description of Work (listing labor and material separately);
 - .2 the total value;
 - .3 the percent and value of the Work completed to date;
 - .4 the percent and value of previous amounts billed; and
 - .5 the current percent completed and amount billed.
- **9.2.2** Any schedule of values or trade breakdown that fails to include sufficient detail, is unbalanced, or exhibits "front-loading" of the value of the Work shall be rejected. If a schedule of values or trade breakdown is used as the basis for payment and later determined to be inaccurate, sufficient funds shall be withheld from future Applications for Payment to ensure an adequate reserve (exclusive of normal retainage) to complete the Work.
- **3.59** *Delete Section 9.3.1 and substitute the following:*

Monthly, the Contractor shall submit to the Architect an itemized Application for Payment prepared in accordance with the schedule of values, if required under Section 9.2., for completed portions of the Work. Such application shall be notarized, if required, and supported by such data substantiating the Contractor's right to payment as the Owner or Architect may require (such as copies of requisitions from Subcontractors and material suppliers) and shall reflect retainage and any other adjustments provided in Section 5 of the Agreement. If required by the Owner or Architect, the Application for Payment shall be accompanied by a current construction schedule.

3.60 In Section 9.3.2, add the following words to the end of the second sentence:

provided such materials or equipment will be subsequently incorporated in the Work

Insert the following at the end of Section 9.3.2:

The Contractor shall 1) protect such materials from diversion, vandalism, theft, destruction, and damage, 2) mark such materials specifically for use on the Project, and 3) segregate such materials from other materials at the storage facility. The Architect and the Owner shall have the right to make inspections of the storage areas at any time.

3.61 In Section 9.4.2, in the first sentence, after the words "Work has progressed to the point indicated," insert the following:

in both the Application for Payment and, if required to be submitted by the Contractor, the accompanying current construction schedule

In the last sentence, delete the third item starting with "(3) reviewed copies" and ending with "Contractor's right to payment,"

3.62 In Section 9.5.1, in the first sentence, delete the word "may" after the opening words "The Architect" and substitute the word "shall."

In Section 9.5.1, insert the following sentence after the first sentence:

The Architect shall withhold a Certificate of Payment if the Application for Payment is not accompanied by the current construction schedule required by Section 3.10.1.

3.63 *In Section 9.6.2*, delete the word "The..." at the beginning of the first sentence and substitute the following:

Pursuant to Chapter 6 of Title 29 of the South Carolina Code of Laws, as amended, the

3.64 *Delete Section 9.7 and substitute following:*

9.7 FAILURE OF PAYMENT

If the Architect does not issue a Certificate for Payment to the Owner, through no fault of the Contractor, within seven days after receipt of the Contractor's Application for Payment, or if the Owner does not pay the Contractor within seven days after the time established in the Contract Documents the amount certified by the Architect or awarded by a final dispute resolution order, then the Contractor may, upon seven additional days' written notice to the Owner and Architect, stop the Work until payment of the amount owing has been received. The Contract Time shall be extended appropriately and the Contract Sum shall be increased, in accordance with the provisions of Section 7.3.3, by the amount of the Contractor's reasonable costs of shut-down, delay and start-up, plus interest as provided for in the Contract Documents.

3.65 *Insert the following words at the end of the sentence in Section 9.8.1:*

and when all required occupancy permits, if any, have been issued and copies of same have been delivered to the Owner.

- 3.66 In Section 9.8.2, insert the word "written" after the word "comprehensive" and before the word "list."
- **3.67** *Delete Section 9.8.3 and substitute the following:*
 - **9.8.3.1** Upon receipt of the Contractor's list, the Architect, with the Owner and any other person the Architect or the Owner choose, will make an inspection on a date and at a time mutually agreeable to the Architect, Owner, and Contractor, to determine whether the Work or designated portion thereof is substantially complete. The Contractor shall furnish access for the inspection and testing as provided in this Contract. The inspection shall include a

demonstration by the Contractor that all equipment, systems and operable components of the Work function properly and in accordance with the Contract Documents. If the Architect's inspection discloses any item, whether or not included on the Contractor's list, which is not sufficiently complete in accordance with the Contract Documents so that the Owner can occupy or utilize the Work or designated portion thereof for its intended use, the Contractor shall, before issuance of the Certificate of Substantial Completion, complete or correct such item upon notification by the Architect. In such case, the Contractor shall then submit a request for another inspection by the Architect to determine Substantial Completion. If more than one Substantial Completion inspection is required, the Contractor shall reimburse the Owner for all costs of reinspections or, at the Owner's option, the costs may be deducted from payments due to the Contractor.

9.8.3.2 If the Architect and Owner concur in the Contractor's assessment that the Work or a portion of the Work is safe to occupy, the Owner and Contractor may arrange for a Certificate of Occupancy Inspection by OSE. The Owner, Architect, and Contractor shall be present at OSE's inspection. Upon verifying that the Work or a portion of the Work is substantially complete and safe to occupy, OSE will issue, as appropriate, a Full or Partial Certificate of Occupancy.

- **3.68** *In the second sentence of Section 9.8.5, delete the words "and consent of surety, if any."*
- 3.69 In the first sentence of Section 9.9.1, delete the words "Section 11.3.1.5" and substitute the words "Section 11.3.1.3."
- **3.70** *Delete Section 9.10.1 and substitute the following:*
 - 9.10.1 Unless the parties agree otherwise in the Certificate of Substantial Completion, the Contractor shall achieve Final Completion no later than thirty days after Substantial Completion. Upon receipt of the Contractor's written notice that the Work is ready for final inspection and acceptance and upon receipt of a final Application for Payment, the Architect, with the Owner and any other person the Architect or the Owner choose, will make an inspection on a date and at a time mutually agreeable to the Architect, Owner, and Contractor, and, when the Architect finds the Work acceptable under the Contract Documents and the Contract fully performed, the Architect will promptly issue a final Certificate for Payment stating that to the best of the Architect's knowledge, information and belief, and on the basis of the Architect's on-site visits and inspections, the Work has been completed in accordance with terms and conditions of the Contract Documents and that the entire balance found to be due the Contractor and noted in the final Certificate is due and payable. The Architect's final Certificate for Payment will constitute a further representation that conditions listed in Section 9.10.2 as precedent to the Contractor's being entitled to final payment have been fulfilled. If more than one Final Completion inspection is required, the Contractor shall reimburse the Owner for all costs of reinspections or, at the Owner's option, the costs may be deducted from payments due to the Contractor. If the Contractor does not achieve final completion within thirty days after Substantial Completion or the timeframe agreed to by the parties in the Certificate of Substantial Completion, whichever is greater, the Contractor shall be responsible for any additional Architectural fees resulting from the delay.
- 3.71 Delete the first sentence of Section 9.10.2 and substitute the following:

Neither final payment nor any remaining retained percentage shall become due until the Contractor submits to the Architect (1) an affidavit that payrolls, bills for materials and equipment, and other indebtedness connected with the Work for which the Owner or the Owner's property might be responsible or encumbered (less amounts withheld by Owner) have been paid or otherwise satisfied, (2) a certificate evidencing that insurance required by the Contract Documents to remain in force after final payment is currently in effect and will not be canceled or allowed to expire until at least 30 days' prior written notice has been given to the Owner, (3) a written statement that the Contractor knows of no substantial reason that the insurance will not be renewable to cover the period required by the Contract Documents, (4) consent of surety, if any, to final payment (5), if required by the Owner, other data establishing payment or satisfaction of obligations, such as receipts, releases and waivers of liens, claims, security interests or encumbrances arising out of the Contract, to the extent and in such form as may be designated by the Owner, (6) required Training Manuals, (7) equipment Operations and Maintenance Manuals, (8) any certificates of testing, inspection or approval required by the Contract Documents and not previously provided (9) all warranties and guarantees required under or pursuant to the Contract Documents, and (10) one copy of the Documents required by Section 3.11.

If, after Substantial Completion of the Work, final completion thereof is delayed 60 days through no fault of the Contractor or by issuance of Change Orders affecting final completion, and the Architect so confirms, the Owner shall, upon application by the Contractor and certification by the Architect, and without terminating the Contract, make payment of the balance due for that portion of the Work fully completed and accepted.

3.73 *Delete Section 9.10.5 and substitute the following:*

§9.10.5 Acceptance of final payment by the Contractor, a Subcontractor or material supplier shall constitute a waiver of claims by that payee except those specific claims in stated amounts that have been previously made in writing and identified by that payee as unsettled at the time of final Application for Payment.

3.74 Add the following Section 9.10.6:

9.10.6 If OSE has not previously issued a Certificate of Occupancy for the entire Project, the Parties shall arrange for a representative of OSE to participate in the Final Completion Inspection. Representatives of the State Fire Marshal's Office and other authorities having jurisdiction may be present at the Final Completion Inspection or otherwise inspect the completed Work and advise the Owner whether the Work meets their respective requirements for the Project.

3.75 *Delete Section 10.3.1 and substitute the following:*

10.3.1 If the Contractor encounters a hazardous material or substance which was not discoverable as provided in Section 3.2.1 and not required by the Contract Documents, and if reasonable precautions will be inadequate to prevent foreseeable bodily injury or death to persons or serious loss to real or personal property resulting from such material or substance encountered on the site by the Contractor, the Contractor shall, upon recognizing the condition, immediately stop Work in the affected area and report the condition to the Owner and Architect in writing. Hazardous materials or substances are those hazardous, toxic, or radioactive materials or substances subject to regulations by applicable governmental authorities having jurisdiction, such as, but not limited to, the S.C. Department of Health and Environmental Control, the U.S. Environmental Protection Agency, and the U.S. Nuclear Regulatory Commission.

3.76 *Insert the following at the end of Section 10.3.2:*

In the absence of agreement, the Architect will make an interim determination regarding any delay or impact on the Contractor's additional costs. The Architect's interim determination of cost shall adjust the Contract Sum on the same basis as a Change Order, subject to the right of either party to disagree and assert a Claim in accordance with Article 15. Any adjustment in the Contract Sum shall be determined in accordance with Section 7.3.3.

3.77 *Delete Section 10.3.3 and substitute the following:*

10.3.3 The Work in the affected area shall be resumed immediately following the occurrence of any one of the following events: (a) the Owner causes remedial work to be performed that results in the absence of hazardous materials or substances; (b) the Owner and the Contractor, by written agreement, decide to resume performance of the Work; or (c) the Work may safely and lawfully proceed, as determined by an appropriate governmental authority or as evidenced by a written report to both the Owner and the Contractor, which is prepared by an environmental engineer reasonably satisfactory to both the Owner and the Contractor.

3.78 *In Section 10.3.5, delete the word "The" at the beginning of the sentence and substitute the following:*

In addition to its obligations under Section 3.18, the

3.79 Delete the language of Section 10.3.6 and substitute the word "Reserved."

STANDARD SUPPLEMENTARY CONDITIONS

3.80 *Insert the following at the end of Section 10.4:*

The Contractor shall immediately give the Architect notice of the emergency. This initial notice may be oral followed within five days by a written notice setting forth the nature and scope of the emergency. Within fourteen days of the start of the emergency, the Contractor shall give the Architect a written estimate of the cost and probable effect of delay on the progress of the Work.

3.81 *Delete 11.1.2 and substitute the following:*

11.1.2 The insurance required by Section 11.1.1 shall be written for not less than limits of liability specified below or required by law, whichever coverage is greater. Coverages shall be written on an occurrence basis and shall be maintained without interruption from the date of commencement of the Work until the date of final payment and termination of any coverage required to be maintained after final payment, and, with respect to the Contractor's completed operations coverage, until the expiration of the period for correction of Work or for such other period for maintenance of completed operations coverage as specified in the Contract Documents.

In lieu of separate insurance policies for Commercial General Liability, Business Auto Liability, and Employers Liability, the Contractor may provide an umbrella policy meeting or exceeding all coverage requirements set forth in this Section 11.1.2. The umbrella policy limits shall not be less than \$3,000,000.

3.82 *Delete Section 11.1.3 and substitute the following:*

11.1.3 Prior to commencement of the Work, and thereafter upon replacement of each required policy of insurance, Contractor shall provide to the Owner a written endorsement to the Contractor's general liability insurance policy that:

- (i) names the Owner as an additional insureds for claims caused in whole or in part by the Contractor's negligent acts or omissions during the Contractor's operations;
- (ii) provides that no material alteration, cancellation, non-renewal, or expiration of the coverage contained in such policy shall have effect unless all additional insureds have been given at least ten (10) days prior written notice of cancellation for non-payment of premiums and thirty (30) days prior written notice of cancellation for any other reason; and
- (iii) provides that the Contractor's liability insurance policy shall be primary, with any liability insurance of the Owner as secondary and noncontributory.

Prior to commencement of the Work, and thereafter upon renewal or replacement of each required policy of insurance, Contractor shall provide to the Owner a signed, original certificate of liability insurance (ACORD 25). Consistent with this Section 11.1, the certificate shall identify the types of insurance, state the limits of liability for each type of coverage, name the Owner a Consultants as Certificate Holder, provide that the general aggregate limit applies per project, and provide that coverage is written on an occurrence basis. Both the certificates and the

endorsements must be received directly from either the Contractor's insurance agent or the insurance company. An additional certificate evidencing continuation of liability coverage, including coverage for completed operations, naming the Owner as an additional insured for claims made under the Contractor's completed operations, and otherwise meeting the above requirements, shall be submitted with the final Application for Payment as required by Section 9.10.2 and thereafter upon renewal or replacement of such coverage until the expiration of the time required by Section 11.1.2. Information concerning reduction of coverage on account of revised limits or claims paid under the General Aggregate, or both, shall be furnished by the Contractor with reasonable promptness.

- **3.83** *Delete Section 11.1.4 and substitute the following:*

Unless otherwise provided in the Contract Documents, the Contractor shall purchase and maintain, in a company or companies lawfully authorized to do business in the jurisdiction in which the Project is located, property insurance written on a builder's risk "all-risk" or equivalent policy form in the amount of the initial Contract Sum, plus value of subsequent Contract Modifications and cost of materials supplied or installed by others, comprising total value for the entire Project at the site on a replacement cost basis.

- **3.85** Delete the language of Section 11.3.1.2 and substitute the word "Reserved."
- **3.86** Delete the language of Section 11.3.1.3 and substitute the word "Reserved."
- **3.87** *Delete Section 11.3.2 and substitute the following:*

11.3.2 BOILER AND MACHINERY INSURANCE

The Contractor shall purchase and maintain boiler and machinery insurance required by the Contract Documents or by law, which shall specifically cover such insured objects during installation and until final acceptance by the Owner; this insurance shall include interests of the Owner, Contractor, Subcontractors and Sub-subcontractors in the Work, and the Owner and Contractor shall both be named insureds.

3.88 *Delete Section 11.3.3 and substitute the following:*

11.3.3 LOSS OF USE INSURANCE

The Owner, at the Owner's option, may purchase and maintain such insurance as will insure the Owner against loss of use of the Owner's property due to fire or other hazards, however caused. To the extent any losses are covered and paid for by such insurance, the Owner waives all rights of action against the Contractor for loss of use of the Owner's property, including consequential losses due to fire or other hazards however caused.

- **3.89** *Delete Section 11.3.4 and substitute the following:*
 - **11.3.4** If the Owner requests in writing that insurance for risks other than those described herein or other special causes of loss be included in the property insurance policy, the Contractor shall, if possible, include such insurance, and the cost thereof shall be charged to the Owner by appropriate Change Order.

- **3.91** *Delete Section 11.3.6 and substitute the following:*
 - 11.3.6 Before an exposure to loss may occur, the Contractor shall file with the Owner a copy of each policy that includes insurance coverages required by this Section 11.3. Each policy shall contain all generally applicable conditions, definitions, exclusions and endorsements related to this Project. Each policy shall contain a provision that the policy will not be canceled or allowed to expire, and that its limits will not be reduced, until at least 30 days' prior written notice has been given to the Owner.

The Owner and Contractor waive all rights against (1) each other and any of their subcontractors, subsubcontractors, agents and employees, each of the other, and (2) the Architect, Architect's consultants, separate contractors described in Article 6, if any, and any of their subcontractors, sub-subcontractors, agents and employees, for damages caused by fire or other causes of loss to the extent the property insurance provided by the Contractor pursuant to this Section 11.3 covers and pays for the damage, except such rights as they have to proceeds of such insurance held by the Contractor as fiduciary.

3.93 *Delete the first sentence of Section 11.3.8 and substitute the following:*

A loss insured under the Contractor's property insurance shall be adjusted by the Contractor as fiduciary and made payable to the Contractor as fiduciary for the insureds, as their interests may appear, subject to requirements of any applicable mortgagee clause and of Section 11.3.10.

3.94 *Delete Section 11.3.9 and substitute the following:*

11.3.9 If required in writing by a party in interest, the Contractor as fiduciary shall, upon occurrence of an insured loss, give bond for proper performance of the Contractor's duties. The cost of required bonds shall be charged against proceeds received as fiduciary. The Contractor shall deposit in a separate account proceeds so received, which the Contractor shall distribute in accordance with such agreement as the parties in interest may reach. If after such loss no other special agreement is made and unless the Owner terminates the Contract for convenience, replacement of damaged property shall be performed by the Contractor.

3.95 *Delete Section 11.3.10 and substitute the following:*

11.3.10 The Contractor as fiduciary shall have power to adjust and settle a loss with insurers unless one of the parties in interest shall object in writing within five days after occurrence of loss to the Contractor's exercise of this power; if such objection is made, the dispute shall be resolved in the manner provided in the contract between the parties in dispute as the method of binding dispute resolution. The Contractor as fiduciary shall make settlement with insurers or, in the case of a dispute over distribution of insurance proceeds, in accordance with a final order or determination issued by the appropriate authority having jurisdiction over the dispute..

3.96 *Delete Section 11.4.1 and substitute the following:*

11.4.1 Before commencing any services hereunder, the Contractor shall provide the Owner with Performance and Payment Bonds, each in an amount not less than the Contract Price set forth in Article 4 of the Agreement. The Surety shall have, at a minimum, a "Best Rating" of "A" as stated in the most current publication of "Best's Key Rating Guide, Property-Casualty". In addition, the Surety shall have a minimum "Best Financial Strength Category" of "Class V", and in no case less than five (5) times the contract amount. The Performance Bond shall be written on Form SE-355, "Performance Bond" and the Payment Bond shall written on Form SE-357, "Labor and Material Payment Bond", and both shall be made payable to the Owner.

3.97 *Delete Section 11.4.2 and substitute the following:*

11.4.2 The Performance and Labor and Material Payment Bonds shall:

- .1 be issued by a surety company licensed to do business in South Carolina;
- .2 be accompanied by a current power of attorney and certified by the attorney-in-fact who executes the bond on the behalf of the surety company; and
- .3 remain in effect for a period not less than one (1) year following the date of Substantial Completion or the time required to resolve any items of incomplete Work and the payment of any disputed amounts, whichever time period is longer.

If, prior to the date of Substantial Completion, the Contractor, a Subcontractor, or anyone for whom either is responsible, uses or damages any portion of the Work, including, without limitation, mechanical, electrical, plumbing, and other building systems, machinery, equipment, or other mechanical device, the Contractor shall cause such item to be restored to "like new" condition at no expense to the Owner.

3.103 *Delete Section 13.1 and substitute the following:*

13.1 GOVERNING LAW

The Contract, any dispute, claim, or controversy relating to the Contract, and all the rights and obligations of the parties shall, in all respects, be interpreted, construed, enforced and governed by and under the laws of the State of South Carolina, except its choice of law rules.

3.104 Delete Section 13.2, including its Sub-Sections 13.2.1 and 13.2.2, and substitute the following:

13.2 SUCCESSORS AND ASSIGNS

The Owner and Contractor respectively bind themselves, their partners, successors, assigns and legal representatives to covenants, agreements and obligations contained in the Contract Documents. Neither party to the Contract shall assign the Contract as a whole, or in part, without written consent of the other and then only in accordance with and as permitted by Regulation 19-445.2180 of the South Carolina Code of Regulations, as amended. If either party attempts to make such an assignment without such consent, that party shall nevertheless remain legally responsible for all obligations under the Contract.

3.105 *Delete Section 13.3 and substitute the following:*

13.3 WRITTEN NOTICE

Unless otherwise permitted herein, all notices contemplated by the Contract Documents shall be in writing and shall be deemed given:

- .1 upon actual delivery, if delivery is by hand;
- .2 upon receipt by the transmitting party of confirmation or reply, if delivery is by electronic mail, facsimile, telex or telegram;
- .3 upon receipt, if delivery is by the United States mail.

3.108 *Delete Section 13.6 and substitute the following:*

13.6 INTEREST

Payments due to the Contractor and unpaid under the Contract Documents shall bear interest only if and to the extent allowed by Title 29, Chapter 6, Article 1 of the South Carolina Code of Laws. Amounts due to the Owner shall bear interest at the rate of one percent a month or a pro rata fraction thereof on the unpaid balance as may be due.

- **3.109** Delete the language of Section 13.7 and substitute the word "Reserved."
- **3.110** Add the following Sections 13.8 through 13.16:

13.8 PROCUREMENT OF MATERIALS BY OWNER

The Contractor accepts assignment of all purchase orders and other agreements for procurement of materials and equipment by the Owner that are identified as part of the Contract Documents. The Contractor shall, upon delivery, be responsible for the storage, protection, proper installation, and preservation of such Owner purchased items, if any, as if the Contractor were the original purchaser. The Contract Sum includes, without limitation, all costs and expenses in connection with delivery, storage, insurance, installation, and testing of items covered in any assigned purchase orders or agreements. Unless the Contract Documents specifically provide otherwise, all Contractor warranty of workmanship and correction of the Work obligations under the Contract Documents shall apply to the Contractor's installation of and modifications to any Owner purchased items,.

13.9 INTERPRETATION OF BUILDING CODES

As required by Title 10, Chapter 1, Section 180 of the South Caroline Code of Laws, as amended, OSE shall determine the enforcement and interpretation of all building codes and referenced standards on state buildings. The Contractor shall refer any questions, comments, or directives from local officials to the Owner and OSE for resolution.

STANDARD SUPPLEMENTARY CONDITIONS

13.10 MINORITY BUSINESS ENTERPRISES

Contractor shall notify Owner of each Minority Business Enterprise (MBE) providing labor, materials, equipment, or supplies to the Project under a contract with the Contractor. Contractor's notification shall be via the first monthly status report submitted to the Owner after execution of the contract with the MBE. For each such MBE, the Contractor shall provide the MBE's name, address, and telephone number, the nature of the work to be performed or materials or equipment to be supplied by the MBE, whether the MBE is certified by the South Carolina Office of Small and Minority Business Assistance, and the value of the contract.

13.11 SEVERABILITY

If any provision or any part of a provision of the Contract Documents shall be finally determined to be superseded, invalid, illegal, or otherwise unenforceable pursuant to any applicable Legal Requirements, such determination shall not impair or otherwise affect the validity, legality, or enforceability of the remaining provision or parts of the provision of the Contract Documents, which shall remain in full force and effect as if the unenforceable provision or part were deleted.

13.12 ILLEGAL IMMIGRATION

Contractor certifies and agrees that it will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina Code of Laws and agrees to provide to the State upon request any documentation required to establish either: (a) that Title 8, Chapter 14 is inapplicable both to Contractor and its subcontractors or subsubcontractors; or (b) that Contractor and its subcontractors or sub-subcontractors are in compliance with Title 8, Chapter 14. Pursuant to Section 8-14-60, "A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony, and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both." Contractor agrees to include in any contracts with its subcontractors language requiring its subcontractors to (a) comply with the applicable requirements of Title 8, Chapter 14, and (b) include in their contracts with the sub-subcontractors language requiring the sub-subcontractors to comply with the applicable requirements of Title 8, Chapter 14. (An overview is available at www.procurement.sc.gov)

13.13 SETOFF

The Owner shall have all of its common law, equitable, and statutory rights of set-off.

13.14 DRUG-FREE WORKPLACE

The Contractor certifies to the Owner that Contractor will provide a Drug-Free Workplace, as required by Title 44, Chapter 107 of the South Carolina Code of Laws, as amended.

13.15 FALSE CLAIMS

According to the S.C. Code of Laws § 16-13-240, "a person who by false pretense or representation obtains the signature of a person to a written instrument or obtains from another person any chattel, money, valuable security, or other property, real or personal, with intent to cheat and defraud a person of that property is guilty" of a crime.

13.16 NON-INDEMNIFICATION:

Any term or condition is void to the extent it requires the State to indemnify anyone. It is unlawful for a person charged with disbursements of state funds appropriated by the General Assembly to exceed the amounts and purposes stated in the appropriations. (§ 11-9-20) It is unlawful for an authorized public officer to enter into a contract for a purpose in which the sum is in excess of the amount appropriated for that purpose. It is unlawful for an authorized public officer to divert or appropriate the funds arising from any tax levied and collected for any one fiscal year to the payment of an indebtedness contracted or incurred for a previous year. (§ 11-1-40)

3.111 *Delete Section 14.1.1 and substitute the following:*

 - **14.2.1** The Owner may terminate the Contract if the Contractor
 - .1 repeatedly refuses or fails to supply enough properly skilled workers or proper materials, or otherwise fails to prosecute the Work, or any separable part of the Work, with the diligence, resources and skill that will ensure its completion within the time specified in the Contract Documents, including any authorized adjustments;
 - .2 fails to make payment to Subcontractors for materials or labor in accordance with the Contract Documents and the respective agreements between the Contractor and the Subcontractors;
 - .3 repeatedly disregards applicable laws, statutes, ordinances, codes, rules and regulations, or lawful orders of a public authority; or
 - .4 otherwise is guilty of substantial breach of a provision of the Contract Documents.

 - **14.4.3** In case of such termination for the Owner's convenience, the Contractor shall be entitled to receive payment for Work executed, costs incurred by reason of such termination, and any other adjustments otherwise allowed by the Contract. Any adjustment to the Contract Sum made pursuant to this Section 14.4 shall be made in accordance with the requirements of Article 7.3.3.
- **3.122** Add the following Sections 14.4.4, 14.4.5, and 14.5:
 - **14.4.4** Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the Owner's right to require the termination of a subcontract, or (ii) increase the obligation of the Owner beyond what it would have been if the subcontract had contained an appropriate clause.
 - **14.4.5** Upon written consent of the Contractor, the Owner may reinstate the terminated portion of this Contract in whole or in part by amending the notice of termination if it has been determined that:
 - .1 the termination was due to withdrawal of funding by the General Assembly, Governor, or Budget and Control Board or the need to divert project funds to respond to an emergency as defined by Regulation 19-445.2110(B) of the South Carolina Code of Regulations, as amended;
 - .2 funding for the reinstated portion of the work has been restored;
 - .3 circumstances clearly indicate a requirement for the terminated work; and
 - .4 reinstatement of the terminated work is advantageous to the Owner.

14.5 CANCELLATION AFTER AWARD BUT PRIOR TO PERFORMANCE

Pursuant to Title 11, Chapter 35 and Regulation 19-445.2085 of the South Carolina Code of Laws and Regulations, as amended, this contract may be canceled after award but prior to performance.

3.123 *Insert the following sentence after the second sentence of Section 15.1.1:*

A voucher, invoice, payment application or other routine request for payment that is not in dispute when submitted is not a Claim under this definition.

3.124 *Delete Section 15.1.2 and substitute the following:*

15.1.2 NOTICE OF CLAIMS

Claims by either the Owner or Contractor must be initiated by written notice to the other party and to the Architect. Such notice shall include sufficient information to advise the Architect and other party of the circumstances giving rise to the claim, the specific contractual adjustment or relief requested and the basis of such request. Claims by either party arising prior to the date final payment is due must be initiated within 21 days after occurrence of the event giving rise to such Claim or within 21 days after the claimant first recognizes the condition giving rise to the Claim, whichever is later except as stated for adverse weather days in Section 15.1.5.2. By failing to give written notice of a Claim within the time required by this Section, a party expressly waives its claim.

3.125 *Delete Section 15.1.3 and substitute the following:*

15.1.3 CONTINUING CONTRACT PERFORMANCE

Pending final resolution of a Claim, including any administrative review allowed under Section 15.6, except as otherwise agreed in writing or as provided in Section 9.7 and Article 14, the Contractor shall proceed diligently with performance of the Contract and the Owner shall continue to make payments in accordance with the Contract Documents. The Architect will issue Certificates for Payment in accordance with the initial decisions and determinations of the Architect.

STANDARD SUPPLEMENTARY CONDITIONS

3.126 *Insert the following at the end of Section 15.1.5.1:*

Claims for an increase in the Contract Time shall be based on one additional calendar day for each full calendar day that the Contractor is prevented from working.

- **3.127** *Insert the following Sub-Sections at the end of Section 15.1.5.2:*
 - .1 Claims for adverse weather shall be based on actual weather conditions at the job site or other place of performance of the Work, as documented in the Contractor's job site log.
 - .2 For the purpose of this Contract, a total of five (5) calendar days per calendar month (non-cumulative) shall be anticipated as "adverse weather" at the job site, and such time will not be considered justification for an extension of time. If, in any month, adverse weather develops beyond the five (5) days, the Contractor shall be allowed to claim additional days to compensate for the excess weather delays only to the extent of the impact on the approved construction schedule. The remedy for this condition is for an extension of time only and is exclusive of all other rights and remedies available under the Contract Documents or imposed or available by law.
 - .3 The Contractor shall submit monthly with their pay application all claims for adverse weather conditions that occurred during the previous month. The Architect shall review each monthly submittal in accordance with Section 15.5 and inform the Contractor and the Owner promptly of its evaluation. Approved days shall be included in the next Change Order issued by the Architect. Adverse weather conditions not claimed within the time limits of this Subparagraph shall be considered to be waived by the Contractor. Claims will not be allowed for adverse weather days that occur after the scheduled (original or adjusted) date of Substantial Completion.
- **3.128** *Delete Section 15.1.6 and substitute the following:*

15.1.6 CLAIMS FOR LISTED DAMAGES

Notwithstanding any other provision of the Contract Documents, including Section 1.2.1, but subject to a duty of good faith and fair dealing, the Contractor and Owner waive Claims against each other for listed damages arising out of or relating to this Contract.

15.1.6.1 For the Owner, listed damages are (i) lost revenue and profit, (ii) losses resulting from injury to business or reputation, (iii) additional or escalated overhead and administration expenses, (iv) additional financing costs, (v) costs suffered by a third party unable to commence work, (vi) attorney's fees, (vii) any interest, except to the extent allowed by Section 13.6 (Interest), (viii) lost revenue and profit for lost use of the property, (ix) costs resulting from lost productivity or efficiency.

15.1.6.2 For the Contractor, listed damages are (i) lost revenue and profit, (ii) losses resulting from injury to business or reputation, (iii) additional or escalated overhead and administration expenses, (iv) additional financing costs, (v) attorney's fees, (vi) any interest, except to the extent allowed by Section 13.6 (Interest); (vii) unamortized equipment costs; and, (viii) losses incurred by subcontractors for the types of damages the Contractor has waive as against the Owner. Without limitation, this mutual waiver is applicable to all damages due to either party's termination in accordance with Article 14. Nothing contained in this Section shall be deemed to preclude an award of liquidated damages, when applicable, in accordance with the requirements of the Contract Documents. This mutual waiver is not applicable to amounts due or obligations under Section 3.18 (Indemnification).

3.129 Add the following Section 15.1.7:

15.1.7 WAIVER OF CLAIMS AGAINST THE ARCHITECT

Notwithstanding any other provision of the Contract Documents, including Section 1.2.1, but subject to a duty of good faith and fair dealing, the Contractor waives all claims against the Architect and any other design professionals who provide design and/or project management services to the Owner, either directly or as independent contractors or subcontractors to the Architect, for listed damages arising out of or relating to this Contract. The listed damages are (i) lost revenue and profit, (ii) losses resulting from injury to business or reputation, (iii) additional or escalated overhead and administration expenses, (iv) additional financing costs, (v)

attorney's fees, (vi) any interest; (vii) unamortized equipment costs; and, (viii) losses incurred by subcontractors for the types of damages the Contractor has waive as against the Owner. This mutual waiver is not applicable to amounts due or obligations under Section 3.18 (Indemnification).

- 3.130 Delete the language of Sections 15.2, 15.3, and 15.4, including all Sub-Sections, and substitute the word "Reserved" for the deleted language of each Section and Sub-Section.
- **3.131** *Add the following Sections 15.5 and 15.6 with their sub-sections:*

15.5 CLAIM AND DISPUTES - DUTY OF COOPERATION, NOTICE, AND ARCHITECTS INITIAL DECISION

- **15.5.1** Contractor and Owner are fully committed to working with each other throughout the Project to avoid or minimize claims. To further this goal, Contractor and Owner agree to communicate regularly with each other and the Architect at all times notifying one another as soon as reasonably possible of any issue that if not addressed may cause loss, delay, and/or disruption of the Work. If claims do arise, Contractor and Owner each commit to resolving such claims in an amicable, professional, and expeditious manner to avoid unnecessary losses, delays, and disruptions to the Work.
- **15.5.2** Claims shall first be referred to the Architect for initial decision. An initial decision shall be required as a condition precedent to resolution pursuant to Section 15.6 of any Claim arising prior to the date of final payment, unless 30 days have passed after the Claim has been referred to the Architect with no decision having been rendered, or after all the Architect's requests for additional supporting data have been answered, whichever is later. The Architect will not address claims between the Contractor and persons or entities other than the Owner.
- **15.5.3** The Architect will review Claims and within ten days of the receipt of a Claim (1) request additional supporting data from the claimant or a response with supporting data from the other party or (2) render an initial decision in accordance with Section 15.5.5.
- **15.5.4** If the Architect requests a party to provide a response to a Claim or to furnish additional supporting data, such party shall respond, within ten days after receipt of such request, and shall either (1) provide a response on the requested supporting data, (2) advise the Architect when the response or supporting data will be furnished or (3) advise the Architect that all supporting data has already been provided. Upon receipt of the response or supporting data, the Architect will render an initial decision in accordance with Section 15.5.5.
- 15.5.5 The Architect will render an initial decision in writing; (1) stating the reasons therefor; and (2) notifying the parties of any change in the Contract Sum or Contract Time or both. The Architect will deliver the initial decision to the parties within two weeks of receipt of any response or supporting data requested pursuant to Section 16.4, or within such longer period as may be mutually agreeable to the parties. If the parties accept the initial decision, the Architect shall prepare a Change Order with appropriate supporting documentation for the review and approval of the parties and the Office of State Engineer. If either the Contractor, Owner, or both, disagree with the initial decision, the Contractor and Owner shall proceed with dispute resolution in accordance with the provisions of Section 15.6.
- **15.5.6** In the event of a Claim against the Contractor, the Owner may, but is not obligated to, notify the surety, if any, of the nature and amount of the Claim. If the Claim relates to a possibility of a Contractor's default, the Owner may, but is not obligated to, notify the surety and request the surety's assistance in resolving the controversy.

15.6 DISPUTE RESOLUTION

15.6.1 If a claim is not resolved pursuant to Section 15.5 to the satisfaction of either party, both parties shall attempt to resolve the dispute at the field level through discussions between Contractor's Representative and Owner's Representative. If a dispute cannot be resolved through Contractor's Representative and Owner's Representative, then the Contractor's Senior Representative and the Owner's Senior Representative, upon the request of either party, shall meet as soon as conveniently possible, but in no case later than twenty-one days after such a request is made, to attempt to resolve such dispute. Prior to any meetings between the Senior Representatives, the parties will exchange relevant information that will assist the parties in resolving their dispute. The meetings required by this Section are a condition precedent to resolution pursuant to Section 15.6.2.

STANDARD SUPPLEMENTARY CONDITIONS

15.6.2 If after meeting in accordance with the provisions of Section 15.6.1, the Senior Representatives determine that the dispute cannot be resolved on terms satisfactory to both the Contractor and the Owner, then either party may submit the dispute by written request to South Carolina's Chief Procurement Officer for Construction (CPOC). Except as otherwise provided in Article 15, all claims, claims, or controversies relating to the Contract shall be resolved exclusively by the appropriate Chief Procurement Officer in accordance with Title 11, Chapter 35, Article 17 of the South Carolina Code of Laws, or in the absence of jurisdiction, only in the Court of Common Pleas for, or in the absence of jurisdiction a federal court located in, Richland County, State of South Carolina. Contractor agrees that any act by the State regarding the Contract is not a waiver of either the State's sovereign immunity or the State's immunity under the Eleventh Amendment of the United State's Constitution.

15.6.3 If any party seeks resolution to a dispute pursuant to Section 15.6.2, the parties shall participate in non-binding mediation to resolve the claim. If the claim is governed by Title 11, Chapter 35, Article 17 of the South Carolina Code of Laws as amended and the amount in controversy is \$100,000.00 or less, the CPOC shall appoint a mediator, otherwise, the mediation shall be conducted by an impartial mediator selected by mutual agreement of the parties, or if the parties cannot so agree, a mediator designated by the American Arbitration Association ("AAA") pursuant to its Construction Industry Mediation Rules. The mediation will be governed by and conducted pursuant to a mediation agreement negotiated by the parties or, if the parties cannot so agree, by procedures established by the mediator.

15.6.4 Without relieving any party from the other requirements of Sections 15.5 and 15.6, either party may initiate proceedings in the appropriate forum prior to initiating or completing the procedures required by Sections 15.5 and 15.6 if such action is necessary to preserve a claim by avoiding the application of any applicable statutory period of limitation or repose.

15.6.5 SERVICE OF PROCESS

Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any claims, claims, or controversies relating to the Contract; for any court action in connection therewith; or for the entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided for the Contractor's Senior Representative or by personal service or by any other manner that is permitted by law, in or outside South Carolina. Notice by certified mail is deemed duly given upon deposit in the United States mail.

USC SUPPLEMENTAL GENERAL CONDITIONS FOR CONSTRUCTION PROJECTS

- 1. Contractor's employees shall take all reasonable means not to interrupt the flow of student traffic in building corridors, lobbies and stairs. All necessary and reasonable safety precautions shall be taken to prevent injury to building occupants while transporting materials and equipment through the building to the work area. Providing safe, accessible, plywood pedestrian ways around construction may be required if a suitable alternative route is not available.
- 2. Fraternization between Contractor's employees and USC students, faculty or staff is strictly prohibited-zero tolerance!
- 3. USC will not tolerate rude, abusive or degrading behavior on the job site. Heckling and catcalling directed toward students, faculty or staff or any other person on USC property is strictly prohibited. Any contractor whose employees violate this requirement will be assessed a fine of up to \$500 per violation.
- 4. Contractor's employees must adhere to the University's policy of maintaining a drug-free and smoke-free/tobacco free workplace.
- 5. Contractor must sign a Contractor Key Receipt/Return form before any keys are issued. Keys must be returned immediately upon the completion of the work. The Contractor will bear the cost of any re-keying necessary due to the loss of or failure to return keys.
- 6. A welding permit must be issued by the University Fire Marshall before any welding can begin inside a building. Project Manager will coordinate.
- 7. Contractor must notify the University immediately upon the discovery of suspect material such as those potentially containing asbestos or other such hazardous materials. These materials **must not** be disturbed until approved by the USC Project Manager.
- 8. At the beginning of the project, the USC Project Manager will establish the Contractor's laydown area. This area will also be used for the Contractor's work vehicles. No personal vehicles will be allowed in this area, or in any areas surrounding the construction site that are not regular or authorized parking lots. Personal vehicles must be parked in the perimeter parking lots. Parking permits can be obtained at the USC Parking Office located in the Pendleton Street parking garage. The lay down area will be clearly identified to the contractor by the PM, with a sketch or drawing provided to Parking. In turn, the contractor will mark off this area with a sign containing the project name, PM name, Contractor name and contact number, and end date. Where this area is subject to foot traffic, protective barriers will be provided as specified by the PM. The area will be maintained in a neat and orderly fashion. Vehicles parked in the lay down area (or designated parking areas) will be clearly marked or display a CPC furnished placard for identification.
- 9. Contractor will be responsible for providing its own temporary toilet facilities, unless prior arrangements are made with the USC Project Manager.
- 10. Use of USC communications facilities (telephones, computers, etc.) by the Contractor is prohibited, unless prior arrangements are made with the USC Project Manager.

- 11. For all projects over \$100,000, including IDC's, an SE-395, Contractor Performance Evaluation, will be completed by the USC Project Manager and reviewed with the GC at the beginning of the project and a copy given to the GC. At the end of the project the form will be completed and a Construction Performance rating will be established.
- 12. Contractor is responsible for removal of all debris from the site, and is required to provide the necessary dumpsters which will be emptied at least 2 times per week. Construction waste must not be placed in University dumpsters. THE CONSTRUCTION SITE MUST BE THOROUGHLY CLEANED WITH ALL TRASH PICKED UP AND PROPERLY DISPOSED OF ON A DAILY BASIS AND THE SITE MUST BE LEFT IN A SAFE AND SANITARY CONDITION EACH DAY. THE UNIVERSITY WILL INSPECT JOB SITES REGULARLY AND WILL FINE ANY CONTRACTOR FOUND TO BE IN VIOLATION OF THIS REQUIREMENT AN AMOUNT OF UP TO \$1,000 PER VIOLATION.
- 13. <u>Contractor must provide all O&M manuals, as-built drawings, and training of USC personnel on new equipment, controls, etc. prior to Substantial Completion. Final payment will not be made until this is completed.</u>
- 14. The contractor will comply with all regulations set forth by OSHA and SCDHEC. Contractor must also adhere to USC's internal policies and procedures (available by request). As requested, the contractor will submit all Safety Programs and Certificates of Insurance to the University for review.
- 15. Tree protection fencing is required to protect existing trees and other landscape features to be preserved within a construction area. The limits of this fence will be evaluated for each situation with the consultant, USC Arborist and USC Project Manager. The tree protection fence shall be 5' high chain link fence unless otherwise approved by USC Project Manager. No entry or materials storage will be allowed inside the tree protection zone. A 4" layer of mulch shall be placed over the tree protection area to maintain moisture in the root zone.
- 16. Where it is necessary to cross walks, tree root zones (i.e., under canopy) or lawns the following measures shall be taken: For single loads up to 9,000 lbs., a 3/4" minimum plywood base shall be placed over areas impacted. For single loads over 9,000 lbs., two layers of 3/4" plywood is required.
- 17. For projects requiring heavy loads to cross walks tree root zones or lawns. A construction entry road consisting of 10' X 16' oak logging mates on 12" coarse, chipped, hardwood base. Mulch and logging mats shall be supplemented throughout the project to keep matting structurally functional.
- 18. Any damage to existing landscaping (including lawn areas) will be remediated before final payment is made.
- 19. Orange safety fence to be provided by the contractor. (USC Arborist, Kevin Curtis may be contacted at 777-0033 or 315-0319)

CAMPUS VEHICLE EXPECTATIONS

- 1. All motorized vehicles on the University campus are expected to travel and park on roadways and/or in parking stalls.
- 2. All motorized vehicle traffic on USC walkways must first receive the Landscape Manager=s authorization. Violators may be subject to fines and penalties.
- 3. All motorized vehicles that leak or drip liquids are prohibited from traveling or parking on walks or landscaped areas.
- 4. Contractors, vendors, and delivery personnel are required to obtain prior parking authorization before parking in a designated space. Violators may be subject to fines and/or penalties. See Item 10 below.
- 5. Drivers of equipment or motor vehicles that damage university hardscape or landscape will be held personally responsible for damages and restoration expense.
- 6. Vehicle drivers who park on landscape or drives must be able to produce written evidence of need or emergency requiring parking on same.
- 7. All vehicles parked on landscape, hardscape, or in the process of service delivery, must display adequate safety devices, i.e. flashing lights, cones, signage, etc.
- 8. All drivers of equipment and vehicles will be respectful of University landscape, equipment, structures, fixtures and signage.
- 9. All incidents of property damage will be reported to Parking Services or the Work Management Center.
- 10. Parking on campus is restricted to spaces designated by Parking Services at the beginning of the project. Once the project manager and contractor agree on how many spaces are needed, the project manager will obtain a placard for each vehicle. This placard must be hung from the mirror of the vehicle, otherwise a ticket will be issued and these tickets cannot be "fixed". Parking spaces are restricted to work vehicles only; no personal vehicles.

- 1. The Contractor and the Surety, jointly and severally, bind themselves, their heirs, executors, administrators, successors and assigns to the Agency for the full and faithful performance of the contract, which is incorporated herein by reference
- 2. If the Contractor performs the contract, the Surety and the Contractor have no obligation under this Bond, except to participate in conferences as provided in paragraph 3.1.

- **3.2** The Agency has declared a Contractor Default and formally terminated the Contractor's right to complete the Contract.
- **4.** The Surety shall, within 15 days after receipt of notice of the Agency's declaration of a Contractor Default, and at the Surety's sole expense, take one of the following actions:
- **4.1** Arrange for the Contractor, with consent of the Agency, to perform and complete the Contract; or
- **4.2** Undertake to perform and complete the Contract itself, through its agents or through independent contractors; or
- **4.3** Obtain bids or negotiated proposals from qualified contractors acceptable to the Agency for a contract for performance and completion of the Contract, arrange for a contract to be prepared for execution by the Agency and the contractor selected with the Agency's concurrence, to be secured with performance and payment bonds executed by a qualified surety equivalent to the Bonds issued on the Contract, and pay to the Agency the amount of damages as described in paragraph 7 in excess of the Balance of the Contract Sum incurred by the Agency resulting from the Contractor Default; or
- **4.4** Waive its right to perform and complete, arrange for completion, or obtain a new contractor, and:
- **4.4.1** After investigation, determine the amount for which it may be liable to the Agency and, within 60 days of waiving its rights under this paragraph, tender payment thereof to the Agency; or
- **4.4.2** Deny liability in whole or in part and notify the Agency, citing the reasons therefore.
- **5.** Provided Surety has proceeded under paragraphs 4.1, 4.2, or 4.3, the Agency shall pay the Balance of the Contract Sum to either:
- **5.1** Surety in accordance with the terms of the Contract; or
- **5.2** Another contractor selected pursuant to paragraph 4.3 to perform the Contract.
- **5.3** The balance of the Contract Sum due either the Surety or another contractor shall be reduced by the amount of damages as described in paragraph 7.
- **6.** If the Surety does not proceed as provided in paragraph 4 with reasonable promptness, the Surety shall be deemed to be in default on this Bond 15 days after receipt of written notice from the Agency to the Surety demanding that the Surety perform its obligations under this Bond, and the Agency shall be entitled to enforce any remedy available to the Agency.
- **6.1** If the Surety proceeds as provided in paragraph 4.4, and the Agency refuses the payment tendered or the Surety has denied

- liability, in whole or in part, then without further notice the Agency shall be entitled to enforce any remedy available to the Agency.
- **6.2** Any dispute, suit, action or proceeding arising out of or relating to this Bond shall be governed by the Dispute Resolution process defined in the Contract Documents and the laws of the State of South Carolina.
- 7. After the Agency has terminated the Contractor's right to complete the Contract, and if the Surety elects to act under paragraph 4.1, 4.2, or 4.3 above, then the responsibilities of the Surety to the Agency shall be those of the Contractor under the Contract, and the responsibilities of the Agency to the Surety shall those of the Agency under the Contract. To a limit of the amount of this Bond, but subject to commitment by the Agency of the Balance of the Contract Sum to mitigation of costs and damages on the Contract, the Surety is obligated to the Agency without duplication for:
- **7.1** The responsibilities of the Contractor for correction of defective Work and completion of the Contract; and
- **7.2** Additional legal, design professional and delay costs resulting from the Contractor's Default, and resulting from the actions or failure to act of the Surety under paragraph 4; and
- **7.3** Damages awarded pursuant to the Dispute Resolution Provisions of the Contract. Surety may join in any Dispute Resolution proceeding brought under the Contract and shall be bound by the results thereof; and
- **7.4** Liquidated Damages, or if no Liquidated Damages are specified in the Contract, actual damages caused by delayed performance or non-performance of the Contractor.
- 8. The Surety shall not be liable to the Agency or others for obligations of the Contractor that are unrelated to the Contract, and the Balance of the Contract Sum shall not be reduced or set-off on account of any such unrelated obligations. No right of action shall accrue on this Bond to any person or entity other than the Agency or its heirs, executors, administrators, or successors.
- **9.** The Surety hereby waives notice of any change, including changes of time, to the contract or to related subcontracts, purchase orders and other obligations.
- **10.** Notice to the Surety, the Agency or the Contractor shall be mailed or delivered to the address shown on the signature page.
- 11. Definitions
- 11.1 Balance of the Contract Sum: The total amount payable by the Agency to the Contractor under the Contract after all proper adjustments have been made, including allowance to the Contractor of any amounts to be received by the Agency in settlement of insurance or other Claims for damages to which the Contractor is entitled, reduced by all valid and proper payments made to or on behalf of the Contractor under the Contract.
- **11.2** Contractor Default: Failure of the Contractor, which has neither been remedied nor waived, to perform the Contract or otherwise to comply with the terms of the Contract.

NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH THAT:

- 1. The Contractor and the Surety, jointly and severally, bind themselves, their heirs, executors, administrators, successors and assigns to the Agency to pay for all labor, materials and equipment required for use in the performance of the Contract, which is incorporated herein by reference.
- 2. With respect to the Agency, this obligation shall be null and void if the Contractor:
- **2.1** Promptly makes payment, directly or indirectly, for all sums due Claimants; and
- **2.2** Defends, indemnifies and holds harmless the Agency from all claims, demands, liens or suits by any person or entity who furnished labor, materials or equipment for use in the performance of the Contract.
- **3**. With respect to Claimants, this obligation shall be null and void if the Contractor promptly makes payment, directly or indirectly, for all sums due.
- **4.** With respect to Claimants, and subject to the provisions of Title 29, Chapter 5 and the provisions of §11-35-3030(2)(c) of the SC Code of Laws, as amended, the Surety's obligation under this Bond shall arise as follows:
- **4.1** Every person who has furnished labor, material or rental equipment to the Contractor or its subcontractors for the work specified in the Contract, and who has not been paid in full therefore before the expiration of a period of ninety (90) days after the date on which the last of the labor was done or performed by him or material or rental equipment was furnished or supplied by him for which such claim is made, shall have the right to sue on the payment bond for the amount, or the balance thereof, unpaid at the time of institution of such suit and to prosecute such action for the sum or sums justly due him.
- **4.2** A remote claimant shall have a right of action on the payment bond upon giving written notice by certified or registered mail to the Contractor within ninety (90) days from the date on which such person did or performed the last of the labor or furnished or supplied the last of the material or rental equipment upon which such claim is made.
- **4.3** Every suit instituted upon a payment bond shall be brought in a court of competent jurisdiction for the county or circuit in which the construction contract was to be performed, but no such suit shall be commenced after the expiration of o ne year after the day on which the last of the labor was performed or material or rental equipment was supplied by the person bringing suit.
- **5.** When the Claimant has satisfied the conditions of paragraph 4, the Surety shall promptly and at the Surety's expense take the following actions:
- **5.1** Send an answer to the Claimant, with a copy to the Agency, within sixty (60) days after receipt of the claim, stating the amounts that are undisputed and the basis for challenging any amounts that are disputed.

- **5.3** The Surety's failure to discharge its obligations under this paragraph 5 shall not be deemed to constitute a waiver of defenses the Surety or Contractor may have or acquire as to a claim. However, if the Surety fails to discharge its obligations under this paragraph 5, the Surety shall indemnify the Claimant for the reasonable attorney's fees the Claimant incurs to recover any sums found to be due and owing to the Claimant.
- **6.** Amounts owed by the Agency to the Contractor under the Contract shall be used for the performance of the Contract and

- to satisfy claims, if any, under any Performance Bond. By the Contractor furnishing and the Agency accepting this Bond, they agree that all funds earned by the contractor in the performance of the Contract are dedicated to satisfy obligations of the Contractor and the Surety under this Bond, subject to the Agency's prior right to use the funds for the completion of the Work

- B. Cutting and Patching: Submit written request in advance of cutting or alteration that affects:
 - 1. Structural integrity of any element of Project.
 - 2. Integrity of weather exposed or moisture resistant element.
 - 3. Efficiency, maintenance, or safety of any operational element.
 - 4. Visual qualities of sight exposed elements.
 - 5. Work of University of South Carolina or separate Contractor.

1.03 PROJECT CONDITIONS

- A. Ventilate enclosed areas to assist cure of materials, to dissipate humidity, and to prevent accumulation of dust, fumes, vapors, or gases.
- B. Dust Control: Execute work by methods to minimize raising dust from construction operations. Provide positive means to prevent air-borne dust from dispersing into atmosphere and over adjacent property.
- C. Noise Control: Provide methods, means, and facilities to minimize noise produced by construction operations.
- D. Pest and Rodent Control: Provide methods, means, and facilities to prevent pests and insects from damaging the work.
- E. Pollution Control: Provide methods, means, and facilities to prevent contamination of soil, water, and atmosphere from discharge of noxious, toxic substances, and pollutants produced by construction operations. Comply with federal, state, and local regulations.

1.04 COORDINATION

- A. Coordinate scheduling, submittals, and work of the various sections of the Project Manual to ensure efficient and orderly sequence of installation of interdependent construction elements, with provisions for accommodating items installed later.
- B. Notify affected utility companies and comply with their requirements.

- C. Verify that utility requirements and characteristics of new operating equipment are compatible with building utilities. Coordinate work of various sections having interdependent responsibilities for installing, connecting to, and placing in service, such equipment.
- D. Coordinate space requirements, supports, and installation of mechanical and electrical work that are indicated diagrammatically on Drawings. Follow routing shown for pipes, ducts, and conduit, as closely as practicable; place runs parallel with lines of building. Utilize spaces efficiently to maximize accessibility for other installations, for maintenance, and for repairs.
- E. In finished areas except as otherwise indicated, conceal pipes, ducts, and wiring within the construction. Coordinate locations of fixtures and outlets with finish elements.
- F. Coordinate completion and clean-up of work of separate sections.
- G. After University of South Carolina occupancy of premises, coordinate access to site for correction of defective work and work not in accordance with Contract Documents, to minimize disruption of University of South Carolina's activities.

PART 2 PRODUCTS

2.01 PATCHING MATERIALS

- A. New Materials: As specified in product sections; match existing products and work for patching and extending work.
- B. Type and Quality of Existing Products: Determine by inspecting and testing products where necessary, referring to existing work as a standard.
- C. Product Substitution: For any proposed change in materials, submit request for substitution described in Section 01 60 00.

PART 3 EXECUTION

3.01 EXAMINATION

- A. Verify that existing site conditions and substrate surfaces are acceptable for subsequent work. Start of work means acceptance of existing conditions.
- B. Verify that existing substrate is capable of structural support or attachment of new work being applied or attached.
- C. Examine and verify specific conditions described in individual specification sections.
- D. Take field measurements before confirming product orders or beginning fabrication, to minimize waste due to over-ordering or misfabrication.
- E. Verify that utility services are available, of the correct characteristics, and in the correct locations.
- F. Prior to Cutting: Examine existing conditions prior to commencing work, including elements subject to damage or movement during cutting and patching. After uncovering existing work, assess conditions affecting performance of work. Beginning of cutting or patching means acceptance of existing conditions.

3.02 PREPARATION

- A. Clean substrate surfaces prior to applying next material or substance.
- B. Seal cracks or openings of substrate prior to applying next material or substance.

C. Apply manufacturer required or recommended substrate primer, sealer, or conditioner prior to applying any new material or substance in contact or bond.

3.03 GENERAL INSTALLATION REQUIREMENTS

- A. Install products as specified in individual sections, in accordance with manufacturer's instructions and recommendations, and so as to avoid waste due to necessity for replacement.
- B. Make vertical elements plumb and horizontal elements level, unless otherwise indicated.
- C. Install equipment and fittings plumb and level, neatly aligned with adjacent vertical and horizontal lines, unless otherwise indicated.
- D. Make consistent texture on surfaces, with seamless transitions, unless otherwise indicated.
- E. Make neat transitions between different surfaces, maintaining texture and appearance.

3.04 ALTERATIONS

- A. Drawings showing existing construction and utilities are based on casual field observation and existing record documents only.
 - 1. Verify that construction and utility arrangements are as shown.
 - 2. Report discrepancies to Engineer before disturbing existing installation.
 - 3. Beginning of alterations work constitutes acceptance of existing conditions.
- B. Keep areas in which alterations are being conducted separated from other areas that are still occupied.
 - 1. Provide, erect, and maintain temporary dustproof partitions of construction specified in Section 01 50 00 in locations indicated on drawings.
- C. Maintain weatherproof exterior building enclosure except for interruptions required for replacement or modifications; take care to prevent water and humidity damage.
 - 1. Where openings in exterior enclosure exist, provide construction to make exterior enclosure weatherproof.
 - 2. Insulate existing ducts or pipes that are exposed to outdoor ambient temperatures by alterations work.
- D. Remove existing work as indicated and as required to accomplish new work.
 - Remove items indicated on drawings.
 - 2. Relocate items indicated on drawings.
 - 3. Where new surface finishes are to be applied to existing work, perform removals, patch, and prepare existing surfaces as required to receive new finish; remove existing finish if necessary for successful application of new finish.
 - 4. Where new surface finishes are not specified or indicated, patch holes and damaged surfaces to match adjacent finished surfaces as closely as possible.
- E. Services (Including but not limited to HVAC, Plumbing, Fire Protection, Electrical, and Telecommunications): Remove, relocate, and extend existing systems to accommodate new construction.

- Maintain existing active systems that are to remain in operation; maintain access to
 equipment and operational components; if necessary, modify installation to allow access or
 provide access panel.
- 2. Where existing systems or equipment are not active and Contract Documents require reactivation, put back into operational condition; repair supply, distribution, and equipment as required.
- Where existing active systems serve occupied facilities but are to be replaced with new services, maintain existing systems in service until new systems are complete and ready for service.
 - Disable existing systems only to make switchovers and connections; minimize duration of outages.
 - b. Provide temporary connections as required to maintain existing systems in service.
- 4. Verify that abandoned services serve only abandoned facilities.
- 5. Remove abandoned pipe, ducts, conduits, and equipment, including those above accessible ceilings; remove back to source of supply where possible, otherwise cap stub and tag with identification; patch holes left by removal using materials specified for new construction.
- F. Protect existing work to remain.
 - 1. Prevent movement of structure; provide shoring and bracing if necessary.
 - 2. Perform cutting to accomplish removals neatly and as specified for cutting new work.
 - 3. Repair adjacent construction and finishes damaged during removal work.
- G. Adapt existing work to fit new work: Make as neat and smooth transition as possible.
- H. Patching: Where the existing surface is not indicated to be refinished, patch to match the surface finish that existed prior to cutting. Where the surface is indicated to be refinished, patch so that the substrate is ready for the new finish.
- I. Refinish existing surfaces as indicated:
 - 1. Where rooms or spaces are indicated to be refinished, refinish all visible existing surfaces to remain to the specified condition for each material, with a neat transition to adjacent finishes.
 - If mechanical or electrical work is exposed accidentally during the work, re-cover and refinish to match.
- J. Clean existing systems and equipment.
- K. Remove demolition debris and abandoned items from alterations areas and dispose of off-site; do not burn or bury.
- L. Do not begin new construction in alterations areas before demolition is complete.
- M. Comply with all other applicable requirements of this section.

3.05 CUTTING AND PATCHING

- A. Whenever possible, execute the work by methods that avoid cutting or patching.
- B. See Alterations article above for additional requirements.
- C. Perform whatever cutting and patching is necessary to:
 - 1. Complete the work.
 - 2. Fit products together to integrate with other work.
 - 3. Provide openings for penetration of mechanical, electrical, and other services.

- 4. Match work that has been cut to adjacent work.
- 5. Repair areas adjacent to cuts to required condition.
- 6. Repair new work damaged by subsequent work.
- 7. Remove samples of installed work for testing when requested.
- 8. Remove and replace defective and non-conforming work.
- D. Execute work by methods that avoid damage to other work and that will provide appropriate surfaces to receive patching and finishing. In existing work, minimize damage and restore to original condition.
- E. Employ original installer to perform cutting for weather exposed and moisture resistant elements, and sight exposed surfaces.
- F. Cut rigid materials using masonry saw or core drill. Pneumatic tools not allowed without prior approval.
- G. Restore work with new products in accordance with requirements of Contract Documents.
- H. Fit work air tight to pipes, sleeves, ducts, conduit, and other penetrations through surfaces.
- At penetrations of fire rated walls, partitions, ceiling, or floor construction, completely seal voids with fire rated material in accordance with Section 07 84 00, to full thickness of the penetrated element.
- J. Patching:
 - Finish patched surfaces to match finish that existed prior to patching. On continuous surfaces, refinish to nearest intersection or natural break. For an assembly, refinish entire unit.
 - 2. Match color, texture, and appearance.
 - 3. Repair patched surfaces that are damaged, lifted, discolored, or showing other imperfections due to patching work. If defects are due to condition of substrate, repair substrate prior to repairing finish.

3.06 PROGRESS CLEANING

- A. Maintain areas free of waste materials, debris, and rubbish. Maintain site in a clean and orderly condition.
- B. Remove debris and rubbish from pipe chases, plenums, attics, crawl spaces, and other closed or remote spaces, prior to enclosing the space.
- C. Broom and vacuum clean interior areas prior to start of surface finishing, and continue cleaning to eliminate dust.
- D. Collect and remove waste materials, debris, and trash/rubbish from site periodically and dispose off-site; do not burn or bury.

3.07 PROTECTION OF INSTALLED WORK

- A. Protect installed work from damage by construction operations.
- B. Provide special protection where specified in individual specification sections.
- C. Provide temporary and removable protection for installed products. Control activity in immediate work area to prevent damage.
- D. Provide protective coverings at walls, projections, jambs, sills, and soffits of openings.
- E. Protect finished floors, stairs, and other surfaces from traffic, dirt, wear, damage, or movement

- of heavy objects, by protecting with durable sheet materials.
- F. Prohibit traffic or storage upon waterproofed or roofed surfaces. If traffic or activity is necessary, obtain recommendations for protection from waterproofing or roofing material manufacturer.
- G. Prohibit traffic from landscaped areas.
- H. Remove protective coverings when no longer needed; reuse or recycle plastic coverings if possible.

3.08 SYSTEM STARTUP

- A. Coordinate schedule for start-up of various equipment and systems.
- B. Notify Engineer and owner seven days prior to start-up of each item.
- C. Verify that each piece of equipment or system has been checked for proper lubrication, drive rotation, belt tension, control sequence, and for conditions that may cause damage.
- D. Verify tests, meter readings, and specified electrical characteristics agree with those required by the equipment or system manufacturer.
- E. Verify that wiring and support components for equipment are complete and tested.
- F. Execute start-up under supervision of applicable Contractor personnel and manufacturer's representative in accordance with manufacturers' instructions.
- G. Submit a written report that equipment or system has been properly installed and is functioning correctly.

3.09 DEMONSTRATION AND INSTRUCTION

- A. Demonstrate start-up, operation, control, adjustment, trouble-shooting, servicing, maintenance, and shutdown of each item of equipment at scheduled time, at equipment location.
- B. For equipment or systems requiring seasonal operation, perform demonstration for other season within six months.
- C. Provide a qualified person who is knowledgeable about the Project to perform demonstration and instruction of owner personnel.

3.10 ADJUSTING

A. Adjust operating products and equipment to ensure smooth and unhindered operation.

3.11 FINAL CLEANING

- A. Execute final cleaning prior to final project assessment.
- B. Use cleaning materials that are nonhazardous.
- C. Clean interior and exterior glass, surfaces exposed to view; remove temporary labels, stains and foreign substances, polish transparent and glossy surfaces, vacuum carpeted and soft surfaces.
- D. Clean equipment and fixtures to a sanitary condition with cleaning materials appropriate to the surface and material being cleaned.
- E. Clean filters of operating equipment.

- F. Clean debris from roofs, gutters, downspouts, and drainage systems.
- G. Clean site; sweep paved areas, rake clean landscaped surfaces.
- H. Remove waste, surplus materials, trash/rubbish, and construction facilities from the site; dispose of in legal manner; do not burn or bury.

3.12 CLOSEOUT PROCEDURES

- A. Make submittals that are required by governing or other authorities.
 - 1. Provide copies to Engineer, University of South Carolina, and Architect.
- B. Notify Engineer and Architect when work is considered ready for Substantial Completion.
- C. Submit written certification that Contract Documents have been reviewed, work has been inspected, and that work is complete in accordance with Contract Documents and ready for Engineer's review.
- D. Correct items of work listed in executed Certificates of Substantial Completion and comply with requirements for access to University of South Carolina-occupied areas.
- E. Notify Engineer when work is considered finally complete.
- F. Complete items of work determined by Engineer's final inspection.

SECTION 01 74 19

CONSTRUCTION WASTE MANAGEMENT AND DISPOSAL

PART 1 GENERAL

1.01 WASTE MANAGEMENT REQUIREMENTS

- A. Employ processes that ensure the generation of as little waste as possible due to error, poor planning, breakage, mishandling, contamination, or other factors.
- B. Minimize trash/waste disposal in landfills; reuse, salvage, or recycle as much waste as economically feasible.
- C. Methods of trash/waste disposal that are not acceptable are:
 - 1. Burning on the project site.
 - 2. Burying on the project site.
 - 3. Dumping or burying on other property, public or private.
 - 4. Other illegal dumping or burying.
- D. Regulatory Requirements: Contractor is responsible for knowing and complying with regulatory requirements, including but not limited to Federal, state and local requirements, pertaining to legal disposal of all construction and demolition waste materials.

1.02 DEFINITIONS

- A. Clean: Untreated and unpainted; not contaminated with oils, solvents, caulk, or the like.
- B. Construction and Demolition Waste: Solid wastes typically including building materials, packaging, trash, debris, and rubble resulting from construction, remodeling, repair and demolition operations.
- C. Hazardous: Exhibiting the characteristics of hazardous substances, i.e., ignitibility, corrosivity, toxicity or reactivity.
- D. Nonhazardous: Exhibiting none of the characteristics of hazardous substances, i.e., ignitibility, corrosivity, toxicity, or reactivity.
- E. Nontoxic: Neither immediately poisonous to humans nor poisonous after a long period of exposure.
- F. Recyclable: The ability of a product or material to be recovered at the end of its life cycle and remanufactured into a new product for reuse by others.
- G. Recycle: To remove a waste material from the project site to another site for remanufacture into a new product for reuse by others.
- H. Recycling: The process of sorting, cleansing, treating and reconstituting solid waste and other discarded materials for the purpose of using the altered form. Recycling does not include burning, incinerating, or thermally destroying waste.
- I. Return: To give back reusable items or unused products to vendors for credit.
- J. Reuse: To reuse a construction waste material in some manner on the project site.
- K. Salvage: To remove a waste material from the project site to another site for resale or reuse by others.
- L. Sediment: Soil and other debris that has been eroded and transported by storm or well

- production run-off water.
- M. Source Separation: The act of keeping different types of waste materials separate beginning from the first time they become waste.
- N. Toxic: Poisonous to humans either immediately or after a long period of exposure.
- O. Trash: Any product or material unable to be reused, returned, recycled, or salvaged.
- P. Waste: Extra material or material that has reached the end of its useful life in its intended use. Waste includes salvageable, returnable, recyclable, and reusable material.

- D. See Section 01 70 00 for trash/waste prevention procedures related to demolition, cutting and patching, installation, protection, and cleaning.

1.01 SECTION INCLUDES

1.02 SUBMITTALS

- A. Project Record Documents: Submit documents to Engineer and Architect with claim for final Application for Payment.
- B. Operation and Maintenance Data:
 - 1. Submit two copies of preliminary draft or proposed formats and outlines of contents before start of Work. Engineer will review draft and return one copy with comments.
 - 2. For equipment, or component parts of equipment put into service during construction and operated by University of South Carolina, submit completed documents within ten days after acceptance.
 - 3. Submit one copy of completed documents 15 days prior to final inspection. This copy will be reviewed and returned after final inspection, with Engineer comments. Revise content of all document sets as required prior to final submission.
 - 4. Submit two sets of revised final documents in final form within 10 days after final inspection.

C. Warranties and Bonds:

- 1. For equipment or component parts of equipment put into service during construction with University of South Carolina's permission, submit documents within 10 days after acceptance.
- 2. Make other submittals within 10 days after Date of Substantial Completion, prior to final Application for Payment.
- 3. For items of Work for which acceptance is delayed beyond Date of Substantial Completion, submit within 10 days after acceptance, listing the date of acceptance as the beginning of the warranty period.

PART 3 EXECUTION

3.01 PROJECT RECORD DOCUMENTS

- A. Maintain on site one set of the following record documents; record actual revisions to the Work:
 - 1. Drawings.
 - 2. Specifications.
 - 3. Addenda.
 - 4. Change Orders and other modifications to the Contract.
 - 5. Reviewed shop drawings, product data, and samples.
 - 6. Manufacturer's instruction for assembly, installation, and adjusting.

- B. Ensure entries are complete and accurate, enabling future reference by University of South Carolina.
- C. Store record documents separate from documents used for construction.
- D. Record information concurrent with construction progress.
- E. Specifications: Legibly mark and record at each product section description of actual products installed, including the following:
 - 1. Manufacturer's name and product model and number.
 - 2. Changes made by Addenda and modifications.
- F. Record Drawings and Shop Drawings: Legibly mark each item to record actual construction including:
 - 1. Measured locations of internal utilities and appurtenances concealed in construction, referenced to visible and accessible features of the Work.
 - 2. Field changes of dimension and detail.
 - 3. Details not on original Contract drawings.

3.02 OPERATION AND MAINTENANCE DATA

- A. For Each Product or System: List names, addresses and telephone numbers of Subcontractors and suppliers, including local source of supplies and replacement parts.
- B. Product Data: Mark each sheet to clearly identify specific products and component parts, and data applicable to installation. Delete inapplicable information.
- C. Drawings: Supplement product data to illustrate relations of component parts of equipment and systems, to show control and flow diagrams. Do not use Project Record Documents as maintenance drawings.
- D. Typed Text: As required to supplement product data. Provide logical sequence of instructions for each procedure, incorporating manufacturer's instructions.

3.03 OPERATION AND MAINTENANCE DATA FOR EQUIPMENT AND SYSTEMS

- A. For Each Item of Equipment and Each System:
 - 1. Description of unit or system, and component parts.
 - 2. Identify function, normal operating characteristics, and limiting conditions.
 - 3. Include performance curves, with engineering data and tests.
 - 4. Complete nomenclature and model number of replaceable parts.
- B. Panelboard Circuit Directories: Provide electrical service characteristics, controls, and communications; typed.
- C. Include color coded wiring diagrams as installed.
- D. Operating Procedures: Include start-up, break-in, and routine normal operating instructions and sequences. Include regulation, control, stopping, shut-down, and emergency instructions. Include summer, winter, and any special operating instructions.
- E. Maintenance Requirements: Include routine procedures and guide for preventative maintenance and trouble shooting; disassembly, repair, and reassembly instructions; and alignment, adjusting, balancing, and checking instructions.
- F. Provide servicing and lubrication schedule, and list of lubricants required.

- G. Include manufacturer's printed operation and maintenance instructions.
- H. Include sequence of operation by controls manufacturer.
- I. Provide original manufacturer's parts list, illustrations, assembly drawings, and diagrams required for maintenance.
- J. Provide control diagrams by controls manufacturer as installed.
- K. Provide Contractor's coordination drawings, with color coded piping diagrams as installed.
- Include test and balancing reports.
- M. Additional Requirements: As specified in individual product specification sections.

3.04 OPERATION AND MAINTENANCE MANUALS

- Prepare instructions and data by personnel experienced in maintenance and operation of described products.
- B. Prepare data in the form of an instructional manual.
- C. Binders: Commercial quality, 8-1/2 by 11 inch three D side ring binders with durable plastic covers; 2 inch maximum ring size. When multiple binders are used, correlate data into related consistent groupings.
- D. Cover: Identify each binder with typed or printed title OPERATION AND MAINTENANCE INSTRUCTIONS; identify title of Project; identify subject matter of contents.
- E. Provide tabbed dividers for each separate product and system, with typed description of product and major component parts of equipment.
- F. Arrange content by systems under section numbers and sequence of Table of Contents of this Project Manual.
- G. Contents: Prepare a Table of Contents for each volume, with each product or system description identified, in three parts as follows:
 - 1. Part 1: Directory, listing names, addresses, and telephone numbers of Architect, Contractor, Subcontractors, and major equipment suppliers.
 - 2. Part 2: Operation and maintenance instructions, arranged by system and subdivided by specification section. For each category, identify names, addresses, and telephone numbers of Subcontractors and suppliers. Identify the following:
 - a. Significant design criteria.
 - b. List of equipment.
 - c. Parts list for each component.
 - d. Operating instructions.
 - e. Maintenance instructions for equipment and systems.
 - 3. Part 3: Project documents and certificates, including the following:
 - a. Shop drawings and product data.
 - b. Air and water balance reports.
 - c. Certificates.
 - d. Photocopies of warranties and bonds.

H. Table of Contents: Provide title of Project; names, addresses, and telephone numbers of Engineers, Architect, Consultants, and Contractor with name of responsible parties; schedule of products and systems, indexed to content of the volume.

3.05 WARRANTIES AND BONDS

- A. Obtain warranties and bonds, executed in duplicate by responsible Subcontractors, suppliers, and manufacturers, within 10 days after completion of the applicable item of work. Except for items put into use with University of South Carolina's permission, leave date of beginning of time of warranty until the Date of Substantial completion is determined.
- B. Verify that documents are in proper form, contain full information, and are notarized.
- C. Co-execute submittals when required.
- D. Retain warranties and bonds until time specified for submittal.
- E. Include originals of each in operation and maintenance manuals, indexed separately on Table of Contents.

SECTION 23 00 00 - MECHANICAL, GENERAL

PART 1 - GENERAL

- 1.1 Drawings and general provisions of Contract, including General and Supplementary Conditions and Division 1 Specification Sections, apply to the work under Division 23 the same as if incorporated herein.
- 1.2 All materials and work shall comply with the 2012 International Mechanical (IMC), 2012 International Plumbing Code (IPC), 2012 International Building Code (IBC), 2012 International Energy Code (IECC), and the latest National Electric Code.

1.3 CONTRACT DOCUMENTS

- A. Drawings for work under Division 23 indicate generally the location, arrangement and intent of the systems to be installed. They are diagrammatic and indicate reasonable arrangements.
- B. It is not the intent of these documents to be used as installation drawings nor to include all related services or accessories to place systems in operation. They are not intended to be coordination documents for detail adaption to building construction, or for coordination with other trades. Installation of equipment shall be in strict accordance with the respective manufacturer's recommended instructions. Obtain certified drawings and installation instructions before starting work.
- C. After thorough examination of contract documents, bring to attention of Owner prior to bid time any discrepancies, errors or omissions in Division 23. If a conflict exists, the greater quantity or better quality, in the opinion of the Engineer, governs.
- D. It is the intent of these drawings and specifications to describe complete and working mechanical system(s) and to prescribe for the complete installation and testing of the equipment and devices specified under other sections of the specifications or on the drawings. Work under Division 23 includes all work necessary to make equipment and systems operational while following the details of the drawings and specifications as close as possible. When additional items are required to make systems operational, and are not specifically specified, then items shall be in accordance with the manufacturer's recommendations for the applicable conditions encountered.
- E. Drawings and specifications are complimentary; work called for in either shall be provided as if called for by both.

1.4 SITE VISIT

All bidders shall visit the site of work and become familiar with existing conditions before submitting a bid. Submission of a bid will be considered as evidence that the Contractor has

visited the site of work. No extra payments will be allowed the Contractor because of extra work made necessary by his/her failure to do so.

1.5 DEMOLITION ITEMS

The Owner reserves the right to keep any items called for to be removed in the construction documents. Items not kept by the Owner shall be carried away from the site of work. Coordinate with Owner on each item to be removed.

1.6 SEISMIC REQUIREMENTS

- A. All new materials in Division 23 shall comply with the 2012 International Building Code with the latest revisions for seismic requirements, see other sections in Division 23.
- B. The Seismic Design Category shall be C.
- C. Seismic systems as manufactured by Amber/Booth or Mason Industries will be accepted.
- D. Provide acceptance letter from the manufacturer's agent prior to project closeout indicating manufacturer review of installed seismic piping restraint systems throughout project.
- E. Provide approved safety restraining devices and products for water heaters. Attach products and devices to the adjoining structures in accordance with specific manufacturer installation instructions.
- F. <u>Shop Drawings</u>: Design of supports will require installation shop drawings furnished by the manufacturer which shall include installation methods, sizes and materials signed and sealed by a registered professional engineer in the State of South Carolina. Contractor shall furnish shop drawings for Engineer review at start of project.
- 1.7 Temperature and equipment control wiring are included under Division 23. All power sources, breakers, wiring, conduits, relays, contactors, and any power wiring required for the automatic temperature control system shall be provided by Division 23. All power wiring shall comply with the latest edition of the National Electric Code.
- 1.8 Motor starters shall be furnished under Division 23. Mounting and wiring of starters including wiring to equipment shall be provided by others. Disconnect switches when required shall be provided under Division 26. Combination starter/disconnect switches shall be furnished under Division 23. Provide all wiring, conduits, breakers, transformers, etc. required to power all control components requiring a power source.

PART 2 - PRODUCTS

2.1 SUBSTITUTIONS

- A. All requests for substitutions shall be submitted in writing so as to be received by the Engineer at least ten (10) calendar days prior to bid date and must be granted permission to quote before award of contract.
- B. Requests for substitution shall be submitted in the form of a letter (with one copy minimum) on letterhead of submitting firm. Letter to be addressed to the Engineer and referenced to this job.
- C. Permission to substitute items shall not be construed as authorizing any deviations from the contract documents, unless such deviations are clearly indicated in letter form. Contractor shall be responsible for verifying all dimensions with available space conditions (with provisions for proper access, maintenance, part replacement and for coordination of other trades) for proper services and construction requirements. Contractor to bear any additional costs for required changes in associated items which are directly or indirectly related to a substituted item.

2.2 MATERIAL AND EQUIPMENT SUBMITTALS

- A. The Engineer will review and take appropriate action on equipment submittals, product data, samples, and other submittals required by the Contract Documents. Such review shall be only for general compliance with the design and with the information given in the Contract Documents.
- B. Prior to submittal of equipment submittals to the Engineer, review and approve equipment submittals. Equipment submittals which have not been reviewed and approved in writing by the Contractor will not be reviewed by the Engineer.
- C. Submit for review by the Engineer detailed drawings of all equipment and all material listed in this section. All submittal data shall be bound in a hardback binder. Partial submittals will not be reviewed by the Engineer. Furnish six (6) copies of equipment submittals.
- D. Equipment submitted for review shall be detailed, dimensioned drawings or catalog pages showing construction, size, arrangement, operating clearances, performance characteristics and capacities.
- E. Review rendered on equipment submittals shall not be considered as a guarantee of measurements of building conditions. Where drawings are reviewed, said review does not mean that drawings have been checked in detail; said review does not in any way relieve the contractor from his responsibility or necessity of furnishing materials or performing work as required by the contract documents.
- F. Submit equipment submittals for the materials and equipment for review by the Engineer:
 - Pipe Insulation,

- Steam Boiler,
- Boiler Flue Economizer (Alternate No. 1),
- Water Softener (Alternate No. 2),
- Fuel Oil Pump,
- Automatic Temperature Controls.

2.3 ELECTRICAL CONNECTIONS

It shall be the sole responsibility of the Mechanical Subcontractor to verify and ensure equipment ordered for this project matches the voltage and phase per existing conditions. No extra payments will be allowed because of the contractor's failure to do so.

PART 3 - EXECUTION

- 3.1 Deliver to owner a complete, fully operational system. All items to be properly lubricated and operate to their full extent upon completion of the project.
- 3.2 Deliver to Owner any certificates, permits and licenses as required to comply with all City, County and State applicable laws, ordinances, codes, rules and regulations, including any certificates required by fire department. If any of these items are requested, such items shall be furnished prior to final inspection.
- 3.3 All work included in this contract shall be performed by skilled people under competent supervision employing the latest and best practices of the various trades involved. All materials and equipment hereinafter specified shall be new and free from flaws and defects of any nature. Work that is not of good quality will require removal and reinstallation.

3.4 COORDINATION

- A. No work shall be performed on this project before thoroughly coordinating all space requirements for equipment, sleeves, and pipes. Establish necessary tie-ins for each trade.
- B. Prior to starting installation, furnish to all trades concerned copies of reviewed material and equipment submittals, and location of equipment, sleeves, and pipes.
- C. The responsibility for obtaining, cutting and patching for work under Division 23 is included under this section of the specifications.
- D. Coordinate the exact size and location of all construction openings with the proper trades preparing the openings and be responsible for obtaining sizes as required. Supports for equipment shall be in accordance with the manufacturer's certified drawings.
- E. Temperature and equipment control wiring are included under Division 23.

- F. Contractor shall be responsible for the protection and cleanliness of equipment installed under Division 23.
- 3.5 Notify the Architect/Engineer at least three (3) days in advance prior to covering up or concealing any work under Division 23. Any work covered or concealed without consent or review of the Architect/Engineer shall be exposed for examination at the Contractor's expense.
- 3.6 Any costs of repairing any damages caused by this contractor, to the building, building contents, and/or site during construction and warranty period shall be included in Division 23.
- 3.7 Provide all cutting and patching necessary to install the work specified in Division 23. Provide all inserts, sleeves, supports and hanger rods. Lay out work in advance and establish locations of sleeves.

3.8 PROJECT CLOSEOUT

- A. All items shall be cleaned thoroughly inside and outside of all dust, dirt, or other foreign material.
- B. Notify the Owner in writing that he has complied with the above prior to final inspection.

3.9 OWNER INSTRUCTION

- A. Instruct the Owner's representative in complete detail as to proper operation of the overall system.
- B. Provide a hard back three-ring file folder containing all warranties, catalog data and the manufacturer's standard operating and maintenance instructions for each item of the controls system.

3.10 WARRANTY

- A. Warrant all work and materials specified under Division 23 for a period of one (I) year from the date of project acceptance. Upon failure of any part(s) of the system during the warranty period, the affected part(s) shall be repaired or replaced promptly by and at the expense of the Contractor.
- B. If any component fails during regular one year period, then the replacement part(s) shall be given an additional one (1) year warranty from the time of replacement. This shall continue until the item(s) have given one (1) year satisfactory service.

3.11 IDENTIFICATION

- A. Identify each piece of equipment and control component. Items shall be identified by name and numerical sequence. Nameplates shall be 1/16" thick plates with 1/2" high white letters on black background. Nameplates shall be attached securely with screws, not glued.
- B. Provide standard bronze identification tags equal to Seton Nameplate Company for each valve to identify type of service as applicable. Bronze tags shall be attached to the valve by the use of brass S-hooks. Tag identification shall be by service and each valve shall be numbered.

3.12 PAINTING

- A. Pipes in mechanical room shall be painted under Division 23. All pipes shall be color coded to match the USC color coding system. Color coding chart may obtained from the USC Project Manager.
- B. Provide color stenciling of piping for identification of flow.
- C. Provide two coats of black rust preventative on all exposed support metal and hangers mounted in mechanical room.
- D. Paint all new equipment and materials in Division 23 (except factory-painted equipment) exposed to view. Where factory paint has been scratched on new equipment, completely sand, prime and repaint scratched areas. Paint shall be as recommended by equipment manufacturer. Pipes shall be color coded with colors selected by the Engineer. Devoe, Sherwin Williams, Pittsburg, Glidden or approved equal paints may be used.

3.13 ASBESTOS

- A. At any time the Contractor encounters asbestos containing materials, he shall immediately stop work and suspend any further work until asbestos containing materials are removed by others. Contractor shall, upon discovery of asbestos containing materials, notify Owner or Owner's representative, who shall be responsible for the removal of the asbestos containing materials, all in accordance with NESHAP (National Emission Standard for Hazardous Air Pollutants.) Any form of asbestos removal or demolition shall be by Owner. Engineer is not an "Owner or Operator" as defined under NESHAP.
- B. Contractor is responsible for, and shall be aware of all state and federal laws pertaining to asbestos as well as NESHAP requirements.

3.14 LEAD PAINT

At any time the Contractor encounters existing paint containing lead, he shall immediately suspend any further work in the affected area until lead paint is removed by others. Contractor shall, upon discovery of lead paint, notify Owner or Owner's representative, who shall be responsible for the removal of the lead paint.

3.15 RECORD DRAWINGS

- A. Maintain on the job site one complete set of drawings for this project. All changes authorized by the Owner as to locations, sizes and routing of equipment, ductwork, piping and other material shall be indicated in red ink on the drawings as work progresses.
- B. Before Substantial Completion, Contractor shall obtain at his/her expense, a corrected set of drawings which he shall include the information outlined above. Drawings (including schedules, details, and sections) shall be corrected to depict all substituted materials and equipment. For this purpose the Owner will make available to the Contractor, the original drawings of the work, The final, annotated drawings shall be turned over to the Owner at the time of Substantial Completion.

SECTION 23 05 93 - TESTING AND BALANCING

PART 1 - GENERAL

- 1.1 Section 23 00 00 Mechanical, General applies to the work specified in this section of specifications.
- 1.2 Work under this section includes the testing, adjusting and balancing associated with the new boilers, and existing boiler feed pumps at the deaerator. The results of all tests, adjustments and balancing shall be submitted to the Engineer for approval.
- 1.3 Other sections of the specification are a part of this section. Refer to all other sections for a complete description of the work.

1.4 TESTING AND BALANCING AGENCY

- A. All work shall be performed by an independent Test and Balance Agency, certified by NEBB or AABC, who performs testing, adjusting and balancing of HVAC systems as its sole source of income. All work shall be under the direct supervision of a project manager who is qualified for testing and balancing the hydronic and air performance of heating, air conditioning, and ventilating systems.
- B. The Balancing Agency shall provide all labor, equipment, engineering and test equipment required to test, adjust and balance all heating, ventilating, exhaust and air conditioning systems as specified herein.

1.5 INSTRUMENTS

Instruments used shall be of high quality and as recommended by AABC or NEBB for the application. Instruments shall be properly calibrated and certified within the last six months.

1.6 The tests, balancing and adjusting shall be performed as many times as required to prove project requirements have been met. If requested by the Engineer, tests shall be performed in his presence.

1.7 ACCURACY

The balancing firm shall warrant, solely that the system will be set to within 10% of the values as established by the drawings and specifications and also adjust to minimize drafts in all areas.

1.8 CHANGES

Any changes that are required for the final balancing results as determined by the balancing firm shall be provided under this section of the specifications. Such changes shall include, but not limited to, changing of pulleys, belts, dampers or adding dampers or access panels.

PART 2 - PRODUCTS

2.1 SUBMITTALS:

- A. Prior to acceptance of the systems by the Owner, submit to the Engineer for his review, a written testing, adjusting and balancing report, in triplicate, contained in a hard-backed three ring notebook.
- B. All reports, forms and data sheets shall generally be the standards of AABC or NEBB.

PART 3 - EXECUTION

3.1 BALANCING PROCEDURE:

- A. Before starting water balance, check the following items:
 - 1. Cleanliness of system water
 - 2. Cleanliness of all system strainers
 - 3. Manual air vents
 - 4. Pump and motor lubrication
 - 5. Motor overload protectors or heaters for proper size
 - 6. Proper pump rotation
- B. Measure pump capacities by venturi, orifices or flow meters if installed or by differential pressure measurements, amperage and brake horsepower method using pump manufacturer's capacity curve. Position all automatic valves, hand valves and circuit setters for full flow through coils, tube bundles, etc. during pump adjustment. Use only calibrated test gauges for pump adjustment; the use of pressure gages installed within the system will not be permitted.
- C. Coordinate the setting of controls to maintain coil water inlet design temperatures, with coil valves positioned for full flow through coil during adjustment. Balance individual water coils at full flow to maintain temperature differential specified.
- D. Lock in setpoint on circuit setters correctly.

3.2 ADJUSTING AND BALANCING

Existing Boiler Feed Pumps: The deaearator side of the dual tank system has (3) pumps;
 pumps provide 33% of the total flow each, and the 4th pump is a standby capable of 33% of the total flow. All pumps have VFDs and are piped to bypass water back to the

tanks they draw out of should the pump flow requirements drop below the minimum speed of the VFD. Adjust, balance, record and submit as previously specified, for each of the following:

- a. Final Water Flow rate, GPM (95 GPM plus 15% plus the pump minimum by-pass flow)
- b. Wide Open Water Pressure Differential, PSIG (135 PSIG)
- c. No Flow Water Pressure Differential, Ft. of Water
- d. Pump Off Pressure, Ft. of Water
- e. Motor Amperage and Voltage

SECTION 23 07 00 - MECHANICAL INSULATION

PART 1 - GENERAL

1.1 Section 23 00 00 Mechanical, General applies to the work specified in this section of specifications.

1.2 INSULATION

All insulation material shall have a fire hazard classification not to exceed flame spread of 25 and smoke developed rating of 50, as listed by Underwriters Laboratories and acceptable under NFPA standards. This is to apply to the complete system and to the composite insulation with jacket or facings, vapor barrier, joint sealing tapes, mastic and fittings.

PART 2 - PRODUCT

2.1 PIPE INSULATION

A. Rigid pipe insulation shall be Foamglass pipe covering with the following minimum properties:

Absorption of moisture: <1% per ASTM C209
Water vapor permeability: 0.005 per ASTM E96
Compressive strength: 25 psi per ASTM C165

Density: 2.0 lbs/cf per ASTM D1622

Dimensional stability: 0.8% change

Flexural strength: 64 psi per ASTM C203

Thermal conductivity: 0.29 btu-in/hr-sf-°F @ 75°F per ASTM C177

- B. Pipe insulation sealer shall be Foster 60-25 or equal.
- C. See Section 23 00 00 Mechanical, General for pipe markers.

PART 3 - EXECUTION

3.1 INSULATION FIRM

All insulation work shall be performed by a franchised insulation firm. All insulation shall be installed in a workmanlike manner by qualified workers in the regular employ of the insulation firm.

3.2 PIPE INSULATION

A. New steam pipes shall be insulated with 3" thick rigid pipe insulation. New condensate pipes shall be insulated with 2" thick rigid pipe insulation. All seams shall be sealed with pipe insulation sealer. A light coat of sealer shall be applied over the entire surface of the

insulation and embedded with Fab-Cloth in the sealer. This application shall be applied twice over the insulation. Surface to be smooth when complete. All elbows shall be mitered.

- B. All pipe and equipment insulation in Mechanical Rooms shall be insulated as specified in previous paragraphs. Insulation shall be covered with a U.L labeled, 8 ounce cotton canvas and two coats of Childers CP-52 lagging adhesive.
- C. See Identification Section of these specifications.

SECTION 23 21 13 - MECHANICAL PIPING

PART 1 - GENERAL

- 1.1 Section 23 00 00 Mechanical, General applies to the work specified in this section of specifications.
- 1.2 Pipe locations shown are approximate. Exact location of pipes to be as determined in field to avoid other pipes and maintain access clearances. All existing pipe sizes noted on the drawings shall be field verified before connection.
- 1.3 Piping to comply with best trade practice. Provide clearance between pipe and building structure so pipes can expand without damage to building/manhole structure.
- 1.4 Welding shall be done only by qualified welders certified by a recognized and approved local testing laboratory. Welding qualifications shall be in accordance with ANSI Standard Code for Pressure Piping. Welders shall have qualified within the past eighteen (18) months.

PART 2 - PRODUCTS

2.1 PIPE

- A. Steam and condensate pipe shall be schedule 80 black steel (ASTM A53 Gr. B, ERW) with butt weld joints.
- B. Fittings shall be ASTM A234, Gr. WPB, butt weld, ERW.
- C. Flanges shall be ASTM A105, Class 150, R.F., W.N.
- D. Gaskets shall be ring type, 1/16" thick, compressed non-asbestos, Garlock Style 3000 or approved equal. Provide flex-a-talic metal gaskets at all steam piping flanges.
- E. Stud bolts shall be ASTM A193, Gr. B7 with heavy hex nuts, ASTM A194, Gr. 2H.
- F. Cold water and make-up water from water softener shall be type L copper with soldered joints.
- 2.2 Gate valves (for steam piping and condensate piping 2-1/2" and larger) shall be Class 300, R.F., flanged, cast steel body, bolted bonnet, flexible wedge disc., SS trim. Install valves in horizontal piping with stems above the horizontal. Valves shall be manufactured by Velan or approved equal.
- 2.3. Ball valves (for condensate piping 2" and smaller) shall be two piece Class 150 designed for a minimum of 150 psi steam working pressure, 600 PSI non-shock cold water with large port, threaded type, chrome plated ball, and blow-out proof stem. The manufacturer name and the working pressure to be cast on valve body.

2.4 Check valves shall be Class 150, wafer type, swing check valve, cast steel body and disc, SS trim, metal to metal seat, NAF Fig. 526440 or approved equal.

2.5 Pressure Gauges

- A. Pressure gauges shall be 4-1/2" dial, liquid filled, flangeless stainless steel case with glass window and bronze bourdon tube. All gauges shall be high quality liquid filled type, graduated in psig with an accuracy of 1% at mid-scale and 1-1/2% over the balance. All gauges shall be provided with a needle valve and pressure snubber.
- B. Gauge ranges shall be selected so the normal working pressure will be at mid-scale. Gauges shall be located where shown on drawings.
- C. Gauges shall be as manufactured by Trerice, Weksler, Wheatley or approved equal.

2.6 Pipe Hangers

A. Pipe hangers to be the product of one of the following manufacturers shown and of model number indicated in the following table:

- B. Provide oversized pipe hangers over insulated piping. Install 18 gauge galvanized, shield between hanger and insulation. Ten inch long shield to extend 180° around the bottom of the insulated pipe.
- C. Hangers in mechanical rooms shall be cadium plated.
- D. Location and method of support subject to Engineer's approval. Threaded rods and supplementary steel to span structural supports to accommodate hangers is included in Division 15.

2.9 Pipe Sleeves

- A. Where pipes pass through masonry construction, install sleeves sized to allow 1/2" clearance entirely around the passing pipe and insulation. Provide sealing compound in 1/2" clearance. Install sleeves in a waterproof manner.
- B. Sleeves shall be made of schedule 40 steel pipe.

C. Where sleeves are cut into existing masonry walls or floors, grout new sleeve into opening in existing wall or floor.

PART 3 - EXECUTION

- 3.1 Run pipes parallel to walls and floors, using a few fittings consistent with required flexibility. Pipe penetrations shall be perpendicular to walls. Wherever pipes change size, use eccentric fittings.
- 3.2 Ream pipes after cutting. Apply a lubricating non-hardening pipe dope compound to male threads only. Clean insides of pipes before installation.
- 3.3 Provide a union or a flange in ferrous pipes at each piece of equipment, valve, etc. and as required for service and maintenance. Provide dielectric unions where pipes of dissimilar metals connect.
- 3.4 Support pipes 2" size and under by hangers not over 8 feet apart. Support pipes over 2" size by hangers not more than 12 feet apart. Support vertical pipes by clamps not over 6 feet apart.

3.5 Piping Tests

- A. All piping installed shall be hydraulically tested as specified herein. Contractor shall provide all equipment required to make the tests specified herein.
- B. Piping may be tested a section at a time in order to facilitate the construction.
- C. Contractor shall fill the section of pipe to be tested with water and bring the section up to pressure with a test pump. These tests shall be conducted before any insulation is installed and any insulation installed prior to these tests shall be removed. Gauges used in the tests shall have been recently calibrated with a dead weight tester.
- D. All tests shall apply full test pressure to the piping for a minimum of 24 hours.
- E. All tests shall be conducted at 150 pounds per square inch.
- F. When the test pressure has fallen over 5% during the 24 hour test period, the point of leakage shall be found, repaired and the test repeated. This procedure shall be followed until the piping system has met requirements above.

3.6 Chemical Cleaning Of Pipes

- A. The Contractor shall furnish all labor and chemicals for the cleaning of pipes.
- B. Contractor shall chemically clean all steam and condensate return piping systems to remove dirt, oil, grease, and other foreign contaminants. After cleaning, drain and flush

all systems.

3.7 SEISMIC RESTRAINT OF PIPING

- A. Seismically restrain all piping with cable restraints as listed below:
 - 1. Restrain all piping located in boiler rooms and mechanical rooms l-1/4 inches nominal diameter and larger.
 - 2. Restrain all pipes 2-1/2 inches nominal diameter and larger.
 - B. Piping suspended by individual hangers 12 inches or less in length, as measured from the top of the pipe to the bottom of the support where the hanger is attached, need not be restrained.
 - C. Transverse restraint shall be at 40 feet maximum except where a lesser spacing is required to limit pipe stress.
 - D. Longitudinal restraints shall be at 80 feet maximum. In pipes where thermal expansion is a consideration, an anchor point may be used as the specified longitudinal restraint provided that it has a capacity equal to or greater than a longitudinal restraint. The longitudinal restraints and connections must be capable of resisting the additional force induced by expansion and contraction.
 - E. Transverse restraints for one pipe section may also act as longitudinal restraints for a pipe section of the same size connected perpendicular to it if the restraint is installed within 24 inches of the elbow or tee.
 - F. Branch lines my not be used to restrain main lines.
 - G. Cast iron pipe of all types, glass pipe and any other pipe joined with a shield and clamp assembly, where the top of the pipe is 12 inches or more from the supporting structure, shall be restrained on each side of a change in direction of 90° or more.

SECTION 23 51 23 - BOILER STACK

PART 1 - GENERAL

- 1.1 Section 23 00 00 Mechanical, General applies to the work specified in this section of specifications.
- 1.2 The stack shall be in accordance with the drawings along with existing conditions. Final stack design shall be the responsibility of the stack vendor. The stack vendor shall coordinate with the boiler manufacturer to ensure that burner back pressure remains within +/- 0.25" W.C., at all firing rates. Stack diameter, layout, and selected components are critical factors. The stack manufacturer's representative and the boiler manufacturer's representative shall coordinate closely.
- 1.3 The double-wall stack shall be UL-labeled and qualified per NFPA-211, for steam boiler applications. The assembled stack system shall be rated air-tight at internal pressures up to 72"W.C. at room temperature. Stack materials shall be rated for 1400°F continuous service and 1800°F intermittent service. Single-wall or Type-B vents shall not be allowed.
- 1.4 The stack system shall be warranted for a minimum of 15 years, when installed in accordance with the provided manufacturer's instructions.
- 1.5 The stack manufacturer shall be Selkirk/Metalbestos, Metal-Fab, CB-Stacks or approved equal.

PART 2 - PRODUCTS

- 2.1 Provide a double-wall sectional stack, for the boiler. The stack shall have a Type 304 stainless steel inner wall and an aluminized steel outer wall, with a 1" air gap between the walls. As a basis of design, the stack shall have a 24" I.D. and a 26" O.D. Single-wall or Type-B vents will not be allowed.
- 2.2 The stack and stack offset shall include the following components:
 - Boiler attachment flange/assembly
 - Internal drain section, with 1" drain nipple
 - Straight stack sections
 - 45° elbow, for inlet of offset
 - 45-degree tee with 1" drain nipple, for outlet of offset
 - Expansion joints as required for the offset segment
 - Adjustable-length sections as required
 - Flanged guide rings (as needed for lateral support below the roof)
 - Roof penetration thimble, with flashing and storm collar (for proper clearance to combustibles)
 - Open termination assembly
 - Attachment flanges and collar for roof guying

- High temperature sealant, for sealing of joints
- Containment bands for inner and outer walls, with captive screws for ease of assembly

PART 3 - EXECUTION

- 3.1 The stack equipment shall be quoted FOB jobsite, freight allowed to Columbia, SC.
- 3.2 Provide boiler stack as shown on the drawings, originating at flue connection to boiler and terminating 20'-0" above existing roof. Provide guy wires at mid length and at 12" below top of stack attached to roof.
- 3.3 Provide all accessories required for complete installation in accordance with NFPA Standards.

SECTION 23 52 39 - STEAM BOILER

PART 1 - GENERAL

- 1.1 Section 23 00 00 Mechanical, General applies to the work specified in this section of specifications.
- 1.2 The firetube boiler shall have a rated steam capacity of 27,600 lb/hr from and at 212 degrees F, or 800 HP. The boiler shall fire natural gas at 1000 Btu/CuFt or No. 2 fuel oil. The ASME Section I design pressure shall be 150 psig. The operating steam pressure shall be 100 psig.
- 1.3 The boiler shall be a 4-pass horizontal scotch marine dry-back firetube design. It shall be mounted on a heavy steel base frame, with an integrally mounted forced draft burner and controls.
- 1.4 The boiler manufacturers shall be:
 - A. Cleaver-Brooks 4-Pass Scotch Marine Firetube
 - B. Johnston 4-Pass Scotch Marine Firetube
 - C. Superior 4-Pass Scotch Marine Firetube
- 1.5 The complete packaged boiler with burner and 30 ppm low NOx system be approved as a package by Underwriters Laboratories, bearing the UL Assembly label.
- 1.6 The boiler shall be completely preassembled and fire tested at the factory. The unit shall be ready for immediate mounting on the floor or foundation, and ready for attachment of feedwater, steam, fuels, electrical, vent, and blowdown piping.
- 1.7 FUEL OIL PUMP: The system is provided as a complete mechanical assembly with factory mounted pumps, motors, valves, and accessories piped and ready for use. Unit will be hydrostatically tested and fluorescent leak inspected at the factory. The system includes a motor control panel mounted and wired as specified below.

PART 2 - PRODUCTS

- 2.1 The boiler shall be constructed in accordance with ASME Code Section I, and shall receive authorized ASME testing and inspections prior to shipment. A copy of the ASME Data Report shall be furnished to the Owner.
- 2.2 At least two (2) lifting eyes shall be welded to the boiler, to facilitate rigging the unit into place. Front and rear doors shall be hinged, davited, or otherwise mechanically supported by the boiler itself, to simplify door opening.
- 2.3 Full access shall be available to all front and rear tubesheets, for inspection, cleaning, and tube repair/replacement, without requiring OSHA Confined Space Entry Permitting.

- 2.4 The boiler tubes shall not include turbulators, swirlers or other add-ons.
- 2.5 The boiler shall be furnished with multiple handholes and one (1) manhole, to facilitate boiler inspection and cleaning.
- 2.6 O2 Probe and installed in stack and temp in boiler outlet.
- 2.7 Observation ports for inspection of flame conditions shall be provided at the front and rear ends of the boiler.
- 2.8 Boiler shell insulation shall consist of 2" thick high-temperature blanket, beneath a preformed steel lagging.
- 2.9 The boiler, base rails, and other components shall be factory-painted before shipment using a high-temperature primer and a hard finish enamel coating.

2.11 BOILER TRIM:

- A. Safety valves of the type and size required by the ASME Code shall be provided and mounted at the boiler's top center-line. They shall have a set pressure of 150 psig.
- B. An 5" main steam pressure gauge shall be located at the front of the boiler. It shall include a siphon, an isolation cock, and a test connection.
- C. Steam pressure controls to regulate burner firing rate and cycling shall be provided. (Refer to the Boiler Management System section below, for further details). Additionally, a separate high pressure limit switch with manual reset shall be provided.
- D. WATER COLUMN/LOW WATER CUTOFF AND WATER LEVEL CONTROL SYSTEM: Shall be a CB LEVEL MASTER Water level control system and shall be comprised of a microprocessor-based electronic controller, a non-contact, non-wearing, continuously reading absolute level sensor and pressure chamber. The control system shall be designed as follows: The electronic controller shall be mounted in the common control panel and operate in ambient temperatures from 32 degrees F to 125 degrees F. The pressure chamber shall be boiler mounted and operate to pressures of 250 PSIG and the level sensor shall operate to pressures of 250 PSIG and temperatures to 400 degrees F. The pressure-containing components shall be constructed in accordance with ASME Code. A shielded, four conductor cable with ground shall be run in metal conduit between the level sensor and the controller. Supply power shall be 115VAC-1 phase- 60 Hz. All wiring shall be in compliance with the National Electrical Code.
- E. The pressure chamber shall have a sight glass mounted on the side. The level sensor shall have an accuracy of .01" or greater. The electronic controller shall have level and error indicating lights, alphanumeric display for messaging, reset/ menu switch and the following features:
 - a. Continuous Level Indication

- b. Low Water Cutoff & Alarm
- c. High Water Alarm
- d. Low & High Water Warning
- e. Full Modulating Control of Modulating Feedwater Control Valve
- f. Continuous Monitoring of Float Operation
- g. Column Blowdown Detection and Reminder
- h. Auto or Manual Reset
- i. Real Time Clock
- j. Alarm Annunciation
- k. Alarm History Files with Time Stamp
- I. Water Column Blowdown Record
- m. Auxiliary Low Water Cutoff Check
- n. RS 232 Interface
- o. Maximum Contacts Rating 15 amps Resistive Load
- F. A separate externally-piped auxiliary low water cutoff shall also be provided, to prevent burner operation if the primary low water cutoff fails to perform during a low water occurrence. This secondary cutoff shall also have a manual reset.
- G. To limit the need for automatic shutdowns, the boiler shall be equipped with high and low water alarms. These controls shall provide visible and audible alarms prior to burner shutdown, thus allowing for immediate corrective action by the operator.
- H. For local verification of water level, the boiler shall be furnished with a gauge glass set. This assembly shall include ball-check isolation cocks, for immediate containment of steam and hot water if a glass insert fails during boiler operation.
- I. The boiler modulating feedwater control valve shall be included to automatically maintain the boiler water level within normal limits.

2.12 ADDITIONAL BOILER TRIM:

The boiler manufacturer shall include the following:

- 8" ANSI 300# flanged steam outlet, at boiler top center-line
- 8"x6"x48" welded spool piece for steam outlet, 300# flanged, 48" spool length, stamped per ANSI Power Piping Code B31.1, with appropriate documentation furnished to the Owner
- 6" flanged main steam stop valve, per ANSI Power Piping Code B31.1
- 6" flanged main steam stop-check (non-return) valve, angle-type, per ANSI Power Piping Code B31.1
- Steam free-blow drain valve, per ANSI Power Piping Code B31.1
- Bottom blowdown valves, two quick-opening and one slow-opening, factory-piped per ANSI Power Piping Code B31.1, with appropriate documentation furnished to the Owner
- Surface blowdown skimmer tube, factory installed within boiler shell
- Automatic surface blowdown system: This system shall include a ship-loose electronic

TDS controller. It shall also include factory-piped surface blowdown isolation valves and trim (3/4" minimum size), to consist of an isolation valve, a conductivity probe, a motorized control valve, and a needle-type flow control valve with percent-open scale (not an orifice union). All items shall be factory-piped per ANSI Power Piping Code B31.1, with appropriate documentation furnished to the Owner.

• Alarm bell with silencing switch in boiler control panel

The factory shall furnish a platform with treads for the boiler, with handrails and chain guard. The platform shall be mounted directly above the boiler. An OSHA approved steel ladder shall also be provided. The equipment may be shipped loose if needed for shipping clearances. However, the boiler factory shall weld mounting brackets to the pressure vessel, welded in accordance with the ASME Code.

- 2.13 EMISSION CONTROLS: The boiler shall be equipped with low NOx equipment and controls for guaranteed NOx reduction to 30 ppm, dry volume basis and corrected to 3% O2 when firing natural gas. "Standard NOx" burners with no FGR equipment shall not be utilized. NOx reduction shall be via flue gas recirculation (FGR). FGR ducting, if required, shall be factory-installed and insulated by the boiler manufacturer. If an external fan is required for forced FGR, it shall be factory-mounted, piped, and wired. The low NOx system shall be capable of being retrofitted for 20 ppm NOx performance, without requiring burner change-out or additional ducting.
- 2.14 FORCED DRAFT BURNER: The forced draft burner shall be a combination low pressure air atomizing type for No. 2 oil firing and high radiant multi-port type for natural gas firing.
- 2.15 BURNER TURNDOWN: The desired turndown range is 10:1 for natural gas and 8:1 for No. 2 oil. The boiler manufacturer shall furnish manufacturer-guaranteed and published burner turndown ranges for both fuels with the submittal data.
- 2.16 COMBUSTION AIR shall be supplied by a forced draft dan mounted at the front head of the boiler. Desired maximum sound level for the boiler/burner/low NOx package is 88 dbA, measured in accordance with ABMA Sound Test Standards. The bidder shall furnish the manufacturer's published maximum sound levels for both fuels with the bid.
- 2.18 THE COMBUSTION AIR FAN MOTOR shall be TEFC high efficiency, with a 1.15 SF, and NEMA Class F motor insulation. It shall also be inverter duty.

2.19 FUEL PIPING AND CONTROLS:

- A The gas pilot shall be of the premix interruptible type with automatic electric ignition. An electronic flame scanner shall monitor the pilot so that the primary fuel valve cannot open until the pilot flame has been established. The factory-piped pilot gas train shall include manual shut-off valves, a solenoid valve, a pressure regulator, and a pressure gauge.
- B. The main gas train shall be factory-piped per IRI and Factory Mutual requirements. It shall include a primary motorized shutoff valve with proof of closure and a leakage test

connection. A secondary motorized shutoff valve with proof of closure and leakage test connection shall also be provided (both valves to be factory-piped in series). A solenoid vent valve shall be located between the primary and secondary motorized shutoff valves. If a safety shutdown condition occurs, the two motorized gas valves shall automatically close, and the solenoid vent valve shall simultaneously open. These automated measures shall effectively isolate the fuel from the burner. In addition to automatic shutoff valves, the main gas train shall include two manual shutoff valves. High and low gas pressure switches shall also be provided, to shut down the burner if a gas pressure fluctuation occurs.

- C. No. 2 oil supply and return trains shall be factory-piped per IRI and Factory Mutual requirements. This piping shall include oil pressure regulating devices, oil metering controls, two motorized automatic shutoff valves with proof of closure, pressure gauges, relief valve, and inlet strainer, all factory-located adjacent to the burner. The oil supply train shall preferably be equipped with a single tip retractable oil gun with flex hoses, facilitating quick gun removal without shutting down the boiler and/or disturbing the burner. The manufacturer shall provide oil gun assembly details with the submittal data.
- D. No. 2 oil shall be atomized via a factory-mounted atomizing air compressor, with integral filtration and lube oil equipment. The compressor motor shall be TEFC high efficiency, with a 1.15 SF and Class F insulation. The compressor system shall be wired and piped to the burner by the factory. This system shall include a low atomizing air pressure switch.

2.20 BOILER CONTROLS AND CONTROL PANEL

- A. Control/Entrance Panel A common enclosure shall house the control panel and the entrance panel. Enclosure shall be NEMA 4/12 rated and shall be mounted at the side of the boiler in a location convenient to the operator. Enclosure shall consist of upper and lower sections divided by a partition with a separate hinged door for each section. Upper section (low voltage) will house boiler controls including flame safeguard and water level system controller. Lower panel section (high voltage) will house entrance panel.
- B. Cleaver Brooks Combustion Control System Hawk 4000 with parallel positioning with separate actuators for each fuel and combustion air shall be used to provide proper fuel air ratio control.
- C. CB780E Flame Safeguard Each boiler shall be factory equipped with flame safeguard controller incorporated into the Hawk control.
 - Oil, heat and moisture resistant wire shall be used and identified with circuit numbers corresponding to the electrical wiring diagram.

Boiler to be supplied with a control circuit transformer and fuse protection for the control circuit.

D. Boiler Controls:

1. Major Components:

- a. 10" color touch screen monitor mounted no more than 66" above floor
- b. Modbus, BACNET, or LON based network for communication with the various boiler components and existing Building Automation System (BAS)
- c. Burner Management Controller
- d. Infrared Flame Scanner
- e. Flame amplifier
- f. Various temperature and pressure sensors
- g. Alarm Bell
- h. Entire control system shall be capable of operating in up to 85% non-condensing relative humidity
- i. Economizer operation including soot blow

2. Major functions:

- a. Automatic sequencing of boiler through standby, pre-purge, pilot flame establishment, main flame establishment, and pre- and post purge cycles
- b. Flame proof and lockout on flame failure during pilot proving, main flame proving and running mode
- c. Low fire damper/valve positioning for flame ignition trials
- d. Parallel positioning combustion control for air and 2 different fuels
- e. Sensing and controls for parallel positioning full modulation and actuation of all low and high limit alarms and shutdowns
- f. Manual control of boiler firing rate
- g. Interface for commissioning boiler set points and configuring alarms
- h. On screen display of alarms and faults
- i. On screen display of water level and alarm
- j. Interface with existing Siemens Building Automation System (BAS)
- k. Sense and display stack gas temperature out of economizer to:
 - (1) shut down boiler on excess temperature
 - (2) maintain minimum stack gas temperature out of economizer by modulating economizer bypass damper
- I. Display boiler feedwater temperature to boiler
- m. Display boiler feedwater temperature in and out of economizer
- n. Provide automatic lead/lag control for 2 boilers
- o. Provide assured low fire cut-off for remote start/stop
- p. Maintain lag boiler in warm standby
- q. Manually silence alarms
- r. Store historical alarm information for previous 100 alarms including date, time and cycle of occurrence, and date and time of acknowledgment
- s. Indicate failures at start-up or during operation
- t. Self-checking/self-diagnosing of controller internal faults
- u. Primary and secondary low water shutdown and alarm

- v. Economizer damper control to maintain minimum stack gas temperature out of economizer (temperature adjustable)
- 3. Other Attributes
 - a. 4 spare 4-20ma inputs for future flow meters
- 4. Controls shall be Cleaver-Brooks Hawk 4000
- 5. Lead lag Master Panel with either Lead/Lag or Unison Modulation
 - Master panel shall include HMI for display and selection of the following parameters:
 - b. Display
 - 1. Available boilers
 - 2. Number of boilers required
 - 3. Selected sequence of firing
 - 4. Control output to each boiler
 - 5. Header steam pressure
 - 6. Setpoint
 - 7. Elapsed time from last rotation
 - c. Selection
 - 1. Number of boilers
 - 2. Sequence of firing
 - 3. Automatic or manual rotation
 - 4. Individual boiler start and stop points with timers
 - 5. Setpoint
 - 6. PI&D for control algorithm

2.21 FLUE GAS HEAT RECOVERY (Alternate No. 1)

A. Furnish and install an exhaust gas economizer in the vertical exhaust duct of the boiler as supplied and selected by the boiler manufacturer . The economizer shall be a light weight design for easier installation, rectangular, and manufactured and tested in accordance with the requirements of Section VIII, Division I of the ASME Boiler and Pressure Vessel Code. The economizer shall be designed to include as standard, an internal, high temperature heat resistant design flue gas bypass diverter to provide emergency by-pass, requiring no additional ductwork for controlling stack corrosion, turndown performance, or excessive flue gas back pressure due to fouling. The economizer shall have a hinged, full face, gas tight, inspection door, providing access to the heating surface for inspection and/or cleaning. The economizer must be completely drainable when mounted in the vertical position or horizontal position. Header manifolds for low liquid flow pressure drop shall be provided. The liquid header manifolds shall also contain 3/4" NPT connections for venting, draining, and/or safety relief valves as required. 2" thick 1000 degree F thermofiber factory installed, high temperature insulation shall cover the shell less the header. Exterior surfaces shall be 10ga. carbon steel and shall be primed and painted with a high temperature metallic. Furnish with bimetal, 3" adjustable dial, water temperature thermometers with wells, 150-750 degree F bi-metallic

flue gas temperature thermometers, 5" dial, and 300 psig safety relief valve.

B. Boiler and economizer to be designed with integral supports welded to the boiler shell allowing for easy economizer installation on boiler eliminating the requirement for separate structure steel support.

2.22 FUEL-TO-STEAM EFFICIENCY GUARANTEE:

- A. Guaranteed boiler fuel-to-steam efficiencies shall be furnished with the bid, for evaluation by the Engineer and the Owner. Guaranteed efficiency data shall be furnished at firing rates of 25%, 50%, 75%, and 100%. The efficiencies shall consider stack losses as well as radiant losses. Efficiencies and rated boiler capacity shall be guaranteed while the boiler is operating at the specified low NOx level. There shall be no reduction in burner turndown performance.
- B. Manufacturer shall furnish the boiler manufacturer's published monetary efficiency guarantee with the submittal data.
- C. Guaranteed fuel-to-steam efficiencies shall be 83% at 25% through 100% firing (when firing natural gas).
- 2.23 FACTORY TESTS: The boiler and its factory-installed ASME Power Piping shall receive factory tests to certify ASME construction, and fire testing to check controls and operation of the unit. All factory tests may be witnessed by the Owner/Purchaser if desired.
- 2.24 FUEL OIL PUMP: (Field installed by contractor, refer to drawings)
 - A. Viking Pump, Inc. Model: HL4124B or equal by Webster, Critical Fuel Systems, or approved equal.
 - B. ODP motor.
 - C. Enclosed OSHA approved guard.
 - D. Permanent alignment brackets with flexible coulplings.
 - E. Simplex inlet basket strainer, 1/16" perforated baskets, with DP switch/indicator. Inlet/Outlet full port valves.
 - F. Flexible hose connections for suction and discharge. Discharge flow and pressure switches.
 - G. External relief valves.
 - H. Check valve.

- I. All equipment factory assembled and mounted on formed steel base with drip pan.
- J. Motor control panel in Nema #4 enclosure complete with magnetic across the line starters, running lights, HOA switches, fused disconnect switches with external operator, fuse blocks, control circuit transformer (if required).
- K. Single point alarm system with light and horn.
- L. Panel to be mounted on wall adjacent to pump or on pump set base and wired to motors and accessories.

PART 3 - EXECUTION

3.1 START-UP AND FIELD SERVICE:

- A. The manufacturer or its authorized sales and service representative shall provide start-up and combustion set-up of the boiler and low NOx system. Start-up service shall include field set-up of the boiler management PLC and its periphery devices. A factory-authorized start-up report shall be furnished to the Owner.
- B. Boiler system start-up shall include field set-up and adjustment of the boiler management PLC and its periphery devices.
- C. Boiler system start-up shall be included in the boiler price. Limited number of days or per-diem shall not be acceptable.
- D. Two (2) full days of factory-authorized operator training shall be provided, and shall be separate from start-up. Training shall be hands-on, in the boiler room. The training date shall be scheduled in advance with the Owner.
- E. Boilout chemicals and labor shall be by the Contractor. However, the boiler manufacturer's representative shall provide boilout supervision and assistance in flushing the boiler after boilout.
- 3.2 The factory-authorized service company shall have an established service and parts shop within 50 miles of the jobsite, for fast response to service and emergency needs. The manufacturer's representative shall furnish location and contact information for the nearest authorized service and parts shop.
- 3.3 Contractor is responsible for the installation of all parts, pieces, controls and piping shipped loose with the boiler.
- 3.4 FOB AND FREIGHT: The boiler manufacturer shall include FOB jobsite, dedicated freight allowed to Columbia, SC. Insurance covering damage during shipment shall be the responsibility of the boiler manufacturer.

- 3.5 Pipe all vents from fuel regulators or any other fuel related equipment associated with the boiler to outdoors as directed by the 2012 International Fuel Gas Code and the manufacturer's installation instructions. Vent piping shall be schedule 40 black steel.
- 3.6 Contractor shall mount modulating feedwater valve to the boiler. This piping shall include a three-valve bypass, as well as the ASME-required feed globe and check valves. The feed check valve shall be of the in-line spring-check type. Swing-check valves shall not be utilized.
- 3.7 A main gas pressure regulator shall be provided to reduce 15 psig supply gas pressure to that required by the burner. The regulator shall be Fisher model 1098-EGR or approved equal.
- 3.8 Install boiler, piping, fuel train, gas vent, etc. in strict accordance with manufacturer's written installation instructions.
- 3.9 Provide all sensors, contactors, relays, transformers, wiring, conduit, and any other control component required for boiler controller per the manufacturer's written installation instructions and wiring diagrams.
- 3.10 Bolt new boiler supports to new concrete pad (see detail on drawings) per the seismic requirements of the 2012 International Building Code.
- 3.11 Mount, install, and pipe fuel oil set in accordance with manufacturer's printed installation instructions. Mount unit in compliance with the seismic requirements of the 2012 International Building Code.

SECTION 25 55 00 - AUTOMATIC TEMPERATURE CONTROLS

PART 1 - GENERAL

1.1 Section 23 00 00 Mechanical, General applies to the work specified in this section of specifications.

1.2 SCOPE OF WORK

- A. Provide and install new DDC controls as specified for complete operation of the new Boiler #2, new Boiler #3, and existing Dearator/Surge Tank with transfer/boiler feed pumps. DDC controls must be capable of directly communicating with, and be completely compatible with, METASYS controllers as manufactured by Johnson Controls, Inc.
- B. New DDC controls shall be capable of directly interfacing and communication with the existing campus METASYS Facilities Management System.
- C. All new PLC controls associated with the new Boiler #2, new Boiler #3, and existing Dearator/Surge Tank with transfer/boiler feed pumps shall have seamless communication with the existing Metasys energy management system. See section 23 53 29 Steam Boiler for controls for the new Boilers #2 and #3.

1.3 FACILITIES MANAGEMENT SYSTEM

- A. All necessary hardware and software shall be provided to allow for remote monitoring of the new Boiler #2, new Boiler #3, and existing Dearator/Surge Tank with transfer/boiler feed pumps from the University of South Carolina existing Johnson Controls campus FMS system. The FMS system software, hardware and communication protocol shall be compatible with the existing Johnson Controls FMS system in every respect.
- B. The existing Johnson Control FMS system will be expanded as required to accomplish the sequence of operation as described herein. Provide all necessary software and hardware to allow for monitoring and override of all input/output points. All new control points, monitoring points and software points will be added to the existing FMS database. Separate or parallel systems are not acceptable.
- C. Full graphics capabilities will be provided at the campus FMS computer. It shall be possible to monitor, override and adjust setpoints from any graphic screen. Provide data archiving capabilities on the FMS computer harddrive for storage of alarms, trends and all other data associated with this system. It shall be possible to download and upload field panel software from the campus FMS computer. Provide all necessary software and hardware needed to accomplish the graphics, archiving and downloading and uploading requirements.

1.4 CONTROL SYSTEM

- A. Combination pneumatic/direct digital control (DDC) system, as specified herein, shall be provided for control of the following:
 - New Boiler #2, new Boiler #3, and existing Dearator/Surge Tank with transfer/boiler feed pumps
- B. The system shall be complete in all respects and shall be installed by trained mechanics in the direct employ of the control equipment manufacturer who is to be responsible for the proper installation and operation of the control equipment. The control manufacturer shall furnish the services of an experienced engineer or superintendent to supervise the installation of the work and to insure job coordination. All components not specifically indicated or specified, but necessary to make the system function within the intent of the specification, are to be included. Size all control apparatus to properly supply and/or operate and control the apparatus served. All electrical products shall be listed and labeled by UL and comply with NEMA Standards.

1.5 SUBMITTALS

The control system manufacturer/installer shall provide the following SUBMITTALS prior to commencement of any work:

- Sequence of operation
- Bill of material
- Hardware system diagrams
- Point to point installation drawings
- Manufacturer's product data sheets.

1.6 OPERATING AND MAINTENANCE INSTRUCTIONS

- A. The automatic temperature controls sub-contractor shall furnish to the U.S.C. project manager, upon completion of the work, but before final acceptance of the system, five (5) bound copies of typewritten instructions covering complete maintenance and operation of the system and a complete set of as-built drawings of control diagram.
- B. Contractor shall instruct the Owner on the care, operation, and maintenance of all parts of the system.
- 1.7 All electrical work required under this section of specifications shall comply with the latest National Electrical Code. Control system power supply shall be served by a separate breaker and fused in control center for secondary protection.
- 1.8 Provide all wiring, conduits, breakers, transformers, etc. required to power all control components requiring a power source.
- 1.9 All control wiring shall be run in Galvanized EMT with compression fittings. No screws will be allowed. Control wiring shall be color coded #16 TFF or TFFN wire with 600 volt

insulation.

PART 2 - PRODUCTS

2.1 BUILDING FACILITIES MANAGEMENT SYSTEM (FMS)

- A. The Facility Management System shall be capable of integrating multiple building functions including equipment supervision and control, alarm management, energy management, and historical data collection and archiving.
- B. The Facility Management System shall consist of the following:
 - Interface to existing campus FMS computer
 - Standalone application specific controllers (ASC)
 - Field sensors and devices
 - Other temperature control devices.
- C. The system shall be modular in nature, and shall permit expansion of both capacity and functionality through the addition of sensors, actuators, Standalone DDC panels, and operator devices.

2.2 APPLICATION SPECIFIC CONTROLLERS

- A. Each Standalone DDC Controller shall be able to extend its performance and capacity through the use of remote Application Specific Controllers (ASCs).
- B. Each ASC shall operate as a Standalone controller capable of performing its specified control responsibilities independently of other controllers in the network. Each ASC shall be a microprocessor-based, multi-tasking, real-time digital control processor.
- C. Each ASC shall have sufficient memory to support its own operating system and data bases including:
 - Control Processes
 - Operator I/O (Portable Service Terminal)
- D. The operator interface to any ASC point data or programs shall be through any network-resident PC workstation, or any PC or portable operator's terminal connected to any future DDC panel in the network.
- E. Application Specific Controllers shall directly support the temporary use of a portable service terminal. The capabilities of the portable service terminal shall include but not be limited to the following:
 - Display temperatures
 - Display status

Controllers that require manual tuning of loops or perform automatic tuning on command only shall not be acceptable.
- 4. The FEC shall be assembled in a plenum-rated plastic housing with flammability rated to UL94-5VB.
- 5. The FEC shall include a removable base to allow pre-wiring without the controller.
- 6. The FEC shall include troubleshooting LED indicators to identify the following conditions:
 - a. Power On
 - b. Power Off
 - c. Download or Startup in progress, not ready for normal operation
 - d. No Faults
 - e. Device Fault

- f. Field Controller Bus Normal Data Transmission
- g. Field Controller Bus No Data Transmission
- h. Field Controller Bus No Communication
- i. Sensor-Actuator Bus Normal Data Transmission
- j. Sensor-Actuator Bus No Data Transmission
- k. Sensor-Actuator Bus No Communication
- 7. The FEC shall accommodate the direct wiring of analog and binary I/O field points.
- 8. The FEC shall support the following types of inputs and outputs:
 - a. Universal Inputs shall be configured to monitor any of the following:
 - Analog Input, Voltage Mode
 - Analog Input, Current Mode
 - Analog Input, Resistive Mode
 - Binary Input, Dry Contact Maintained Mode
 - Binary Input, Pulse Counter Mode
 - b. Binary Inputs shall be configured to monitor either of the following:
 - Dry Contact Maintained Mode
 - Pulse Counter Mode
 - c. Analog Outputs shall be configured to output either of the following
 - Analog Output, Voltage Mode
 - Analog Output, current Mode
 - d. Binary Outputs shall output the following:
 - 24 VAC Triac
 - e. Configurable Outputs shall be capable of the following:
 - Analog Output, Voltage Mode
 - Binary Output Mode
- 9. The FEC shall have the ability to reside on a Field Controller Bus (FC Bus).
 - a. The FC Bus shall be a Master-Slave/Token-Passing (MS/TP) Bus supporting BACnet Standard protocol SSPC-135, Clause 9.
 - b. The FC Bus shall support communications between the FECs and the NAE.
 - c. The FC Bus shall also support Input/Output Module (IOM) communications with the FEC and with the NAE.
 - d. The FC Bus shall support a minimum of 100 IOMs and FECs in any combination.

- e. The FC Bus shall operate at a maximum distance of 15,000 Ft. between the FEC and the furthest connected device.
- 10. The FEC shall have the ability to monitor and control a network of sensors and actuators over a Sensor-Actuator Bus (SA Bus).
 - a. The SA Bus shall be a Master-Slave/Token-Passing (MS/TP) Bus supporting BACnet Standard Protocol SSPC-135, Clause 9.
 - b. The SA Bus shall support a minimum of 10 devices per trunk.
 - c. The SA Bus shall operate at a maximum distance of 1,200 Ft. between the FEC and the furthest connected device.
- 11. The FEC shall have the capability to execute complex control sequences involving direct wired I/O points as well as input and output devices communicating over the FC Bus or the SA Bus.
- 12. The FEC shall support, but not be limited to, the following:
 - a. Hot water, chilled water/central plant applications
 - b. Built-up air handling units for special applications
 - c. Terminal units
 - d. Special programs as required for systems control
- 13. The FEC shall support a Local Controller Display either as an integral part of the FEC or as a remote device communicating over the SA Bus.
 - a. The Display shall use a BACnet Standard SSPC-135, clause 9 Master-Slave/Token-Passing protocol.
 - b. The Display shall allow the user to view monitored points without logging into the system.
 - c. The Display shall allow the user to view and change setpoints, modes of operation, and parameters.
 - d. The Display shall provide password protection with user adjustable password timeout.
 - e. The Display shall be menu driven with separate paths for:
 - Input/Output
 - Parameter/Setpoint
 - Overrides
 - f. The Display shall use easy-to-read English text messages.
 - g. The Display shall allow the user to select the points to be shown and in what order.
 - h. The Display shall support a back lit Liquid Crystal Display (LCD) with adjustable contrast and brightens and automatic backlight brightening during user interaction.
 - i. The display shall be a minimum of 4 lines and a minimum of 20 characters per

line

- j. The Display shall have a keypad with no more than 6 keys.
- k. The Display shall be panel mountable.

2.3 FIELD SENSORS AND DEVICES

A. Analog Input Devices:

Water Temperature Sensors shall be Resistor Temperature Detectors (RTD). RTD's shall have a range of minus 50/F to plus 250/F, with a resistance tolerance of .25% at 70°F.
