1. Revision: Reference Drawing M-3. Refer to Expansion Joint Details. Expansion joints should be bolted to anchor plates in lieu of welding. Provide anchor base with all expansion joints. Install expansion joints so drain ports are accessible from below.

Clarifications

Item No. Description

2. Steam outages will be coordinated with USC during times of least impact to the building occupants. It was discussed during the pre-bid meeting that the installation of the expansion joints near the Blatt PE Center would require a steam outage for the Blatt Center. This outage will be scheduled for Spring Break, March 3-11, 2012.
