- 2. Please confirm the type of sand joint used in Unit Paver Specifications 02782 2.3,D. Polymeric Sand should be used instead of washed sand.
- 3. Please confirm that the use of Bermuda Tifway 419 or Tifway 417 is required in Turf and Grassing Specification # 02820.Bermuda Tifway 419 is required.




