1. PRE-BID SIGN IN SHEET:

2. WORK SCHEDULE:

3. SHEET E001 PARTIAL FIRE ALARM RISER DIAGRAM:

- The (2) new 20A/1P breakers in Electrical Room 026 to be from the existing emergency generator panel located in the room.
- Refer to Fire Alarm System Note #12 for additional fire alarm devices required.

4. SHEET E002 COMMAND CENTER PLAN:

- Change "BLANK ENGRAVED NAMEPLATES" to read "BLACK ENGRAVED NAMEPLATES".
- Add the following note: "CONTRACTOR TO RELOCATE EXISTING CONDUIT AND BOXES IN COMMAND CENTER AS REQUIRED TO INSTALL NEW ITEMS."

5. SHEET E601 ELEVATOR RISER DIAGRAM:

 Clarification: For bidding purposes one smoke detector per elevator is required at the top of each elevator hoistway, even for shared hoistways.

Each Bidder shall acknowledge receipt of this Addendum and all other Addenda on his bid form.
