

## Item No. Description

- 1. <u>Revision:</u> Reference Drawing FP-1. On note 4 under "Notes to Sheet" delete the requirement to protect above the ceiling of the rack room with the clean agent system. This would also apply to any references in the specifications or elsewhere on the plan.
- 2. <u>Clarification:</u> Reference Drawing FP-1. On note 5 under "Notes to Sheet" the tank size indicated is to give the contractor some reference point of what size system will be required. It will ultimately be the successful contractor's responsibility to calculate the required amount of agent and associated tank size.
- 3. <u>Clarification:</u> Reference Drawing FP-1. The raised floor is a 12" space from the floor slab to the raised floor. The new ACT ceiling is anticipated to be 10'-0" from the floor slab to the ceiling grid, leaving a 9'-0" ceiling height in the rack room. The height to the structure above from the finished floor varies, but on average is approximately 14'-0".
- 4. <u>Clarification:</u> Reference Drawing FP-1. The owner is performing the general contracting work in this area. No reflected ceiling plan is available and the successful contractor will need to coordinate with the owner for grid layouts.
