**Addendum One

Except as specified or otherwise indicated by this addendum, all work shall be in accordance with the basic requirements of the Contract Documents.

**GENERAL:**

1. The Pre-Bid Meeting was held at the 743 Greene Street facility conference room on May 29, 2012 followed by a visit to the project site. The sign-in sheet of attendees is attached. The following items were discussed are hereby part of the contract documents:
  - a. It was determined and stated during this meeting that all questions must be submitted to the Architect by end of day Wednesday 5/30 and the Addenda will be posted Thursday 5/31.
  - b. The waterproofing contractor will need to coordinate with separate contractor installing the HVAC equipment above the video production room so that he has access to the roof.
  - c. The owner has added a "U" shaped vending booth within this work area. Therefore, it is now part of this scope of work to provide the waterproofing around these 8" CMU walls. Same condition as the existing concession areas on each side of the elevators.
  - d. The contractor is responsible for providing his own dumpster.
