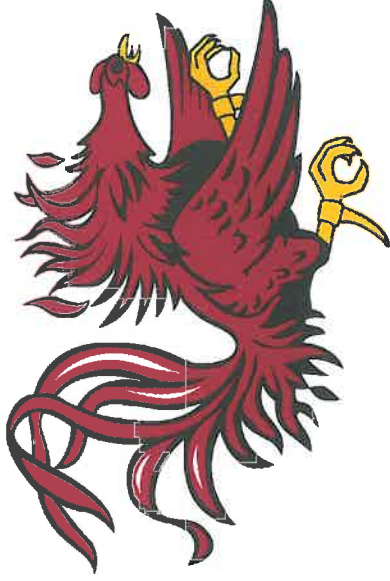
Answer The RFP state where items do not count against the page limit. What is put in the proposal is up to the person putting the proposal together.
