- 4. Bids are due June 17, 2015 at 2:00 P.M. at 743 Greene Street, Rm. 53, Columbia SC 29208, Attention: Ms. Juaquana Brookins.
  - Bids will be accepted by hand delivery or mail.
  - It is the responsibility of the contractor to confirm the delivery of their bid.
- 5. Bid Bonds (5% of the contract amount) are required for the project.
- 6. Payment and Performance Bonds (100% of the contract amount) are required for the project.
- 7. Contractors should become familiar with the nonresponsive bid section of the project documents.
- 8. The University will issue contracts per state requirements.
  - The successful contractor is required to execute contracts in a timely manner.
  - Failure to acknowledge addendum can be considered nonresponsive.
- 9. One hundred twenty (120) days have been allocated for the construction schedule.
  - Liquidated damages of \$250.00 per day will be assessed for every day exceeding the construction schedule.
- 10. Laydown, parking, and staging areas were discussed. Only designated areas discussed during the prebid meeting will be allocated by the University. Any additional space needed on Main Street will have to be coordinated through the City of Columbia.
  - All cost associated with parking and street closures shall be included in the base bid.
  - Contractors must not block the tank located near the designated parking area.
- 11. The Contractor must protect building property, occupants, etc. from Contractor's operations and all related hazards using adequate barricades and fencing. Contractor will be required to maintain egress and provide protection barriers, including overhead protection.
- 12. Safety barricades shall be implemented to protect pedestrian traffic around Roof Section B.
- 13. Dale Branham will have the final say and last refusal for the safety plan.
  - Roof Area B is the most critical roof area for planning. The University desires Roof Area B to be roofed first.
- 14. Although use of the building over the summer period will be limited, the facility will be lightly occupied during the course of the work.
- 15. Contractor work hours shall typically be from 8:00 a.m. to 8:00 p.m., Sunday to Saturday. Work may be limited or postponed due to University events.
- 16. Ty Russell with the University of South Carolina discussed the University's asbestos abatement and hazmat concerns.
  - The University has more stringent requirements than OSHA. The contractor is responsible to abide by all OSHA and University requirements.

- The Contractor is required to furnish certificates from DHEC for employees who will be in contact with any ACM.
- Manual means of removal are required to remove ACM in order to keep it non-friable.
  - i. If mechanical means of removal are used the contractor shall treat all ACM as friable.
- 17. The University's EH&S department will review the successful contractor's fall protection and safety plan.
- 18. Contractor must provide an Asbestos Free Warranty and the Contractor's Two Year Warranty to the Owner prior to project closeout. Manufacturer's 20 year, single source, roofing system watertightness warranty and a 20 year finish warranty for the metal components will also be required.
- 19. Contractors will be granted access to the building interior through means of the stairwell.
  - Protective shoe covers are required while accessing the building's interior.
    - i. The contractor is required to clean the stairwell upon project completion.
  - Building washroom and toilet facilities will not be available to the Contractor. Port-ojohns must be provided by the Contractor.
- 20. USC prohibits possession of drugs, firearms, and alcohol. USC prohibits smoking and other tobacco products on campus.
- 21. Fraternization with staff and students is unacceptable and will not be tolerated. Accusations of Contractor's employees for fraternization or interaction with students or staff will result in dismissal of the individual from the project site for the remainder of the project. Contractor crew must wear shirts at all times.
- 22. Building property, landscaping, etc. must be protected from damage. Damage is to be corrected to the condition equivalent to that at the start of work at no additional cost to the Owner.
- 23. The existing roof system consists of a built up roof with gravel surfacing, over a structural lightweight concrete deck, over a concrete deck, over a metal form deck.
- 24. The project generally consist of the removal of the existing roof system down to the existing concrete deck and installation of a two-ply modified bitumen roof system with a granular surfaced cap sheet, over 1/2" cover-board, over 1/4" per foot tapered insulation and 1/2" per foot crickets, over two layers of 2" polyisocyanurate.
  - Repairs to the lightning protection system are to be included in the base bid.
  - Metal panels along the parapet wall on Roof Section C shall be included in the base bid.
  - Through-wall flashing and masonry work on Roof Section C shall be included in the base bid.
  - Modifications to the existing satellite deck and installation of stairs and guard rails shall be included in the base bid.
  - All necessary permits and inspections are to be included in contractor's bid.
  - Unit price allowances are included in the Base Bid. Unit price quotes will be Add or Deducts to the Contract Sum.

- 25. Bees are present on the upper roofs of the project. The contractor should be aware of this and take any precautions necessary to protect employees and building tenants.
- 26. Keith Cappelluti informed the contractors an addendum will be issued.
- 27. A walk through of the project was accomplished.
