I. GENERAL:

- 5. Refer to Specification Section 142410 Hydraulic Elevator Upgrades paragraph 2.40. Requests for approval of additional Elevator Manufacturer and other Elevator Service Repair and Modernization Companies not already listed under this specification are to be submitted to the architect for approval 10 days prior to the bid date and time, which is by 2:00 pm Monday April 1, 2013.
- 7. Current Davis Bacon Wage Act rates and requirements are to be followed on this project.
- 8. In accordance with SC Code of Laws, Section 40-11-340; Qualifications for acting as a sole prime contractor: "An entity licensed under the classifications or subclassification in Sections 40-11-410 (1), (2), or (3) may act as a sole prime contractor on a project if <u>forty percent</u> or more of the work as measured by the total cost of construction falls under one or more of the licensee's classifications or subclassifications ..." The sole prime contractor does not need to perform 40% of the work; 40% of the work just needs to follow under one or more of the licensee's classifications or subclassifications.

 - 4. Company must have been open and operating for at least 5 years in the elevator industry.
 - 5. Company must have a continuous and comprehensive safety and training plan for all field employees."
- 2. Refer to Specification Section 142410 Hydraulic Elevator Upgrades; everywhere this specification references "Elevator Manufacturer" and independent Elevator Service Repair and Modernization Company is also acceptable.

- 3. Refer to Specification Section 142410 Hydraulic Elevator Upgrades; revise paragraph 2.40 as follows:
 - "2.40 Manufacturers or Elevator Service Repair and Modernization Companies:
 - A. Manufacturers or Companies: Subject to compliance with requirements, provide elevator upgrades by one of the following.
 - 1. ThyssenKrupp Elevator.
 - 2. Carolina Elevator Service Inc.
 - 3. Additional Manufacturers or Companies approved prior to bidding.
 - a. Manufacturers or companies requesting permission to bid prior to the bid date must submit to the architect qualifications and demonstrate compliance with being able to meet all requirements; specifically the requirements described under section of 1.7 Quality Assurance of this specification. Requests must be submitted a minimum of 10 days prior to bid date to the architect. Additional manufacturers deemed eligible to bid will be listed as an acceptable manufacturer by Addendum. Additional manufacturers not listed by Addendum are not approved to bid on this project.
