2. Ann Derrick noted general key issues for the project:

- a. All drawings, specifications and addenda can be accessed from the USC website. It is the responsibility of the Contractor to check for addenda on the last day (April 5<sup>th</sup>).
- b. Bids are due on Wednesday, April 10<sup>th</sup> at 3:00 pm and each Contractor is responsible for assuring their bid forms are submitted on time.
- c. Construction period will be 100 days from Notice to proceed to Substantial Completion.
- d. Construction commencement date will be no earlier than May 6<sup>th</sup> (due to concert at stadium).
- e. The project site is the upper level of the east stands of Williams Brice Stadium near the southeast ramp.
- 3. Cleve Walker gave a general description of the scope of work:

The project consists of a new women's restroom on the east side of the stadium. The project includes a new elevated slab structure of steel beams and composite decking, masonry load bearing walls, roof structure, PVC roofing, demolition, associated plumbing and HVAC work. Electrical work will be performed by USC. Temporary access to remove existing double-T concrete beams was discussed and further reviewed on site.

Alternates 1 & 2 were described (and further clarified on site).
