- 2. All questions should be submitted to the architect by noon on Thursday, April 16, 2015. The final addendum will be posted by 5:00pm on Friday, April 17, 2015.
- 3. The existing Horseshoe irrigation is in linear zones running east and west, (i.e. not in north-south zones or sections as quantified on the Site Plan). This will inform how the work is planned. The contractor may elect to cap off selected heads to better control irrigation during the installation.
- 4. The contractor shall protect the interior brick walkways from equipment and other damage with plywood.
- 5. USC will arrange and pay for delivery and servicing of a 30-yard roll-off container at the project site, to be used for organic debris removed from the project site.
- 6. Zoysia sod shall be a 'SC Certified Grass' as defined by the Clemson Department of Plant Industry, or an equivalent certification from the state of sod production. Contractor shall submit certificates signed by producer for each shipment.
- 7. The contractor shall apply a slow-release-nitrogen formula starter fertilizer with an analysis of 14-20-4, at the rate of five pounds per 1,000 square feet.
