Attendees: Clarissa Clark, Troy Green – USC Columbia (via speaker phone); Brian Enter – USC Aiken; Rick Clamp – Sims Group Engineers; Reginald Smith – Bank and Business Systems; Dale Willm – Simplex Grinnell; Randy Bundrick – Palmetto State Electric

Minutes:

- Brian Enter opened the meeting and introductions of all parties were made
- Clarissa Clark discussed the bid documents and procedures:
 - o bonding requirements
 - o no tobacco policy of the University of South Carolina
 - o contractor's employee requirements
 - o notice of Iran Divestment Act
 - o 120 construction period
 - o bid opening is 3/5/2015 at 3:00pm at 743 Greene Street, Columbia SC
- Rick Clamp discussed technical items and requirements for the fire alarm design:
 - Penland building is predominantly admin on first floor, classrooms on second
 - H&SS building is predominantly classrooms on first floor, offices on second
 - System audible notification shall be horns, visual shall be strobes for both buildings
 - Rated doors requiring door holders exist in both buildings
 - Elevators exist in both buildings
 - o HVAC interfaces exist in both buildings
 - Acceptable manufacturers and system series described in technical specifications
 - o Detector type to be multi sensor detectors where shown
 - Neither building is protected by a fire sprinkler system
 - Request for all contractor questions in writing via email to Sims Group
- Clarissa Clark announced contractor questions are due no later than 12:00 noon on 2/25/2015 for addressing via addenda
- Troy Green announced that the first addendum would contain the pre-bid sign in sheet and pre-bid meeting minutes
