A. Paragraph 3.18: Delete paragraph in its entirety.

CLARIFICATIONS

4.01 RFI'S AND RESPONSES

A. Specification Section 331100, 3.17, D, 2

1. Q: Section states the As-Built drawings be signed and sealed by a Professional Land Surveyor registered in the State of Florida. Will a surveyor registered in the State of South Carolina be acceptable?

a. A: Yes. A surveyor registered in South Carolina is acceptable. This requirement will be waved in lieu of the data conduit and water piping must be wired for future utility finding. The general contractor's as-builts should suffice in lieu of a survey.

B. Q: Will the contractor be responsible for locating/staking the corners of the buildings and if so will it have to be done by a professional land surveyor?

1. A: The general contractor is responsible for staking the building with final building location approval by the owner. A professional surveyor will not be required to provide this service.

C. Q: Is construction power available from one of the existing facilities?

1. A: Yes. Construction power can be pulled from either the soccer field house building or facility's ground maintenance shed. Coordinate final location with the owner.

D. Specification Section 331100, 3.18.

1. Q: Are the greenhouse structures to have fire protection systems?

a. A: No. There is not fire protection system to be installed in the greenhouse structure.
