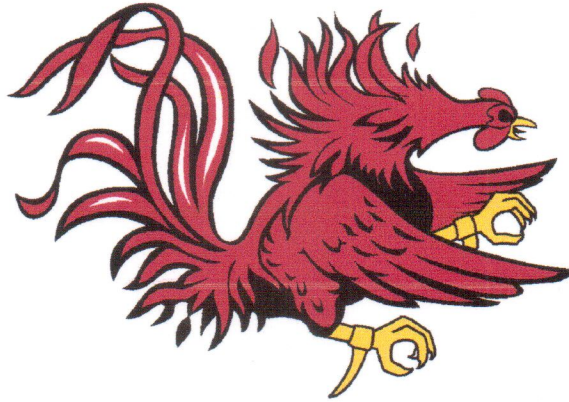
NOTICE TO BIDDER

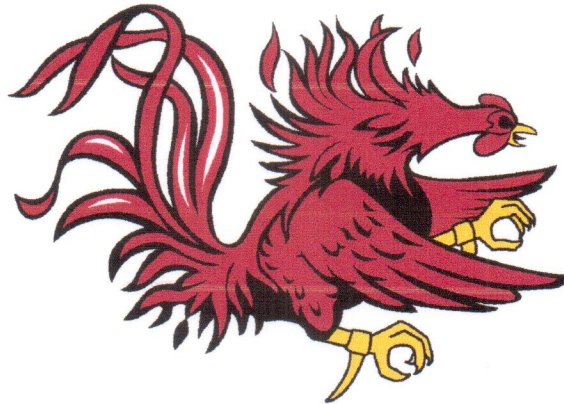
