

#### 1. STANDARD SUPPLEMENTAL INSTRUCTIONS TO BIDDERS

- **1.1.** These Standard Supplemental Instructions To Bidders amend or supplement Instructions To Bidders (AIA Document A701-1997) and other provisions of Bidding and Contract Documents as indicated below.
- **1.2.** Compliance with these Standard Supplemental Instructions is required by the Office of State Engineer (OSE) for all State projects when competitive sealed bidding is used as the method of procurement.
- 1.3. All provisions of A701-1997, which are not so amended or supplemented, remain in full force and effect.
- **1.4.** Bidders are cautioned to carefully examine the Bidding and Contract Documents for additional instructions or requirements.

#### 2. MODIFICATIONS TO A701-1997

- **2.1.** *Delete Section 1.1 and insert the following:* 
  - 1.1 Bidding Documents, collectively referred to as the Invitation for Bids, include the Bidding Requirements and the proposed Contract Documents. The Bidding Requirements consist of the Advertisement, Instructions to Bidders (A-701), Supplementary Instructions to Bidders, the bid form (SE-330), the Intent to Award Notice (SE-370), and other sample bidding and contract forms. The proposed Contract Documents consist of the form of Agreement between the Owner and Contractor, Conditions of the Contract (General, Supplementary and other Conditions), Drawings, Specifications, all Addenda issued prior to execution of the Contract, and other documents set forth in the Bidding Documents. Any reference in this document to the Agreement between the Owner and Contractor, AIA Document A101, or some abbreviated reference thereof, shall mean the AIA A101, 2007 Edition as modified by OSE Form 00501 Standard Modification to Agreement Between Owner and Contractor. Any reference in this document to the General Conditions of the Contract for Construction, AIA Document A201, or some abbreviated reference thereof, shall mean the AIA A201, 2007 Edition as modified by OSE Form 00811 Standard Supplementary Conditions.
- **2.2.** In Section 1.8, delete the words "and who meets the requirements set forth in the Bidding Documents".
- **2.3.** In Section 2.1, delete the word "making" and substitute the word "submitting."
- **2.4.** *In Section 2.1.1:*

After the words "Bidding Documents," delete the word "or" and substitute the word "and."

Insert the following at the end of this section:

Bidders are expected to examine the Bidding Documents and Contract Documents thoroughly and should request an explanation of any ambiguities, discrepancies, errors, omissions, or conflicting statements. Failure to do so will be at the Bidder's risk. Bidder assumes responsibility for any patent ambiguity that Bidder does not bring to the Owner's attention prior to bid opening.

**2.5.** In Section 2.1.3, insert the following after the term "Contract Documents" and before the period: and accepts full responsibility for any pre-bid existing conditions that would affect the Bid that could have been ascertained by a site visit. As provided in Regulation 19-445.2042(B), A bidder's failure to attend an advertised pre-bid conference will not excuse its responsibility for estimating properly the difficulty and cost of successfully performing the work, or for proceeding to successfully perform the work without additional expense to the State.

**2.6.** *Insert the following Sections* 2.2 *through* 2.6:

#### 2.2 CERTIFICATION OF INDEPENDENT PRICE DETERMINATION

GIVING FALSE, MISLEADING, OR INCOMPLETE INFORMATION ON THIS CERTIFICATION MAY RENDER YOU SUBJECT TO PROSECUTION UNDER SECTION 16-9-10 OF THE SOUTH CAROLINA CODE OF LAWS AND OTHER APPLICABLE LAWS.

- (a) By submitting an bid, the bidder certifies that—
  - (1) The prices in this bid have been arrived at independently, without, for the purpose of restricting competition, any consultation, communication, or agreement with any other bidder or competitor relating to—
    - (i) Those prices;
    - (ii) The intention to submit an bid; or
    - (iii) The methods or factors used to calculate the prices offered.
  - (2) The prices in this bid have not been and will not be knowingly disclosed by the bidder, directly or indirectly, to any other bidder or competitor before bid opening (in the case of a sealed bid solicitation) or contract award (in the case of a negotiated solicitation) unless otherwise required by law; and
  - (3) No attempt has been made or will be made by the bidder to induce any other concern to submit or not to submit an bid for the purpose of restricting competition.
- (b) Each signature on the bid is considered to be a certification by the signatory that the signatory—
  - (1) Is the person in the bidder's organization responsible for determining the prices being offered in this bid, and that the signatory has not participated and will not participate in any action contrary to paragraphs (a)(1) through (a)(3) of this certification; or
  - (2)(i) Has been authorized, in writing, to act as agent for the bidder's principals in certifying that those principals have not participated, and will not participate in any action contrary to paragraphs (a)(1) through (a)(3) of this certification [As used in this subdivision (b)(2)(i), the term "principals" means the person(s) in the bidder's organization responsible for determining the prices offered in this bid];
  - (ii) As an authorized agent, does certify that the principals referenced in subdivision (b)(2)(i) of this certification have not participated, and will not participate, in any action contrary to paragraphs (a)(1) through (a)(3) of this certification; and
  - (iii) As an agent, has not personally participated, and will not participate, in any action contrary to paragraphs (a)(1) through (a)(3) of this certification.
- (c) If the bidder deletes or modifies paragraph (a)(2) of this certification, the bidder must furnish with its offer a signed statement setting forth in detail the circumstances of the disclosure.

#### 2.3 DRUG FREE WORKPLACE

By submitting a bid, the Bidder certifies that Bidder will maintain a drug free workplace in accordance with the requirements of Title 44, Chapter 107 of South Carolina Code of Laws, as amended.

#### 2.4 CERTIFICATION REGARDING DEBARMENT AND OTHER RESPONSIBILITY MATTERS

- (a) (1) By submitting an Bid, Bidder certifies, to the best of its knowledge and belief, that-
  - (i) Bidder and/or any of its Principals-
    - (A) Are not presently debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any state or federal agency;
    - (B) Have not, within a three-year period preceding this bid, been convicted of or had a civil judgment rendered against them for: commission of fraud or a criminal offense in

connection with obtaining, attempting to obtain, or performing a public (Federal, state, or local) contract or subcontract; violation of Federal or state antitrust statutes relating to the submission of bids; or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, tax evasion, or receiving stolen property; and

- (C) Are not presently indicted for, or otherwise criminally or civilly charged by a governmental entity with, commission of any of the offenses enumerated in paragraph (a)(1)(i)(B) of this provision.
- (ii) Bidder has not, within a three-year period preceding this bid, had one or more contracts terminated for default by any public (Federal, state, or local) entity.
- (2) "Principals," for the purposes of this certification, means officers; directors; owners; partners; and, persons having primary management or supervisory responsibilities within a business entity (e.g., general manager; plant manager; head of a subsidiary, division, or business segment, and similar positions).
- (b) Bidder shall provide immediate written notice to the Procurement Officer if, at any time prior to contract award, Bidder learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
- (c) If Bidder is unable to certify the representations stated in paragraphs (a)(1), Bid must submit a written explanation regarding its inability to make the certification. The certification will be considered in connection with a review of the Bidder's responsibility. Failure of the Bidder to furnish additional information as requested by the Procurement Officer may render the Bidder nonresponsible.
- (d) Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render, in good faith, the certification required by paragraph (a) of this provision. The knowledge and information of an Bidder is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
- (e) The certification in paragraph (a) of this provision is a material representation of fact upon which reliance was placed when making award. If it is later determined that the Bidder knowingly or in bad faith rendered an erroneous certification, in addition to other remedies available to the State, the Procurement Officer may terminate the contract resulting from this solicitation for default.

#### 2.5 ETHICS CERTIFICATE

By submitting a bid, the bidder certifies that the bidder has and will comply with, and has not, and will not, induce a person to violate Title 8, Chapter 13 of the South Carolina Code of Laws, as amended (ethics act). The following statutes require special attention: Section 8-13-700, regarding use of official position for financial gain; Section 8-13-705, regarding gifts to influence action of public official; Section 8-13-720, regarding offering money for advice or assistance of public official; Sections 8-13-755 and 8-13-760, regarding restrictions on employment by former public official; Section 8-13-775, prohibiting public official with economic interests from acting on contracts; Section 8-13-790, regarding recovery of kickbacks; Section 8-13-1150, regarding statements to be filed by consultants; and Section 8-13-1342, regarding restrictions on contributions by contractor to candidate who participated in awarding of contract. The state may rescind any contract and recover all amounts expended as a result of any action taken in violation of this provision. If contractor participates, directly or indirectly, in the evaluation or award of public contracts, including without limitation, change orders or task orders regarding a public contract, contractor shall, if required by law to file such a statement, provide the statement required by Section 8-13-1150 to the procurement officer at the same time the law requires the statement to be filed.

#### 2.6 RESTRICTIONS APPLICABLE TO BIDDERS & GIFTS

Violation of these restrictions may result in disqualification of your bid, suspension or debarment, and may constitute a violation of the state Ethics Act. (a) After issuance of the solicitation, bidder agrees not to discuss this procurement activity in any way with the Owner or its employees, agents or officials. All communications must be solely with the Procurement Officer. This restriction may be lifted by express written permission from the Procurement Officer. This restriction expires once a contract has been formed. (b) Unless otherwise approved in writing by the Procurement

Officer, bidder agrees not to give anything to the Owner, any affiliated organizations, or the employees, agents or officials of either, prior to award. (c) Bidder acknowledges that the policy of the State is that a governmental body should not accept or solicit a gift, directly or indirectly, from a donor if the governmental body has reason to believe the donor has or is seeking to obtain contractual or other business or financial relationships with the governmental body. Regulation 19-445.2165(C) broadly defines the term donor.

#### **2.7.** *Delete Section 3.1.1 and substitute the following:*

**3.1.1** Bidders may obtain complete sets of the Bidding Documents from the issuing office designated in the Advertisement in the number and for the deposit sum, if any, stated therein. If so provided in the Advertisement, the deposit will be refunded to all plan holders who return the Bidding Documents in good condition within ten days after receipt of Bids. The cost of replacement of missing or damaged documents will be deducted from the deposit. A Bidder receiving a Contract award may retain the Bidding Documents and the Bidder's deposit will be refunded.

- **2.8.** Delete the language of Section 3.1.2 and insert the word "Reserved."
- **2.9.** In Section 3.1.4, delete the words "and Architect may make" and substitute the words "has made."

#### **2.10.** Insert the following Section 3.1.5

**3.1.5** All persons obtaining Bidding Documents from the issuing office designated in the Advertisement shall provide that office with Bidder's contact information to include the Bidder's name, telephone number, mailing address, and email address.

#### **2.11.** *In Section 3.2.2:*

Delete the words "and Sub-bidders"

Delete the word "seven" and substitute the word "ten"

#### **2.12.** *In Section 3.2.3:*

In the first Sentence, insert the word "written" before the word "Addendum."

*Insert the following at the end of the section:* 

As provided in Regulation 19-445.2042(B), nothing stated at the pre-bid conference shall change the Bidding Documents unless a change is made by written Addendum.

#### **2.13.** *Insert the following at the end of Section 3.3.1:*

Reference in the Bidding Documents to a designated material, product, thing, or service by specific brand or trade name followed by the words "or equal" and "or approved equal" shall be interpreted as establishing a standard of quality and shall not be construed as limiting competition.

#### **2.14.** *Delete Section 3.3.2 and substitute the following:*

**3.3.2** No request to substitute materials, products, or equipment for materials, products, or equipment described in the Bidding Documents and no request for addition of a manufacturer or supplier to a list of approved manufacturers or suppliers in the Bidding Documents will be considered prior to receipt of Bids unless written request for approval has been received by the Architect at least ten days prior to the date for receipt of Bids established in the Invitation for Bids. Any subsequent extension of the date for receipt of Bids by addendum shall not extend the date for receipt of such requests unless the addendum so specifies. Such requests shall include the name of the material or equipment for which it is to be substituted and a complete description of the proposed substitution including drawings, performance and test data, and other information necessary for an evaluation. A statement setting forth changes in other materials, equipment or other portions of the Work, including changes in the work of other contracts that incorporation of the proposed substitution would require, shall be included. The burden of proof of the merit of the proposed substitution is upon the proposer. The Architect's decision of approval or disapproval of a proposed substitution shall be final.

#### **2.15.** *Delete Section 3.4.3 and substitute the following:*

**3.4.3** Addenda will be issued no later than 120 hours prior to the time for receipt of Bids except an Addendum withdrawing the request for Bids or one which includes postponement of the date for receipt of Bids.

#### **2.16.** *Insert the following Sections 3.4.5 and 3.4.6:*

- **3.4.5** When the date for receipt of Bids is to be postponed and there is insufficient time to issue a written Addendum prior to the original Bid Date, Owner will notify prospective Bidders by telephone or other appropriate means with immediate follow up with a written Addendum. This Addendum will verify the postponement of the original Bid Date and establish a new Bid Date. The new Bid Date will be no earlier than the fifth (5th) calendar day after the date of issuance of the Addendum postponing the original Bid Date.
- **3.4.6.** If an emergency or unanticipated event interrupts normal government processes so that bids cannot be received at the government office designated for receipt of bids by the exact time specified in the solicitation, the time specified for receipt of bids will be deemed to be extended to the same time of day specified in the solicitation on the first work day on which normal government processes resume. In lieu of an automatic extension, an Addendum may be issued to reschedule bid opening. If state offices are closed at the time a pre-bid or pre-proposal conference is scheduled, an Addendum will be issued to reschedule the conference. - **2.17.** In Section 4.1.1, delete the word "forms" and substitute the words "SE-330 Bid Form."
- **2.18.** *Delete Section 4.1.2 and substitute the following:* 
  - **4.1.2** Any blanks on the bid form to be filled in by the Bidder shall be legibly executed in a non-erasable medium. Bids shall be signed in ink or other indelible media.
- **2.19.** *Delete Section 4.1.3 and substitute the following:* 
  - **4.1.3** Sums shall be expressed in figures.
- **2.20.** *Insert the following at the end of Section 4.1.4:*

Bidder shall not make stipulations or qualify his bid in any manner not permitted on the bid form. An incomplete Bid or information not requested that is written on or attached to the Bid Form that could be considered a qualification of the Bid, may be cause for rejection of the Bid.

- **2.21.** Delete Section 4.1.5 and substitute the following:
  - **4.1.5** All requested Alternates shall be bid. The failure of the bidder to indicate a price for an Alternate shall render the Bid non-responsive. Indicate the change to the Base Bid by entering the dollar amount and marking, as appropriate, the box for "ADD TO" or "DEDUCT FROM". If no change in the Base Bid is required, enter "ZERO" or "No Change." For add alternates to the base bid, Subcontractor(s) listed on page BF-2 of the Bid Form to perform Alternate Work may be used for both Alternates and Base Bid Work if Alternates are accepted.
- **2.22.** *Delete Section 4.1.6 and substitute the following:* 
  - **4.1.6** Pursuant to Title 11, Chapter 35, Section 3020(b)(i) of the South Carolina Code of Laws, as amended, Section 7 of the Bid Form sets forth a list of subcontractor specialties for which Bidder is required to list only the subcontractors Bidder will use to perform the work of each listed specialty. Bidder must follow the Instructions in the Bid Form for filling out this section of the Bid Form. Failure to properly fill out Section 7 may result in rejection of Bidder's bid as non-responsive.
- **2.23.** Delete Section 4.1.7 and substitute the following:
  - **4.1.7** Each copy of the Bid shall state the legal name of the Bidder and the nature of legal form of the Bidder. Each copy shall be signed by the person or persons legally authorized to bind the Bidder to a contract. A Bid submitted by an agent shall have a current power of attorney attached certifying the agent's authority to bind the Bidder.
- **2.24.** *Delete Section 4.2.1 and substitute the following:* 
  - **4.2.1** If required by the Invitation for Bids, each Bid shall be accompanied by a bid security in an amount of not less than five percent of the Base Bid. The bid security shall be a bid bond or a certified cashier's check. The Bidder pledges to enter into a Contract with the Owner on the terms stated in the Bid and will, if required, furnish bonds covering the faithful performance of the Contract and payment of all obligations arising thereunder. Should the Bidder refuse to enter into such Contract or fail to furnish such bonds if required, the amount of the bid security shall be forfeited to the Owner as liquidated damages, not as a penalty.

#### **2.25.** *Delete Section 4.2.2 and substitute the following:*

**4.2.2** If a surety bond is required, it shall be written on AIA Document A310, Bid Bond, and the attorney-in-fact who executes the bond on behalf of the surety shall affix to the bond a certified and current copy of the power of attorney. The bid bond shall:

- .1 Be issued by a surety company licensed to do business in South Carolina;
- .2 Be issued by a surety company having, at a minimum, a "Best Rating" of "A" as stated in the most current publication of "Best's Key Rating Guide, Property-Casualty", which company shows a financial strength rating of at least five (5) times the contract price.
- .3 Be enclosed in the bid envelope at the time of Bid Opening, either in paper copy or as an electronic bid bond authorization number provided on the Bid Form and issued by a firm or organization authorized by the surety to receive, authenticate and issue binding electronic bid bonds on behalf the surety.

The Owner may reply within 14 days to the Contractor in writing stating (1) whether the Owner has reasonable objection to any such proposed person or entity. Failure of the Owner to reply within the 14 day period shall constitute notice of no reasonable objection.

  - **5.2.2** The Contractor shall not contract with a proposed person or entity to whom the Owner has made reasonable and timely objection. The Owner shall not direct the Contractor to contract with any specific individual or entity for supplies or services unless such supplies and services are necessary for completion of the Work and the specified individual or entity is the only source of such supply or services.

  - **5.2.5** A Subcontractor identified in the Contractor's Bid in response the specialty subcontractor listing requirements of Section 7 of the Bid Form (SE-330) may only be substituted in accordance with and as permitted by the provisions of Title 11, Chapter 35, Section 3021 of the South Carolina Code of Laws, as amended. A proposed substitute for a Listed Subcontractor shall be subject to the Owner's approval as set forth is Section 5.2.3.
- 3.44 In Section 5.3, delete everything following the heading "SUBCONTRACTUAL RELATIONS" and insert the following Sections 5.3.1, 5.3.2, 5.3.3, and 5.3.4:
  - **5.3.1** By appropriate written agreement, the Contractor shall require each Subcontractor, to the extent of the Work to be performed by the Subcontractor, to be bound to the Contractor by terms of the Contract Documents, and to assume toward the Contractor all the obligations and responsibilities, including the responsibility for safety of the Subcontractor's Work, which the Contractor, by these Documents, assumes toward the Owner and Architect. Each subcontract agreement shall preserve and protect the rights of the Owner and Architect under the Contract Documents with respect to the Work to be performed by the Subcontractor so that subcontracting thereof will not

- § 5.3.2 Without limitation on the generality of Section 5.3.1, each Subcontract agreement and each Sub-subcontract agreement shall include, and shall be deemed to include, the following Sections of these General Conditions: 3.2, 3.5, 3.18, 5.3, 5.4, 6.2.2, 7.3.3, 7.5, 7.6, 13.1, 13.12, 14.3, 14.4, and 15.1.6.
- § 5.3.3 Each Subcontract Agreement and each Sub-subcontract agreement shall exclude, and shall be deemed to exclude, Sections 13.2.1 and 13.6 and all of Article 15, except Section 15.1.6, of these General Conditions. In the place of these excluded sections of the General Conditions, each Subcontract Agreement and each Sub-subcontract may include Sections 13.2.1 and 13.6 and all of Article 15, except Section 15.1.6, of AIA Document A201-2007, Conditions of the Contract, as originally issued by the American Institute of Architects.
- § 5.3.4 The Contractor shall assure the Owner that all agreements between the Contractor and its Subcontractor incorporate the provisions of Subparagraph 5.3.1 as necessary to preserve and protect the rights of the Owner and the Architect under the Contract Documents with respect to the work to be performed by Subcontractors so that the subcontracting thereof will not prejudice such rights. The Contractor's assurance shall be in the form of an affidavit or in such other form as the Owner may approve. Upon request, the Contractor shall provide the Owner or Architect with copies of any or all subcontracts or purchase orders.
- **3.45** Delete the last sentence of Section 5.4.1.
- **3.46** *Add the following Sections 5.4.4, 5.4.5 and 5.4.6:* 
  - § 5.4.4 Each subcontract shall specifically provide that the Owner shall only be responsible to the subcontractor for those obligations of the Contractor that accrue subsequent to the Owner's exercise of any rights under this conditional assignment.
  - § 5.4.5 Each subcontract shall specifically provide that the Subcontractor agrees to perform portions of the Work assigned to the Owner in accordance with the Contract Documents.
  - § 5.4.6 Nothing in this Section 5.4 shall act to reduce or discharge the Contractor's payment bond surety's obligations to claims arising prior to the Owner's exercise of any rights under this conditional assignment.

If the Contractor requests a change to the Work that involves a revision to either the Drawings or Specifications, the Contractor shall reimburse the Owner for any expenditures associated with the Architects' review of the proposed revisions, except to the extent the revisions are accepted by execution of a Change Order.
  - **7.2.5** Agreement on any Change Order shall constitute a final settlement of all matters relating to the change in the Work that is the subject of the Change Order, including, but not limited to, any adjustments to the Contract Sum or the Contract Time.

All costs incurred by the Contractor must be justifiably compared with prevailing industry standards. Except as provided in Section 7.5, all adjustments to the Contract Price shall be limited to job specific costs and shall not include indirect costs, overhead, home office overhead, or profit.
- **3.52** *Delete Section 7.3.7 and substitute the following:* 
  - **7.3.7** If the Contractor does not respond promptly or disagrees with the method for adjustment in the Contract Sum, the Architect shall make an initial determination, consistent with Section 7.3.3, of the method and the adjustment on the basis of reasonable expenditures and savings of those performing the Work attributable to the change, including, in case of an increase in the Contract Sum, an amount for overhead and profit as set forth in Section 7.5. In such case, and also under Section 7.3.3.1.3, the Contractor shall keep and present, in such form as the Architect may prescribe, an itemized accounting together with appropriate supporting data. Unless otherwise provided in the Contract Documents, costs for the purposes of this Section 7.3.7 shall be limited to the following:

The percentages cited below shall be considered to include all indirect costs including, but not limited to: field and office managers, supervisors and assistants, incidental job burdens, small tools, and general overhead allocations. The allowable percentages for overhead and profit are as follows:
  - .1 To the Contractor for work performed by the Contractor's own forces, 17% of the Contractor's actual costs.
  - .2 To each Subcontractor for work performed by the Subcontractor's own forces, 17% of the subcontractor's actual costs.
  - .3 To the Contractor for work performed by a subcontractor, 10% of the subcontractor's actual costs (not including the subcontractor's overhead and profit).

#### 7.6 PRICING DATA AND AUDIT

### § 7.6.1 Cost or Pricing Data.

Upon request of the Owner or Architect, Contractor shall submit cost or pricing data prior to execution of a Modification which exceeds \$500,000. Contractor shall certify that, to the best of its knowledge and belief, the cost or pricing data submitted is accurate, complete, and current as of a mutually determined specified date prior to the date of pricing the Modification. Contractor's price, including profit, shall be adjusted to exclude any significant sums by which such price was increased because Contractor furnished cost or pricing data that was inaccurate, incomplete, or not current as of the date specified by the parties. Notwithstanding Subparagraph 9.10.4, such adjustments may be made after final payment to the Contractor.

§ 7.6.2 Cost or pricing data means all facts that, as of the date specified by the parties, prudent buyers and sellers would reasonably expect to affect price negotiations significantly. Cost or pricing data are factual, not judgmental; and are verifiable. While they do not indicate the accuracy of the prospective contractor's judgment about estimated future costs or projections, they do include the data forming the basis for that judgment. Cost or pricing data are more than historical accounting data; they are all the facts that can be reasonably expected to contribute to the soundness of estimates of future costs and to the validity of determinations of costs already incurred.

### § 7.6.3 Records Retention.

As used in Section 7.6, the term "records" means any books or records that relate to cost or pricing data that Contractor is required to submit pursuant to Section 7.6.1. Contractor shall maintain records for three years from the date of final payment, or longer if requested by the chief procurement officer. The Owner may audit Contractor's records at reasonable times and places.

If a schedule of values or trade breakdown is used as the basis for payment and later determined to be inaccurate, sufficient funds shall be withheld from future Applications for Payment to ensure an adequate reserve (exclusive of normal retainage) to complete the Work.

If the Architect does not issue a Certificate for Payment to the Owner, through no fault of the Contractor, within seven days after receipt of the Contractor's Application for Payment, or if the Owner does not pay the Contractor within seven days after the time established in the Contract Documents the amount certified by the Architect or awarded by a final dispute resolution order, then the Contractor may, upon seven additional days' written notice to the Owner and Architect, stop the Work until payment of the amount owing has been received. The Contract Time shall be extended appropriately and the Contract Sum shall be increased, in accordance with the provisions of Section 7.3.3, by the amount of the Contractor's reasonable costs of shut-down, delay and start-up, plus interest as provided for in the Contract Documents.

If the Contractor does not achieve final completion within thirty days after Substantial Completion or the timeframe agreed to by the parties in the Certificate of Substantial Completion, whichever is greater, the Contractor shall be responsible for any additional Architectural fees resulting from the delay.

Department of Health and Environmental Control, the U.S. Environmental Protection Agency, and the U.S. Nuclear Regulatory Commission.

**3.76** *Insert the following at the end of Section 10.3.2:* 

In the absence of agreement, the Architect will make an interim determination regarding any delay or impact on the Contractor's additional costs. ### 13.12 ILLEGAL IMMIGRATION

Contractor certifies and agrees that it will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina Code of Laws and agrees to provide to the State upon request any documentation required to establish either: (a) that Title 8, Chapter 14 is inapplicable both to Contractor and its subcontractors or subsubcontractors; or (b) that Contractor and its subcontractors or sub-subcontractors are in compliance with Title 8, Chapter 14. Pursuant to Section 8-14-60, "A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony, and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both." Contractor agrees to include in any contracts with its subcontractors language requiring its subcontractors to (a) comply with the applicable requirements of Title 8, Chapter 14, and (b) include in their contracts with the sub-subcontractors language requiring the sub-subcontractors to comply with the applicable requirements of Title 8, Chapter 14. The Contractor certifies to the Owner that Contractor will provide a Drug-Free Workplace, as required by Title 44, Chapter 107 of the South Carolina Code of Laws, as amended.

### 13.15 FALSE CLAIMS

According to the S.C. Code of Laws § 16-13-240, "a person who by false pretense or representation obtains the signature of a person to a written instrument or obtains from another person any chattel, money, valuable security, or other property, real or personal, with intent to cheat and defraud a person of that property is guilty" of a crime.

### 13.16 NON-INDEMNIFICATION:

Any term or condition is void to the extent it requires the State to indemnify anyone. It is unlawful for a person charged with disbursements of state funds appropriated by the General Assembly to exceed the amounts and purposes stated in the appropriations. ### 15.1.2 NOTICE OF CLAIMS

Claims by either the Owner or Contractor must be initiated by written notice to the other party and to the Architect. Such notice shall include sufficient information to advise the Architect and other party of the circumstances giving rise to the claim, the specific contractual adjustment or relief requested and the basis of such request. Claims by either party arising prior to the date final payment is due must be initiated within 21 days after occurrence of the event giving rise to such Claim or within 21 days after the claimant first recognizes the condition giving rise to the Claim, whichever is later except as stated for adverse weather days in Section 15.1.5.2. By failing to give written notice of a Claim within the time required by this Section, a party expressly waives its claim.

#### 15.1.3 CONTINUING CONTRACT PERFORMANCE

Pending final resolution of a Claim, including any administrative review allowed under Section 15.6, except as otherwise agreed in writing or as provided in Section 9.7 and Article 14, the Contractor shall proceed diligently with performance of the Contract and the Owner shall continue to make payments in accordance with the Contract Documents. The Architect will issue Certificates for Payment in accordance with the initial decisions and determinations of the Architect.

Claims for an increase in the Contract Time shall be based on one additional calendar day for each full calendar day that the Contractor is prevented from working.

Adverse weather conditions not claimed within the time limits of this Subparagraph shall be considered to be waived by the Contractor. Claims will not be allowed for adverse weather days that occur after the scheduled (original or adjusted) date of Substantial Completion.

### 15.1.6 CLAIMS FOR LISTED DAMAGES

Notwithstanding any other provision of the Contract Documents, including Section 1.2.1, but subject to a duty of good faith and fair dealing, the Contractor and Owner waive Claims against each other for listed damages arising out of or relating to this Contract.

- **15.1.6.1** For the Owner, listed damages are (i) lost revenue and profit, (ii) losses resulting from injury to business or reputation, (iii) additional or escalated overhead and administration expenses, (iv) additional financing costs, (v) costs suffered by a third party unable to commence work, (vi) attorney's fees, (vii) any interest, except to the extent allowed by Section 13.6 (Interest), (viii) lost revenue and profit for lost use of the property, (ix) costs resulting from lost productivity or efficiency.
- **15.1.6.2** For the Contractor, listed damages are (i) lost revenue and profit, (ii) losses resulting from injury to business or reputation, (iii) additional or escalated overhead and administration expenses, (iv) additional financing costs, (v) attorney's fees, (vi) any interest, except to the extent allowed by Section 13.6 (Interest); (vii) unamortized equipment costs; and, (viii) losses incurred by subcontractors for the types of damages the Contractor has waive as against the Owner. Without limitation, this mutual waiver is applicable to all damages due to either party's termination in accordance with Article 14. Nothing contained in this Section shall be deemed to preclude an award of liquidated damages, when applicable, in accordance with the requirements of the Contract Documents. This mutual waiver is not applicable to amounts due or obligations under Section 3.18 (Indemnification).
- **3.129** Add the following Section 15.1.7:

#### 15.1.7 WAIVER OF CLAIMS AGAINST THE ARCHITECT

Notwithstanding any other provision of the Contract Documents, including Section 1.2.1, but subject to a duty of good faith and fair dealing, the Contractor waives all claims against the Architect and any other design professionals who provide design and/or project management services to the Owner, either directly or as independent contractors or subcontractors to the Architect, for listed damages arising out of or relating to this Contract. The listed damages are (i) lost revenue and profit, (ii) losses resulting from injury to business or reputation, (iii) additional or escalated overhead and administration expenses, (iv) additional financing costs, (v)

## 15.5 CLAIM AND DISPUTES - DUTY OF COOPERATION, NOTICE, AND ARCHITECTS INITIAL DECISION

- **15.5.1** Contractor and Owner are fully committed to working with each other throughout the Project to avoid or minimize claims. To further this goal, Contractor and Owner agree to communicate regularly with each other and the Architect at all times notifying one another as soon as reasonably possible of any issue that if not addressed may cause loss, delay, and/or disruption of the Work. If claims do arise, Contractor and Owner each commit to resolving such claims in an amicable, professional, and expeditious manner to avoid unnecessary losses, delays, and disruptions to the Work.
- **15.5.2** Claims shall first be referred to the Architect for initial decision. An initial decision shall be required as a condition precedent to resolution pursuant to Section 15.6 of any Claim arising prior to the date of final payment, unless 30 days have passed after the Claim has been referred to the Architect with no decision having been rendered, or after all the Architect's requests for additional supporting data have been answered, whichever is later. The Architect will not address claims between the Contractor and persons or entities other than the Owner.
- **15.5.3** The Architect will review Claims and within ten days of the receipt of a Claim (1) request additional supporting data from the claimant or a response with supporting data from the other party or (2) render an initial decision in accordance with Section 15.5.5.
- **15.5.4** If the Architect requests a party to provide a response to a Claim or to furnish additional supporting data, such party shall respond, within ten days after receipt of such request, and shall either (1) provide a response on the requested supporting data, (2) advise the Architect when the response or supporting data will be furnished or (3) advise the Architect that all supporting data has already been provided. Upon receipt of the response or supporting data, the Architect will render an initial decision in accordance with Section 15.5.5.
- 15.5.5 The Architect will render an initial decision in writing; (1) stating the reasons therefor; and (2) notifying the parties of any change in the Contract Sum or Contract Time or both. The Architect will deliver the initial decision to the parties within two weeks of receipt of any response or supporting data requested pursuant to Section 16.4, or within such longer period as may be mutually agreeable to the parties. If the parties accept the initial decision, the Architect shall prepare a Change Order with appropriate supporting documentation for the review and approval of the parties and the Office of State Engineer. If either the Contractor, Owner, or both, disagree with the initial decision, the Contractor and Owner shall proceed with dispute resolution in accordance with the provisions of Section 15.6.
- **15.5.6** In the event of a Claim against the Contractor, the Owner may, but is not obligated to, notify the surety, if any, of the nature and amount of the Claim. If the Claim relates to a possibility of a Contractor's default, the Owner may, but is not obligated to, notify the surety and request the surety's assistance in resolving the controversy.

### 15.6 DISPUTE RESOLUTION

**15.6.1** If a claim is not resolved pursuant to Section 15.5 to the satisfaction of either party, both parties shall attempt to resolve the dispute at the field level through discussions between Contractor's Representative and Owner's Representative. If a dispute cannot be resolved through Contractor's Representative and Owner's Representative, then the Contractor's Senior Representative and the Owner's Senior Representative, upon the request of either party, shall meet as soon as conveniently possible, but in no case later than twenty-one days after such a request is made, to attempt to resolve such dispute. Prior to any meetings between the Senior Representatives, the parties will exchange relevant information that will assist the parties in resolving their dispute. The meetings required by this Section are a condition precedent to resolution pursuant to Section 15.6.2.

**15.6.2** If after meeting in accordance with the provisions of Section 15.6.1, the Senior Representatives determine that the dispute cannot be resolved on terms satisfactory to both the Contractor and the Owner, then either party may submit the dispute by written request to South Carolina's Chief Procurement Officer for Construction (CPOC). Except as otherwise provided in Article 15, all claims, claims, or controversies relating to the Contract shall be resolved exclusively by the appropriate Chief Procurement Officer in accordance with Title 11, Chapter 35, Article 17 of the South Carolina Code of Laws, or in the absence of jurisdiction, only in the Court of Common Pleas for, or in the absence of jurisdiction a federal court located in, Richland County, State of South Carolina. Contractor agrees that any act by the State regarding the Contract is not a waiver of either the State's sovereign immunity or the State's immunity under the Eleventh Amendment of the United State's Constitution.

**15.6.3** If any party seeks resolution to a dispute pursuant to Section 15.6.2, the parties shall participate in non-binding mediation to resolve the claim. If the claim is governed by Title 11, Chapter 35, Article 17 of the South Carolina Code of Laws as amended and the amount in controversy is \$100,000.00 or less, the CPOC shall appoint a mediator, otherwise, the mediation shall be conducted by an impartial mediator selected by mutual agreement of the parties, or if the parties cannot so agree, a mediator designated by the American Arbitration Association ("AAA") pursuant to its Construction Industry Mediation Rules. The mediation will be governed by and conducted pursuant to a mediation agreement negotiated by the parties or, if the parties cannot so agree, by procedures established by the mediator.

**15.6.4** Without relieving any party from the other requirements of Sections 15.5 and 15.6, either party may initiate proceedings in the appropriate forum prior to initiating or completing the procedures required by Sections 15.5 and 15.6 if such action is necessary to preserve a claim by avoiding the application of any applicable statutory period of limitation or repose.

#### 15.6.5 SERVICE OF PROCESS

Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any claims, claims, or controversies relating to the Contract; for any court action in connection therewith; or for the entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided for the Contractor's Senior Representative or by personal service or by any other manner that is permitted by law, in or outside South Carolina. Notice by certified mail is deemed duly given upon deposit in the United States mail.

## USC SUPPLEMENTAL GENERAL CONDITIONS FOR CONSTRUCTION PROJECTS

- 1. Contractor's employees shall take all reasonable means not to interrupt the flow of student traffic in building corridors, lobbies and stairs. All necessary and reasonable safety precautions shall be taken to prevent injury to building occupants while transporting materials and equipment through the building to the work area. Providing safe, accessible, plywood pedestrian ways around construction may be required if a suitable alternative route is not available.
- 2. Fraternization between Contractor's employees and USC students, faculty or staff is strictly prohibited-zero tolerance!
- 3. USC will not tolerate rude, abusive or degrading behavior on the job site. Heckling and cat-calling directed toward students, faculty or staff or any other person on USC property is strictly prohibited. Any contractor whose employees violate this requirement will be assessed a fine of up to \$500 per violation.
- 4. Contractor's employees must adhere to the University's policy of maintaining a drug-free and smoke-free/tobacco free workplace.
- 5. Contractor must sign a Contractor Key Receipt/Return form before any keys are issued. Keys must be returned immediately upon the completion of the work. The Contractor will bear the cost of any re-keying necessary due to the loss of or failure to return keys.
- 6. A welding permit must be issued by the University Fire Marshall before any welding can begin inside a building. Project Manager will coordinate.
- 7. Contractor must notify the University immediately upon the discovery of suspect material such as those potentially containing asbestos or other such hazardous materials. These materials **must not** be disturbed until approved by the USC Project Manager.
- 8. At the beginning of the project, the USC Project Manager will establish the Contractor=s lay-down area. This area will also be used for the Contractor=s work vehicles. No personal vehicles will be allowed in this area, or in any areas surrounding the construction site that are not regular or authorized parking lots. Personal vehicles must be parked in the perimeter parking lots. Parking permits can be obtained at the USC Parking Office located in the Pendleton Street parking garage. The lay down area will be clearly identified to the contractor by the PM, with a sketch or drawing provided to Parking. In turn, the contractor will mark off this area with a sign containing the project name, PM name, Contractor name and contact number, and end date. Where this area is subject to foot traffic, protective barriers will be provided as specified by the PM. The area will be maintained in a neat and orderly fashion. Vehicles parked in the lay down area (or designated parking areas) will be clearly marked or display a CPC furnished placard for identification.

- 9. Contractor will be responsible for providing its own temporary toilet facilities, unless prior arrangements are made with the USC Project Manager.
- 10. Use of USC communications facilities (telephones, computers, etc.) by the Contractor is prohibited, unless prior arrangements are made with the USC Project Manager.
- 11. For all projects over \$100,000, including IDC's, an SE-395, Contractor Performance Evaluation, will be completed by the USC Project Manager and reviewed with the GC at the beginning of the project and a copy given to the GC. At the end of the project the form will be completed and a Construction Performance rating will be established.
- 12. Contractor is responsible for removal of all debris from the site, and is required to provide the necessary dumpsters which will be emptied at least \_\_\_\_\_1 \_\_ times per week. Construction waste must not be placed in University dumpsters. THE CONSTRUCTION SITE MUST BE THOROUGHLY CLEANED WITH ALL TRASH PICKED UP AND PROPERLY DISPOSED OF ON A DAILY BASIS AND THE SITE MUST BE LEFT IN A SAFE AND SANITARY CONDITION EACH DAY. THE UNIVERSITY WILL INSPECT JOB SITES REGULARLY AND WILL FINE ANY CONTRACTOR FOUND TO BE IN VIOLATION OF THIS REQUIREMENT AN AMOUNT OF UP TO \$1,000 PER VIOLATION.
- 13. Contractor must provide all O&M manuals, as-built drawings, and training of USC personnel on new equipment, controls, etc. prior to Substantial Completion. Final payment will not be made until this is completed.
- 14. The contractor will comply with all regulations set forth by OSHA and SCDHEC. Contractor must also adhere to USC's internal policies and procedures (available by request). As requested, the contractor will submit all Safety Programs and Certificates of Insurance to the University for review.
- 15. Tree protection fencing is required to protect existing trees and other landscape features to be preserved within a construction area. The limits of this fence will be evaluated for each situation with the consultant, USC Arborist and USC Project Manager. The tree protection fence shall be 5' high chain link fence unless otherwise approved by USC Project Manager. No entry or materials storage will be allowed inside the tree protection zone. A 4" layer of mulch shall be placed over the tree protection area to maintain moisture in the root zone.
- 16. Where it is necessary to cross walks, tree root zones (i.e., under canopy) or lawns the following measures shall be taken: For single loads up to 9,000 lbs., a 3/4" minimum plywood base shall be placed over areas impacted. For single loads over 9,000 lbs., two layers of 3/4" plywood is required.
- 17. For projects requiring heavy loads to cross walks tree root zones or lawns. A construction entry road consisting of 10' X 16' oak logging mates on 12" coarse, chipped, hardwood base. Mulch and logging mats shall be supplemented throughout the project to keep matting structurally functional.

- 18. Any damage to existing landscaping (including lawn areas) will be remediated before final payment is made.
- 19. Orange safety fence to be provided by the contractor. (USC Arborist, Kevin Curtis may be contacted at 777-0033 or 315-0319)

### **Campus Vehicle Expectations**

- 1. All motorized vehicles on the University campus are expected to travel and park on roadways and/or in parking stalls.
- 2. All motorized vehicle traffic on USC walkways must first receive the Landscape Manager=s authorization. Violators may be subject to fines and penalties.
- 3. All motorized vehicles that leak or drip liquids are prohibited from traveling or parking on walks or landscaped areas.
- 4. Contractors, vendors, and delivery personnel are required to obtain prior parking authorization before parking in a designated space. Violators may be subject to fines and/or penalties. See Item 10 below.
- 5. Drivers of equipment or motor vehicles that damage university hardscape or landscape will be held personally responsible for damages and restoration expense.
- 6. Vehicle drivers who park on landscape or drives must be able to produce written evidence of need or emergency requiring parking on same.
- 7. All vehicles parked on landscape, hardscape, or in the process of service delivery, must display adequate safety devices, i.e. flashing lights, cones, signage, etc.
- 8. All drivers of equipment and vehicles will be respectful of University landscape, equipment, structures, fixtures and signage.
- 9. All incidents of property damage will be reported to Parking Services or the Work Management Center.
- 10. Parking on campus is restricted to spaces designated by Parking Services at the beginning of the project. Once the project manager and contractor agree on how many spaces are needed, the project manager will obtain a placard for each vehicle. This placard must be hung from the mirror of the vehicle, otherwise a ticket will be issued and these tickets cannot be "fixed". Parking spaces are restricted to work vehicles only; no personal vehicles.

### NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH THAT:

- 1. The Contractor and the Surety, jointly and severally, bind themselves, their heirs, executors, administrators, successors and assigns to the Agency for the full and faithful performance of the contract, which is incorporated herein by reference
- 2. If the Contractor performs the contract, the Surety and the Contractor have no obligation under this Bond, except to participate in conferences as provided in paragraph 3.1.
- 3. The Surety's obligation under this Bond shall arise after:
- **3.1** The Agency has notified the Contractor and the Surety at the address described in paragraph 10 below, that the Agency is considering declaring a Contractor Default and has requested and attempted to arrange a conference with the Contractor and the Surety to be held not later than 15 days after receipt of such notice to discuss methods of performing the Contract. If the Agency, the Contractor and the Surety agree, the Contractor shall be allowed a reasonable time to perform the Contract, but such an agreement shall not waive the Agency's right, if any, subsequently to declare a Contractor Default; or
- **3.2** The Agency has declared a Contractor Default and formally terminated the Contractor's right to complete the Contract.
- **4.** The Surety shall, within 15 days after receipt of notice of the Agency's declaration of a Contractor Default, and at the Surety's sole expense, take one of the following actions:
- **4.1** Arrange for the Contractor, with consent of the Agency, to perform and complete the Contract; or
- **4.2** Undertake to perform and complete the Contract itself, through its agents or through independent contractors; or
- **4.3** Obtain bids or negotiated proposals from qualified contractors acceptable to the Agency for a contract for performance and completion of the Contract, arrange for a contract to be prepared for execution by the Agency and the contractor selected with the Agency's concurrence, to be secured with performance and payment bonds executed by a qualified surety equivalent to the Bonds issued on the Contract, and pay to the Agency the amount of damages as described in paragraph 7 in excess of the Balance of the Contract Sum incurred by the Agency resulting from the Contractor Default; or
- **4.4** Waive its right to perform and complete, arrange for completion, or obtain a new contractor, and:
- **4.4.1** After investigation, determine the amount for which it may be liable to the Agency and, within 60 days of waiving its rights under this paragraph, tender payment thereof to the Agency; or
- **4.4.2** Deny liability in whole or in part and notify the Agency, citing the reasons therefore.
- **5.** Provided Surety has proceeded under paragraphs 4.1, 4.2, or 4.3, the Agency shall pay the Balance of the Contract Sum to either:
- **5.1** Surety in accordance with the terms of the Contract; or
- **5.2** Another contractor selected pursuant to paragraph 4.3 to perform the Contract.
- **5.3** The balance of the Contract Sum due either the Surety or another contractor shall be reduced by the amount of damages as described in paragraph 7.
- **6.** If the Surety does not proceed as provided in paragraph 4 with reasonable promptness, the Surety shall be deemed to be in default on this Bond 15 days after receipt of written notice

- from the Agency to the Surety demanding that the Surety perform its obligations under this Bond, and the Agency shall be entitled to enforce any remedy available to the Agency.
- **6.1** If the Surety proceeds as provided in paragraph 4.4, and the Agency refuses the payment tendered or the Surety has denied liability, in whole or in part, then without further notice the Agency shall be entitled to enforce any remedy available to the Agency.

- 7. After the Agency has terminated the Contractor's right to complete the Contract, and if the Surety elects to act under paragraph 4.1, 4.2, or 4.3 above, then the responsibilities of the Surety to the Agency shall be those of the Contractor under the Contract, and the responsibilities of the Agency to the Surety shall those of the Agency under the Contract. To a limit of the amount of this Bond, but subject to commitment by the Agency of the Balance of the Contract Sum to mitigation of costs and damages on the Contract, the Surety is obligated to the Agency without duplication for:
- **7.1** The responsibilities of the Contractor for correction of defective Work and completion of the Contract; and
- **7.2** Additional legal, design professional and delay costs resulting from the Contractor's Default, and resulting from the actions or failure to act of the Surety under paragraph 4; and
- **7.3** Damages awarded pursuant to the Dispute Resolution Provisions of the Contract. Surety may join in any Dispute Resolution proceeding brought under the Contract and shall be bound by the results thereof; and
- **7.4** Liquidated Damages, or if no Liquidated Damages are specified in the Contract, actual damages caused by delayed performance or non-performance of the Contractor.
- **8.** The Surety shall not be liable to the Agency or others for obligations of the Contractor that are unrelated to the Contract, and the Balance of the Contract Sum shall not be reduced or set-off on account of any such unrelated obligations. No right of action shall accrue on this Bond to any person or entity other than the Agency or its heirs, executors, administrators, or successors.
- **9.** The Surety hereby waives notice of any change, including changes of time, to the contract or to related subcontracts, purchase orders and other obligations.
- **10.** Notice to the Surety, the Agency or the Contractor shall be mailed or delivered to the address shown on the signature page. **11.** Definitions
- 11.1 Balance of the Contract Sum: The total amount payable by the Agency to the Contractor under the Contract after all proper adjustments have been made, including allowance to the Contractor of any amounts to be received by the Agency in settlement of insurance or other Claims for damages to which the Contractor is entitled, reduced by all valid and proper payments made to or on behalf of the Contractor under the Contract.
- **11.2** Contractor Default: Failure of the Contractor, which has neither been remedied nor waived, to perform the Contract or otherwise to comply with the terms of the Contract.

### **Labor and Material Payment Bond**

### NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH THAT:

- 1. The Contractor and the Surety, jointly and severally, bind themselves, their heirs, executors, administrators, successors and assigns to the Agency to pay for all labor, materials and equipment required for use in the performance of the Contract, which is incorporated herein by reference.
- 2. With respect to the Agency, this obligation shall be null and void if the Contractor:
- **2.1** Promptly makes payment, directly or indirectly, for all sums due Claimants; and
- **2.2** Defends, indemnifies and holds harmless the Agency from all claims, demands, liens or suits by any person or entity who furnished labor, materials or equipment for use in the performance of the Contract.
- 3. With respect to Claimants, this obligation shall be null and void if the Contractor promptly makes payment, directly or indirectly, for all sums due.
- **4.** With respect to Claimants, and subject to the provisions of Title 29, Chapter 5 and the provisions of §11-35-3030(2)(c) of the SC Code of Laws, as amended, the Surety's obligation under this Bond shall arise as follows:
- **4.1** Every person who has furnished labor, material or rental equipment to the Contractor or its subcontractors for the work specified in the Contract, and who has not been paid in full therefore before the expiration of a period of ninety (90) days after the date on which the last of the labor was done or performed by him or material or rental equipment was furnished or supplied by him for which such claim is made, shall have the right to sue on the payment bond for the amount, or the balance thereof, unpaid at the time of institution of such suit and to prosecute such action for the sum or sums justly due him.
- **4.2** A remote claimant shall have a right of action on the payment bond upon giving written notice by certified or registered mail to the Contractor within ninety (90) days from the date on which such person did or performed the last of the labor or furnished or supplied the last of the material or rental equipment upon which such claim is made.
- **4.3** Every suit instituted upon a payment bond shall be brought in a court of competent jurisdiction for the county or circuit in which the construction contract was to be performed, but no such suit shall be commenced after the expiration of o ne year after the day on which the last of the labor was performed or material or rental equipment was supplied by the person bringing suit.
- **5.** When the Claimant has satisfied the conditions of paragraph 4, the Surety shall promptly and at the Surety's expense take the following actions:
- **5.1** Send an answer to the Claimant, with a copy to the Agency, within sixty (60) days after receipt of the claim, stating the amounts that are undisputed and the basis for challenging any amounts that are disputed.
- **5.2** Pay or arrange for payment of any undisputed amounts.
- **5.3** The Surety's failure to discharge its obligations under this paragraph 5 shall not be deemed to constitute a waiver of defenses the Surety or Contractor may have or acquire as to a claim. However, if the Surety fails to discharge its obligations under this paragraph 5, the Surety shall indemnify the Claimant for the reasonable attorney's fees the Claimant incurs to recover any sums found to be due and owing to the

Claimant.

- **6.** Amounts owed by the Agency to the Contractor under the Contract shall be used for the performance of the Contract and to satisfy claims, if any, under any Performance Bond. By the Contractor furnishing and the Agency accepting this Bond, they agree that all funds earned by the contractor in the performance of the Contract are dedicated to satisfy obligations of the Contractor and the Surety under this Bond, subject to the Agency's prior right to use the funds for the completion of the Work.
- 7. The Surety shall not be liable to the Agency, Claimants or others for obligations of the Contractor that are unrelated to the Contract. The Agency shall not be liable for payment of any costs or expenses of any claimant under this bond, and shall have under this Bond no obligations to make payments to, give notices on behalf of, or otherwise have obligations to Claimants under this Bond.
- **8.** The Surety hereby waives notice of any change, including changes of time, to the Contract or to related Subcontracts, purchase orders and other obligations.
- 9. Notice to the Surety, the Agency or the Contractor shall be mailed or delivered to the addresses shown on the signature page. Actual receipt of notice by Surety, the Agency or the contractor, however accomplished, shall be sufficient compliance as of the date received at the address shown on the signature page.
- 10. By the Contractor furnishing and the Agency accepting this Bond, they agree that this Bond has been furnished to comply with the statutory requirements of the South Carolina Code of Laws, as amended, and further, that any provision in this Bond conflicting with said statutory requirements shall be deemed deleted herefrom and provisions conforming to such statutory or other legal requirement shall be deemed incorporated herein. The intent is that this Bond shall be construed as a statutory Bond and not as a common law bond.
- **11.** Upon request of any person or entity appearing to be a potential beneficiary of this bond, the Contractor shall promptly furnish a copy of this Bond or shall permit a copy to be made.
- 12. Any dispute, suit, action or proceeding arising out of or relating to this Bond shall be governed by the laws of the State of South Carolina.

The intent of this Bond shall be to include without limitation in the terms "labor, materials or equipment" that part of water, gas, power, light, heat, oil, gasoline, telephone service or rental equipment used in the Contract, architectural and engineering services required for performance of the Work of the Contractor and the Contractor's Subcontractors, and all other items for which a mechanic's lien might otherwise be asserted.
- **13.2** Remote Claimant: A person having a direct contractual relationship with a subcontractor of the Contractor or subcontractor, but no contractual relationship expressed or implied with the Contractor.
- 13.3 Contract: The agreement between the Agency and the

Contractor identified on the signature page, including all Contract Documents and changes thereto.

### 1.01. SUBMITTAL SCHEDULE

A. Include a submittal register listing all anticipated submittals, shop drawings, product data, and samples as defined in the Contract Documents and also include certificates, test data, schedules, and other submitted data required to demonstrate compliance with the Contract Documents.

### 1.02 SUBMITTAL DESCRIPTIONS

- A. Submit four copies of each of the following unless otherwise specified.
  - 1. SD-01 Manufacturer's Catalog Data
    - a. Data composed of catalog cuts, brochures, circulars, specifications and product data, and printed information in sufficient details and scope to verify compliance with requirements of the Contract Documents. Reviews and submittals shall be as specified for shop drawings. Clearly mark product data to identify the applicable products or models proposed for use. Clearly identify items where options or modifications are required by the Contract Documents.

### 2. SD-02 Drawings/Procedures/Schedules

a. Shop Drawings: Submit shop drawings in the form of one reproducible print and three blue line or black line prints. Drawings size shall not exceed 24 inches by 30 inches. After review, the Engineer will return the reproducible print with any applicable notations and an appropriate stamp. If corrections are to be made, the original drawings shall be revised and a new reproducible and three prints submitted, and repeated until so approved. Upon approval, a reproducible marked as such will be returned to the Contractor. A minimum clear space, 4 inches high x 6 inches long, shall be left on the reproducible print above or to the left of the title block or application of the approval stamp. The contractor shall be responsible for the prints required for the work, and these prints shall be from the final reproducible bearing the final stamp of the Engineer.

### SD-03 Certificates

a. Certificates signed by responsible officials of a manufacturer of a project, system, or material attesting that the product, system, or material meet specified requirements. Submit certificates certifying the method of installation or quality of installation at the completion of the work. The submittal must be dated after the award of this contract, name the project

and list the specific requirements, which it is intended to address.

### 4. SD-04 Samples

- a. Samples, including both fabricated and un-fabricated physical examples of materials, products, and units of work as complete units or as portions of units of work.
- b. Submit samples of sufficient size and quantity to illustrate clearly the functional characteristics of the product with integrally related parts and attachment devices. Approved samples are the standard by which the finished work will be evaluated. Furnish one sample for each required submittal unless otherwise specified in the technical specifications. In general, deliver samples to the office of the Engineer unless the Engineer requests delivery to the Owner or the building site. Full-size usable samples will be returned to the Contractor and approved samples may be used as part of the work unless they are specified otherwise in the technical specifications.

### 5. SD-05 Warranty Forms

a. Prior to installation, submit warranty forms complete in every respect, except for authorized signature(s) and date of commencement.

### 1.03 CONTRACTOR PREPARATION

### A. Certification:

- 1. Contractor submittals shall be reviewed by the Contractor prior to submittal to the Engineer and shall include the following certification:
  - a. "I hereby certify that the material(s), equipment, and/or article(s) shown and marked in this submittal and proposed to be incorporated into the Work is (are) in strict conformance with the Contract Documents, can be installed in the allocated spaces, and comprises(s) no variation thereto, unless specifically noted otherwise."
- 2. Contractor Review and Coordination: Before submitting a show drawing or related material to the Engineer, the Contractor shall:
  - a. Review each such submission for conformance with the Contractor's means, method techniques, sequences and operations of construction, and safety precautions and programs incidental thereto, all of which are the sole responsibility of the Contractor.
  - b. Review and coordinate each such submission with other related or affected work.

- c. Approve each such submission before submitting same; and
- d. Provide the required Contractor's certification as specified in Paragraph A1a Certification, above.
- 3. By approving a submittal, the Contractor thereby warrants and represents that he has determined and verified applicable field measurements, field construction criteria, materials, catalog numbers and similar data, and has checked and coordinated the submittal with the requirements of the Work and for conformance with the Contract Documents. Submittals submitted without the required certification and coordination will be returned to the Contractor without review. Delays in construction because of late submission or resubmission of required submittals shall be the sole responsibility of the Contractor.
- 4. Deviations: If a submittal deviates from the drawings and project manual because of standard shop practice, substitutions (approved in accordance with the General Conditions as amended), or any other reason advise Engineer via a separate written instrument. Otherwise, the Contractor will not be relieved of the responsibility for executing the Work in accordance with the Contract Documents even though such submittals may have been approved.
- 5. Extent of Submittals: Submit only submittals required by the Contract Documents. The Engineer reserves the right to refrain from reviewing other submittals.
  - a. Do not include items from more than one specification section per submittal.
  - b. Contractor may require additional documentation from subcontractors or suppliers for his own use at no additional cost to the Owner. Such documentation shall not be submitted for review without prior written consent from the Engineer.
  - c. Submit only complete specifications sections for review; no partial submittals will be accepted. Incomplete specifications sections will be returned without review by the Engineer.

## 1.04 FORM OF SUBMITTAL

A. Submit letter of transmittal in duplicate with each submission listing the contents of the submission and identifying each items by reference to specifications section or drawing. Clearly label shop drawings with the name of the project and other necessary information. Bound product data and other similar material that cannot be so labeled conveniently in suitable covers bearing the identifying data. Distribution of submittals by Engineer will be as specified in Paragraph "Owner's Representative Procedures." Additional copies, as required, shall be marked by the Contractor for his use after submittals have been approved.

#### 1.05 TIME FOR REVIEW

A. The Contractor shall allow a minimum of ten (10) consecutive working days (i.e. Monday through Friday, excluding holidays, and measured from the date of receipt of the Contractor's submittal) for the Engineer's review of each submittal. ## 1.06 RESUBMISSION

- A. Change or correct submittals as required by the Engineer and resubmit until approved. Indicate any changes which have been made other than those requested by the Engineer.
- B. Use the same transmittal procedure as outlined above.

## 1.07 OWNER'S REPRESENTATIVE'S PROCEDURES

- A. Owner's Representative's Review: Submittals will be reviewed with reasonable promptness.

  - 2. One copy of all submittals to the Owner's Representative.

# B. Changes After Approval

1. Make no change in a submittal marked "Reviewed" or "Furnish as Corrected" without obtaining the prior written consent of the Engineer. If such written consent is obtained, revise the submittal to show fully the altered parts of the work and resubmit according to the procedures specified herein. State on resubmittal that the work shown supersedes and voids identified parts of the same work previously shown. Give full identification on the drawings previously approved by the Engineer and the date of such action.

#### 1.09 PROCEEDING WITHOUT APPROVAL

A. No submittal may be used in the shop or on the work, except in accordance with the

foregoing paragraphs. Proceeding with any construction and ordering or fabricating materials before all relevant drawings have been "Reviewed" or marked "Furnish as Corrected" shall be done at the Contractor's sole risk.

Arrange for timely pickups from the site or deliveries to recycling facility in order to prevent contamination of recyclable materials.
- F. Reuse of Materials ON-Site: Set aside, sort, and protect separated products in preparation for reuse.
- G. Salvage: Set aside, sort, and protect products to be salvaged for reuse off-site.
- H. Clean site daily to remove trash and debris.

## PART 1 - GENERAL

#### 1.1 RELATED DOCUMENTS:

- A. Drawings and General Provisions of Contract, including General and Supplementary Conditions and Division-1 Specification sections, apply to work of this section.
- B. This section is a Division-15 Basic Materials and Methods Section, and a part of each Division-15 section making reference to mechanical related work specified herein.

## 1.2 SUMMARY OF MECHANICAL WORK:

- A. Drawings: Refer to the HVAC-Series drawings for graphic representations, schedules and notations showing mechanical work.
- B. Specifications: Refer to Division-15 sections for the primary technical specifications of mechanical work.
- C. General Outline: The facilities and systems of the mechanical work can be described (but not by way of limitation) as follows: Replacement of existing air handling unit serving main gymnasium as well as installation of new condensing boiler.

#### 1.3 COORDINATION OF MECHANICAL WORK:

- A. GENERAL: Refer to the Division 1 sections for general coordination requirements applicable to the entire work. It is recognized that the contract documents are diagrammatic in showing certain physical relationships which must be established within the mechanical work, and in its interface with other work including utilities and electrical work, and that such establishment is the exclusive responsibility of the Contractor.
- B. Coordination Drawings: For locations where several elements of mechanical (or combined mechanical and electrical) work must be sequenced and positioned with precision in order to fit into the available space, prepare coordination drawings (shop drawings) showing the actual physical dimensions (at accurate scale) required for the installation. Prepare and submit coordination drawings prior to purchase-fabrication-installation of any of the elements involved in the coordination.
- C. The Contractor shall be responsible for coordinating with all other divisions and if any item called for in another division requires work by the Contractor in this division he shall be required to furnish it at his cost whether it was specifically called for in this division or not.

# 1.4 QUALITY ASSURANCE, STANDARDS AND SYMBOLS:

A. General: Refer to Division 1 sections for general administrative/procedural requirements related to compliance with codes and standards. Specifically, for the mechanical work (in addition to standards specified in individual work sections), the

following standards are imposed, as applicable to the work in each instance:

- 1. International Building Code (IBC, 2012 Edition)
- 2. International Energy Conservation Code (IECC), 2009 Edition
- 3. International Mechanical Code (IMC), 2012 Edition
- 4. South Carolina Department of Health & Environmental Control
- 5. National Electrical Code, NFPA 70
- B. Secure and pay for all costs related to permits, governmental fees, license, cost necessary for the proper execution and completion of the work, which are applicable at the time the bids are received.

# 1.5 ELECTRICAL CODE LABELING REQUIREMENTS:

A. All electrically powered equipment to be UL labeled or labeled by similar testing agency or shall meet International Building Code for Alternate Material and Methods in lieu of labels.

#### 1.6 SUBMITTALS:

A. General: Refer to Division 1 sections for general requirements concerning work-related submittals (refer to other Division 1 sections for administrative submittals). For mechanical work, the following quantities are required for each category of submittal (in addition to the quantities specified in Division 1), unless otherwise indicated in individual work sections (quantity does not include copies required by governing authorities, or by Contractor for its own purposes):

6 sets, including 3 for maintenance manuals.

- B. Engineer will review Contractor's shop drawings and related submittals with respect to the ability of the detailed work, when complete, to be a properly functioning integral element of the overall system designed by the Engineer.
- C. Before submitting a shop drawing or any related material to the Engineer, the Contractor, and his Subcontractor (if any) shall: review each such submission for conformance with the means, methods, dimensional space limitations, techniques, sequences, operations of construction, safety precautions, and programs incidental thereto, all of which are the sole responsibility of the Contractor; approve each such submission before submitting it; and so stamp each such submission before submitting it. The Engineer shall assume that no shop drawing or related submittal comprises a variation unless the Contractor and his Subcontractor (if any) advises the Engineer otherwise via a written instrument which is acknowledged by the Engineer in writing. The shop drawings and related material (if any) called for are indicated below. In the event that the Engineer will require more than ten (10) working days to perform review, the Engineer shall so notify the Contractor.
- D. The Engineer shall return shop drawings and related materials with comments provided that each submission has been called for and is stamped by the Contractor and his Subcontractor (if any) as indicated above. The Engineer shall return without comment material not called for or which has not been approved by the Contractor and his Subcontractor (if any).

- E. Product Data Required: (if not owner furnished)
  - 1. Air Handling Unit
  - 2. Boiler
  - 3. Piping Accessories
  - 4. Mechanical Insulation
  - Valves
  - 6. Piping
- F. Certifications: 3 copies.
- G. Test Reports: 3 copies.
- H. Warranties (Guarantees): 6 copies, including 3 for maintenance manuals.
- I. Maintenance Manuals: 3 complete sets with individual sets of this data bound in 10-1/2 x 11-1/2 loose-leaf 3-ring binders, 1-1/2", 2", or 3" ring size, with rigid permanent vinyl covered back and front. Separators with index tabs and loose-leaf sheet protectors shall be provided. One set shall have all sheets individually encased in clear plastic document protectors.

Each set shall include the following data:

- 1. Valve Directory indicating valve number, size, manufacturer, location, function, and normal position. Valve tag numbers shall be as specified.
- 2. Mechanical Equipment: Show the following information for all mechanical equipment:

- 4. Maintenance Instruction: A typewritten form of instructions for maintenance of the systems, in itemized form and with time schedule for maintenance

work, shall be furnished. The instructions shall list each item of mechanical equipment requiring inspection, lubrication or service, and describe the performance of such maintenance. The list shall include the type of bearings for each piece of equipment, the type of frequency of lubrication required. The operating personnel shall be instructed in the care of the system in accordance with the typewritten instructions.

## 1.7 PRODUCTS, MECHANICAL WORK:

1. All control wiring (120V and less) to be complete to all motorized equipment and control devices listed in this specification and shown on the mechanical drawings shall be done under Division 15. The Contractor shall refer to Electrical plans and specifications to determine the source of electrical energy for the various control circuits. All wiring shall be in conduit, shall conform with Division 16 of these specification, all local codes, the National Electrical Code, and shall be installed by an approved licensed Electrical Contractor. Wiring diagrams indicating wire sizes and conduit runs for all electrical work that is required to be installed under this contract shall be submitted to the Engineer for prior approval before work is begun. Upon completion of the work, the wiring diagrams shall be revised to incorporate any additions or corrections and two copies of the "as installed" diagrams shall be furnished to the owner and one to the Engineer on reproducible paper or electronic media.

#### B. MOTORS:

- 1. Motors for equipment shall be of approved manufacture and of electrical, speed, and torque characteristics shown on the drawings. Motors 3/4 h.p. and above shall be wound for 3 phase, 60 cycle current; and 1/2 h.p. and under, 1 phase, 60 cycle current. Single phase motors shall be furnished with built-in overload and under-voltage protection. Nameplates for all motors shall be stamped for the current characteristics indicated on the drawings.
- 2. The use of shaded pole motors above 1/20 h.p. is prohibited.
- 3. Motors shall be premium high efficiency type (90% plus) and shall have capacity of not less than the horsepower noted on the drawings, and shall not exceed their full rated load when the driven equipment is operating at specified capacity under the most severe conditions likely to be encountered.
- 4. Motors shall have continuous-duty classification based on 40 deg. C. ambient temperature of reference.

- 5. All motors 1/2 h.p. and larger shall have grease lubricated ball bearings.
- 6. All motors, regardless of horsepower, shall have over-current protection installed either as an integral part of the motor, or within the motor controlling device in accordance with the National Electrical Code.

#### C. MOTOR STARTERS:

1. Motor starters not integral to supplied equipment shall be furnished and installed by the Electrical Contractor.

## 2.2 FOUNDATIONS AND MISCELLANEOUS STEEL SUPPORTS:

- A. Foundations: All concrete foundations anchor forms, or pads that may be necessary and required for the installation of equipment specified under this contract, shall be furnished and installed. This contractor to provide anchor bolts for the equipment foundations/pads.
- B. Miscellaneous Steel Supports: All supporting steel grillage, steel angles, channels, pipe or structural steel stands, and anchoring devices that may be required to adequately and rigidly support either piping, insulation, or equipment installed under this contract, shall be provided and installed.

#### 2.3 CHASES AND OPENINGS:

A. Lay out all chases and openings, required for the execution of this work. Provide thimbles in walls and partitions. Thimbles shall be standard weight galvanized steel pipe.

#### 2.4 MECHANICAL SYSTEM IDENTIFICATION:

- A. Piping System: All piping installed under this division of the specifications shall be identified as follows.
- B. Method of Marking: Colored stencil letters that designate the material being handled, shall be applied at not more than 40 foot intervals on straight pipe runs, at each terminal piece of equipment, adjacent to valves, and where pipe passes through walls and floors. Piping shall be marked at all the equipment connections.
- C. Identification: Lettering shall be stenciled in block letters, size as scheduled below. Letters on covered (insulated) pipe shall be stenciled on covering. On uncovered pipe, painted bands shall be wide enough (See Table 1) to accommodate required letters. Lettering shall be positioned so that it can be easily read by a man standing on the floor. Lettering on parallel groups of lines shall be neatly lined up. Surfaces of piping or insulation finished in dark colored shall be lettered in white; and that finished in light colors shall be lettered in black.
  - 1. All lines also shall be marked with arrows indicating the direction of flow.

## 2.5 ACCESSIBILITY:

A. No valves, controls, unions, etc., shall be placed in any pipe line at a location that will be inaccessible after the system is completed.

## 2.6 EXCAVATING FOR MECHANICAL WORK:

A. Not Applicable

## 2.7 PAINTING MECHANICAL WORK:

A. General: No painting shall be done under this division other than the sizing of the insulation jackets. Color stenciling of piping for identification, and touching up paint that is chipped or scratched from mechanical equipment supplied; and 2 coats of black rust preventative on all exposed support metal and hangers mounted outdoors and in mechanical rooms.

## 2.8 CLEANING, TESTING, ADJUSTMENTS, AND INSPECTIONS:

- A. Shall be accomplished in accordance with the following instructions and requirements. Provide temporary fill and drainage lines, wherever required, and connect them to the piping systems for these procedures and, finally, upon completion disconnect and remove these temporary lines.
- B. Cleaning and Oiling: All piping systems shall be thoroughly cleaned of grease, iron cuttings, welding slag, loose scale, and other refuse. Should any pipe, valves, strainers, other specialties, and equipment be stopped up by refuse, disconnect, clean, reconnect such pipe, equipment and material. All strainer baskets shall be removed, cleaned, and replaced.
- C. Exterior surfaces of piping, materials, or equipment that is to be painted or insulated shall be cleaned to remove lint, grease, and oil.
- D. All components of the mechanical systems shall be cleaned on outside of dust, trash, paint, and masonry dropping, and left in first class condition. Belt drives shall be adjusted for proper tension and sheaves aligned. All motor and equipment bearings shall be lubricated as recommended by the individual manufacturer and oil reservoir shall be left full.

### 2.9 TESTS

- A. All tests are to be made in the presence of the Owner's/Engineer's Field Representative.
  - 1. Water Piping shall be hydrostatically tested with water pressure of not less than 150 psi. Care shall be taken to avoid putting excessive pressures on mechanical seals, accessories, specialties, safety devices, chillers, pumps, etc. Water system shall be filled and all air vented at least 24 hours before the actual test pressure is applied. Test pressure shall be applied, if practical, when water and average ambient temperatures are approximately equal and constant. Test pressure shall be maintained for not less than two (2) hours without appreciable drop after the force pump has been disconnected. Leaks in screwed fittings shall be corrected by remaking the joints. Leaks in welded joints shall be cut out and rewelded. Contractor shall exercise care to not place excessive pressure on existing piping.
  - 2. Adjustments and balancing shall be coordinated with cleaning and testing to assure equipment performance as specified and shown on the drawings.

## 2.10 Equipment Start-up:

- A. The contractor to responsible for all equipment start-up. All equipment to be started by the contractor or under the contractor's direct supervision.
- B. The entire temperature control system shall be adjusted and placed in operation by the Controls Contractor.

## 2.11 Balancing:

A. Systems balancing tests and adjusting shall be performed by an independent NEBB certified agency contracted by the owner. Testing and balancing shall begin after the contractor informs the Owner that construction has progressed to the point of allowing testing and balancing. The HVAC contractor shall assist the balancing subcontractor during the balancing phases of work to expedite the work. Assistance to include, but not limited to, operation of system, installing valves that may have been omitted, etc.

#### 2.12 MECHANICAL WORK CLOSEOUT:

- A. General: Refer to the Division 1 sections for general closeout requirements. Maintain a daily log of operational data on mechanical equipment and systems through the closeout period.
- B. Record Drawings: For mechanical work, give special attention to the complete and accurate recording of piping, other concealed and non-accessible work, branching arrangement and valve location for piping systems, and work of change orders where not shown accurately by contract documents. Submit to Engineer at end of project one set of electronic media that show all recorded changes in the mechanical work.
- C. Closeout Equipment/Systems Operations: Sequence operations properly so that

work of project will not be damaged or endangered. Coordinate with seasonal requirements. Operate each item of equipment and each system in a test run of appropriate duration (with the Engineer present, and with the Owner's operating personnel present), to demonstrate sustained, satisfactory performance. Adjust and correct operations as required for proper performance. Clean and lubricate each system, and replace excessively worn parts and similar expendable items of the work.

- D. Operating Instructions: Conduct a one (1) day walk-through instruction seminar for the Owner's personnel to be involved in the continued operation and maintenance of mechanical equipment and systems. Explain the identification system, operational diagrams, emergency and alarm provisions, sequencing requirements, seasonal provisions, security, safety, efficiency and similar features of the systems.
- E. Turn-Over of Operations: At the time of substantial completion, turn over the prime responsibility for operation of the mechanical equipment and systems to the Owner's operating personnel. However, until the time of final acceptance, provide one full-time operating engineer, who is completely familiar with the work, to consult with and continue training the Owner's personnel.

## SECTION 15001 - DEMOLITION

#### PART 1 - GENERAL

#### 1.1. RELATED DOCUMENTS:

A. Drawings and General Provisions of Contract, including General and Supplementary Conditions and Division - 1 Specification sections, apply to work of this section.

## 1.2 DESCRIPTION OF WORK:

- A. The extent of demolition work shall be as indicated by the drawings and/or by the requirements of this section. In general, but not limited to, removal of existing air handling unit, along with ductwork and piping necessary for the installation of new air handling equipment.
- B. Demolition includes removal and disposal of demolished materials.

# 1.3 SUBMITTALS:

A. Schedule: Submit proposed methods and operations of demolition to Engineer for review prior to start of work. Include in schedule coordination for systems shut-off.

#### 1.4 JOB CONDITIONS:

- A. Occupancy: Building will be in operation during work and can be shut down at scheduled shut-down times.
- B. Condition of existing systems: The Owner assumes no responsibility for actual condition of items to be demolished. Conditions existing at time of inspection for bidding purposes will be maintained by Owner in so far as practicable.
- C. Protection: Ensure safe passage of persons in and around areas of demolition. Conduct operations to prevent injury to building, structure, other facilities, and persons.
- D. Damages: Promptly repair damages caused to facilities by demolition operations at no cost to Owner.
- E. Utility Services: Maintain existing utilities, keep in service, and protect against damage during demolition operations.

## PART 2 - PRODUCTS

Not applicable.

#### 3.1 DEMOLITION:

A. Demolition of all parts to be removed shall be done in a safe, orderly fashion taking care to avoid damage to parts which are to be left in place. All debris shall be removed from the premises as it is generated and shall not be allowed to accumulate. In the event the Contractor has any question about items to be removed, the Contractor to ask the Engineer.

## 3.2 DISPOSAL OF DEMOLISHED MATERIALS:

- A. General: Remove from site debris, rubbish, and other materials resulting from demolition operations.
- B. Removal: Transport demolished materials removed from premise and legally dispose of off site.

# SECTION 15060 - PIPE, TUBE, AND FITTINGS

#### PART 1 - GENERAL

## 1.1 RELATED DOCUMENTS:

- A. Drawings and General Provisions of Contract, including General and Supplementary Conditions and Division 1 specification sections, apply to work of this section.
- B. This section is a Division-15 Basic Materials and Methods Section, and a part of each Division-15 section making reference to pipe, tube and fittings specified herein.

## 1.2 DESCRIPTION:

A. Extent of pipe, tube, and fittings required by this section is indicated on drawings and/or specified in other Division-15 sections.

## 1.3 QUALITY ASSURANCE:

- A. Manufacturers: Firms regularly engaged in the manufacture of piping products of types and sizes required, and which have been in satisfactory use for not less than five (5) years in similar service.
- B. Welding: Qualify welding procedures, welders, and operators in accordance with ANSI B 31.1, paragraph 127.5, for shop and project site welding of piping work.
- C. Certify welding of piping work using the Standard Procedure Specifications by, and welders tested under supervision of, the National Certified Pipe Welding Bureau.
- D. Welding Certifications, Piping Work: Submit reports as required for welding certifications.

## 1.4 PRODUCT HANDLING:

- A. Provide factory-applied plastic end-caps on each length of pipe and tube. Maintain end-caps through shipping, storage and handling as required to prevent pipe-end damage and eliminate dirt and moisture from inside of pipe and tube.
- B. Where possible, store pipe and tube inside and protected from weather. Where necessary to store outside, elevate well above grade and enclose with durable, waterproof wrapping.
- C. Protect flanges and fittings from moisture and dirt by inside storage and enclosure, or by packaging with durable, waterproof wrapping.

#### PART 2 - PRODUCTS

#### 2.1 PIPING MATERIALS:

A. General: Provide domestic manufactured (U.S.A.) pipe and tube of the type, joint

type, grade, size and weight (wall thickness or Class) indicated for each service. Where type, grade or class is not indicated, provide proper selection as determined by Installer for installation requirements, and comply with governing regulations and industry standards.

# B. Steel Pipe:

- 1. Black Steel Pipe Schedule 40: ASTM A 53, A 106 or A 120; except comply with ASTM A 53 or A 106 where close coiling or bending is required.
- 2. Galvanized Steel Pipe Schedule 40: ASTM A 53 or A 120; except comply with ASTM A 53 where close coiling or bending is required.
- C. Copper Tube: ASTM B88, Type (L) hard-drawn temper; except as otherwise indicated.

#### 2.2 PIPE/TUBE FITTINGS:

A. General: Provide factory-fabricated fittings of the type, materials, grade, class and pressure rating indicated for each service and pipe size. Provide sizes and types matching pipe, tube, valve or equipment connection in each case. Where not otherwise indicated, comply with governing regulations and industry standards for selections, and with pipe manufacturer's recommendations where applicable.

# B. Fittings for Steel Pipe:

- 1. Steel Pipe Nipples: shall be of the same material and finish as the lines in which they are installed. No all-thread (close) nipples will be permitted.
- 2. Joints in steel pipe shall be in accordance with the following:
  - a. Screwed Piping: Joints shall be made with a non-hardening pipe joint compound applied to the male thread only.
  - b. Welded Piping Joints shall be made as specified within.
  - c. Gasket Material for flanged joints shall be similar in all respects to Style D,

150 lb. series, as produced by Flexitallic Gasket Company. Comparable material by Garlock, or Akron Metallic Gasket Company will be acceptable.

# C. Fittings for Black Steel Pipe shall be:

- 1. Screwed Fittings 150 lb. gray cast iron conforming to ANSI No. B16.4.
- 2. Flanged Fittings 150 Lb. gray cast iron conforming to ASTM No. A181.
- 3. Unions: 300 lb. malleable iron ground joints with brass-to-iron seats conforming to ANSI No. B16.3.
- 4. Flanges 150 lb. steel welding neck with raised face conforming to ASTM No. A181 except for matching flanges required at equipment and valves.

- Welding Fittings, including elbows, reducing ells, caps, straight tees, reducing tees, straight and reducing laterals and reducers shall be "standard weight", Grade B fittings, meeting ASTM A234, as produced by Crane, Tube-Turns, Taylor Forge or equal. Furnish long radius 90 degree elbows. Complete ASTM specification information shall be stamped on each fitting.
- 6. Standard Weight Weldolets or Threadolets may be used in lieu of welding tees only where the branch line is at least two pipe sizes smaller than main. Under no circumstances will it be permissible for one pipe line to be welded directly into another, regardless of size.
- 7. Manufacture. Welding fittings and flanges which have been machined, remarked, painted, or otherwise produced domestically from non-domestic forgings will not be acceptable. Fittings and flanges shall have the manufacturer's trademark permanently identified in accordance with MSS SP-25.
- D. Fittings for Galvanized Steel Pipe shall be:
  - 1. Screwed Fittings 150 lb. galvanized malleable iron banded type conforming to ANSI No. B16.3.
  - 2. Unions 150 lb. galvanized malleable iron, ground joint with brass-to-iron seat conforming to ANSI No. B16.3.
- E. Fittings for Copper Tube:
  - 1. Cast-Bronze Solder-Joint Fittings: ANSI No. B16.18.
  - 2. Wrought-Copper/Bronze Solder-Joint Fittings: ANSI No. B16.22.
  - 3. Copper-Tube Unions: Provide standard products recommended by the manufacturer for use in the service indicated.
  - 4. Soldered Joints in copper tubing shall be in accordance with the following:
    - a. Pipe Sizes 1-1/2" and Smaller Joints shall be made with a non-corrosive flux and solder composed of 95% tin and 5% antimony. Flux and solder to be lead free.
    - b. Pipe Sizes 2" and Larger Joints shall be made with a non-corrosive flux and either "Sil-Phos", "Easy-Flo" or "Phos-Copper". Flux and solder to be lead free.

# 2.3 MISCELLANEOUS PIPING MATERIALS/PRODUCTS:

A. Insulating (Dielectric) Unions: Provide standard products recommended by the manufacturer for use in the service indicated, and which effectively isolate ferrous from non-ferrous piping (electrical conductance), prevent galvanic action, and stop corrosion.

## PART 3 - EXECUTION

### 3.1 INSTALLATION:

- A. General: Install pipe, tube and fittings in accordance with recognized industry practices which will achieve permanently-leakproof piping systems, capable of performing each indicated service without piping failure. Install each run with a minimum of joints and couplings, but with adequate and accessible unions for disassembly and maintenance/replacement of valves and equipment. Reduce sizes (where indicated) by use of reducing fittings. Align piping accurately at connections, within 1/16" misalignment tolerance.
- B. Locate piping runs, except as otherwise indicated, vertically and horizontally (pitched to drain) and avoid diagonal runs wherever possible. Orient horizontal runs parallel with walls and column lines. Locate runs as shown or described by diagrams, details and notations, or, if not otherwise indicated, run piping in the shortest route which does not obstruct usable space or block access for servicing the building and its equipment. Hold piping close to walls, overhead construction, columns and other structural and permanent-enclosure elements of the building; limit clearance to 0.5" where furring is shown for enclosure or concealment of piping, but allow for insulation thickness, if any. Where possible, locate insulated piping for 1.0" clearance outside insulation.
- C. Electrical Equipment Spaces: Do not run piping over electrical or electronic equipment spaces and enclosures unless unavoidable. Install drip pan under piping that must be run over electrical spaces.
- D. Piping System Joints: Provide joints of the type indicated in each piping system.
- E. Thread pipe in accordance with ANSI No. B2.1; cut threads full and clean using sharp dies. Ream threaded ends to remove burrs and restore full inside diameter. Apply pipe joint compound, or pipe joint tape (Teflon) where recommended pipe/fitting manufacturer, on male threads at each joint and tighten joint to leave not more than 3 threads exposed.
- F. Solder copper tube and fitting joints where indicated, in accordance with recognized industry practice. Cut tube ends squarely, ream to full inside diameter, and clean outside of tube ends and inside of fittings. Apply solder flux to joint areas of both tubes and fittings. Insert tube full depth into fittings, and solder in a manner which will draw soldered full depth and circumference of joint. Wipe excess solder from joint before it hardens.
- G. Where pipe passes through walls, use galvanized iron sleeve with double layers of tar paper between pipe and sleeves to prevent electrolysis.
- H. Furnish and install dielectric couplings at all connections of dissimilar metals as required.
- I. Weld pipe joints in accordance with recognized industry practice and as follows:

- 1. Black steel pipe and fittings 2" & larger, except connections to equipment, shall have welded or flanged joints; pipe sizes 1-1/2" and below shall have screwed joints. Welded fittings shall be used in all Lines 2" and above.
- 2. The electric welding process shall be used and all welding must be done in accordance with the latest accepted standards.
- 3. All joints must be absolutely tight under test and operating conditions; defective joints must be remade. After completing a welded joint, it shall be mandatory for the welder to stamp or otherwise identify it as his work by number, letter or symbol assigned to him.
- 4. Weld pipe joints only when ambient temperature is above 0 degrees F where possible.
- 5. Bevel pipe ends at a 37.5 degree angle where possible, smooth rough cuts, and clean to remove slag, metal particles and dirt.
- 6. Install welding rings for buttwelded joints.
- 7. Use pipe clamps or tack-weld joints with 1.0" long welds; 4 welds for pipe sizes to 12".
- 8. Build up welds with a stringer-bead pass, followed by a hot pass, followed by a cover or filler pass. Eliminate valleys at center and edges of each weld. Weld by procedures which will ensure elimination of unsound or unfused metal, cracks, oxidation, blow-holes and non-metallic inclusions.
- 9. Do not weld-out piping system imperfections by tackwelding procedures; re-fabricate to comply with requirements.
- 10. Install forged branch-connection fittings wherever branch pipe is indicated, or install regular "T" fitting (at Contractor's option).
- 11. Spray paint all welded connections with black rust preventative paint.
- J. Flanged joints: Match flanges within piping system and at connections with valves and equipment. Clean flange faces and install gaskets. Tighten bolts to provide uniform compression of gaskets.
- K. Insulating (Dielectric) Unions: Comply with manufacturer's instructions for installing unions. Install unions in a manner which will prevent galvanic action and stop corrosion where the "joining of ferrous and non-ferrous piping" is required.

## 3.2 CLEANING, FLUSHING, INSPECTING:

A. General: Clean exterior surfaces of installed piping systems of superfluous materials, and prepare for application of specified coatings (if any). Clean piping as specified in Section 15000. Flush out piping systems with clean water before proceeding with required tests. Inspect each run of each system for completion of joints, supports and accessory items.

- B. Inspect pressure piping in accordance with procedures of ANSI No. B31.
- C. PIPING TESTS: See Section 15000.

#### SECTION 15080 - PIPING ACCESSORIES

#### PART 1 - GENERAL

#### 1.1 RELATED DOCUMENTS:

- A. Drawings and general provisions of Contract, including General and Supplementary Conditions and Division 1 specification sections, apply to work of this section.
- B. This section is a Division-15 Basic Materials and Methods Section, and is a part of each Division-15 section making reference to piping specialties specified herein.

#### 1.2 DESCRIPTION:

- A. Extent of piping accessories work is indicated by drawings and schedules, and by requirements of this section.
- B. In addition, the requirements of this section apply to piping work specified elsewhere in these specifications.

## 1.3 QUALITY ASSURANCE:

- A. Manufacturers: Firms regularly engaged in the manufacture of piping accessories of types and sizes required, whose products have been in satisfactory use in similar service for not less than 2 years.
- B. Installer: A firm with at least 3 years of successful installation experience on projects with piping accessories work similar to that required for this project.

#### 1.4 SUBMITTALS:

- A. Manufacturer's Data; Piping Accessories:
  - 1. Submit manufacturer's data on piping accessories.

## 1.5 PRODUCT DELIVERY, STORAGE AND HANDLING:

- A. Delivery piping accessories in factory-wrapped water-resistant fiber board type containers.
- B. Handle products carefully to avoid damage to components and to finish. Do not install damaged accessories; replace and remove from project site.
- C. Store accessories in a clean dry space; protect from dirt, fumes, water and construction traffic.

### PART 2 - PRODUCTS

#### 2.1 MANUFACTURED PRODUCTS:

- A. General: Provide factory-fabricated piping accessories recommended by the manufacturer for use in the service indicated. Provide products of the types and pressure-ratings indicated for each service or, if not indicated, provide proper selection as determined by the piping system installer to comply with installation requirements. Provide sizes and connections which properly mate with pipe, tube, valve and equipment connections. Where more than one type is indicated, selection is Installer's option.
- B. Gauges and Thermometers: Furnish and install gauges with 4-1/2" dials and thermometers with Digital Solar Readouts.
  - 1. Gauges. Dials shall be white with black figures and markings. A plexiglass dial with dual scale plate shall protect the face and pointer. Brass gauge cocks shall be furnished suitable for 250 psig SWP. Gauges shall be similar to Trerice 600 C with 1/2 of 1% accuracy. Gauges of comparable construction by Weiss, or Weksler, will be acceptable.
  - 2. Thermometers. Furnish Weiss Model DVS35 or DVBM25 Digital Vari-Angle thermometer with Hi-impact ABS case, 040/300 Deg. F range 3/8" LCD display, 1% accuracy, 1/10 Deg. Resolution, and recalibration with internal potentiometer. Thermometer to have 10 Lux rating with 10 second update. Ambient operation conditions shall be -30/140 Deg. F Sensor shall be passivated thermistor.

#### PART 3 - EXECUTION

## 3.1 INSTALLATION OF MANUFACTURED PRODUCTS:

- A. Flexible pump connectors: Install connectors on suction and discharge of all pumps (floor mounted and inline).
- B. Strainers: Install strainers at locations shown.
- C. Install escutcheon plates at pipe sleeves where piping is exposed to view in the building, on the exterior, and in the mechanical rooms.

## 3.2 INSTALLATION OF FABRICATED PRODUCTS:

A. Drip Pans: Provide and Install drip pans under each air handling unit (2 required). Drip pans to be fabricated from stainless steel sheet metal with watertight joints, and with edges turned up 2.5" and reinforced either by structural angles or by rolling over 0.25" steel rod; provided 1.25" flanged pipe for drain connections on side of pan edges. Drain pan metal gauge to be 20 gauge.

Pipe Sleeves: Install pipe sleeves of the types indicated where piping passes through walls, floors, ceilings, roofs and structural members of the work. Provide sleeves of adequate size, accurately centered on pipe runs. Size sleeves so that piping and insulation (if any) will have free

movement in the sleeve, including allowance for thermal expansion. Where insulation includes a vapor-barrier covering, provide sleeve with sufficient clearance for installation of vapor barrier, but not less than 2 pipe sizes larger than piping run. Install length of sleeve equal to thickness of construction penetrated, except extend floor sleeves 1 inch above floor finish. Provide temporary support of sleeves during placement of concrete and other work around sleeves, and provide temporary closure to prevent concrete and other materials from entering pipe sleeves. Install fire retardant material as discussed.

### SECTION 15090 - HANGERS, SUPPORTS AND ANCHORS

#### PART 1 - GENERAL

#### 1.1 RELATED DOCUMENTS:

- A. Drawings and general provisions of Contract, including General and Supplementary Conditions and Division 1 specification sections, apply to work of this section.
- B. This section is a Division-15 Basic Materials and Methods Section, and is a part of each Division-15 section making reference to hangers, supports and anchors specified herein.

#### 1.2 DESCRIPTION OF WORK:

A. Extent of hangers, supports and anchors required by this section is indicated on drawings and/or specified in other Division-15 sections.

## 1.3 QUALITY ASSURANCE:

- A. Manufacturer: A firm regularly engaged in the manufacture of hangers, supports and anchors, of types and sizes required, whose products have been in satisfactory use in similar service for not less than 5 years.
- B. Code Compliance: Comply with International Mechanical Code pertaining to product materials and installation of hangers, supports and anchors unless otherwise indicated in these specifications.
- C. UL and FM Compliance: Provide products which are Underwriters' Laboratories listed and Factory Mutual approved.
- D. MSS Standard Compliance: Provide products which comply with Manufacturers' Standardization Society's SP-69 for type required.
- E. Federal Specifications: WW-H-171D, for type indicated.

#### 1.4 SUBMITTALS:

- A. Manufacturer's Data; Hangers, Supports, and Anchors:
  - 1. Submit manufacturer's data on hangers, supports and anchors, including but not limited to, dimensions, sizes, loading capacities, and installation instructions.

## 1.5 PRODUCT DELIVERY, STORAGE AND HANDLING:

- A. Deliver products wrapped in factory-fabricated fiberboard type containers.
- B. Do not install damaged products; replace and return damaged units to manufacturer.

C. Store hangers, supports and anchors in a clean dry space. Store in original cartons and protect from dirt, physical damage and construction traffic.

#### PART 2 - PRODUCTS:

#### 2.1 HORIZONTAL-PIPING HANGERS AND SUPPORTS:

- A. General: Except as otherwise indicated, provide factory-fabricated horizontal piping hangers and supports of MSS type and size indicated, bolts (if any) and washers; comply with MSS SP-58 and manufacturer's published product information. Where MSS type or size is not indicated, provide proper selection as determined by Installer for installation requirements, and comply with MSS SP-69 and manufacturer's published product information; size hangers and supports properly for piping including insulation (if any). Provide copper-plated hangers and supports for uninsulated copper-piping systems.
  - 1. Adjustable Clevis Hanger: MSS Type 1, fabricated from steel. **Hanger to be large enough to be on outside of pipe insulation.**

#### 2.2 VERTICAL-PIPING CLAMPS:

- A. General: Except as otherwise indicated, provide factory-fabricated vertical piping clamps of MSS type and size indicated; comply with MSS SP-58 and manufacturer's published product information. Where MSS type or size is not indicated, provide proper selection as determined by Installer for installation requirements, and comply with MSS SP-69 and manufacturer's published product information. Size clamps properly for piping, including insulation (if any). Provide copper-plated clamps for copper-piping systems.
  - 1. Two-Bolt Riser Clamp: MSS type 8.

#### 2.3 HANGER-ROD ATTACHMENTS:

A. General: Except as otherwise indicated, provide factory-fabricated hanger-rod attachments of MSS type and size indicated; comply with MSS SP-58 and manufacturer's published product information. Where MSS type or size is not indicated, provide proper selection determined by Installer for installation requirements, and comply with MSS SP-69 and manufacturer's published product information. Size attachments properly for piping, including insulation (if any). Provide copper-plated hanger-rod attachments for uninsulated copper-piping systems.

#### 2.4 BUILDING ATTACHMENTS:

- A. General: Except as otherwise indicated, provide factory-fabricated building attachments of MSS type and load-rating indicated; comply with MSS SP-58 and manufacturer's published product information. Where MSS type or load-rating is not indicated, provide proper selection determined by Installer for installation requirements, and comply with MSS SP-69 and manufacturer's published product information. Size units properly for the piping loading.
  - 1. Concrete Inserts: MSS type 18, steel.

- 2. Steel C-Clamps: MSS type 23, steel.
- 3. Malleable Iron C-Clamps: MSS type 23, malleable iron.
- 4. Top-I-Beam Clamp: MSS type 25.
- 5. Beam Clamp/Eye-Nut: MSS type 28.
- 6. Wide-Flange Beam Clamp/Eye-Nut: MSS type 29.
- 7. SADDLES: MSS type 40

#### PART 3 - EXECUTION

#### 3.1 PREPARATION:

- A. Proceed with installation of hangers, supports and anchors only after required building structural work has been completed in areas where the work is to be installed. Correct inadequacies including (but not limited to) proper placement of inserts, anchors and other building structural attachments.
- B. Prior to installation of hangers, supports, and associated work, Installer shall meet at project site with Contractor, installer of each component of associated work, inspection and testing agency representatives (if any), installers of other work requiring coordination with work of this section and Engineer for purpose of reviewing material selections and procedures to be followed in performing the work in compliance with requirements specified.

#### 3.2 INSTALLATION OF BUILDING ATTACHMENTS:

A. Install building attachments at required locations within concrete or on structural steel for proper piping support. Space attachments within maximum piping span length indicated in MSS SP-69.

#### 3.3 INSTALLATION OF HANGERS AND SUPPORTS:

- A. General: Install hangers, supports, clamps and attachments to support piping properly from building structure; comply with MSS SP-69. Arrange for grouping of parallel runs of horizontal piping to be supported together on trapeze type hangers where possible. Install supports with maximum spacings complying with MSS SP-69. Where piping of various sizes is to be supported together by trapeze hangers, space hangers for smallest pipe size or install intermediate supports for smaller diameter pipe. Do not use wire or perforated metal to support piping, and do not support piping from other piping.
- B. Install hangers and supports complete with necessary inserts, bolts, rods, nuts, washers and other accessories. Except as otherwise indicated for exposed continuous pipe runs, install hangers and supports of same type and style as installed for adjacent similar piping.
- C. Prevent electrolysis in support of copper tubing by use of hangers and supports which are copper plated, or by other recognized industry methods.

#### D. Provisions for Movement:

- 1. Install hangers and supports to allow controlled movement of piping systems and to permit freedom of movement between pipe anchors, and to facilitate action of expansion joints, expansion loops, expansion bends and similar units.
- 2. Load Distribution: Install hangers and supports so that piping live and dead loading and stresses from movement will not be transmitted to connected equipment.
- 3. Insulated Piping: Comply with the following installation requirements.
  - a. Clamps: Attach clamps, (where required) including spacers (if any), to piping with clamps projecting through insulation; do not exceed pipe stresses allowed by ANSI No. B31.
  - b. Shields: Install galvanized coated protective shields at each hanger on insulated piping.

#### 3.4 ADJUSTMENT OF HANGERS AND SUPPORTS:

A. Adjust hangers and supports to bring piping to proper levels and elevations.

#### 1.1 RELATED DOCUMENTS:

- A. Drawings and general provisions of Contract, including General and Supplementary Conditions and Division 1 specification sections, apply to work of this section.
- B. This section is a Division-15 Basic Materials and Methods Section and is a part of each Division-15 section making reference to valves specified herein.

#### 1.2 DESCRIPTION OF WORK:

A. Extent of valves required by this section is indicated on drawings and/or specified in other Division-15 sections.

# 1.3 QUALITY ASSURANCE:

- A. Manufacturers: Firms regularly engaged in the manufacture of valves, of types and sizes required, and which have been in satisfactory use for not less than one year in similar service.
- B. Inspection of Castings: Provide valve bodies, bonnets and discs which have been inspected in accordance with manufacturer's standard written quality control procedure and, where indicated in accordance with standards of the Manufacturers' Standardization Society of the Valve and Fitting Industry (MSS).
- C. Marking of Valves: Comply with MSS SP-55, except as otherwise indicated.
- D. Hydrostatic Testing of Valves: Provide valves which have been tested in accordance with manufacturer's standard written test procedure and, where indicated, as follows:
  - 1. Standard Method: Comply with MSS SP-61, except as otherwise indicated.

#### 1.4 PRODUCT HANDLING:

A. Provide manufacturer's standard temporary protective coating on cast iron and steel valves, and provide factory-applied end-caps on valves. Maintain coating and end-caps through shipping, storage and handling, in adequate condition to inhibit corrosion, prevent damage and eliminate dirt and moisture from inside of valves. During transportation and delivery, handle valves with care using adequate lifting equipment. Do not drop or abuse valves. Store valves inside and protected from weather. Where coating has been removed or damaged, and where valves are in environment which could reasonably be expected to cause rusting, protect valves with separate, durable, waterproof wrapping.

#### PART 2 - PRODUCTS:

#### 2.1 VALVE TYPES AND SIZES:

A. General: Except as otherwise indicated, provide factory-fabricated valves of the type, body material and pressure class indicated. Where type or body material is not indicated, provide proper selection as determined by Installer for installation requirements, with pressure class selected from MSS or ANSI standards based on the maximum pressure and temperature in the piping system. Except as otherwise indicated, provide valve size same as connecting pipe size.

#### 2.2 HVAC PIPING VALVES:

- A. Butterfly Valves: to be "Milwaukee" Valve Series ML for "On-Off" operation. Valves shall be constructed for a working pressure of 150 psi with bodies of cast iron, discs of ductile iron, shafts of 17-4PH stainless steel, seats and O-rings Type E.P.D.M. All valves 6 inches and greater to have gear drive operator. Valves of similar design and equivalent construction as manufactured by Demco, Keystone, or Norris will be acceptable. Any valve offered shall be lugbody-drilled and tapped.
- B. Manual Air Vents: to be provided as required. Vents that require pipe discharges to drains shall be 1/4" Crane No. 17 angle valves. All other manual vents shall be 3/8" ball valves as specified.

#### C. Ball Valves:

- 1. For Pipe sizes 1" to 3": Three piece carbon steel with swing out accessibility, 150 psi working pressure. Similar to Grinnell Series 3914, threaded full port.
- 2. For pipe sizes less than 1": Use Series 3911.
- 3. Comparable valves as manufactured by Flowset or Apollo will be acceptable.
- D. Drain Cocks: to be Wolverine 1/2" No. 667 W.S.A. with stuffing box. Comparable cocks as manufactured by Nibco or Chicago Faucet will be acceptable.

#### PART 3 - EXECUTION:

# 3.1 INSTALLATION:

- A. General: Except as otherwise indicated, comply with the following requirements.
  - 1. Install valves where required for proper operation of piping and equipment, including valves in branch lines where necessary to isolate sections of piping. Locate valves so as to be accessible and so that separate support can be provided when necessary.

- 2. Install valves with stems pointed up, in the vertical position where possible, but in no case with stems pointed downward from a horizontal plane unless unavoidable. Install valve drains with hose-end adaptor for each valve that must be installed with stem below horizontal plane.

#### SECTION 15250 - SYSTEMS INSULATION

#### PART 1 - GENERAL

#### 1.1 RELATED DOCUMENTS:

- A. Drawings and general provisions of Contract, including General and Supplementary Conditions and Division 1 specification sections, apply to work of this section.
- B. This section is a Division-15 Basic Materials and Methods Section, and is a part of each Division-15 section making reference to insulation products specified herein.

#### 1.2 DESCRIPTION:

- A. Extent of insulation work is indicated by drawings and by the requirements of this section. In general, the work to include insulating all piping systems, valve bodies, flanges, unions, drip legs, vents, drains, etc. as described hereafter.
- B. The piping systems to be insulated include:
  - 1. Chilled water piping
  - 2. Heating Hot Water Piping

# 1.3 QUALITY ASSURANCE:

- A. Manufacturers: Provide piping insulation products produced by one of the following for each type and temperature range of insulation:
  - 1. Certainteed Corp.
  - 2. Johns-Manville Corp.
  - 3. Owens-Corning Fiberglas Corp.
  - 4. Pittsburg Corning Corp.
- B. Installer: A firm with at least 5 years successful installation experience on projects with piping insulations similar to that required for this project.
- C. Flame/Smoke Ratings: Flame/Smoke Ratings: Provide composite piping insulation (insulation, jackets, coverings, sealers, mastics, and adhesives) with flame-spread rating of 25 or less and a smoke-developed rating of 50 or less, as tested by ASTM E84 (NFPA 255) method.

# 1.4 SUBMITTALS:

- A. Manufacturer's Data, Insulation:
- B. Submit manufacturer's data on piping insulation.

C. Provide certifications or other data as necessary to show compliance with these specifications and governing regulations. Include proof of compliance for test of products for fire rating, corrosiveness, and compressive strength.

# 1.5 PRODUCT DELIVERY, STORAGE AND HANDLING:

- A. Protect insulation against dirt, water and chemical and mechanical damage. Do not install damaged insulation; remove from project site.
- B. Deliver insulation, coverings, cements, adhesives and coatings to the site in factory-fabricated containers with the manufacturer's stamp, or label, affixed showing fire hazard ratings of the products.
- C. Store insulation in original wrappings and protect from weather and construction traffic.

#### PART 2 - PRODUCTS:

#### 2.1 PIPE INSULATION

- A. As designated below shall be insulated with one-piece molded fibrous glass insulation (-60 to 850 degrees F.) with all service jacket double self-sealing lap and thickness as follows:
  - 1. Chilled Water Supply and Return Piping, All pipe sizes (inside building).
    - a. Pipe size 2-1/2 inches and larger 2"
- B. Insulation shall be Owens Corning Fiberglas "Evolution" Paper Free ASJ/SSL-11. Similar insulation from listed manufacturers will be considered. Insulation properties to include but not be limited to the following:
  - 1. Paper Free reinforced foil vapor barrier jacketing.
  - 2. Jacket to have factory applied double pressure sensitive adhesive.
  - 3. Self-sealing butt strips for circumferential joints.
  - 4. UL listed.
  - 5. Permeance: 0.02 perm/in.
  - 6. Puncture resistance: 50 units (ASTM D781)
  - 7. Thermal conductivity:  $0.27\,$  BTU .IN/HR ./ft.  $^2\,$  Deg. F @ 150 Deg. F mean temperature
- C. On all piping exposed in Equipment rooms and exposed piping in building, finish with 8 oz. thermo canvas jacket, ULC listed flame spread 25 or less, smoke developed 50 or less. Canvas as supplied by S. Fattal Canvas, Inc.
- D. Adjoining insulation sections shall be butted firmly together and the butt ends shall be sealed to pipe with a thick coating of vapor seal mastic at 21 feet intervals and at each fitting. Longitudinal seams of the vapor barrier jacket shall be sealed with Foster "Spark-Fas" No. 85-20, adhesive. End joints shall be sealed with 4" factory furnished vapor barrier strips applied with the above adhesive. Canvas shall be neatly pasted in place with Foster "Sealfas"

SYSTEMS INSULATION 15250 - 2

No. 30-36 or equal, vapor barrier coating. Canvas surface shall be finished with a coat of the "Sealfas" coating as a primer. All longitudinal laps in the 8oz. canvas shall be on top of the pipe.

E. All fittings, valve bodies, unions and flanges shall be vapor seal insulated with molded pipe fittings of same material and thickness to adjoining insulation, wired on with two (2) #14 copper wires and vapor sealed by applying a 1/8" thick vapor barrier mastic recommended by insulation manufacturer. While the mastic is tacky, embed a layer of glass fabric lagging tape in the mastic. After the initial mastic coat has dried, finish the surface with an additional 1/8" thick mastic coat, troweled on to a smooth and neat contour. Finally, cover with 8 oz. canvas secured and sized with adhesive as specified above.

#### PART 3 - EXECUTION

#### 3.1 INTALLATION OF INSULATION:

- A. General: Install insulation products in accordance with the manufacturer's written instructions, and in accordance with recognized industry practices to ensure that the insulation serves its intended purpose.
- B. Install insulation on pipe systems subsequent to testing and acceptance of tests and until any electric heating cable that may be required has been installed.
- C. Install insulation materials with smooth and even surfaces. Insulate each continuous run of piping with full-length units of insulation, with a single cut piece to complete the run. Do not use cut pieces or scraps abutting each other.
- D. Clean and dry pipe surfaces prior to insulating. Butt insulation joints firmly together to ensure a complete and tight fit over surfaces to be covered.
- E. Maintain integrity of vapor-barrier jackets on pipe insulation, and protect to prevent puncture or other damage.
- F. Cover valves, flanges, fittings and similar items in each piping system with equivalent thickness and composition of insulation as applied to adjoining pipe run. Install factory molded, precut or job fabricated units (at Installer's option) except where a specific form or type is indicated.
- G. Extend piping insulation without interruption through walls, floors and similar piping penetrations, except where otherwise indicated. Install protective metal shields and insulated inserts wherever needed to prevent compression of insulation.
- H. All insulation work shall be done by mechanics skilled in its application and regularly employed by the Insulation Contractor who shall be a sub-contractor to this Contractor. Special care shall be given to the covering of irregular fittings in order to obtain an even surface resulting in a neat and workmanlike appearance.

# 3.2 PROTECTION AND REPLACEMENT:

- A. Replace damaged insulation which cannot be repaired satisfactorily, including units with vapor barrier damage and moisture saturated units. Replace/Repair pipe insulation that is removed from existing piping to make new alterations or pipe connections or removal of existing pipe.
- B. Protection: The Installer of the piping insulation shall advise the Contractor of required protection for the insulation work during the remainder of the construction period, to avoid damage and deterioration.

# SECTION 15350 - FUEL GAS PIPING AND EQUIPMENT

# PART 1 - GENERAL

#### 1.1 RELATED DOCUMENTS:

- A. Division-15 Basic Materials and Methods Sections apply to the work of this section.
- B. Division-15 Basic Materials and Methods Sections apply to the work of this section.

#### 1.2 DESCRIPTION OF THE WORK:

- A. The extent of fuel gas piping work and its associated equipment is indicated by drawings and by the requirements of this section. Fuel gas piping is defined to include piping for natural gas, from the point of delivery (outlet of the meter set assembly) to the connections with each gas utilization device, and the gas venting piping of gas equipment to the outside. The contractor to coordinate with local gas utility company to assure gas meter is of proper size.
- B. The applications for fuel gas piping include connections to the following gas utilization appliances:
  - 1. Rooftop DX Packaged Air Conditioning with Gas Heat
  - 2. Domestic Water Heater

# 1.3 OUALITY ASSURANCE:

- A. Manufacturers: Firms regularly engaged in the manufacture of gas piping products, of the quality and sizes required, whose products have been in satisfactory use in similar service for not less than 5 years.
- B. Installer: A firm with at least 5 years of successful installation experience on projects with gas piping similar to that required for this project.
- C. ANSI Code Compliance: Comply with applicable provisions of "National Fuel Gas Code", ANSI Z 223.1 (NFPA Standard No. 54).

#### PART 2 - PRODUCTS:

#### 2.1 PIPING MATERIALS:

- A. General: Comply with the Division 15 sections for product requirements of piping materials. For each service, provide the piping materials indicated including pipe, tube, fittings, hangers, supports, anchors, valves and accessories. Where more than one type is indicated, selection is Installer's option.
- B. Materials: Provide products complying with "National Fuel Gas Code", 2012 Edition, ANSI Z 223.1 (NFPA Standard No. 54), where type is not indicated.
  - 1. Pipe Size 3/4" and Smaller: Black steel pipe of the size indicated.

- a. Pipe Weight: Schedule 40.
- b. Fittings: Class 150 malleable iron threaded.
- 2. Pipe Size 1" and Larger: Black steel pipe of the size indicated.
  - a. Pipe Weight: Schedule 40.
  - b. Fittings: Forged steel socket welding.
- 3. ALL PIPING LOCATED IN CEILING RETURN PLENUMS SHALL BE WELDED REGARDLESS OF PIPE SIZE.

#### 2.2 FUEL GAS PIPING PRODUCTS:

- A. General: Provide factory-fabricated piping products of the size and type indicated. Where not otherwise indicated, provide products as determined by the Installer to comply with installation requirements. Provide sizes and types matching piping and equipment connections.
- B. Gas Meter: Coordinate with the local gas utility company to have service routed to the building and install gas meter. Assure that the gas meter to the complex is of sufficient size. Run gas piping from the meter to the new gas equipment. Meter shall not be installed until entire piping system is complete to include but not be limited to all piping, flue vents, and regulator vents.
- C. Gas Pressure Regulation (at Meter): Provide single-stage, steel jacketed, corrosion resistant, pressure regulator, with vent to atmosphere, elevation compensated, with flanged ends of size indicated, for inlet and outlet gas pressures, specific gravity and volume flow indicated. All regulators inside mechanical rooms to be pipe vented individually to outside.
- D. Provide gas pressure regulators at appliances for the service indicated and required by the manufacturer. All regulators shall have an over pressurization protection device.

#### PART 3 - EXECUTION

# 3.1 INSTALLATION OF PIPING SYSTEM:

- A. General: Comply with the requirements of the Division 15 sections for installation of basic piping materials. Install piping products in accordance with the manufacturer's written instructions, the applicable requirements of ANSI Z 223.1, and in accordance with recognized industry practices to insure that products serve the intended function.
- B. Use sealants on metal gas piping threads which are chemically resistant to natural gas. Use sealants sparingly and apply to only male threads of metal joints.
- C. Remove cutting and threading burrs before assembling piping.
- D. Do not install defective piping or fittings. Do not use pipe with threads which are chipped, stripped or damaged.

- E. Plug each gas outlet, including valves with a threaded plug or cap, immediately after installation, and retain until continuing piping or equipment connection is completed.
- F Ground gas piping electrically and continuously within project, and bond to grounding electrode. Buried bare metal piping is acceptable as a grounding electrode.
- G. Install accessible 6" drip-legs in gas piping at each piece of equipment that uses gas.
- H. Protection of Gas Piping Against Corrosion: Protect metal gas piping in contact with the earth, or other corrosive material, against corrosion. Seal wrap piping with coal-tar saturated wrapping tape over coal-tar epoxy coating (20 mils thick).
- I. Coordinate with gas utility company as necessary to interface gas piping with gas service supply work.
- J. Pre-wrapped piping shall be protected. Any damage to this piping shall be touched up by manufacturer's approved method.
- K. All underground piping shall be inspected by owner/engineer prior to bury.

# 3.2 EQUIPMENT CONNECTIONS:

A. General: Connect fuel gas piping to equipment and comply with equipment manufacturer's instructions.

# 3.3 FIELD QUALITY CONTROL:

- A. Fuel Gas Piping Tightness Test: Prior to initial operation, test and purge fuel gas piping in accordance with ANSI Z 223.1, National Fuel Gas Code, 2012 Edition.
- B. Repair or replace fuel gas piping as required to eliminate leaks, and retest as specified to demonstrate compliance.

#### 1.2 DESCRIPTION OF WORK:

- A Extent of boiler work required by this section is indicated on drawings and schedules, and by requirements of this section.
- B. Type of boiler specified in this section include the following:
  - 1. Packaged gas-fired boilers, condensing type
- C. Refer to other Division-15 sections for concrete pads, piping, specialties, pumps, etc. required external to boilers for installation, not work of this section.

# 1.3 QUALITY ASSURANCE:

- A Manufacturers: Firms regularly engaged in manufacture of boilers, of types and capacities required, whose products have been in satisfactory use in similar service for not less than 5 years. Provide products produced by one of the following for each type and capacity of heat generation units:
  - 1. Lochinvar
  - 2. Raypack
  - 3. Patterson-Kelly
- B. Installer: A firm with at least 3 years of successful installation experience on projects with installation work similar to that required for the project.
- C. NEC Compliance: Comply with National Electrical Code (NFPA 70) as applicable to installation and electrical connections of electrical components.

#### **PART 2- PRODUCTS**

#### 2.1 BOILER-GENERAL

- A The boiler basis of design shall be equal to "LOCHINVAR KNIGHT XL" having a modulating input gas heat and shall be operated on Natural Gas. The boiler shall be capable of full modulation firing down to 20% of rated input with a turndown ratio of 5:1.
- B. The boiler shall bear the ASME "H" stamp for 160 psi working pressure. The 316L

stainless steel combustion chamber shall be designed to drain condensation to the bottom of the heat exchanger assembly. A built-in trap shall allow condensation to drain from the heat exchanger assembly. The complete heat exchanger assembly shall carry a ten (10) year limited warranty.

C. The boiler shall be certified and listed by C.S.A. International under the latest edition of the harmonized ANSI Z21.13 test standard for the U.S. and Canada. The boiler shall comply with the energy efficiency requirements of ASHRAE 90.1-2007. The boiler shall operate at a minimum of 93% thermal efficiency at full fire, and shall operate up to 98% thermal efficiency with return water temperatures at 100°F or below. The boiler shall be certified for indoor installation. The boiler's thermal efficiency shall be verified through third party testing by the Hydronics Institute Division of AHRI and listed in the AHRI Certification Directory.

#### 2.2 BOILER-CONSTRUCTION

A. The boiler shall be constructed with a heavy gauge steel jacket assembly, primed and pre painted on both sides. The combustion chamber shall be sealed and completely enclosed, independent of the outer jacket assembly. A burner/flame observation port shall be provided. The burner shall be a premix design and constructed of high temperature stainless steel with a woven metal fiber outer covering to provide modulating firing rates. The boiler shall be supplied with a gas valve designed with negative pressure regulation and be equipped with a variable speed blower system, to precisely control the fuel/air mixture to provide modulating boiler firing rates for maximum efficiency. The boiler shall operate in a safe condition at a derated output with gas supply pressures as low as 4 inches of water column. The boiler shall be equipped with leveling legs.

#### 2.3 CONTROLS

- A. The boiler shall utilize a 24 VAC control circuit and components. The control system shall have an electronic display for boiler set-up, boiler status, and boiler diagnostics. All components shall be easily accessed and serviceable from the front and top of the jacket. The boiler shall be equipped with; a temperature/pressure gauge, high limit temperature control certified to UL353, ASME certified pressure relief valve, outlet water temperature sensor, return water temperature sensor, a UL 353 certified flue temperature sensor, outdoor air sensor, low water flow protection and built-in adjustable freeze protection.
- B. The boiler shall feature control with a Multi-Colored Graphic LCD display with Navigation Dial and Soft Keys for three loop temperature setpoints with individual outdoor air reset curves, pump delay with adjustable freeze protection, pump exercise, and USB PC port connection. The boiler shall have the capability to accept a 0-10 VDC input connection for BMS control of modulation or setpoint, enable disable of the boiler, variable system pump signal and a 0-10 VDC output of boiler modulation rate. The Boiler shall have a built-in "Cascade" with sequencing options for "lead lag" or "efficiency optimized" modulation logic, with both capable of rotation while maintaining

modulation of up to eight boilers without utilization of an external controller. Supply voltage shall be 120 volt *I* 60 hertz *I* single phase.

#### 2.4 ELECTRICAL

A. The boiler shall be equipped with two terminal strips for electrical connection, and a low voltage connection board with 42 data points for safety and operating controls. A high voltage terminal strip shall be provided for supply voltage. The high voltage terminal strip plus integral relays are provided for independent pump control of the Boiler pump.

# 2.5 VENTING AND COMBUSTION AIR

- A. The boiler shall be installed and vented with a vertical vent and vertical combustion air system with a vertical rooftop termination of both, through connection to concentric vent kit accessory. The flue shall be PVC sealed vent material terminating at concentric vent kit. A separate pipe shall supply combustion air directly to the boiler from the concentric vent kit. The air inlet shall be PVC sealed pipe. The air inlet must terminate on the concentric vent kit.
- B. The boiler shall have an independent laboratory rating for Oxides of Nitrogen (NOx) of 20 ppm or less corrected to 3% O2. The manufacturer shall verify proper operation of the burner, all controls and the heat exchanger by connection to water and venting for a factory fire test prior to shipping.

#### 1.02 DESCRIPTION OF WORK:

A. Extent of air distribution and terminal HVAC equipment work as indicated, and by the requirements of this section.

#### 1.03 QUALITY ASSURANCE:

A. Manufacturers: Firms regularly engaged in the manufacture of terminal HVAC equipment, of types and sizes required, whose products have been in satisfactory use in similar service for not less than 5 years.

#### 1.04 SUBMITTALS:

A. Manufacturer's Data; Terminal HVAC Equipment:

Submit manufacturer's data on terminal HVAC equipment, including certified drawings showing overall dimensions of complete assembly, weights, support requirements, sizes and locations of connections, accessories, and parts lists. Include the following information:

- 1. Performance certifications.
- 2. Product warranties available from manufacturers.
- 3. Wiring diagrams, where applicable.
- 4. Written instructions for installations, including assembly where not factory assembled.
- 5. Written maintenance instructions where applicable, including recommendation on spare parts inventory.
- 6. Written report of sound pressure level when operating at scheduled speed, where applicable.

# 1.05 PRODUCT HANDLING:

- A. Protect terminal HVAC equipment from damage during shipping, storage, and handling. Avoid crushing or bending element fins, and prevent dirt and debris from entering or settling in enclosures. Store equipment in original cartons and protect from weather and construction work traffic.
- B. Where possible, store inside; when necessary to store outside, store above grade and enclose with waterproof wrapping.

#### PART 2 - PRODUCTS

#### 2.01 MATERIALS AND EQUIPMENT:

- A. General: Except as otherwise indicated, provide manufacturer's standard materials, finishes, HVAC elements, equipment and accessories, of the type, duty and capacity ratings indicated, as shown by published product information and as required for a complete installation.
- B. Performance requirements of terminal HVAC equipment are indicated either by provisions of this section, or by schedules and notes on the drawings.

# 2.02 INDOOR AIR HANDLING UNITS (AHU-1)

# A. Acceptable Manufacturers

1. Provide custom indoor air handling units as manufactured by "Innovent" as the basis-of-design. Equipment manufactured by "Temtrol" or "Marcraft" shall be considered provided the construction specifications, capacities, and performance criteria are met.

# B. GENERAL

 Furnish and install where shown on the plans, framed style air handling units with construction features as specified. The units shall be provided and installed in strict accordance with the specifications. All units shall be complete with all components and accessories as specified.

# C. Factory Testing and Quality Control

 Standard Factory Tests: The fans shall be factory run tested to ensure structural integrity and proper RPM. All electrical circuits shall be tested to ensure correct operation before shipment of unit. Units shall pass quality control and be thoroughly cleaned prior to shipment.

# D. UNIT CONSTRUCTION DESCRIPTION

General: Provide factory-fabricated air handling units with capacity as indicated on the schedule. Units shall have overall dimensions as indicated and fit into the space available with adequate clearance for service. Multiple sectioned units shall be shipped as a single factory assembled piece (except where shipping limitations prevent) de-mounted into modular sections in the field by the contractor. Units shall be furnished with sufficient gasket and bolts for reassembly in the field by the contractor. Unit manufacturer shall provide certified ratings conforming to the latest edition of AMCA 210, 310, 500 and ARI 410. All electrical components and assemblies shall comply with NEMA standards. Unit internal insulation shall have a flame spread rating not over 25 and smoke developed rating no higher than 50 complying with NFPA 90A, "Standard for the Installation of Air Conditioning and Ventilating Systems." Units shall comply with NFPA 70, "National Electrical Code," as applicable for installation and electrical connections of ancillary electrical components of air handling units. Tags and decals to aid in service or indicate caution areas shall be provided. Electrical wiring diagrams shall be attached to the control panel access doors. Operation and maintenance manuals shall be furnished with each unit. Units shall be UL listed.

- Unit Base Floor: Unit perimeter base shall be completely welded and fabricated using heavy gauge structural steel tubing. (Note: bolted bases are not acceptable) C-Channel cross supports shall be welded to perimeter base steel tubing and located on maximum 24" centers to provide support for internal components. Base rails shall include lifting lugs welded to perimeter base at the corner of the unit or each section if de-mounted. Entire base frame shall be painted with a phenolic coating for long term corrosion resistance. Internal floor shall be 16 GA galvanized steel. The outer sub-floor of the unit shall be made from 20 GA galvanized steel. The 4" double wall floor shall be insulated with spray foam insulation. Floor seams shall be gasketed for thermal break and sealed for airtight / watertight construction. Single wall floors with glued and/or pinned insulation and no sub floor shall not be acceptable. Base frame shall be attached to the unit at the factory. The base and unit frame shall be painted with a lacquer resisting gray phenolic corrosion inhibitive primer.
- Rigging Provision Multiple Piece Units: Units shipped in multiple 3. sections shall be engineered for field assembly. The base frame shall have integral lifting lugs. The lifting lugs shall be fabricated from structural steel with an appropriate rigging hole. The lifting lug shall be fixed. Lifting lugs shall be located at the corner of each section and along the sides and sized to allow rigging and handling of the unit. Demount sealing gasket shall be required and provided. Internal lifting eyes shall be provided so that mating sections can be set together in their proper location by the crane without dragging or pushing them together. The mating upper frame of each section shall also be fabricated with a mating perimeter tube. Mating sections shall have bolt brackets attached with oversized clearance holes for alignment and assembly. The mating perimeter tube shall be continuously gasketed. High-quality, weather-resistant closed cell type demount gasket shall be supplied with the unit. Assembly lugs, fabricated from structural steel with appropriate assembly clearance holes, shall be electrically welded to the base frame. All gasket and necessary assembly hardware shall ship loose with unit. Junction boxes with a factory supplied numbered terminal strip shall be supplied at each shipping split for reconnection of control wiring.
- 4. Unit Casing The construction of the air handling unit shall consist of a steel frame with formed 16 gauge galvanized steel exterior casing panels. The exterior casing panels shall be attached to the gasketed steel frame with corrosion resistant fasteners. All casing panels shall be completely removable from the unit exterior without affecting the unit's structural integrity. The air handling unit casing shall be of the "no-through-metal" design. The casing shall incorporate insulating thermal breaks as required so that, when fully assembled, there's no path of continuous unbroken metal to metal conduction from inner to outer surfaces. Provide necessary support to limit casing deflection to L/200 of the narrowest panel dimension. All panel seams shall be caulked and sealed for an airtight unit. Leakage rates shall be less than 1% at design static pressure or 9" W.C. whichever is greater.

The exterior panel finish shall be mill galvanized finish.

5. Double Wall Liner - Each unit shall have double wall construction with 20 gauge solid galvanized liner in the entire unit with the exception of the fan

- section. 20 gauge perforated galvanized liner in the fan section. The double wall interior panel shall be removable from the outside if the unit without affecting the structural integrity of the unit.
- 6. Insulation Entire unit to be insulated with a full 2" (R-8) thick non-compressed fiberglass insulation. The insulation shall have an effective thermal conductivity (C) of .24 (BTU in./sq.ft. F°) and a noise reduction coefficient (NRC) of 0.70 / per inch thick (based on a type "A" mounting). The coefficients shall meet or exceed a 3.0 P.C.F. density material rating. Insulation shall meet the erosion requirements of UL 181 facing the air stream and fire hazard classification of 25/50 (per ASTM-84 and UL 723 and CAN/ULC S102-M88). All insulation edges shall be encapsulated within the panel. All perforated sections shall have Tuf-Skin or equal insulation with black acrylic coating.
- 7. Access Doors The unit shall be equipped with a solid double wall insulated, hinged access doors as shown on the plans. The doorframe shall be extruded aluminum with a built in thermal break barrier and full perimeter gasket. The door hinge assembly shall be die cast zinc with stainless steel pivot mechanism, completely adjustable. There shall be a minimum of two heavy duty handles per door. Provide ETL, UL 1995, and CAL-OSHA approved tool operated safety latch on all fan section access doors.
  - a. Access doors in the fan section shall be provided with a 10 x 10 dual thermal pane safety glass window.

# E. UNIT COMPONENT DESCRIPTION

- 1. Unit Fans shall be SWSI type fans shall meet the air flow performance specified and shall not exceed the break horsepower specified on the mechanical equipment schedule. Fan performance shall be based on testing and be in accordance with AMCA Standards 210 and 300. All fans shall have a steep pressure/volume curve. Fan shaft shall be turned, ground and polished solid steel rated at maximum RPM below critical speed. Fan wheel shall be keyed to the shaft. Fan shall be balanced per ANSI / AMCA 204-96 fan application category BV-3 using a digital signal analyzer at the design RPM drives in place to a vibration velocity less than or equal to 0.157 inches per second measured horizontal and vertical at each bearing pad. Vibration amplitudes shall be in inches/second-Peak. All values shall be filter-in at the fan speed. Fan assemblies shall be designed for heavy-duty industrial applications. Fan framing assemblies shall be fabricated from structural steel. The structural steel shall be electrically welded together to form a rigid integral base. Fan assemblies shall be independently isolated with spring-type vibration isolators. Inlet cones shall be precision spun or die formed. Inlet cones shall be aerodynamically matched to the wheel side plate to provide streamlined airflow in the wheel and ensure full loading of the blades.
  - a. Plug Fan (PF) SWSI fans: Fan shall be single width single inlet arrangement 3 plenum fan as indicated on the schedule. Fan blades shall be hollow airfoil in shape, welded to the center and wheel side plates. Fan bearings shall be heavy duty, self-aligning, concentric "Grip Tight" type with full contact on shaft. Bearings

shall be selected for a minimum L-10 life (100,000) hours at maximum horsepower and operating speed for the classification. Rigid support for the inlet bearing must be removable for access to the wheel. Inlet cone shall be precision spun. The fan shall be rated in accordance with AMCA 210 for performance and AMCA 300 for sound.

- The following fan options shall be provided: Provide airflow b. monitoring device equal to TemFLO device at the inlet of all supply fans. Air monitoring device shall consist of an array of differential pressure flow sensors mounted at opposing 90° positions around the inlet of the plenum fan. Flow sensors shall be manifolded together with pneumatic tubing to form a piezometric ring. Each fan assembly and air monitoring device shall have been tested for airflow vs. differential pressure and calibrated in an AMCA Accredited Laboratory throughout the fans range of operation. 4-20ma low pressure transducer with accuracy of ±1% full span and temperature compensated from 25 to 150°F, shall be mounted on fan inlet plate or fan bulk head wall to provide feedback. Air monitoring device shall not obstruct the fan inlet, be directly mounted across the fan inlet or have any effect on fan air performance or sound power levels.
- c. Motors shall be NEMA Design B; T-FRAME mounted on an adjustable steel base. All motors shall be tested to IEEE standard 112 test method B and rated per NEMA MG1, Part 31 "Inverter Fed Motors". All motors shall be specifically designed to meet or exceed all (EPAct) requirements for energy efficiency and include Class 'F' insulation. Motors shall be as manufactured by Baldor, Toshiba, Reliance or equal.
- VFDs Each unit shall be provided with separate variable frequency d. drives. Drives shall be factory mounted with adequate ventilation provided. The variable frequency drive shall convert 208 volt +/-10%, three phase, 60 hertz (+/- 2 Hz.) utility power to adjustable voltage/frequency, three phase, A-C power step less motor control from 5% to 105% of base speed. The variable frequency drive (VFD) shall produce an adjustable A-C voltage/frequency output of complete motor speed control and an input power factor near unity over the entire speed range. The VFD shall be automatically controlled by an control signal. The VFD shall be self contained, totally enclosed in a NEMA 1 ventilated cabinet and capable of operation between 0 and 40 ° Celsius. The VFD shall be UL listed. Components used in all options shall be UL listed. The VFD shall have a hand/off/auto operator switch, drive switch with run or stop command and panel mounted digital display capable of indicating unit status, frequency, and fault diagnostics.

#### 2. Heat Transfer Coils – Water Coil

a. All coil assemblies shall be leak tested under water at 315 PSIG and PERFORMANCE is to be CERTIFIED under ARI Standard 410. Coils exceeding the range of ARI standard rating conditions shall be noted.

- b. Cooling coils shall be mounted on stainless steel support rack to permit coils to slide out individually from the unit. Provide intermediate drain pans on all stacked cooling coils. The intermediate pan shall drain to the main drain pan through a copper downspout. Water coils shall be constructed of seamless copper tubing mechanically expanded into fin collars. All fins shall be continuous within the coil casing to eliminate carryover inherent with a split fin design. Fins are die formed Plate type.
- c. Headers shall be seamless copper with die formed tube holes.
- d. Connections shall be male pipe thread (MPT) Schedule 40 Red Brass with 1/8" vent and drain provided for complete coil drainage. All coil connections shall be extended to the exterior of the unit casing by the manufacturer. Coils shall be suitable for 250 PSIG working pressure. Intermediate tube supports shall be supplied on coils over 44" fin length with an additional support every 42" multiple thereafter.
- e. Water coils shall have the following construction:
  5/8" o.d. x .020" wall copper tube with .028 return bends.
  .008" aluminum fins
  16 gauge 304 stainless steel casing all chilled water coils
  16 gauge galvanized steel casing all hot water coils
- 3. Condensate / Drain Pans IAQ style drain pans shall be provided under all cooling coils as shown on the drawings. The drain pan shall be fabricated from 16 gauge 304 stainless steel. All pans are to be triple pitched for complete drainage with no standing water in the unit. They shall be insulated minimum 3-inch "Double Bottom" construction with welded corners. Provide stainless steel, 1-1/4" MPT drain connection extended to the exterior of the unit base rail. Units in excess of 159 inches shall have drain connections on both sides. All drain connections shall be piped and trapped separately for proper drainage.
- 4. Filters Provide filters of the type indicated on the schedule. Factory fabricated filter sections shall be of the same construction and finish as the unit. Face loaded pre and final filters shall have Type 8 frames as manufactured by AAF, FARR or equal. Side service filter sections shall include hinged access doors on both sides of the unit. Internal blank-offs shall be provided by the air unit manufacturer as required to prevent air bypass around the filters. The filters shall be as manufactured by Farr, Purolator, AAF or equal. Filters shall be in compliance with ANSI/UL 900 Test Performance of Air Filters.
  - a. Filter Gauge: Each Filter bank shall be furnished with: Magnehelic filter gauge with a 4 3/4" OD white static pressure dial with black figures and zero pointer adjustment.
  - b. Flat Racks Filter racks shall be completely factory assembled. Filter racks shall be fabricated from no less than 16 gauge galvanized steel. Filter racks shall be applied in MERV 8 filter applications and will be either upstream or side accessible. Filter racks shall be designed for a maximum of 500 fpm, or meet or exceed the area specified in the mechanical schedule.

5. Control Dampers –Ruskin CD-50 or equal. Provide Class 1 rated, ultra low leak dampers as indicated on the unit drawings. Low leakage dampers shall have extruded aluminum airfoil blades. Flat or formed metal blades are not acceptable. The damper blade shall incorporate santoprene rubber edge seals and zinc plated tubular steel shaft for a non-slip operation. Shaft bearings holes shall be N.C. machine punched and fitted with one inch O.D. heavy duty nylon bearings to eliminate friction and any metal to metal contact. Damper jamb seals shall be UV rated, nylon glass reinforced or stainless steel spring arcs designed for a minimum air leakage and smooth operation. Damper linkage shall be concealed within a 16 gauge galvanized steel frame.

# F. ELECTRICAL POWER AND CONTROLS

- 1. The unit shall feature a mounted permanent nameplate displaying at a minimum the manufacturer, serial number, model number, date of manufacture, and current and voltage readings. The unit shall have an ETL or UL Listing and bear the appropriate mark.
- 2. Provide permanent schematic and connection wiring diagrams indicating how the unit motors, starters, controls are wired. The controls diagram shall follow recognized industry standards and shall feature line and terminal numbers.
- 3. The unit shall bear warning alerting personnel of arc flash hazard and the need for PPE.
- 4. Conduit shall consist of a combination of EMT or flexible metal conduit as required. Liquidtite flexible metal conduit may be used outside the air tunnel for wet locations. Electrical connection boxes shall be galvanized steel with knockouts. In wet locations the connection boxes shall be Nema 4 epoxy coated.

#### 2.03 DUCT SYSTEM:

A. General Sheet Metal Work: Shall comprise furnishing and installing all air ducts, plenums, risers, branches, collars, adapters, dampers (automatic or manual), connections and splitters to complete the systems in accordance with the intent of the plans and specifications. No duct sizes shall be changed or departures made from these general specifications without prior written approval by the Engineers. All ducts shall be air tight, rigid and free from vibration, noise and rattles, and all lap joints shall be made in direction of air flow. Ductwork must present a smooth interior surface. All uninsulated ducts 18" and larger shall be cross-broken.

Construction shall include the fastening of all ducts to grounds at openings, diffusers, registers, grilles, louvers, plenums, dampers, and equipment. All duct dimensions shown are internal dimensions.

B. Ductwork receiving registers, grilles and diffusers shall be flanged in or out to receive same and installed flush with finished walls or ceiling. On exposed ductwork a collar will be necessary to install the register or diffuser to provide space for the O.B. volume control and the air deflector device in the duct. Ducts connecting to outside air intakes shall be pitched to drain outside and shall be soldered watertight. Where ductwork passes through floors, ceilings and walls the space around ducts shall be sealed in an approved manner with fire retardant U.L. approved material and in areas exposed to view finished with a

suitable metal collar. This includes openings in equipment rooms. Support vertical ducts at floor level by angle iron frame riveted to ductwork on four sides. Ductwork behind all grilles and registers shall be painted with black asphalt paint as far as can be seen through the openings.

- C. No pipes or conduit shall be run through ducts without the Engineers' approval.
- D. Provide adjustable air balance dampers in branch take-offs from all main ducts and for each diffuser whether indicated or not on drawings and as may be required to balance the system. Branch take-off dampers shall be Air Balance Inc., Model AC-112 for round take-offs and Young Regulator Company, 820 Series, for rectangular ductwork. All dampers to have lock and graduated quadrants. Spin-ins will not be allowed.
- E. Provide balance dampers as described hereafter at major branch splits, return ducts opening, return duct splits, plenums....etc.
- F. All duct and plenum connections to fans and/or air handling equipment at both inlets and outlets shall be provided with heavy prefabricated closely woven 30 oz. glass fabric, double coated with Neoprene and secured by double lock seams to 26-gauge galvanized steel connectors on sides. Sleeves shall be not less than 6" long. Material shall be UL approved and similar in all respects to "Ventglas" manufactured by Ventfabrics, Inc.
- G. Covered test openings of size suitable for insertion of Pitot Tube shall likewise be provided in ducts at locations as may be required by the Engineer.
- H. All Sheet Metal Work shall be installed in accordance with the requirements stipulated in the current issue of NFPA Pamphlet No. 90.
- I. Sheet Metal Construction: Ductwork shall be constructed of galvanized steel. Gauges (U.S. Standards) of metal which shall be used, together with the type of joints and methods of stiffening and bracing for various size ducts shall be as follows: Metal gauges shall be:

- J. Access Doors: Provide access doors in ducts at each splitter and balancing damper and fire damper. Doors shall have hinges, latches, gaskets, and frames, and be constructed according to SMACNA Duct Manual. Doors to be a minimum size of 14"W x 20"H. Access doors shall be labeled per the requirements of Paragraph 607.4 in the 2012 IMC.
- K. All ducts shall have all seams and joints sealed airtight with United Sheet Metal Sealer to be applied as per Mfg. Bulletin DS-3. No duct tape will be allowed. Ductwork installation shall be approved by owner/engineer prior to applying insulation.

- L. Duct Hangers and Supports: Shall be either strap hangers or trapeze hangers properly secured to the building construction. Strap hangers, metal attached to ducts, shall be fastened to supporting member by clamps, anchor bolts, or metal screws whichever is most applicable. Supporting shelf of trapeze hangers shall be attached to supporting rods, straps or angles, by welding, bolting, or push nuts.
- M. Hanger Sizes: Shall be in accordance with the following schedules:

#### N. Dampers:

1. Acceptable manufacturers: Safe Air, National Controlled Air, Nailor-Hart, Louver and Dampers, Inc., American Warming and Ventilation, Ruskin Co., Air Control Products, Carnes, Air Balance, Prefco, or Arrow.

# 2. Fire Dampers:

Fire dampers shall be solid steel curtain type corrosion-resistant galvanized steel construction blades to rotate full 180 degrees F and stack compactly for minimal air resistance. Sub-frame shall be continuous one-piece construction, with mounting flanges. In closed position, blades will interlock completely for positive elimination of flame passage. Dampers to provide approximately 100% free area in Type C design for supply air ducts. Dampers to be easily reset or inspected through standard access panel. Dampers shall bear UL 555 label and shall be installed to maintain structural fire-resistive integrity of wall or floor installed. Refer to Architectural drawings for fire rating of walls, ceilings, or floor assemblies.

#### PART 3 - EXECUTION

#### 3.01 INSTALLATION:

- A. General: Except as otherwise indicated, install terminal HVAC equipment including components required, in accordance with manufacturer's instructions.
- B. Locate each unit accurately in position indicated with sufficient clearance for enclosure removal.
- C. Support hanging units from structure as detailed on the drawings.
- D. Level or pitch units and elements to indicated tolerance. Install shims as required.
- E. Comb out damaged fins where bent or crushed, before covering elements with enclosures.

- F. Clean dust and debris from each unit as it is installed.
- G. Touch up finish on each cabinet and component after final adjustments are made.
- H. Install valves, including balancing valves, to comply with Division 15 sections of these specifications.
- I. Install control valves to comply with 15900 Section of these specifications.
- J. Install control devices to comply with 15900 Section of these specifications.

#### 3.02 FIELD QUALITY CONTROL:

- A. Repair or replace terminal equipment as required to eliminate leaks, following purging and tightness testing of piping, and retest by specified method to demonstrate proper performance.
- B. Replace elements which have excessively damaged fins, and replace enclosures and accessories which are damaged beyond restoration to an acceptable condition.

#### SECTION 15900 - CONTROLS AND INSTRUMENTATION

#### PART 1 - GENERAL

# 1.1 RELATED DOCUMENTS

A. The general provisions of the Contract, including General and Supplementary Conditions and General Requirements, apply to the work specified in this Section.

#### 1.2 SCOPE

- A. This section includes the controls, instrumentation and associated piping and wiring required to make the mechanical systems provided under Division 15 perform as described in these specifications and as shown. Provide a complete system of automatic temperature control of the direct digital type as manufactured only by Johnson Controls Company. The Johnson Controls Representative for the project is Mrs. Allison Knox 430-A Roper Mountain Road, Greenville, SC 29615, (864) 234-3812.
- B. The base bid for this project shall include, but not by way of limitation, all DDC panels, power supplies, wiring, conduit, solenoid valves, relays, differential pressure transmitters, differential pressure switches, RTDS, pressure sensors, etc. necessary for a complete and operable automatic control system and DDC field panels and connecting LAN.
- C. The installation of the added components must be performed without interrupting the operation of existing equipment.

# 1.3 COORDINATION

- A. The complete control system provided by the control equipment manufacturer shall include all control and interlock wiring.
- B. Automatic temperature control valves and separable wells for immersion elements furnished by the control manufacturer shall be installed by the mechanical contractor under the control manufacturer's supervision.
- C. Furnish all flow and fail switches indicated and necessary to perform control sequences described. Water flow switches shall be furnished by the control manufacturer and installed by the mechanical contractor under the control manufacturer's supervision.
- D. The control manufacturer shall cooperate with the water balancing agency in the performance of their work as required or directed.

#### 1.4 SUBMITTALS

A. Submit six (6) copies of the data specified for the manufacturer and the installation specialist proposed. Upon receipt and approval manufacturer and specialist pre-qualifications, proceed with the preparation of shop drawings and other submittal data.

#### PART 2 - PRODUCTS

#### 2.1 INPUT DEVICES

# A. General Requirements

1. Installation, testing, and calibration of all sensors, transmitters, and other input devices shall be provided to meet the system requirements.

#### 2. Thermowells

- a. When thermowells are required, the sensor and well shall be supplied as a complete assembly, including well head and Greenfield fitting.
- 3. Acceptable Manufacturers: Johnson Controls.

# B. Status and Safety Switches

- 1. General Requirements
  - a. Switches shall be provided to monitor equipment status, safety conditions, and generate alarms at the FMS when a failure or abnormal condition occurs.
     Safety switches shall be provided with two sets of contacts and shall be interlock wired to shut down respective equipment.

#### 2.2 OUTPUT DEVICES

A. General Requirements: Damper and valve actuators shall be electronic and/or pneumatic, as specified in the System Sequence. Refer to the valve schedule for sizes and flow requirements.

#### 2.3 SEQUENCE OF OPERATION:

#### A. General

1. The air handling shall be energized to operate by the existing "JCI" Building Management System. The controls subcontractor shall utilize existing building automation system infrastructure. The controls subcontractor shall also provide wiring between all control end devices including control valves, temperature sensors, switches, etc. and existing controls system.

# PART 3 - EXECUTION

#### 3.1 HVAC CONTROL SYSTEM WIRING

A. All conduit, wiring, accessories and wiring connections required for the installation of the Facility Management System, as herein specified, shall be provided by the FMS Contractor unless specifically shown on the Electrical Drawings under Division 16 Electrical. All wiring shall comply with the requirements of applicable portions of Division 16 and all local and national electric codes, unless specified otherwise in this section.

#### 3.2 CONTROL AIR PIPING

A. Instrument Air piping shall be copper or polyethylene tubing, where control air is required for new chiller installation.

# 3.3 INPUT DEVICES

- A. All Input devices shall be installed per the manufacturer's recommendation. The mechanical contractor shall install all in-line devices such as temperature wells, pressure taps, etc.
- B. Differential Pressure Status Switches: Provide complete installation kit including; static pressure tops, tubing, fittings and air filters. Provide appropriate scale range and differential adjustment for intended service.
- C. Temperature Sensors: Temperature sensors shall be RTD's with high resistance change versus temperature or thermistors to insure good resolution and accuracy. RTD's shall be platinum measuring elements with aluminum oxide encapsulation, 3,000 OHM two wire.

#### 3.4 OUTPUT DEVICES

- A. All output devices shall be installed per the manufacturer's recommendation. The mechanical contractor shall install all in-line devices such as control valves, etc.
- B. Actuators: All control actuators shall be sized capable of closing against the maximum system shut-off pressure. The actuator shall modulate in a smooth fashion through the entire stroke.
   When any pneumatic actuator is sequenced with another device, pilot positioners shall be installed to allow for proper sequencing.

# 3.5 TRAINING

A. One day of on-site orientation by a field engineer who is fully knowledgeable of the specific installation details of the project. This orientation shall, at a minimum, consist of a review of the project as-built drawings, the control system software layout and naming conventions, and a walk through of the facility to identify panel and device locations.

# 3.6 COMMISSIONING

A. Commissioning the Facility Management System is a mandatory documented performance requirement of the selected FMS Contractor for all control systems detailed in this Specification and sequence of operations. Commissioning shall include verification of proper installation practices by the FMS Contractor and subcontractors under the FMS Contractor, point verification and calibration, system/sequence of operation verification with respect to specified operation, and network/workstation verification. Documentation shall be presented upon completion of each commissioning step and final completion to ensure proper operation of the Facility Management System.

# B. Acceptance Check List

1. An acceptance checklist shall be completed that documents compliance with each item of this Specification.

# SECTION 16001 — ELECTRICAL DEMOLITION

#### PART 1 - GENERAL

- D. Damages: Promptly repair damages caused to facilities by demolition operations at no cost to Owner.
- E. Utility Services: Maintain existing service entrance utilities and gear and protect against damage during demolition operations.

SECTION 16010 — GENERAL PROVISIONS

PART 1 - GENERAL

#### 1.1 RELATED SECTIONS

A. The provisions of The Supplement to Advertisement, The Instructions to Bidders, Supplement to Instruction to Bidders, General Conditions, Supplementary Conditions and all other sections of Division 1 of these Specifications shall govern the work under this Division or Section the same as if incorporated herein.

# 1.2 SCOPE

- A. The Contractor shall provide and install complete electrical systems including all conductors, raceways, fittings, protective devices, wiring devices, fixtures, supports, and all miscellaneous hardware necessary. All of the above equipment shall be completely installed and left in proper operating condition. All electrically powered equipment whether furnished by others or by the Contractor shall be wired by the Contractor.
- B. Complete Power distribution and utilization system shall be installed, including utilization devices and equipment as indicated on drawings.
- C. The Contractor shall furnish and install power, wiring and/or disconnects as shown on drawings for wiring systems for mechanical systems specified in the Mechanical Divisions of the specifications. Temperature control wiring, equipment control and interlock wiring are not included in this division unless specifically noted in these specifications or shown on the plans. All motor disconnects, starters, combination motor controllers and motor control centers shall be furnished under this division of specifications unless noted otherwise.

# 1.3 REQUIREMENTS

- A. Field verification of scale on electrical plans is directed since actual locations, distances and levels will be governed by actual field conditions.
- B. In case of conflicts or discrepancies between plans, plans and specifications and/or actual field conditions, Contractor shall notify the Engineer before work is continued. Coordinate with other trades to avoid conflicts.
- C. Permits, and Tests The Contractor shall procure and pay for all permits, fees and licenses required. Perform all tests to ensure all systems are in good operating condition.
- D. Review of Material; Specific reference in the specification to any article, device, product, material, fixture, form or type of construction by name, make or catalog

number, with or without the words "or equal", shall be interpreted as establishing a standard of quality and shall not be construed as limiting competition.

- E. Bidders shall base bids on the material specified or on equals receiving approval 10 days prior to Bid Opening. Any increase in the cost of work resulting from substitution of any product specified is part of this contract and shall be accomplished in an approved manner at no extra cost to the Owner.
- F. Substitutions. No substitution will be considered unless written request for approval has been received by the Engineer at least 10 days prior to the date of receipt of bids. Each such request shall include the name of the material or equipment for which it is to be substituted and a complete description of the proposed substitution including drawings, cuts, performance and test data and any other information necessary for an evaluation. A statement setting forth any changes in other materials, equipment or other Work that incorporation of the substitute would require shall be included; failure to do so does not alleviate the Contractor of his responsibility to make any and all necessary changes required for installation of the approved substitution. The burden of proof of the merit of the proposed substitute is upon the proposer. The Engineer's decision of approval or disapproval of a proposed substitution shall be final.
- G. All materials shall be new and of current manufacturer. Where more than one of a type of device is used, all shall be by the same manufacturer. All materials shall conform to the grade, quality and standards of those specified.
- H. Shop drawings shall be submitted in accordance with the General Conditions. Forward all shop drawings at one time. Each item shall bear project name and identifying symbol from plans. Shop Drawings required are as follows:
  - 1. Motor Circuit Protectors
  - 2. Wiring Devices
  - 3. Conduit
  - 4. Cable
  - 5. Fire Alarm Devices
- Interferences The drawings are generally diagrammatic in nature, and accordingly the Contractor shall coordinate his work with that of all other trades to avoid interferences. The Contractor shall examine the complete set of drawings and specifications for the job before installation of electrical work, coordinating locations and routings with other trades to avoid interferences. Work installed by the Contractor which does interfere with another trade shall be removed and reinstalled at the Contractor's expense when directed by the Architect.
- J. Workmanship shall be of the highest quality and all work shall be done by workmen skilled in the trades involved.
- K. The Contractor shall guarantee all work under this contract for one year and shall be responsible for the maintenance of all electrical equipment furnished and installed under this contract, excluding lamp replacement, for a period of one year from the date of substantial completion.

SECTION 16100 — BASIC MATERIALS

PART 1 - GENERAL

#### 1.1 RELATED SECTIONS

A. Materials specified in this section shall comply with all applicable requirements of SECTION 16010, GENERAL PROVISIONS.

### 1.2 SCOPE

- A. Contractor Furnished. Unless otherwise noted on the drawings, equipment list, or specifications, the Contractor shall furnish and install all materials, devices, and apparatus necessary for the complete electrical system. All materials and equipment shall be of types and manufacturer specified wherever practical. Should materials or equipment so specified be unobtainable, the Contractor shall submit the description and manufacturer's literature, reason for the substitution request and shall secure the approval of the Engineers before substitution of other material or equipment. This specification establishes performance requirements and the quality of equipment acceptable for use and shall in no way be construed to limit procurement from other manufacturers.
- B. Equal or Equivalent. The term "or equal" and similar terms as used on the drawings or specifications shall be interpreted to mean "equal or equivalent" in the opinion of the Engineers.
- C. Manufacturer's Prints. Where the Contractor furnishes equipment other than standard construction items, he shall furnish manufacturer's prints and reproducibles of all such equipment to the Engineers.
- D. U.L. Listing. All equipment and materials shall be new and conform to the requirements of this specification. All equipment and materials shall be listed by the Underwriter's Laboratories, Inc., and shall bear their label whenever standards have been established and label service is regularly furnished. All equipment and materials shall be of the best grade of their respective kind for the purpose.

## PART 2 - PRODUCTS AND EXECUTION

## 2.1 CIRCUIT BREAKERS

A. Contractor Furnished. The contractor will provide breakers unless specifically designated to be "Owner Furnished" on the drawings, equipment list, or within the specifications.

- B. As Specified. Breakers shall be of the type, rating, number of poles, size, and interrupting capacity, specified or required for the environment, location, application, and load served.
- C. Molded Case Circuit Breakers. Molded case circuit breakers shall be circuit interrupting devices which will operate both manually for normal switching functions and automatically under overload and short circuit conditions. Circuit breakers shall provide circuit protection when applied within rating.
- D. Operating and Switching Mechanism. The operating mechanism shall be entirely tripfree so that the contacts cannot be held closed against an abnormal over-current or short circuit condition. The switching mechanism shall be quick-make, quick-break type.
- E. Overload and Short Circuit Protection. The operating handle of the circuit breaker shall open and close all poles of a multi-pole breaker simultaneously. The breakers shall meet applicable NEMA and U.L. specifications. Each circuit breaker shall have a trip unit to provide overload and short circuit protection. The trip unit for each pole shall have elements providing inverse time delay under overload conditions and instantaneous magnetic tripping for short circuit protection. The trip element shall operate a common trip bar which shall operate all poles in case of an overload or short circuit through any one pole. Automatic tripping shall be clearly indicated by handle position.

## 2.2 SAFETY SWITCHES

- A. Contractor Furnished. The contractor shall provide all safety disconnect switches required. The switches shall be of the type, voltage, ampere, and horsepower rating, number of poles, fusible or nonfusible, as specified or required for the environment, location, application, and load served.
- B. Description. All safety switches shall be NEMA premium heavy duty, horsepower rated, industrial type, and shall be Underwriters' Laboratories listed. Fusible switches shall be complete with fuses of the type and rating specified (refer to paragraph "Fuses") and as indicated on the drawings or within these specifications. All switches shall have switch blades that are fully visible in the OFF position when the door is open and shall be of dead front construction with arc suppressors. The mechanism shall be quick-make, quick-break type. The door shall be interlocked (defeatable type) with the handle or mechanism to prevent unauthorized opening of the door in ON position. Pad-locking provisions shall be provided for padlocking in the OFF position with one or more locks or lockable hasps. Grounded switches in a common enclosure shall be mounted in enclosure types specified elsewhere. Individually mounted switches shall be mounted in enclosures suitable for the location and environment as specified on the drawings.
- C. Nameplate. All switches shall be provided with an engraved laminated phenolic nameplate showing the power source (Unit No. or other), and title of equipment served. Nameplates to be black letters on white background.

D. Manufacturer and Enclosures. All switches furnished shall have enclosures as specified on the drawings. Acceptable manufacturers shall be Square D, General Electric, Siemens, and Cutler-Hammer.

## 2.3 FUSES

- A. Contractor Furnished. The contractor shall furnish and install fuses in all fusible devices and equipment that are furnished by the contractor.
- B. Manufacturer and Listing. The following fuse types shall be used for the applications listed. The following are trade names of the Bussman Manufacturing Division, however, equivalent products by Chase Shawmut Division shall be acceptable.

## 2.4 MISCELLANEOUS CONTROL DEVICES

- A. Furnished by Others. Miscellaneous control devices such as duct switches, air flow switches, thermostats and temperature control devices, and similar equipment shall normally be furnished under another division. Any such device that is to be furnished under this division shall be specifically designated on the drawings.
- B. Enclosures. All devices furnished shall be suitable for the control requirements and shall have voltage rating and adequate capacity for the application. They shall be housed in enclosures suitable for the location and environment as indicated on the drawings.

### 2.5 BOXES

- A. Contractor Furnished. The contractor shall furnish and install all electrical boxes required for the proper installation of the electrical systems. Boxes shall be of the NEMA type suitable for the location. Boxes shall be installed as specified on the drawings and as described under "Wiring Methods", and other applicable sections of this specification for wiring devices such as switches, receptacles, and similar devices.
- B. Concealed. Fixture, outlet, and switch boxes installed concealed in walls or ceiling areas shall be galvanized or cadmium plated sheet steel of not less than the minimum size as recommended in the National Electrical Code and shall be furnished with appropriate covers as specified in other applicable sections of these specifications or on the drawings. All boxes shall be accessible for maintenance purposes.

- C. Exact locations of all floor boxes shall be coordinated in the field with the architect unless specific dimensions are shown on the drawings. Also, see Section 16500 of these specifications.
- D. Surface Mounted. Fixture, outlet, and switch boxes installed surface mounted in plant, shop, operating, and unfinished areas shall be threaded, cast alloy iron or malleable iron. Iron type shall have a cadmium/zinc electroplate, or galvanized finish with appropriate lacquer. Boxes shall be of the approved type for the outlets, switches, and fixtures served and shall be made of the material and finish compatible with the conduit system and location. Surface mounted boxes shall be only as noted on the plans.
- E. Splice and Tap Boxes. Splice and tap boxes for power circuits shall be used only where designated on the drawings and shall be of the type and size indicated. Otherwise all power wiring shall be continuous, splice and tap free, between equipment. On lighting and convenience receptacle circuitry, wiring may be spliced and boxes shall be provided for concealed or surface mounting as previously specified or may be JIC oil-tight of size and type indicated on the drawings or minimum size as specified in the National Electrical Code.
- F. Pull Boxes. Pull boxes for interior, or outdoor exposed power wiring shall be provided where shown or required to facilitate the installation of the wiring. Pull boxes shall not be located in finished rooms and shall be accessible for maintenance use. For conduit sizes 3/4 and 1 inch, conduit fittings of the "C", "LB", "TB" and similar types may be used for "Pulling In." Unless designated otherwise, all pull boxes shall be the straight-through type and changes in direction shall not be made in the box. The boxes shall be of the minimum size and type as required by the National Electric Code or as sized on the drawings.

### 2.6 COVERS AND DEVICE PLATES

A. Contractor Furnished. The contractor shall furnish and install the appropriate cover on all boxes, conduit fittings, panels, cabinets, switches, receptacles, and similar wiring devices and other equipment that is Contractor furnished. Conduit outlet fitting covers shall be the type specified under "Conduit Fittings."

### 2.7 ENCLOSURES

A. Enclosures and housings for all Contractor furnished electrical equipment and devices shall be suitable for the location and environmental conditions and shall be of NEMA type as shown on symbol sheet drawing.

# SECTION 16110 — ELECTRICAL RACEWAYS

#### PART 1 - GENERAL

### 1.1 RELATED SECTIONS

A. Materials specified in this Section shall comply with all applicable requirements of SECTION 16010, GENERAL PROVISIONS.

### 1.2 SCOPE

- A. Contractor Furnished. The contractor shall provide all conduit, fittings, and supports required and not otherwise shown on plans as furnished by others.
- B. The types of electrical raceways required for the project include the following:
  - 1. Electrical Metallic Tubing
  - 2. Intermediate Metal Conduit
  - 3. Flexible Metal Conduit
  - 4. Liquid-Tight Flexible Metal Conduit
- C. The minimum raceway size shall be 3/4".
- D. Product Delivery, Storage, and Handling. Contractor is to provide color-coded end-cap thread protectors and handle conduit and tubing carefully to prevent damage. Store pipe and tubing inside whenever possible. When necessary to store outdoors, elevate well above grade and enclose with durable, watertight wrapping.

#### PART 2 - PRODUCTS

#### 2.1 MATERIALS AND COMPONENTS

- A. Electrical Metallic Tubing. Galvanized, thin wall tubing, fittings shall be hex-nut, expansion gland type, zinc plated, and U.L. listed as "raintight." No crimp, spring, or set-screw type fittings will be accepted.
- B. Intermediate Metal Conduit. Galvanized steel tubing, with zinc coated interior.
- C. Flexible Metal Conduit. Galvanized single steel strip, flexible, interlocked.
- D. Liquid-Tight Flexible Metal Conduit. Galvanized single steel strip, flexible, interlocked, double wrapped, with liquid-tight PVC jacket.
- E. Conduit, tubing and duct accessories including straps, hangers, expansion and deflection fittings as recommended by conduit, tubing, and duct manufacturers.

### PART 3 - EXECUTION

- A. Electrical Metallic Tubing. Branch circuits protected by location. Not to be exposed.
- B. Flexible Metal Conduit. Connection of motors and for other electrical equipment where subject to movement and vibration and located in a dry, interior location. Flexible conduit is not to exceed 60" in length for any one application.
- C. Liquid-tight Flexible Metal Conduit. Connection of motors and for other electrical equipment where subject to movement and vibration, and also subjected to one or more of the following conditions: Exterior location; moist or humid atmosphere where condensate can be expected to accumulate; corrosive atmosphere; subjected to water spray; subjected to dripping oil, grease or water. Flexible conduit is not to exceed 60" in length for any one application.
- D. Intermediate Metal Conduit. All conduits of 2" nominal trade size or more and/or where exposed. Not to be stubbed up at floor level.

### 3.2 INSTALLATION

- A. Install conduit and tubing in accordance with NEC and National Electrical Contractors Association's "Standard of Installation", and with recognized industry practices. Where NECA and NEC standards differ, use the more stringent requirement.
- B. Complete the installation of raceways before starting installation of wires.
- C. Wherever possible, install horizontal raceway runs above water and steam piping.
- D. Care shall be taken to keep the interior of conduits clean, and each conduit run shall be thoroughly cleaned and dried before any cable is pulled through.
- E. Unless indicated otherwise on drawings, all exposed conduits shall be run parallel with or perpendicular to building structural members.
- F. Conduits entering sheet metal enclosures shall be made up with double locknut and insulating bushing. Locknut shall be of the type which will bite into the metal of the box.
- G. Conduits entering threaded openings in equipment enclosures, boxes, etc., shall have at least five full threads engaged. In outdoor and underground locations, threaded joints shall be made up with a thin application of conducting joint compound. The inside of the fitting shall be thoroughly cleaned of any excess compound.
- H. Power operated bending machines shall be used on conduits 1-1/4" and larger. Heating with torches will not be permitted.
- I. All conduit runs shall be continuous from outlet to outlet with all joints and connections pulled tight to insure an electrically continuous and mechanically secure raceway system.

## 3.3 CONDUIT AND TRAY OPENINGS

- A. Contractor's Responsibility. The Contractor shall be responsible for all sleeves and openings through walls and floors necessary for passage of electrical conduits and raceways. Where contractor must provide openings and/or drill concrete floors and/or walls, he shall be responsible for the repair of these openings. Structural members and reinforcing shall not be cut, burned or damaged in any way. All openings in walls and floors, and under switchgear and panels where electrical cables and conduits are installed, shall be closed up by the Contractor to prevent dust, dirt and water from entering.
- B. Sealing. The Contractor shall be responsible for sealing all wall and floor openings and all floor and wall sleeve openings utilized by the contractor whether furnished by Others or by the Contractor.
- C. Sleeves and openings shall be sealed with materials that will withstand fire and heat to the same rating as the wall, floor, or ceiling through which the conduit or tray passes and shall not be less than a 30-minute barrier.

### SECTION 16130 — CONDUCTORS

#### PART 1 - GENERAL

#### 1.1 RELATED SECTIONS

A. Materials specified in this Section shall comply with all applicable requirements of SECTION 16010, GENERAL PROVISIONS.

### 1.2 SCOPE

- A. This specification covers the requirements for all wire and cable to be used in the installation of the electrical systems for the project, including all power, control, and instrumentation systems.
- B. Wire and cable will normally be furnished by the Contractor for installation. Drawings will indicate where cable is not to be furnished.
- C. All cable is to be "Contractor-furnished", the Contractor shall submit for approval by the Owner any deviations anticipated or proposed with respect to the cable manufacturer, cable type, or specification contained herein.

## PART 2 - PRODUCTS

## 2.1 MATERIALS

- A. All wire and cable shall be Underwriters' Laboratories (UL) listed. In addition to other standard labeling, all wire and cable shall be marked UL on the outer surface indicating Underwriters' Laboratories, Inc. certification.
- B. Grounding conductors, where insulated, shall be colored solid green. Conductors intended as a neutral shall be colored solid white.
- C. For all circuits 600 volt and less, wires and cables shall have code grade, 600 volt type THWN-THHN, 75 degrees C., wet or dry locations, moisture and heat resistant thermoplastic insulation. Insulation thickness shall be per National Electrical Code, Table 310-13.
- D. Conductor sizes are expressed in American Wire Gage (AWG) or in circular mils. Conductors shall be annealed copper wire, minimum size #12 AWG, except that #14 AWG may be used for control. All conductors shall be stranded.

## PART 3 - EXECUTION

## 3.1 INSTALLATION

- A. Separation of Usage. Lighting and power wiring shall be routed in conduits, or other raceways as shown on the drawings. Lighting and power wiring shall not be routed in a common raceway except where shown on drawings. Push-button wiring shall be routed in separate raceways even though related to a particular motor circuit.
- B. Pulling. Where mechanical assistance is used for pulling conductors, patented wire pulling compounds having inert qualities that do not harm the wire insulation or covering shall be applied to the conductors as they are pulled into raceways. Interior of all raceways shall be free from grease, filings or foreign matter before conductors are pulled in.

## 3.2 IDENTIFICATION

- A. Wire, Cable, Raceways, and Conduits.
- B. Circuit identification numbers shall be placed on each end of the conductor involved by using self-laminating marker tags, T&B Company E-Z Code Type WSL or equal. Circuit numbers shall be as shown on the plan and panel schedule drawings.
- C. Phase Identification. Phase sequence throughout the installation shall be standardized wherever practical in all electrical power equipment as follows:

## 3.3 SPLICES AND TERMINATIONS

A. Power Conductors shall be continuous. No power cable shall be spliced except on explicit instructions of the Owner's Representative.

### 3.4 LUGS

A. All lugs shall be furnished and installed by the Contractor where required.

- B. Lugs for copper power wiring, Sizes No. 12 and No. 10 AWG, shall be T&B "Sta-Kon" uninsulated ring type lugs. Lugs for copper power wiring from No. 10 AWG to size 1/0 AWG shall be T&B 1-hole Type 54100 Series. Size 2/0 AWG and larger lugs shall be 2-hole type 54200 series (except where 1-hole is required to match motor lead lugs). Sizes above 1/0 are to be applied using hydraulic pump tool.
- C. Where motor leads are furnished without lugs, T&B 54500 Series 2-way connectors (splicing sleeves) shall be used. Splice sleeves may be desirable where limited space for termination exists.
- D. The proper lugs will normally be furnished with equipment in all Owner-furnished equipment. All other lugs shall be furnished and installed by the Contractor. No mechanical type lugs shall be used except in panelboards. If any mechanical type lugs are furnished with Owner-furnished equipment, the Contractor shall replace them with proper compression type lugs where practical.

### 3.5 TAPING

- A. All voids, sharp corners and bolt projections shall be made smooth by filling with Okonite or Scotch Fill before applying the laps of tape required for insulation. All loose strands of wire shall be removed before taping. Duxseal will not be permitted.
- B. Joints and other sections of wiring requiring tape shall be half lap and at least two layers. Taping shall be neatly done and shall form a permanent insulation equal in mechanical and electrical strength to the insulation of the conductor. Taping shall be as follows:
  - 1. 600 Volt insulation A minimum of 1-1/2 lap layer varnished cambric and 2-1/2 lap layers of 3M No. 33 vinyl plastic electrical tape.
- C. All taping, splicing and termination materials shall be furnished by the Contractor.

SECTION 16450 — GROUNDING

PART 1 - GENERAL

#### 1.1 RELATED SECTIONS

A. Materials specified in this Section shall comply with all applicable requirements of SECTION 16010, GENERAL PROVISIONS.

### 1.2 WORK INCLUDES

A. As Required By the NEC. In general, fixtures, outlets, the enclosing cases, mounting frames, etc., of all switches, circuit breakers, control panels, motors and any other electrically operated or electrical equipment, conduit, trays, and other raceways shall be effectively and permanently grounded with a separate copper grounding conductor of cross-section as required by the National Electrical Code and drawings. It shall be of capacity sufficient to insure continuity and continued effectiveness of the ground connections to carry fault currents. Ground conductors must be as short and straight as possible, protected from mechanical injury and if practicable without splice or joint. The grounding conductor shall be run from a ground established at the source of supply to the equipment to be grounded. All grounding conductors shall be copper.

PART 3 - EXECUTION

#### 3.1 INSTALLATION

- A. Power Conductors Supplying Equipment. A copper grounding conductor must be run inside the conduit or raceway, enclosing the power conductors supplying the equipment, or in case of a multi-conductor power cable, must be located within the sheath.
- B. Connect at Source. Ground conductors in power cable or ground wire in conduits shall always be connected directly to station ground at the source end, and to motor frame or equipment enclosure and/or equipment ground bar.
- C. System Neutral. The equipment grounding conductor in all circuits shall be connected to the frame and ground lug in the panelboards and not the neutral bus. Equipment ground connections to a system neutral are not permitted.

- D. Fuses. In all cases of grounded circuits, fuses must be omitted from the grounded neutral conductor throughout the entire installation.
- E. Equipment Frames. Frames of all electrical apparatus will be connected to the grounding system. Neutrals of service transformers shall be connected to the grounding system.
- F. Metallic Raceways. All metallic conduits and wiring channels must be connected at each end to the grounding conductor with a good electrical contact.
- G. Identification. The grounding conductor shall be stranded and covered with a green jacket.
- H. In all cases the white wire should be used for the current-carrying neutral only and never as a grounding conductor, or other purpose.

### SECTION 16720 - FIRE ALARM SYSTEM

#### PART 1 - GENERAL

### 1.1 SUMMARY

- A. This Section includes modifications to existing fire alarm systems.
- B. Definitions:
  - 1. FACP: Fire alarm control panel.
  - 2. LED: Light-emitting diode.
  - 3. Definitions in NFPA 72 apply to fire alarm terms used in this Section.

## C. System Description:

1. The building has a fire alarm system currently installed which will remain in place and operational throughout the construction period.

## D. Performance Requirements:

- 1. Comply with NFPA 72.
- 2. Provide duct detectors in new AHU compatible with the existing fire alarm system. Provide two contacts, one for fire alarm panel use, and one for mechanical contractor's use to shut down the air handler.

## 1.2 SUBMITTALS

A. Product Data: Duct Detectors.

## B. Shop Drawings:

- 1. System Operation Description: Detailed description for this Project, including method of operation and supervision of each type of circuit and sequence of operations for manually and automatically initiated system inputs and outputs. Manufacturer's standard descriptions for generic systems are not acceptable.
- 2. Device Address List: Coordinate with final system programming. Modify Owner's existing records.
- 3. System riser diagram with device addresses, conduit sizes, and cable and wire types and sizes.
- 4. Wiring Diagrams: Power, signal, and control wiring. Include diagrams for equipment and for system with all terminals and interconnections identified. Show wiring color code. Modify Owner's existing records.
- C. Field quality-control test reports.
- D. Operation and maintenance data.

E. Submittals to Authorities Having Jurisdiction: In addition to distribution requirements for submittals specified in Division 1 Section "Submittals," make an identical submittal to authorities having jurisdiction. To facilitate review, include copies of annotated Contract Drawings as needed to depict component locations. Resubmit if required to make clarifications or revisions to obtain approval. On receipt of comments from authorities having jurisdiction, submit them to Architect for review.

### F. Documentation:

- 1. Approval and Acceptance: Provide the "Record of Completion" form according to NFPA 72 to Owner, Architect, and authorities having jurisdiction.
- 2. Record of Completion Documents: Provide the "Permanent Records" according to NFPA 72 to Owner. Format of the written sequence of operation shall be the optional input/output matrix.
  - a. Hard copies on paper to Owner.

## 1.3 QUALITY ASSURANCE

- A. Installer Qualifications: Personnel shall be trained and certified by manufacturer for installation of units required for this Project.
- B. Electrical Components, Devices, and Accessories: Listed and labeled as defined in NFPA 70, Article 100, by a testing agency acceptable to authorities having jurisdiction, and marked for intended use.

## PART 2 - PRODUCTS

### 2.1 MANUFACTURERS

A. Available Manufacturers: Subject to compliance with requirements, manufacturers offering products that may be incorporated into the Work include, but are not limited to, the following:

## 2.2 SYSTEM SMOKE DETECTORS

## A. General Description:

- 1. UL 268 listed, operating at 24-V dc, nominal.
- 2. Integral Addressable Module: Arranged to communicate detector status (normal, alarm, or trouble) to the FACP.
- 3. Multipurpose type, containing the following:
  - a. Integral Addressable Module: Arranged to communicate detector status (normal, alarm, or trouble) to the FACP.
  - b. Heat sensor, combination rate-of-rise and fixed temperature.
- 4. Plug-in Arrangement: Detector and associated electronic components shall be mounted in a plug-in module that connects to a fixed base. Provide terminals in the fixed base for connection of building wiring.
- 5. Self-Restoring: Detectors do not require resetting or readjustment after actuation to restore them to normal operation.
- 6. Integral Visual-Indicating Light: LED type. Indicating detector has operated and power-on status.

#### B. Duct Smoke Detectors:

## 1. Photoelectric Smoke Detectors:

- a. Sensor: LED or infrared light source with matching silicon-cell receiver.
- b. Detector Sensitivity: Between 1.0 and 3.5 percent/foot (0.003 and 0.011 percent/mm) smoke obscuration when tested according to UL 268A.
- 2. UL 268A listed, operating at 24-V dc, nominal.
- 3. Integral Addressable Module: Arranged to communicate detector status (normal, alarm, or trouble) to the FACP.
- 4. Plug-in Arrangement: Detector and associated electronic components shall be mounted in a plug-in module that connects to a fixed base. The fixed base shall be designed for mounting directly to the air duct. Provide terminals in the fixed base for connection to building wiring.
- 5. Self-Restoring: Detectors shall not require resetting or readjustment after actuation to restore them to normal operation.
- 6. Integral Visual-Indicating Light: LED type. Indicating detector has operated and power-on status. Provide remote status and alarm indicator and test station for duct detectors mounted above ceilings and other locations which are out of sight.
- 7. Sampling Tubes: Design and dimensions as recommended by manufacturer for the specific duct size, air velocity, and installation conditions where applied.
- 8. Relay Fan Shutdown: Rated to interrupt fan motor-control circuit.

### 2.3 WIRE AND CABLE

A. Wire and cable for fire alarm systems shall be UL listed and labeled as complying with NFPA 70, Article 760.

- B. Signaling Line Circuits: Twisted, shielded pair, size as recommended by system manufacturer, but not less than No. 18 AWG.
  - Circuit Integrity Cable: Twisted shielded pair, NFPA 70 Article 760, Classification CI, for power-limited fire alarm signal service. UL listed as Type FPL, and complying with requirements in UL 1424 and in UL 2196 for a 2-hour rating.
- C. Non-Power-Limited Circuits: Solid-copper conductors with 600-V rated, 75 deg C, color-coded insulation.
  - 1. Low-Voltage Circuits: No. 14 AWG, minimum.
  - 2. Line-Voltage Circuits: No. 12 AWG, minimum.

### PART 3 - EXECUTION

### 3.1 EQUIPMENT INSTALLATION

- A. HVAC: Locate detectors not closer than 3 feet (1 m) from air-supply diffuser or return-air opening.
- B. Duct Smoke Detectors: Installed by Division 15. Fire alarm AHU shut down circuits shall be wired from the FACP to a termination point, adjacent to the AHU control, under Division 16. AHU control wiring from the termination point to the equipment shall be under Division 15. Comply with NFPA 72 and NFPA 90A. Sampling tubes shall be installed so they extend the full width of the duct.
- C. Device Location-Indicating Lights: Locate in public space near the device they monitor if required by location.

## 3.2 WIRING INSTALLATION

- A. Install wiring according to the following:
  - 1. NECA 1.
  - 2. TIA/EIA 568-A.
- B. Wiring Method: Install wiring in metal raceway according to Division 16 Section "Electrical Raceways."
  - 1. Fire alarm circuits and equipment control wiring associated with the fire alarm system shall be installed in a dedicated raceway system. This system shall not be used for any other wire or cable.
- C. Wiring within Enclosures: Separate power-limited and non-power-limited conductors as recommended by manufacturer. Install conductors parallel with or at right angles to sides and back of the enclosure. Bundle, lace, and train conductors to terminal points with no excess. Connect conductors that are terminated, spliced. or

interrupted in any enclosure associated with the fire alarm system to terminal blocks. Mark each terminal according to the system's wiring diagrams. Make all connections with approved crimp-on terminal spade lugs, pressure-type terminal blocks, or plug connectors.

- D. Cable Taps: Use numbered terminal strips in junction, pull, and outlet boxes, cabinets, or equipment enclosures where circuit connections are made.
- E. Color-Coding: Color-code fire alarm conductors differently from the normal building power wiring. Use one color-code for alarm circuit wiring and a different color-code for supervisory circuits. Color-code audible alarm-indicating circuits differently from alarm-initiating circuits. Use different colors for visible alarm-indicating devices. Paint fire alarm system junction boxes and covers red.

### 3.3 GROUNDING

A. Ground the FACP and associated circuits; comply with IEEE 1100.

### 3.4 FIELD QUALITY CONTROL

- A. Perform the following field tests and inspections and prepare test reports:
  - 1. Before requesting final approval of the installation, submit a written statement using the form for Record of Completion shown in NFPA 72.
  - 2. Perform each applicable electrical test and visual and mechanical inspection listed in NFPA 72. Certify compliance with test parameters.
  - 3. Visual Inspection: Conduct a visual inspection before any testing. Use as-built drawings and system documentation for the inspection. Identify improperly located, damaged, or nonfunctional equipment, and correct before beginning tests
  - 4. Testing: Follow procedure and record results complying with requirements in NFPA 72.
    - a. Detectors that are outside their marked sensitivity range shall be replaced.
  - 5. Test and Inspection Records: Prepare according to NFPA 72, including demonstration of sequences of operation by using the matrix-style form in Appendix A in NFPA 72.

## 3.5 DEMONSTRATION

A. Engage a factory-authorized service representative to train Owner's maintenance personnel to adjust, operate, and maintain the fire alarm system, appliances, and devices.

## 3.7 RECORD DOCUMENTATION

- A. Record Drawings: Provide Owner with a redline copy of all changes made during construction to original design.
- B. Provide Owner with Operations and Maintenance manuals prior to close out with manufacturer's data and equipment cut sheets. Owner's maintenance responsibilities and a copy of all testing, NFPA reports and final programming of the system, in compliance with NFPD 72; 10.18.2.3 Provide copy of warranty with date of system energization.
