



- 1. No asbestos has been detected in this building.
- 2. Submittals are required on pump, heat exchanger, & heater.
- 3. Contractor must schedule all work in advance with USC Lancaster. Note: Existing pool heater and pool water pump are available for work from 7/1/2013 through 7/6/2013. New equipment must be made operational by 7/6/2013.
- 4. Contractor must attend pre construction conference prior to start of work. Contractor must obtain hot work permit prior to starting of any hot work.
- 5. Any shutdown of utilities or pool water systems can only be done by USCL employees. Note: Gas company will provide 2" T and a valve for new connection for new pool heater.
