NOTE: The bid opening for the project has been postponed until Tuesday, June 26, 2012 at 2:00 PM. The location of the bid opening remains the same.

## Clarification:

- 1) Step flashing will have to be installed around the chimney on the Boy Scout Building.
- 2) Step flashing will need to be installed at the side and rear entrances of the Health Learners Center building.
- 3) Roofing tar will need to be installed to cover the gap where the chimney meets the shingles on the main Hut building.
- 4) There are two locations of vertical shingles installed on each side of the main entrance to the front porch of the Hut. The vertical shingles will have to be removed and step flashing installed. USC Salkehatchie will replace these vertical shingles with siding.
- 5) Reuse the existing copper flashing on the Health Learners Center.
- 6) The contractor will need to tar the chimney on the Hut.

Bidder shall acknowledge receipt of addendum in the space provided on the quote form (SE-331). Make sure that you submit both pages of the SE-331 Quote Form.
