Days are calculated as provided in Section 11-35-310(13). Both protests and notices of intent to protest must be submitted in writing and must be received by the appropriate Chief Procurement Officer within the time provided. See clause entitled "Protest-CPO." The grounds of the protest and the relief requested must be set forth with enough particularity to give notice of the issues to be decided.
