- 2. Q: How can bidders determine the square footage on each floor and for each area?
  - A: See above clarification.

- 3. Q: Which tile to use?
  - A: ACT#1-3 are specified on drawings.
- 4. Q: Clarify where the 2x4 vs the 2x2 tile was installed originally.

A: Bidders should assume that 2x2 tiles were used in the Close and Hipp corridor areas, elevator lobby and stair lobby areas. Bidders should assume that 2x4 tiles were used everywhere else. Original reflected ceiling plans for Hipp side floors 6 and 7 are attached for reference. Please note that there are some 2x2 fixtures shown within the open spaces but it is believed these were mounted within a 2x4 grid. After award, the successful bidder is to double check this information against where the walls are marked and quantity adjustments will be made at that time, if appropriate.






