TO: ALL HOLDERS OF RECORD OF CONTRACT DOCUMENTS

Acknowledge receipt of this addendum by inserting its number and date in the Bid Form. Failure to do so may subject bidder to disqualification. This addendum forms a part of the Contract Documents. It modifies them as follows:

GENERAL / CLARIFICATIONS

- 1. A non-mandatory pre-bid meeting was held on 9/9/15. A list of attendees is attached.
- 2. Deadline for questions is Wednesday 9/16/15 at 5 PM. All questions should be directed in writing to the Engineer, AECOM (formerly URS) at bryan.thomas@aecom.com.
- 3. The final addendum will be issued by 2:00 PM Friday 9/18/15.
- 4. Bids are due on 9/23/15 at 2:00 PM and are to be delivered to the USC (Columbia campus), Facilities Management Office, 743 Greene Street, Columbia, SC 29208, Attn: Juaquana Brookins. Bids will then be publicly opened in Conference Room 053.
- 5. <u>DO NOT deliver/mail your bid to the USC Upstate campus all bids must go to the USC Columbia campus.</u>
- 6. Please ensure the following information is placed on the exterior of the bid envelope: <u>Bid Enclosed</u> for USC Upstate Facilities Parking Lot Repair, Project No. H34-I371, Attn: <u>Juaquana Brookins</u>.
- 7. It is the contractor's responsibility to ensure you are properly licensed for the required work, according to LLR licensing requirements, prior to submitting a bid.
- 8. All third party testing and inspections, including geotechnical services and/or SWPPP inspections, will be **provided by the university** and shall not be included in the contractor's bid.
- 9. The project contains one bid alternate, of which the contractor must provide a price for with his/her bid.
- 10. The approved plans are located at the offices of Spartanburg County and must be picked-up by the winning contractor. At this time the grading permit fee must also be paid by the contractor. All other permits, licenses, etc. are the responsibility of the contractor (project is in Spartanburg County limits, not the City limits).
- 11. Contractor must abide by all USC/USC Upstate safety policies and rules.
- 12. All empty conduit installed shall have pull wires.
- 13. All pavement markings shall be non-thermoplastic.

- 14. Cast-in-Place Concrete stairs will be allowed in lieu of the specified pre-cast stairs, so long as shop drawings are submitted to the engineer for review/approval prior to construction.
- 15. The large grass area in front of the facility will be partially available to the contractor for use as a laydown area. The remaining portion will be barricaded off by USC Upstate for use as temporary employee parking. USC Upstate will be responsible for re-seeding this laydown/temp parking area after construction is complete.
- 16. The contractor must provide full-time access to the storage area to the northwest of the facilities building.
- 17. Asphalt pricing shall be fixed and will not be indexed.
- 18. Provide hand-placed rip-rap (with underlying filter fabric) in areas shown on the plans per the following:
 - a. Has thickness of 12" minimum.
 - b. Weighs a minimum of 25 lbs. to a maximum of 150 lbs.
 - c. Has at least 60% of stone weighing more than 60 lbs.
 - d. Properly compact depressions that may be filled in trimming and shaping the slope.
 - e. Install filter fabric, lapping sides 12".
 - f. Begin placing in a trench at least 2' below the toe of the slope.
 - g. Fill the spaces between the larger pieces with spalls of suitable size, thoroughly ram into place.
 - h. The finished surface shall present an even, tight surface true to line, grade and section.
