## **I. Scope of Solicitation**

Provide film printing work required by the University of South Carolina Newsfilm Library.

### **Scope of Services**

The purpose of this document is to define the film printing work required by the University of South Carolina Newsfilm Library and to create a maximum Fixed Price Bid Specification that could remain in place for up to five years.

**Maximum Contract Period:** 5 years from date of award.

## **II. Instructions to Offerors**

### **A. Special Instructions**

#### **Type of Contract**

An agency contract or contracts will be awarded by the University of South Carolina Purchasing department for the period indicated and in accordance with the provisions and conditions of this solicitation.

#### **Bidding Instructions**

A Vendor Checklist is enclosed for your use in providing ALL the required items. Failure to include all requirements will result in rejection of the bid.

### **B. General Instructions**

AMENDMENTS TO SOLICITATION (AUG 2004) (a) The Solicitation may be amended at any time prior to opening. All actual and prospective Offerors should monitor the following web site for the issuance of Amendments: [www.procurement.sc.gov](http://www.procurement.sc.gov). (b) Offerors shall acknowledge receipt of any Amendment to this solicitation (1) by signing and returning the Amendment, (2) by letter, or (3) by submitting a bid that indicates in some way that the offeror received the amendment.

AWARD NOTIFICATION (AUG 2004) Notice regarding the University's intent to award a contract will be posted at the location specified on the Cover Page. The date and location of posting will be announced at opening. If the contract resulting from this Solicitation has a total or potential value in excess of fifty thousand

dollars, such notice will be sent to all Offerors responding to the Solicitation and any award will not be effective until the sixteenth day after such notice is given.

**BID / PROPOSAL AS OFFER TO CONTRACT (AUG 2004)** By submitting Your Bid or Proposal, You are offering to enter into a contract with the University of South Carolina. Without further action by either party, a binding contract shall result upon final award. Any award issued will be issued to, and the contract will be formed with, the entity identified as the Offeror on the Cover Page. An Offer may be submitted by only one legal entity; “joint bids” are not allowed.

**DEADLINE FOR SUBMISSION OF OFFER (AUG 2004)** Any offer received after the procurement officer or his designee has declared that the time set for opening has arrived, shall be rejected unless the offer has been delivered to the designated purchasing office or the University’s mail room which services the purchasing office prior to the bid opening. [R.19-445.2070(H)]

**DEFINITIONS (AUG 2004)** Except as otherwise provided herein, the following definitions are applicable to all parts of the solicitation. For additional definitions, see the terms and conditions below.

- (1) **AMENDMENT** - means a document issued to supplement the original solicitation document.
- (2) **BUYER** - means the Procurement Officer.
- (3) **COVER PAGE** - means the top page of the original solicitation on which the solicitation is identified by number. Offerors are cautioned that Amendments may modify information provided on the Cover Page.
- (4) **OFFER** - means the bid or proposal submitted in response this solicitation. The terms “Bid” and “Proposal” are used interchangeably with the term “Offer.”
- (5) **OFFEROR** - means the single legal entity submitting the offer. The term “Bidder” is used interchangeably with the term “Offeror.” See bidding provisions entitled “Signing Your Offer” and “Bid/Proposal As Offer To Contract.”
- (6) **PROCUREMENT OFFICER** - means the person, or his successor, identified as such on the Cover Page.
- (7) **YOU and YOUR** - means Offeror.
- (8) **SOLICITATION** - means this document, including all its parts, attachments, and any Amendments.
- (9) **SUBCONTRACTOR** - means any person having a contract to perform work or render service to Contractor as a part of the Contractor’s agreement arising from this solicitation.

**DUTY TO INQUIRE (AUG 2004)** Offeror, by submitting an Offer, represents that it has read and understands the Solicitation and that its Offer is made in compliance with the Solicitation. Offerors are expected to examine the Solicitation thoroughly and should request an explanation of any ambiguities, discrepancies, errors, omissions, or conflicting statements in the Solicitation. Failure to do so will be at the Offeror’s risk. Offeror assumes responsibility for

any patent ambiguity in the Solicitation that Offeror does not bring to the University's attention.

OMIT TAXES FROM PRICE (AUG 2004) Do not include any taxes in Your price that the State may be required to pay.

PROTESTS (AUG 2004) Any prospective bidder, offeror, contractor, or subcontractor who is aggrieved in connection with the solicitation of a contract shall protest within fifteen days of the date of issuance of the applicable solicitation document at issue. Any actual bidder, offeror, contractor, or subcontractor who is aggrieved in connection with the intended award or award of a contract shall protest within fifteen days of the date notification of award is posted in accordance with this code. A protest shall be in writing, submitted to the appropriate chief procurement officer, and shall set forth the grounds of the protest and the relief requested with enough particularity to give notice of the issues to be decided. [§ 11-35-4210]

PUBLIC OPENING (AUG 2004) Offers will be publicly opened at the date / time and at the location identified on the Cover Page, or last Amendment, whichever is applicable.

QUESTIONS FROM OFFERORS (Aug 2004) (a) Any prospective offeror desiring an explanation or interpretation of the solicitation, drawings, specifications, etc., must request it in writing. Questions must be received by the Procurement Officer no later than five (5) days prior to opening unless otherwise stated on the Cover Page. Oral explanations or instructions will not be binding. Any information given a prospective offeror concerning a solicitation will be furnished promptly to all other prospective offerors as an Amendment to the solicitation, if that information is necessary for submitting offers or if the lack of it would be prejudicial to other prospective offerors. (b) The University seeks to permit maximum practicable competition. Offerors are urged to advise the Procurement Officer - as soon as possible - regarding any aspect of this procurement, including any aspect of the Solicitation, that unnecessarily or inappropriately limits full and open competition.

RESPONSIVENESS / IMPROPER OFFERS (AUG 2004) (a) Bid as Specified. Offers for supplies or services other than those specified will not be considered unless authorized by the Solicitation.

(b) Multiple Offers. Offerors may submit more than one Offer, provided that each Offer has significant differences other than price. Each separate Offer must satisfy all Solicitation requirements. While multiple Offers may be submitted as one document, Offeror is responsible for clearly differentiating between each separate Offer. If this solicitation is a Request for Proposals, each separate Offer must include a separate cost proposal.

(c) Responsiveness. Any Offer which fails to conform to the material requirements of the Solicitation may be rejected as nonresponsive. Offers which impose conditions that modify material requirements of the Solicitation may be rejected. If a fixed price is required, an Offer will be rejected if the total possible cost to the State cannot be determined. Offerors will not be given an opportunity to correct any material nonconformity. Any deficiency resulting from a minor informality may be cured or waived at the sole discretion of the Procurement Officer. [R.19-445.2070 and Section 11-35-1520(13)]

(d) Unbalanced Bidding. The State may reject an Offer as nonresponsive if the prices bid are materially unbalanced between line items or subline items. A bid is materially unbalanced when it is based on prices significantly less than cost for some work and prices which are significantly overstated in relation to cost for other work, and if there is a reasonable doubt that the bid will result in the lowest overall cost to the State even though it may be the low evaluated bid, or if it is so unbalanced as to be tantamount to allowing an advance payment.

**RESTRICTIONS APPLICABLE TO OFFERORS (AUG 2004)** By submitting an Offer, You agree not to discuss this procurement activity in any way with any university department or its employees, agents or officials. All communications must be solely with the Procurement Officer. This restriction expires once a contract has been formed and may be lifted by express written permission from the Procurement Officer.

**SIGNING YOUR OFFER (AUG 2004)** Every Offer must be signed by an individual with actual authority to bind the Offeror. (a) If the Offeror is an individual, the Offer must be signed by that individual. If the Offeror is an individual doing business as a firm, the Offer must be submitted in the firm name, signed by the individual, and state that the individual is doing business as a firm. (b) If the Offeror is a partnership, the Offer must be submitted in the partnership name, followed by the words "by its Partner," and signed by a general partner. (c) If the Offeror is a corporation, the Offer must be submitted in the corporate name, followed by the signature and title of the person authorized to sign. (d) An Offer may be submitted by a joint venturer involving any combination of individuals, partnerships, or corporations. Offeror agrees to defend, indemnify and hold harmless the State of South Carolina, its officers and employees, from every claim, demand, loss, expense, cost, damage or injury, including attorney's fees, arising out of or resulting from the State withholding information that Offeror marked as "confidential" or "trade secret" or "PROTECTED". (All references to S.C. Code of Laws.)

**SUBMITTING YOUR OFFER OR MODIFICATION (AUG 2004)** (a) Offers and offer modifications shall be submitted in sealed envelopes or packages (unless submitted by approved electronic means) - (1) Addressed to the office specified in the Solicitation; and (2) Showing the time and date specified for opening, the solicitation number, and the name and address of the offeror. (b) Each Offeror must submit the number of copies indicated on the Cover Page. (c) Offerors using commercial carrier services shall ensure that the Offer is addressed and marked on the outermost envelope or wrapper as prescribed in paragraphs (a)(1) and (2) of this provision when delivered to the office specified in the Solicitation. (d) Facsimile Offers, modifications, or withdrawals, will not be considered unless authorized by the Solicitation. (e) Offers submitted by electronic commerce shall be considered only if the electronic commerce method was specifically stipulated or permitted by the solicitation.

**TAX CREDIT FOR SUBCONTRACTING WITH MINORITY FIRMS (AUG 2004)** Pursuant to Section 12-6-3350, taxpayers, who utilize certified minority subcontractors, may take a tax credit equal to 4% of the payments they make to said subcontractors. The payments claimed must be based on work performed directly for a South Carolina state contract. The credit is capped at \$25,000 per year or the total tax liability; whichever is lesser. The taxpayer is eligible to claim the credit for 6 consecutive taxable years beginning with the taxable year in which the credit is first claimed. There is no carry forward of unused credits. The credit may be claimed on Form TC-2, "Minority Business Credit." A copy of the subcontractor's certificate from the Governor's Office of Small and Minority Business (OSMBA) is to be attached to the contractor's income tax return. Taxpayers must maintain evidence of work performed for a State contract by the minority subcontractor. Questions regarding the tax credit and how to file are to be referred to: SC Department of Revenue, Research and Review, Phone: (803) 898-5786, Fax: (803) 898-5888. The subcontractor must be certified as to the criteria of a "Minority Firm" by the Governor's Office of Small and Minority Business Assistance (OSMBA). Certificates are issued to subcontractors upon successful completion of the certification process. ### **III. Scope of Work / Specifications**

The maximum per foot price is not a guarantee of work nor is it an established set price at which all work performed will be billed. Rather, it specifies the ceiling per foot price beneath which the University of South Carolina Newsfilm Library and an approved vendor can negotiate the per foot value of a given work order. By establishing a 5-year contract, the University of South Carolina does not seek to nullify a qualified vendors ability to set a minimum price per order.

The Newsfilm Library is not obligated to provide any work to any vendor that submits a quote nor is it obligated to provide a minimum amount of work to a vendor that has contracted with the University of South Carolina under this agreement.

All quotes for printing will be provided as a maximum 'cost per foot.' The maximum 'cost per foot' must include all costs other than shipping.

The University of South Carolina Newsfilm Library is solely responsible for the selection of qualified vendors.

The University of South Carolina Newsfilm Library is solely responsible for making decisions or selections options required by the vendor during a printing project.

#### **Technical requirements for proper completion of the work.**

May include all or some as required:

1. Cleaning
2. Splicing or re-splicing
3. Repair to sprockets as required
4. Timing of the film elements.
5. Wet Gate
6. Optical or Contact Printing with Set Up
7. Composite sound sync at 22 frames separation
8. Telecine transfer
9. Color Correction

#### **Work to be produced**

One or more of the below listed products may be requested of a qualified vendor for a given work order; however, the maximum per foot must allow for the purchase of all of the items listed below.

1. One Fine Grain Master Positive, composite sound or silent for each reel of film submitted. And/or
2. One Duplicate Negative, composite sound or silent for each reel of film submitted

3. One Answer Print on polypropylene reel, sound or silent for each reel submitted.  
And/or
4. One digital video tape. And/or
5. MPEG2 and AIFF files on optical disc

**Description of the type of film offered for printing**

The film offered by the University of South Carolina Newsfilm Library for work under this Fixed Price Bid may have all or some of the following properties:

1. 35 mm or 16mm
2. Black & white or color
3. Silent, full frame or optical sound composite with the picture
  - a. Note that the Fox Case sound negatives all have a separation of only eleven frames between syncing image and sound. The vendor is expected to delay the final composite soundtrack by an additional eleven frames when working with these negatives.
4. Nitrocellulose base (UN1324) or acetate
5. Shrinkage of the film varies, but could be as much as 2.5%
6. Emulsion scratches and or deterioration caused by microbes.
7. Tape and cement splices will be found at intervals.

**Pre-inspection of the Film** to be printed cannot be provided.

**Payment** will be made to the vendor after the new prints have been received and approved by the Newsfilm Library.

The vendor is obligated to reprint any work not deemed satisfactory by the Newsfilm Library. The Newsfilm Library will provide written instructions describing the desired correct in the case a reprint of work is required. The Newsfilm Library is not obligated to reveal its methods and criteria for making its determinations about the quality of work.

**Shipping** to the Vendor will be provided by the University of South Carolina Newsfilm Library.

Shipping from the Vendor will be paid for by the University of South Carolina Newsfilm Library.

The Vendor will prepare and return ship the nitrocellulose film materials as per IATA or DOT as required. The University shall assume no legal or financial liabilities for fines incurred by the vendor as a result of return shipping.

The Vendor shall ship the completed prints and/or video tapes to the University via the carrier of its choice. The vendor may chose to insure the completed prints as its own expense. The Newsfilm Library will accept shipping charges after approval of a shipping estimate. The completed prints should be evaluated and approved by the Newsfilm

Library before the nitrocellulose elements are returned by the vendor. Payment for the work shall be approved by the Newsfilm Library after the new printed elements have been received and inspected.

The vendor is expected to exercise all due caution with copies of the University of South Carolina's film elements. All film elements are the property of the University of South Carolina and no copies of the film elements should be made available to any other parties without the written consent of the Newsfilm Library.

## **ADDITIONAL REQUIREMENTS**

### **1. CONTRACTOR'S AND SUBCONTRACTOR'S INSURANCE**

Contractor shall not commence work under this contract until he has obtained all insurance required hereunder and such insurance has been approved by the University of South Carolina; any and all subcontractors performing any service pursuant to this contract must meet the minimum insurance coverage limits set for the primary contractor.

#### **Bodily Injury Liability & Property Damage Liability Insurance**

The Contractor shall provide and maintain, during the life of this contract, the following minimum insurance coverage with the University of South Carolina named as an additional insured. All vendors must submit with their bid (or within ten (10) days after notification of intent to award) the original or certified true copy insurance certificate. If this information is not provided within this time frame the bid will be rejected. All insurance coverage costs must be exclusive of any legal costs.

All insurance shall remain in effect for the duration of this contract, including extensions. Insurance and/or bond shall be secured from companies licensed to do business in the State of South Carolina and shall be countersigned by a licensed resident agent authorized to conduct business in South Carolina. All policies must include the University of South Carolina as an additional insured.

#### IV. Information for Offerors to Submit

- a. Contract Rate Per Foot: In Attachment A, provide the maximum rate per foot to be charged to the University for performing the services as described in the specifications.
- b. Qualifications and Experience: Provide a description of company profile, structure, length of time in business and specific experience to indicate ability to perform, manage and service the University in accordance with the specifications as stated herein. Offeror must provide information that they meet the qualifications as provided in Part V. Describe company resources available including adequate staff to accomplish stated requirements and to serve the University during peak demands. Submit resumes indicating the credentials and experience of key personnel to be assigned to this program and their training and qualifications.
- c. References: Offeror should provide a minimum of four (4) references; one of which must be a University. Such listing should include one (1) current client for whom your company is currently providing services of similar nature. Services must include handling shrunken nitrocellulose film stock in a safe manner as prescribed by NFPA 40 and NFPA 221. List must include institution name and contact persons with complete and accurate mailing addresses and telephone numbers and contain any required written consent from clients listed as references to allow the University to inquire about the company performance.
- c. Insurance: Offeror must provide evidence of insurance as requested in this solicitation, with the University of South Carolina as the named insured.

## V. Qualifications

Offerors must have experience in handling shrunken nitrocellulose film stock in a safe manner as prescribed by NFPA 40 and NFPA 221. Offerors must be able to provide client references that deal specifically with nitrate film.

## VI. Award Criteria

### Evaluation/Award

Award will be made to all responsive and responsible bidders to the University's request for competitive fixed price bidding. The maximum pay rate per foot is listed in Attachment "A".

During the term of this contract, the University may add additional contractors annually to the approved provider list upon verification of the contractor's qualifications as mandated herein by the University.

## VII. Terms and Conditions

### A. Special

#### **SPECIAL CONTRACT CLAUSES**

##### **Bidding Condition of Price**

Bid price must be fixed for the initial contract period, except the University shall be advised of, and receive the benefit of, any price decrease. The contractor must agree to provide written price reduction information within ten (10) days of its effective date.

##### **Insurance Requirements**

Certificate of insurance evidencing the required **Employment Practices Liability Insurance** coverage must be provided with the bid response. Failure to provide this evidence will be considered as though no EPLI coverage is in force and will result in rejection of the bid. Also, all other liability insurances as specified herein must be maintained during the entire term of the contract.

##### **Indemnification**

The University of South Carolina, its officers, agents, and employees shall be held harmless from liability from any claims, damages and actions of any nature arising from the use of any materials furnished by the contractor, provided that such liability is not attributable to negligence on the part of the using agency or

failure of the using agency to use the materials in the manner outlined by the contractor in descriptive literature or specifications submitted with the contractor's bid.

**Term/Option to Extend:**

Initial contract period: One year from date of award.

A resulting contract will automatically extend on each anniversary date unless either party elects not to extend the contract. Extensions may be less than, but will not exceed 4 additional one (1) year periods. If contractor elects not to extend on the anniversary date, the contractor must notify the University of South Carolina Purchasing department of its intention in writing ninety (90) days prior to the anniversary date.

**B. General**

**AFFIRMATIVE ACTION:** The contractor will take affirmative action in complying with all Federal and State requirements concerning fair employment and employment of the handicapped, and concerning the treatment of all employees, without regard or discrimination by reason of race, color, religion, sex, national origin or physical handicap. The following are incorporated herein by reference: 41 C.F.R. 60-1.4, 60-250.4 and 60-741-4.

**ASSIGNMENT:** No contract or its provisions may be assigned, sublet, or transferred without the written consent of the University of South Carolina Purchasing department.

**CONTRACT AMENDMENTS:** Amendments to any contract between the agency and the contractor must be reviewed and approved by the University of South Carolina Purchasing department.

**COMPLIANCE WITH FEDERAL REQUIREMENTS:** State or Federal requirements that are more restrictive shall be followed.

**FORCE MAJEURE:** The Contractor shall not be liable for any excess costs if the failure to perform the contract arises out of causes beyond the control and without the fault or negligence of the contractor. Such causes may include, but are not restricted to acts of God or of the public enemy, acts of the Governments in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, and unusually severe weather; but in every case the failure to perform must be beyond the control and without the fault or negligence of the contractor. If the failure to perform is caused by the default of a subcontractor, and if such default arises out of causes beyond the control of both the contractor and subcontractor, and without the fault or negligence of either of them, the contractor shall not be liable for any excess costs for failure to perform, unless the supplies or services to be furnished by the subcontractor were

obtainable from other sources in sufficient time to permit the contractor to meet the required delivery schedule.

**INDEMNIFICATION:** The University of South Carolina, its officers, agents, and employees, shall be held harmless from liability from any claims, damages and actions of any nature arising from a resultant contract, provided that such liability is not attributable to negligence on the part of the using agency or failure of the using agency to comply with the offer as outlined in the offeror's proposal.

**LEGAL OR CONSULTANT SERVICES:** If this contract is for legal or consultant services, it is subject to the provisions of Section 11-9-105 of the 1976 Code of Laws of South Carolina as amended. "Any contract for legal or consultant services entered into by a state agency or institution shall include a provision which requires completion of all services. The Provisions shall further require that in the event all services are not fully rendered as provided for in the contract, any Monies which have been paid by the agency under the contract must be refunded to the agency along with a twelve (12) percent penalty".

**PAYMENT FOR GOODS & SERVICES:** Payment for goods & services received by the University shall be processed in accordance with Section 11-35-45 of the South Carolina Procurement Code.

**PRIME CONTRACTOR RESPONSIBILITIES:** The contractor will be required to assume sole responsibility for the complete effort as required by this RFP. The University will consider the contractor to be the sole point of contact with regard to contractual matters.

**RECORDS RETENTION & RIGHT TO AUDIT:** The University shall have the right to audit the books and records of the contractor as they pertain to this contract, both independent of, and pursuant to, S.C. Code Section 11-35-2220. Such books and records shall be maintained for a period of six (6) years from the date of final payment under the contract. The University may conduct, or have conducted, performance audits of the contractor. The University may conduct, or have conducted, audits of specific requirements of this bid as determined necessary by the University. Pertaining to all audits, contractor shall make available to the University access to its computer files containing the history of contract performance and all other documents related to the audit. Additionally, any software used by the contractor shall be made available for auditing purposes at no cost to the University.

**SOUTH CAROLINA GOVERNING LAW CLAUSE:** The Agreement and any dispute, claim, or controversy relating to the Agreement shall, in all respects, be interpreted, construed, enforced and governed by and under the laws of the State of South Carolina. All disputes, claims, or controversies relating to the Agreement shall be resolved exclusively by the appropriate Chief Procurement Officer in accordance with Title 11, Chapter 35, Article 17 of the South Carolina Code of



Laws, or in the absence of jurisdiction, only in the Court of Common Pleas for, or a federal court located in, Richland County, State of South Carolina. Contractor agrees that any act by the Government regarding the Agreement is not a waiver of either the Government's sovereign immunity or the Government's immunity under the Eleventh Amendment of the United State's Constitution. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation. The parties expressly agree that the UN Convention on the International Sale of Goods shall not apply to this agreement.

**SUBCONTRACTING:** If any part of the work covered by this RFP is to be subcontracted, the offeror shall identify the subcontracting organization and the contractual arrangements made therewith. All subcontractors must be approved by the University. The offeror will also furnish the corporate or company name and the names of the officers of any subcontractors engaged by the offeror.

**TERMINATION:** Subject to the Provisions below, any contract resulting from this proposal may be terminated by the University of South Carolina Purchasing department provided a thirty (30) days advance notice in writing is given to the contractor.

**Non-Appropriations:** Funds for this contract are payable from State and/or Federal appropriations. In the event sufficient appropriations are not made to pay the charges under the contract it shall terminate without any obligation to the University of South Carolina.

**Convenience:** In the event that this contract is terminated or canceled upon request and for the convenience of the University without the required thirty (30) days advance written notice, then the University shall negotiate reasonable termination costs, if applicable.

**Cause:** Termination by the University for cause, default or negligence on the part of the contractor shall be excluded from the foregoing provisions; termination costs, if any shall not apply. The thirty (30) days advance notice requirement is waived and the default provision listed herein shall apply.

**Default:** In case of default on contractor, the University reserves the right to purchase any or all items/services in default in open market, charging contractor with any excessive costs. **SHOULD SUCH CHARGE BE ASSESSED, NO SUBSEQUENT PROPOSALS OF THE DEFAULTING CONTRACTOR WILL BE CONSIDERED UNTIL THE ASSESSED CHARGE HAS BEEN SATISFIED.**

**OFFEROR RESPONSIBILITY:** Each offeror shall fully acquaint himself with conditions relating to the scope and restrictions attending the execution of the work under the conditions of this proposal. It is expected that this will sometimes require on-site observation. The failure or omission of an offeror to acquaint himself with existing conditions shall in no way relieve him of any obligation with respect to this proposal or to the contract.

**OWNERSHIP OF MATERIAL:** Ownership of all data, material and documentation originated and prepared for the University pursuant to this contract shall belong exclusively to the University.

**OWNERSHIP OF MATERIAL:** Ownership of all data, material and documentation originated and prepared for the State pursuant to this contract shall belong exclusively to the University.

**PURCHASING LIABILITY:** The University of South Carolina Purchasing department is acting under the authority given to it in the Consolidated Procurement Code to procure contracts on behalf of its departments and acts only as their agent in this respect. The resulting contract is between the department and the successful offeror and the University of South Carolina Purchasing department bears no liability for any damages that any party may incur in the execution or enforcement of the contract.

**IMPORTANT TAX NOTICE - NONRESIDENTS ONLY**

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C.
