I. Scope Of Solicitation

ACQUIRE SERVICES (JAN 2006): The purpose of this solicitation is to acquire services complying with the enclosed description and/or specifications and conditions.

MAXIMUM CONTRACT PERIOD — ESTIMATED (JAN 2006): [**September 2013 – August 2018**]. Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract – Effective Date / Initial Contract Period".

II. Instructions To Offerors - A. General Instructions

DEFINITIONS (JANUARY 2006) EXCEPT AS OTHERWISE PROVIDED HEREIN, THE FOLLOWING DEFINITIONS ARE APPLICABLE TO ALL PARTS OF THE SOLICITATION.

AMENDMENT – means a document issued to supplement the original solicitation document.

BUYER – means the Procurement Officer.

CHANGE ORDER - means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract.

CONTRACT - See clause entitled “Contract Documents & Order of Precedence.”

CONTRACT MODIFICATION – means a written order signed by the Procurement Officer, directing the contractor to make changes which the changes clause of the contract authorizes the Procurement Officer to order without the consent of the contractor.

CONTRACTOR - means the Offeror receiving an award as a result of this solicitation.

COVER PAGE – means the top page of the original solicitation on which the solicitation is identified by number. Offerors are cautioned that Amendments may modify information provided on the Cover Page.

OFFER – means the bid or proposal submitted in response this solicitation. The terms “Bid” and “Proposal” are used interchangeably with the term “Offer.”

OFFEROR – means the single legal entity submitting the offer. The term “Bidder” is used interchangeably with the term “Offeror.” See bidding provisions entitled “Signing Your Offer” and “Bid/Proposal As Offer To Contract.”

ORDERING ENTITY - Using Governmental Unit that has submitted a Purchase Order.

PAGE TWO – means the second page of the original solicitation, which is labeled Page Two.

PROCUREMENT OFFICER – means the person, or his successor, identified as such on the Cover Page.

YOU and YOUR – means Offeror.

SOLICITATION – means this document, including all its parts, attachments, and any Amendments.

STATE – means the Using Governmental Unit(s) identified on the Cover Page.

SUBCONTRACTOR – means any person having a contract to perform work or render service to Contractor as a part of the Contractor’s agreement arising from this solicitation.

USING GOVERNMENTAL UNIT – means the unit(s) of government identified as such on the Cover Page. If the Cover Page names a “Statewide Term Contract” as the Using Governmental Unit, the Solicitation seeks to establish a Term Contract [11-35-310(35)] open for use by all South Carolina Public Procurement Units [11-35-4610(5)].

WORK - means all labor, materials, equipment and services provided or to be provided by the Contractor to fulfill the Contractor’s obligations under the Contract.

(c) If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.

AWARD NOTIFICATION (NOV 2007):Notice regarding any award or cancellation of award will be posted at the location specified on the Cover Page. If the contract resulting from this Solicitation has a total or potential value of fifty thousand dollars or more, such notice will be sent to all Offerors responding to the Solicitation. Should the contract resulting from this Solicitation have a total or potential value of one hundred thousand dollars or more, such notice will be sent to all Offerors responding to the Solicitation and any award will not be effective until the eleventh day after such notice is given. BID / PROPOSAL AS OFFER TO CONTRACT (JANUARY 2006) By submitting Your Bid or Proposal, You are offering to enter into a contract with the Using Governmental Unit(s). Without further action by either party, a binding contract shall result upon final award. Any award issued will be issued to, and the contract will be formed with, the entity identified as the Offeror on the Cover Page. An Offer may be submitted by only one legal entity; “joint bids” are not allowed.

(a)(1) By submitting an Offer, Offeror certifies, to the best of its knowledge and belief, that-

(i) Offeror and/or any of its Principals-

(A) Are not presently debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any state or federal agency;

(B) Have not, within a three-year period preceding this offer, been convicted of or had a civil judgment rendered against them for: commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (Federal, state, or local) contract or subcontract; violation of Federal or state

antitrust statutes relating to the submission of offers; or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, tax evasion, or receiving stolen property; and

(ii) Offeror has not, within a three-year period preceding this offer, had one or more contracts terminated for default by any public (Federal, state, or local) entity.

(2) "Principals," for the purposes of this certification, means officers; directors; owners; partners; and, persons having primary management or supervisory responsibilities within a business entity (e.g., general manager; plant manager; head of a subsidiary, division, or business segment, and similar positions).

(b) Offeror shall provide immediate written notice to the Procurement Officer if, at any time prior to contract award, Offeror learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.

(c) If Offeror is unable to certify the representations stated in paragraphs (a)(1), Offer must submit a written explanation regarding its inability to make the certification. The certification will be considered in connection with a review of the Offeror's responsibility. Failure of the Offeror to furnish additional information as requested by the Procurement Officer may render the Offeror nonresponsible.

(d) Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render, in good faith, the certification required by paragraph (a) of this provision. The knowledge and information of an Offeror is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.

(e) The certification in paragraph (a) of this provision is a material representation of fact upon which reliance was placed when making award. If it is later determined that the Offeror knowingly or in bad faith rendered an erroneous certification, in addition to other remedies available to the State, the Procurement Officer may terminate the contract resulting from this solicitation for default.

CERTIFICATE OF INDEPENDENT PRICE DETERMINATION (MAY 2008)

(a) By submitting an offer, the offeror certifies that-

(ii) The intention to submit an offer; or

(iii) The methods or factors used to calculate the prices offered.

(2) The prices in this offer have not been and will not be knowingly disclosed by the offeror, directly or indirectly, to any other offeror or competitor before bid opening (in the case of a sealed bid solicitation) or contract award (in the case of a negotiated solicitation) unless otherwise required by law; and

(3) No attempt has been made or will be made by the offeror to induce any other concern to submit or not to submit an offer for the purpose of restricting competition.

If this solicitation is a Request for Proposals, multiple offers may be submitted as one document, provided that you clearly differentiate between each offer and you submit a separate cost proposal for each offer, if applicable.

(c) Responsiveness. Any Offer which fails to conform to the material requirements of the Solicitation may be rejected as nonresponsive. Offers which impose conditions that modify material requirements of the Solicitation may be rejected. If a fixed price is required, an Offer will be rejected if the total possible cost to the State cannot be determined. Offerors will not be given an opportunity to correct any material nonconformity. (d) Price Reasonableness: Any offer may be rejected if the Procurement Officer determines in writing that it is unreasonable as to price. [R. 19-445.2070].

(e) Unbalanced Bidding. The State may reject an Offer as nonresponsive if the prices bid are materially unbalanced between line items or subline items. A bid is materially unbalanced when it is based on prices significantly less than cost for some work and prices which are significantly overstated in relation to cost for other work, and if there is a reasonable doubt that the bid will result in the lowest overall cost to the State even though it may be the low evaluated bid, or if it is so unbalanced as to be tantamount to allowing an advance payment.

RESTRICTIONS APPLICABLE TO OFFERORS (JANUARY 2006) Violation of these restrictions may result in disqualification of your offer, suspension or debarment, and may constitute a violation of the state Ethics Act.

(a) After issuance of the solicitation, ***you agree not to discuss this procurement activity in any way with the Using Governmental Unit or its employees, agents or officials.*** All communications must be solely with the Procurement Officer. This restriction may be lifted by express written permission from the Procurement Officer. This restriction expires once a contract has been formed. (b) Unless otherwise approved in writing by the Procurement Officer, ***you agree not to give anything to any Using Governmental Unit***

SIGNING YOUR OFFER (JANUARY 2006) Every Offer must be signed by an individual with actual authority to bind the Offeror. (a) If the Offeror is an individual, the Offer must be signed by that individual. If the Offeror is an individual doing business as a firm, the Offer must be submitted in the firm name, signed by the individual, and state that the individual is doing business as a firm. (b) If the Offeror is a partnership, the Offer must be submitted in the partnership name, followed by the words "by its Partner," and signed by a general partner. (c) If the Offeror is a corporation, the Offer must be submitted in the corporate name, followed by the signature and title of the person authorized to sign. (d) An Offer may be submitted by a joint venturer involving any combination of individuals, partnerships, or corporations. If the Offeror is a joint venture, the Offer must be submitted in the name of the Joint Venture and signed by every participant in the joint venture in the manner prescribed in paragraphs (a) through (c) above for each type of participant. TAXPAYER IDENTIFICATION NUMBER (JANUARY 2006): (a) If Offeror is owned or controlled by a common parent as defined in paragraph (b) of this provision, Offeror shall submit with its Offer the name and TIN of common parent.

III. Scope of Work / Specifications

I. Scope - The University of South Carolina is interested in establishing a contract with merchants in close proximity to campus to allow funds deposited by students, faculty and staff on their Carolina Card account to be used for the purchase of groceries, certain prepared food and beverages, gasoline, dry cleaning services, certain items sold in convenience stores, and entertainment venues. The businesses that will be included in this program should typically be located within a 5 mile radius of campus and must meet criteria prescribed in this RFP and in the attached Merchant Agreement. The program is one that will be established initially in pilot form and will be expanded over the term of the contract.

II. Carolina Card - The Carolina Card is the official University ID that is used for residential and building access, meal plans and as a pre-paid declining balance card. Students, faculty and staff may choose to deposit funds on their Carolina Card at any time. Deposits can be made electronically online through a debit or credit card or over the counter in cash or credit card at the Carolina Card office which is located in the University Student Union (the Russell House.) Each time a purchase is made using the card, the amount of the transaction is deducted from the Carolina Cash account balance. There are currently 29,047 students, 4,402 staff, and 2,944 faculty with active cards issued for the Columbia Campus. Deposits made to the Carolina Card during FY 2012 totaled \$9,140,042.

III. Carolina Card Locations - The Carolina Card is currently used on campus at the following locations:

- Campus Dining Locations
- University Bookstores
- On Campus Vending machines
- Laundry services in campus residential housing
- Campus computer labs for printing and copying
- Printing and copying at Libraries on Campus
- Strom Thurmond Wellness and Blatt PE Center
- Health Services
- Parking Services
- Carolina Styles (Hair Styles/Beauty/Barber services)
- Russell House Information Desk and Game Room
- Stadiums and Colonial Life Arena concessions

- Student Tickets for Athletic events
- USC Post Office

IV. Pilot Phase – To ensure a smooth implementation of the Card usage off-campus, the University desires to enter an initial pilot phase choosing at least one merchant for each of the following merchant types:

- a. Grocery Store
- b. Health Food Specialty Store
- c. Gas Station/Convenience
- d. Convenience Store/Pharmacy
- e. Dry Cleaner/Laundry
- f. Full Service Seated Dining
- g. Other Prepared Food Venues for in-house or take-out dining
- h. Dessert Venues

The Pilot Phase will be conducted for the period of time determined necessary by the University of South Carolina to fully evaluate the operational requirements of the program and ensure its accountability and success. Following this determination, the University will add additional merchants to the program on a schedule that it deems appropriate. Participation in this program will be earned through this procurement process. Minimum rates of commission required to participate have been set by the University based upon the experience of other Universities and Colleges with similar programs. There is also a required charge per transaction that each Merchant must pay to reimburse the University for the cost that it must pay to its third party vendor who will provide the technological and accounting services necessary for the operation of the program. The current per transaction rate is \$.30, but this may increase or decrease during the term of the contract as these costs increase/decrease for the University. The minimum rates of commission per merchant category are listed in Section VII . Any Merchant who meets the University’s specifications and review and is willing to agree to the minimum commission rate, transaction fees and terms of the attached Merchant Agreement, may be selected to participate in the contract.

The University intends to award contracts to at least one merchant in each category. The order of implementation, including implementation of the pilot phase of the program, will be determined by the following criteria which are listed in relative order of importance:

1. Proposed commission rate
2. Support from the student body
3. Proximity to campus

V. Full Implementation Phase - When the University determines that the Pilot Program has been successful in establishing a smooth operation of the program, it will begin adding additional vendors to the program that have been selected through this process. The additional vendors that are added in each category will be sequenced in the order determined by the University taking into account the commission rate that they offer the University.

VI. Post-Pilot Categories of Merchants - The following additional categories of Merchants are encouraged to submit proposals to be included in the final full implementation Phase of the program:

1. Delivered Food
2. Coffee/Pastries only
3. Taxis
4. Recreational and Entertainment Locations

VII. Additional Categories and Merchants – The University reserves the right to add additional business categories and assign minimum commission rates and maximum transaction charges (as deemed reasonable

within industry standards) throughout the term of this contract as the University's needs change. When such actions occur, an amendment to the existing solicitation will be posted and will be available for interested merchants to review and respond accordingly. Commission rates offered by new Merchants for existing categories must be at or above the minimum rates provided in this solicitation, and for new categories, will be determined based upon the average commissions earned by other SEC schools for the same category of merchant.

IV. Qualifications

QUALIFICATION OF OFFEROR (JAN 2006) To be eligible for award of a contract, a prospective contractor must be responsible. In evaluating an Offeror's responsibility, the State Standards of Responsibility [R.19-445.2125] and information from any other source may be considered. An Offeror must, upon request of the State, furnish satisfactory evidence of its ability to meet all contractual requirements. Unreasonable failure to supply information promptly in connection with a responsibility inquiry may be grounds for determining that you are ineligible to receive an award. S.C. Code Section 11-35-1810.

SUBCONTRACTOR – IDENTIFICATION (JAN 2006): If you intend to subcontract with another business for any portion of the work and that portion exceeds 10% of your price, your offer must identify that business and the portion of work which they are to perform. Identify potential subcontractors by providing the business' name, address, phone, taxpayer identification number, and point of contact. In determining your responsibility, the state may evaluate your proposed subcontractors.

V. Award Criteria

VI. Terms and Conditions - A. General

ASSIGNMENT (JAN 2006): No contract or its provisions may be assigned, sublet, or transferred without the written consent of the Procurement Officer.

BANKRUPTCY (JAN 2006): (a) Notice. In the event the Contractor enters into proceedings relating to bankruptcy, whether voluntary or involuntary, the Contractor agrees to furnish written notification of the bankruptcy to the Using Governmental Unit. This notification shall be furnished within five (5) days of the initiation of the proceedings relating to the bankruptcy filing. This notification shall include the date on which the bankruptcy petition was filed, the identity of the court in which the bankruptcy petition was filed, and a listing of all State contracts against which final payment has not been made. This obligation remains in effect until final payment under this Contract. (b) Termination. This contract is voidable and subject to immediate termination by the State upon the contractor's insolvency, including the filing of proceedings in bankruptcy.

CHOICE-OF-LAW (JAN 2006): The Agreement, any dispute, claim, or controversy relating to the Agreement, and all the rights and obligations of the parties shall, in all respects, be interpreted, construed, enforced and governed by and under the laws of the State of South Carolina, except its choice of law rules. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation.

CONTRACT DOCUMENTS & ORDER OF PRECEDENCE (JAN 2006): (a) Any contract resulting from this solicitation shall consist of the following documents: (1) a Record of Negotiations, if any, executed by you and the Procurement Officer, (2) documentation regarding the clarification of an offer [e.g., 11-35-1520(8) or 11-35-1530(6)], if applicable, (3) the solicitation, as amended, (4) modifications, if any, to your offer, if accepted by the Procurement Officer, (5) your offer, (6) any statement reflecting the state's final acceptance (a/k/a "award"), and (7) purchase orders. These documents shall be read to be consistent and complimentary. Any conflict among these documents shall be resolved by giving priority to these documents in the order listed above. (b) The terms and conditions of documents (1) through (6) above shall apply notwithstanding any additional or different terms and conditions in either (i) a purchase order or other instrument submitted by the State or (ii) any invoice or other document submitted by Contractor. Except as otherwise allowed herein, the terms and conditions of all such documents shall be void and of no effect. (c) No contract, license, or other agreement containing contractual terms and conditions will be signed by any Using Governmental Unit. Any document signed or otherwise agreed to by persons other than the Procurement Officer shall be void and of no effect.

DISCOUNT FOR PROMPT PAYMENT (JAN 2006)

(a) Discounts for prompt payment will not be considered in the evaluation of offers. However, any offered discount will form a part of the award, and will be taken if payment is made within the discount period indicated in the offer by the offeror. As an alternative to offering a discount for prompt payment in conjunction with the offer, offerors awarded contracts may include discounts for prompt payment on individual invoices.

(b) In connection with any discount offered for prompt payment, time shall be computed from the date of the invoice. If the Contractor has not placed a date on the invoice, the due date shall be calculated from the date the designated billing office receives a proper invoice, provided the state annotates such invoice with the date of receipt at the time of receipt. For the purpose of computing the discount earned, payment shall be considered to have been made on the date that appears on the payment check or, for an electronic funds transfer, the specified payment date. When the discount date falls on a Saturday, Sunday, or legal holiday when Federal Government offices are closed and Government business is not expected to be conducted, payment may be made on the following business day.

DISPUTES (JAN 2006): (1) Choice-of-Forum. All disputes, claims, or controversies relating to the Agreement shall be resolved exclusively by the appropriate Chief Procurement Officer in accordance with Title 11, Chapter 35, Article 17 of the South Carolina Code of Laws, or in the absence of jurisdiction, only in the Court of Common Pleas for, or a federal court located in, Richland County, State of South Carolina. Contractor agrees that any act by the Government regarding the Agreement is not a waiver of either the Government's sovereign immunity or the Government's immunity under the Eleventh Amendment of the United State's Constitution. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation. (2) Service of Process. Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any disputes, claims, or controversies relating to the Agreement; for any court action in connection therewith; or for the entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided as the Notice Address on Page Two or by personal service or by any other manner that is permitted by law, in or outside South Carolina. Notice by certified mail is deemed duly given upon deposit in the United States mail.

EQUAL OPPORTUNITY (JAN 2006): Contractor is referred to and shall comply with all applicable provisions, if any, of Title 41, Part 60 of the Code of Federal Regulations, including but not limited to Sections 60-1.4, 60-4.2, 60-4.3, 60-250.5(a), and 60-741.5(a), which are hereby incorporated by reference.

FALSE CLAIMS (JAN 2006): According to the S.C. Code of Laws § 16-13-240, "a person who by false pretense or representation obtains the signature of a person to a written instrument or obtains from another person any chattel, money, valuable security, or other property, real or personal, with intent to cheat and defraud a person of that property is guilty" of a crime.

FIXED PRICING REQUIRED (JAN 2006): Any pricing provided by contractor shall include all costs for performing the work associated with that price. Except as otherwise provided in this solicitation, contractor's price shall be fixed for the duration of this contract, including option terms. This clause does not prohibit contractor from offering lower pricing after award.

NON-INDEMNIFICATION (JAN 2006): Any term or condition is void to the extent it requires the State to indemnify anyone.

NOTICE (JAN 2006): (A) After award, any notices shall be in writing and shall be deemed duly given (1) upon actual delivery, if delivery is by hand, (2) upon receipt by the transmitting party of automated confirmation or answer back from the recipient's device if delivery is by telex, telegram, facsimile, or electronic mail, or (3) upon deposit into the United States mail, if postage is prepaid, a return receipt is requested, and either registered or certified mail is used. (B) Notice to contractor shall be to the address identified as the Notice Address on Page Two. Notice to the state shall be to the Procurement Officer's address on the Cover Page. Either party may designate a different address for notice by giving notice in accordance with this paragraph.

PAYMENT (JAN 2006): (a) The Using Governmental Unit shall pay the Contractor, after the submission of proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified in this contract,

including the purchase order, payment shall not be made on partial deliveries accepted by the Government. (b) Unless the purchase order specifies another method of payment, payment will be made by check. (c) Payment and interest shall be made in accordance with S.C. Code Section 11-35-45. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable.

PUBLICITY (JAN 2006): Contractor shall not publish any comments or quotes by State employees, or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer.

PURCHASE ORDERS (JAN 2006): Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order.

SETOFF (JAN 2006): The state shall have all of its common law, equitable, and statutory rights of set-off. These rights shall include, but not be limited to, the State's option to withhold for the purposes of set-off any moneys due to the Contractor under this contract up to any amounts due and owing to the state with regard to this contract, any other contract with any state department or agency, including any contract for a term commencing prior to the term of this contract, plus any amounts due and owing to the state for any other reason including, without limitation, tax delinquencies, fee delinquencies or monetary penalties relative thereto.

SURVIVAL OF OBLIGATIONS (JAN 2006): The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit.

TAXES (JAN 2006): Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by the State, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by the State. It shall be solely the State's obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. Contractor agrees to refund any tax collected, which is subsequently determined not to be proper and for which a refund has been paid to contractor by the taxing authority. In the event that the contractor fails to pay, or delays in paying, to any taxing authorities, sums paid by the State to contractor, contractor shall be liable to the State for any loss (such as the assessment of additional interest) caused by virtue of this failure or delay. Taxes based on Contractor's net income or assets shall be the sole responsibility of the contractor.

TERMINATION DUE TO UNAVAILABILITY OF FUNDS (JAN 2006): Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefor. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term.

THIRD PARTY BENEFICIARY (JAN 2006): This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise.

WAIVER (JAN 2006): The State does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of the State's rights under this Contract. Any waiver must be in writing.

Terms and Conditions - B. Special

HIPAA LAW: The Contractor agrees that to the extent that some or all of the activities within the scope of this Contract are subject to the Health Insurance Portability Accountability Act of 1996, P.L. 104-91, as amended (“HIPAA”), or its implementing regulations, it will comply with the HIPAA requirements and will execute such agreements and practices as the University of South Carolina may require to ensure compliance. Additional information may be viewed at: <http://www.sc.edu/hipaa/>

PROTECTION OF HUMAN HEALTH AND THE ENVIRONMENT - The University of South Carolina requires that all contractual activities to be in compliance with local, state and federal mandates concerning “protection of human health and the environment”. In addition, the University of South Carolina is a “Drug Free Work Place” and requires all contractors to comply with South Carolina Code of Laws Section 41-15-10 ET sequence (1976 w/amendments). Any contractor doing business with the University will be required to document compliance with these mandates and to furnish specific information requested by the University’s Department of Environmental Health and Safety when notified to do so. The Contractor understands and agrees that jobsites are open at all times work is being performed by the Contractor to authorized University employees who have been trained to identify unsafe work conditions. The Contractor will immediately correct any deficiencies noted by these inspections when requested by the University’s Department of Environmental Health and Safety to do so. In work areas where a specific hazard is posed which includes but is not limited to lead paint and asbestos abatement projects, Contractors will be required to produce Lead Compliance Plans and Asbestos Project Designs which outline their method of work prior to the start of work. Each contractor shall designate a responsible member of the Contractor’s organization to be at the site whose duty shall be the prevention of accidents. By submission of this bid, the vendor agrees to take all necessary steps to insure compliance with the requirements outlined above.

COMPLIANCE WITH LAWS (JAN 2006): During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs.

CONTRACTOR'S LIABILITY INSURANCE (JAN 2006): (1) Contractor shall purchase from and maintain in a company or companies lawfully authorized to do business in South Carolina such insurance as will protect the contractor from the types of claims set forth below which may arise out of or result from the contractor's operations under the contract and for which the contractor may be legally liable, whether such operations be by the contractor or by a subcontractor or by anyone directly or indirectly employed by any of them, or by anyone for whose acts any of them may be liable: (a) claims under workers' compensation, disability benefit and other similar employee benefit acts which are applicable to the work to be performed; (b) claims for damages because of bodily injury, occupational sickness or disease, or death of the contractor's employees; (c) claims for damages because of bodily injury, sickness or disease, or death of any person other than the contractor's employees; (d) claims for damages insured by usual personal injury liability coverage; (e) claims for damages, other than to the work itself, because of injury to or destruction of tangible property, including loss of use resulting therefrom; (f) claims for damages because of bodily injury, death of a person or property damage arising out of ownership, maintenance or use of a motor vehicle; (g) claims for bodily injury or property damage arising out of completed operations; and (h) claims involving contractual liability insurance applicable to the Contractor's obligations under the provision entitled Indemnification – Third Party Claims.

(2) Coverage shall be written on an occurrence basis and shall be maintained without interruption from date of commencement of the work until date of final payment. Coverage must include the following on a commercial basis: (i) Premises – Operations, (ii) Independent Contractor’s Protective, (iii) Products and Completed Operations, (iv) Personal and Advertising Injury, (v) Contractual, including specific provision for contractor’s obligations under the provision entitled Indemnification – Third Party Claims, (vi) Broad Form Property Damage including Completed Operations, and (vii) Owned, Non-owned and Hired Motor Vehicles.

(3) The insurance required by this paragraph shall be written for not less than the following limits of liability or as required by law, whichever coverage is greater.:

Products/Completed Operations \$1,000,000

Personal and Advertising Injury \$1,000,000

BUSINESS AUTO LIABILITY (including All Owned, Nonowned, and Hired Vehicles):

Combined Single Limit \$1,000,000

OR

Bodily Injury & Property Damage (each) \$750,000

WORKER’S COMPENSATION:

State Statutory

Employers Liability \$100,000 Per Acc.

\$500,000 Disease, Policy Limit; \$100,000 Disease, Each Employee

(4) Required Documentation. (a) Prior to commencement of the work, contractor shall provide to the state a signed, original certificate of liability insurance (ACORD 25). The certificate shall identify the types of insurance, state the limits of liability for each type of coverage, include a provision for 30 days notice prior to cancellation, name every applicable using governmental unit (as identified on the cover page) as a Certificate Holder, provide that the general aggregate limit applies per project, and provide that coverage is written on an occurrence basis. (b) Prior to commencement of the work, contractor shall provide to the state a written endorsement to the contractor’s general liability insurance policy that (i) names every applicable using governmental unit (as identified on the Cover Page) as an additional insured, (ii) provides that no material alteration, cancellation, non-renewal, or expiration of the coverage contained in such policy shall have effect unless the named governmental unit(s) has been given at least thirty (30) days prior written notice, and (iii) provides that the Contractor’s liability insurance policy shall be primary, with any liability insurance of the state as secondary and noncontributory. (c) Both the certificate and the endorsement must be received directly from either the contractor's insurance agent or the insurance company.

(5) Contractor shall provide a minimum of thirty (30) days written notice to every applicable using governmental unit of any proposed reduction of coverage limits (on account of revised limits or claims paid under the General Aggregate) or any substitution of insurance carriers.

(6) The state's failure to demand either a certificate of insurance or written endorsement required by this paragraph is not a waiver of contractor's obligations to obtain the required insurance.

Insurance Requirement: The successful bidder must provide a copy of its Liability Insurance certificate within ten (10) days upon the posting of the intent to award statement or statement of award and on each anniversary date thereafter attesting to such insurance coverage. Liability insurance must be maintained by the contractor during the entire term of the contract

CONTRACTOR PERSONNEL (JAN 2006): The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them.

CONTRACTOR'S OBLIGATION – GENERAL (JAN 2006): The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other

acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements.

CONTRACTOR'S USE OF STATE PROPERTY (JAN 2006): Upon termination of the contract for any reason, the State shall have the right, upon demand, to obtain access to, and possession of, all State properties, including, but not limited to, current copies of all State application programs and necessary documentation, all data, files, intermediate materials and supplies held by the contractor. Contractor shall not use, reproduce, distribute, display, or sell any data, material, or documentation owned exclusively by the State without the State's written consent, except to the extent necessary to carry out the work.

DEFAULT (JAN 2006):

(a)(1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to-

- (i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;
- (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or
- (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).

(2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.

(b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.

(c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

(d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.

(e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest.

(f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders.

(g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.

(h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract.

ESTIMATED QUANTITY -- PURCHASES FROM OTHER SOURCES (JAN 2006)

The state may bid separately any unusual requirements or large quantities of supplies covered by this contract.

ESTIMATED QUANTITY -- UNKNOWN (JAN 2006)

The total quantity of purchases of any individual item on the contract is not known. The State does not guarantee that the State will buy any specified item or total amount. The omission of an estimated purchase quantity does not indicate a lack of need but rather a lack of historical information.

INDEMNIFICATION - THIRD PARTY CLAIMS (JAN 2006): Notwithstanding any limitation in this agreement, Contractor shall defend and indemnify the State of South Carolina, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees against all suits or claims of any nature (and all damages, settlement payments, attorneys' fees, costs, expenses, losses or liabilities attributable thereto) by any third party which arise out of, or result in any way from, any defect in the goods or services acquired hereunder or from any act or omission of Contractor, its subcontractors, their employees, workmen, servants or agents. Contractor shall be given written notice of any suit or claim. State shall allow Contractor to defend such claim so long as such defense is diligently and capably prosecuted through legal counsel. State shall allow Contractor to settle such suit or claim so long as (i) all settlement payments are made by (and any deferred settlement payments are the sole liability of) Contractor, and (ii) the settlement imposes no non-monetary obligation upon State. State shall not admit liability or agree to a settlement or other disposition of the suit or claim, in whole or in part, without the prior written consent of Contractor. State shall reasonably cooperate with Contractor's defense of such suit or claim. The obligations of this paragraph shall survive termination of the parties' agreement.

INTELLECTUAL PROPERTY INFRINGEMENT (JAN 2006) (a) Without limitation and notwithstanding any provision in this agreement, Contractor shall, upon receipt of notification, defend and indemnify the State, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees against all actions, proceedings or claims of any nature (and all damages, settlement payments, attorneys' fees (including inside counsel), costs, expenses, losses or liabilities attributable thereto) by any third party asserting or involving an IP right related to an acquired item. State shall allow Contractor to defend such claim so long as the defense is diligently and capably prosecuted. State shall allow Contractor to settle such claim so long as (i) all settlement payments are made by Contractor, and (ii) the settlement imposes no non-

monetary obligation upon State. State shall reasonably cooperate with Contractor's defense of such claim. (b) In the event an injunction or order shall be obtained against State's use of any acquired item, or if in Contractor's opinion, the acquired item is likely to become the subject of a claim of infringement or violation of an IP right, Contractor shall, without in any way limiting the foregoing, and at its expense, either: (1) procure for State the right to continue to use, or have used, the acquired item, or (2) replace or modify the acquired item so that it becomes non-infringing but only if the modification or replacement does not adversely affect the specifications for the acquired item or its use by State. If neither (1) nor (2), above, is practical, State may require that Contractor remove the acquired item from State, refund to State any charges paid by State therefor, and take all steps necessary to have State released from any further liability. (c) Contractor's obligations under this paragraph do not apply to a claim to the extent (i) that the claim is caused by Contractor's compliance with specifications furnished by the State unless Contractor knew its compliance with the State's specifications would infringe an IP right, or (ii) that the claim is caused by Contractor's compliance with specifications furnished by the State if the State knowingly relied on a third party's IP right to develop the specifications provided to Contractor and failed to identify such product to Contractor. (d) As used in this paragraph, these terms are defined as follows: "IP right(s)" means a patent, copyright, trademark, trade secret, or any other proprietary right. "Acquired item(s)" means the rights, goods, or services furnished under this agreement. "Specification(s)" means a detailed, exact statement of particulars such as a statement prescribing materials, dimensions, and quality of work. (e) Contractor's obligations under this clause shall survive the termination, cancellation, rejection, or expiration of this Agreement.

LICENSES AND PERMITS (JAN 2006): During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the State, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract.

MATERIAL AND WORKMANSHIP (JAN 2006): Unless otherwise specifically provided in this contract, all equipment, material, and articles incorporated in the work covered by this contract are to be new and of the most suitable grade for the purpose intended.

OWNERSHIP OF DATA & MATERIALS (JAN 2006): All data, material and documentation either prepared for the state pursuant to this contract shall belong exclusively to the State.

PRICE ADJUSTMENTS (JAN 2006): (1) Method of Adjustment. Any adjustment in the contract price made pursuant to a clause in this contract shall be consistent with this Contract and shall be arrived at through whichever one of the following ways is the most valid approximation of the actual cost to the Contractor (including profit, if otherwise allowed):

(a) by agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;

(b) by unit prices specified in the Contract or subsequently agreed upon;

(c) by the costs attributable to the event or situation covered by the relevant clause, including profit if otherwise allowed, all as specified in the Contract; or subsequently agreed upon;

(d) in such other manner as the parties may mutually agree; or,

(e) in the absence of agreement by the parties, through a unilateral initial written determination by the Procurement Officer of the costs attributable to the event or situation covered by the clause, including profit if otherwise allowed, all as computed by the Procurement Officer in accordance with generally accepted accounting principles, subject to the provisions of Title 11, Chapter 35, Article 17 of the S.C. Code of Laws.

(2) Submission of Price or Cost Data. Upon request of the Procurement Officer, the contractor shall provide reasonably available factual information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830.

PRICING DATA – AUDIT – INSPECTION (JAN 2006) [Clause Included Pursuant to § 11-35-1830, - 2210, & -2220] (a) Cost or Pricing Data. Upon Procurement Officer's request, you shall submit cost or pricing data, as defined by 48 C.F.R. § 2.101 (2004), prior to either (1) any award to contractor pursuant to 11-35-1530 or 11-35-1560, if the total contract price exceeds \$500,000, or (2) execution of a change order or contract modification with contractor which exceeds \$100,000. In addition to the obligation stated in this subparagraph (b), you shall retain all records and allow any audits provided for by 11-35-2220(2). (c) Inspection. At reasonable times, the state may inspect any part of your place of business which is related to performance of the work. (d) Instructions – Certification. When you submit data pursuant to subparagraph (a), you shall (1) do so in accordance with the instructions appearing in Table 15-2 of 48 C.F.R. § 15.408 (2004) (adapted as necessary for the state context), and (2) submit a Certificate of Current Cost or Pricing Data, as prescribed by 48 CFR § 15.406-2(a) (adapted as necessary for the state context). (e) Subcontracts. You shall include the above text of this clause in all of your subcontracts. (f) Nothing in this clause limits any other rights of the state.

RELATIONSHIP OF THE PARTIES (JAN 2006): Neither party is an employee, agent, partner, or joint venturer of the other. Neither party has the right or ability to bind the other to any agreement with a third party or to incur any obligation or liability on behalf of the other party.

SHIPPING / RISK OF LOSS (JAN 2006): F.O.B. Destination. Destination is the shipping dock of the Using Governmental Units' designated receiving site, or other location, as specified herein. (See Delivery clause)

SUBCONTRACTOR SUBSTITUTION PROHIBITED - RESIDENT SUBCONTRACTOR PREFERENCE (SEP 2009): If you receive an award as a result of the subcontractor preference, you may not substitute any business for the subcontractor upon which you relied to qualify for the preference, unless first approved in writing by the procurement officer. If you violate this provision, the State may terminate your contract for cause and you may be debarred. In addition, the procurement officer may require you to pay the State an amount equal to twice the difference between the price paid by the State and the price offered by the next lowest bidder, unless the substituted subcontractor qualifies for the preference. [11-35-1524(D)(5)(c)]

TERM OF CONTRACT – EFFECTIVE DATE / INITIAL CONTRACT PERIOD (JAN 2006): The effective date of this contract is the first day of the Maximum Contract Period as specified on the final statement of award. The initial term of this agreement is one year from the effective date. Regardless, this contract expires no later than the last date stated on the final statement of award.

TERM OF CONTRACT – OPTION TO RENEW (JAN 2006): At the end of the initial term, and at the end of each renewal term, this contract shall automatically renew for a period of one year, unless contractor receives notice that the state elects not to renew the contract at least thirty (30) days prior to the date of renewal. Regardless, this contract expires no later than the last date stated on the final statement of award.

TERM OF CONTRACT – TERMINATION BY CONTRACTOR (JAN 2006): Contractor may terminate this contract at the end of the initial term, or any renewal term, by providing the Procurement Officer notice of its election to terminate under this clause at least ninety (90) days prior to the expiration of the then current term.

TERMINATION FOR CONVENIENCE (JAN 2006): (1) Termination. The Procurement Officer may terminate this contract in whole or in part, for the convenience of the State. The Procurement Officer shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective.

(2) Contractor's Obligations. The contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Procurement Officer may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to the State. The contractor must still complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so.

(3) Right to Supplies. The Procurement Officer may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall, upon direction of the Procurement Officer, protect and preserve property in the possession of the contractor in which the State has an interest. If the Procurement Officer does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in accordance with the standards of Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that the State has breached the contract by exercise of the Termination for Convenience Clause.

(4) Compensation. (a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph.

(b) The Procurement Officer and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the State, the proceeds of any sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated;

(c) Absent complete agreement under Subparagraph (b) of this Paragraph, the Procurement Officer shall pay the contractor the following amounts, provided payments agreed to under Subparagraph (b) shall not duplicate payments under this Subparagraph:

(i) contract prices for supplies or services accepted under the contract;

(ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services;

(iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph;

(iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated.

(d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles.

(5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the state's right to require the termination of a subcontract, or (ii) increase the obligation of the state beyond what it would have been if the subcontract had contained an appropriate clause.

YEAR 2000 WARRANTY (JAN 2006): Contractor represents and warrants that the equipment is designed to be used prior to, during, and after the calendar year 2000 A.D., and that the equipment will operate during each such time period without error relating to date data, specifically including any error relating to, or the product of, date data which represents or references different centuries or more than one century.

DATA RIGHTS AND CONFIDENTIALITY

Ownership of Data. The University of South Carolina is and shall remain the owner of all right, title and interest in and to any data that it owned prior to the Effective Date of any contract derived from this solicitation and in and to any data to which it may hereafter acquire ownership.

Confidential Information

General. Contractor will not knowingly disclose to any third party, or make any use of the University's Confidential Information. The contractor will use at least the same standard of care to maintain the confidentiality of the University's Confidential information that it uses to maintain the confidentiality of its own Confidential Information of equal importance.

CONTRACTOR Personnel. CONTRACTOR shall ensure that all personnel providing Services shall be bound by confidentiality agreements that require such personnel to protect and not disclose Confidential Information of the University of South Carolina.

Survival. The terms of this clause, Data Rights and Confidentiality, shall survive the expiration or termination of any contract derived from this solicitation.

SUBCONTRACTING

If any part of the work covered by this Fixed Price Bid is to be subcontracted, CONTRACTOR shall identify the subcontracting organization and the contractual arrangements made therewith. All subcontractors must be approved by the University. The offeror will also furnish the corporate or company name and the names of the officers of any subcontractors engaged by the offeror.

IMPORTANT TAX NOTICE - NONRESIDENTS ONLY

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

CAROLINACARD OFF CAMPUS MERCHANT AGREEMENT

AGREEMENT made as of the ___ day of _____, 2013 by and between University of South Carolina, a State of South Carolina institution of higher learning having its principal offices at 1600 Hampton Street, Suite 606, Columbia, SC 29208 ("USC"), and _____ having its principal place of business

at _____ ("MERCHANT").

WHEREAS, USC offers to its faculty, staff and students a multi-application campus card program ("USC CarolinaCard Program") which includes an optional Carolina Cash account (i.e., discretionary pre-paid debit account) and transactions managed via an automated card-based access control system; and

WHEREAS, under the USC CarolinaCard Program, USC faculty, staff and students are able to purchase goods and services at various locations by using a campus card issued by USC ("CarolinaCard"); and

WHEREAS, the aforementioned MERCHANT desires to provide goods and services to USC faculty, staff and student via the USC CarolinaCard Program as set forth further below.

NOW, THEREFORE, the parties mutually agree as follows:

I. **PARTICIPATION IN USC CAROLINACARD PROGRAM.**

A. System Access.

USC grants MERCHANT access to the USC CarolinaCard Program for purposes of providing sales transactions at the MERCHANT location to authorized and valid cardholders in the USC CarolinaCard Program. MERCHANT agrees to accept CarolinaCards presented to MERCHANT for the purchase of goods or services at MERCHANT location, subject to the terms and conditions set forth herein. Except as otherwise provided in this Agreement, MERCHANT shall not permit access to the USC CarolinaCard Program to any third party, including but not limited to any subsidiary or affiliate of MERCHANT, or any financial institution or entity, without the prior written consent of USC, which consent may be withheld by USC at its sole discretion.

B. Equipment and Installation.

MERCHANT shall be responsible, at its sole expense, for all required CarolinaCard processing communications equipment and required data lines for participation in the USC CarolinaCard Off Campus Program. Equipment Installation Fees (if any) must be paid for in full at the outset of the Agreement.

See ATTACHMENT A for specific equipment and installation requirements.

C. Card Inspection.

Prior to accepting a CarolinaCard for a transaction, MERCHANT shall verify by visual inspection that the person presenting the CarolinaCard to MERCHANT is the person pictured in the photo on the CarolinaCard. If MERCHANT is conducting a delivery sale MERCHANT will be held responsible for verifying the person receiving the sales at the time of delivery is the person pictured on the CarolinaCard that was used for payment. If it is determined that MERCHANT has accepted an unauthorized CarolinaCard, MERCHANT will not be reimbursed by the USC CarolinaCard Off Campus Program for the purchase. If MERCHANT violates this Paragraph, then USC may terminate this Agreement in accordance with Paragraph IV(D) below.

MERCHANT is required to immediately notify the CarolinaCard Office of any card presented that is not that of the person presenting the CarolinaCard with all pertinent information such as full name on card, number on back of card above barcode, and USCID# also on back of card. In addition, MERCHANT is also required to immediately notify the CarolinaCard Office of the full name of fraudulent user of the card and merchant location.

D. Campus Cash Off-Line.

If, at any time, the equipment at MERCHANT's location is in an "off-line" status or is operating improperly, MERCHANT shall **not** accept any USC CarolinaCard transactions until MERCHANT equipment is restored to proper "on-line" and functioning status. In addition, MERCHANT shall immediately notify the USC CarolinaCard Office of any such transaction processing and/or equipment problems. In no event shall USC be liable for any losses, damages, claims, costs or expenses suffered or incurred by MERCHANT due to failure of the equipment or verification of system to operate properly.

E. Receipts.

MERCHANT shall provide a printed receipt to the CarolinaCard cardholder at the time of the transaction. The receipt shall include the amount of the transaction, the date, the card number, and the location and identity of the MERCHANT. MERCHANT must also keep a duplicate copy of the signed receipt for research and audit purposes to be supplied to CarolinaCard Office upon request.

F. Credits and Returns.

Credits to correct an operator error ("Corrections") and/or merchandise returned for full value ("Returns") are the responsibility of the MERCHANT. Any such issues are to be resolved via the USC CarolinaCard card reader (where applicable) or the USC CarolinaCard Services Office in a timely manner. MERCHANT accepts responsibility for all credits processed through CarolinaCard card readers (where applicable) at MERCHANT-location(s). MERCHANT shall not exchange cash for a Return of merchandise purchased with the CarolinaCard. All corrections, credits, or returns MUST be processed no later than ten days of the transaction.

G. CarolinaCard Customer Fees.

MERCHANT agrees not to charge any fees to any CarolinaCard cardholder for CarolinaCard transactions, which exceed the POSTED patron cash price. Any violations of this section must be resolved in a timely manner or may result in immediate termination to this Agreement.

H. Prohibited Transactions.

MERCHANT shall not provide cash advances using the CarolinaCard. MERCHANT shall not accept the CarolinaCard as payment for the purchase of alcoholic beverages, tobacco products, prescription medicines, illegal products, or any unlawful transactions. MERCHANT acknowledges and agrees that if MERCHANT accepts a CarolinaCard in payment for alcoholic beverages or tobacco products or prescription medicines, or products deemed illegal, USC may terminate the contract with the MERCHANT. Any violation of this section must be resolved in a timely manner and will result in immediate termination of this Agreement.

I. Confidentiality of Information.

University agrees that for purposes of the Family Educational Rights and Privacy Act of 1974 (20 U.S.C. § 1232g), as amended (“FERPA”), MERCHANT will be considered a school official with a legitimate educational reason to have access to such limited personally identifiable information that may be contained on the CarolinaCard. MERCHANT agrees that it will not further disclose personally identifiable information about any student or other cardholder that it receives from that student’s or person’s CarolinaCard pursuant to this Agreement, unless such disclosure is legally authorized under FERPA. MERCHANT expressly warrants and represents that it will not itself retain or use, or disclose, transfer, or sell to any third party any personally identifiable information obtained by MERCHANT from the CarolinaCard for any purpose other those that are expressly permitted by the terms of this Agreement with University.

Except as otherwise authorized in this Agreement, MERCHANT agrees that it may not, directly or through any affiliate, disclose any nonpublic personal information about a cardholder to a nonaffiliated third party. For the purposes of this Agreement the term “nonpublic personal information” shall mean personally identifiable financial information. The term “personally identifiable financial information” shall have the same definition ascribed to that term in Section 313.3(o) of Part 313 of Title 16 Code of Federal Regulations. To the extent that MERCHANT receives or collects any nonpublic personal information from either the University or the cardholder pursuant to this Agreement, MERCHANT agrees that its disclosure and use of that information is expressly limited as follows: (1) MERCHANT may disclose the information to its affiliates, but MERCAHNT’s affiliates may, in turn, disclose and use the information only to the extent that the MERCHANT may disclose and use the information and (2) MERCHANT may disclose and use nonpublic personal information only as necessary in the ordinary course of business to effect, administer, or enforce, or in connection with (i) servicing, carrying out, or processing a CarolinaCard sales transaction that a cardholder requests or authorizes; (ii) providing a confirmation, statement, or other record of the CarolinaCard sales transaction to the cardholder; or (iii) authorizing, settling, billing, processing, clearing, transferring, reconciling or collecting amounts debited or otherwise paid using an CarolinaCard. MERCHANT agrees that it shall not, directly or through an affiliate, disclose a CarolinaCard number or similar form of access number or access code for a cardholder’s CarolinaCard account to any nonaffiliated third party for use in telemarketing, direct mail marketing, or other marketing through electronic mail to the cardholder. MERCHANT further agrees that it shall not, directly or through an affiliate, use a CarolinaCard number or similar form of access number or access code for a cardholder’s CarolinaCard account for telemarketing, direct mail marketing, or other marketing through electronic mail to the cardholder

MERCHANT shall, and shall cause its employees, agents, and representatives to, hold in confidence and not disclose, distribute, sell, copy, or otherwise disseminate or use any

information gathered or available to MERCHANT about CarolinaCard cardholders or USC or its students, faculty or staff as a result of MERCHANT participation in the USC CarolinaCard Program (“Confidential Information”) other than as may be required for purposes of accepting and processing transactions pursuant to this Agreement. Confidential Information includes but is not limited to student, faculty or staff identification numbers, account numbers, names, classification, telephone numbers, addresses, etc. This Section shall survive termination of this Agreement.

J. Retention of Records.

MERCHANT shall maintain a signed receipt record of each transaction covered by this Agreement for a period of three (3) years.

II. **COMMISSIONS, FEES & PAYMENTS.**

A. Commission.

MERCHANT agrees to pay USC a Commission equal to _____ % of gross CarolinaCard purchases (including all taxes and tips and before netting any Credits or Returns as set forth in Section I.F of this Agreement) executed by MERCHANT through the USC CarolinaCard Program. The Commission shall be deducted by USC from the business daily ACH (Automated Clearing House) transfer before it is deposited to the account the MERCHANT has designated. USC reserves the right to change the Commission percentage by providing the MERCHANT at least thirty (30) days prior written notice. MERCHANT will have the option of continuing or terminating participation in the USC CarolinaCard Program in the event of a change in the Fee.

B. Transaction Fees/ACH Transactions/Equipment Fees

MERCHANT agrees to pay a transaction fee of \$.30 per transaction for each transaction made with the CarolinaCard to USC. This transaction fee will be deducted by USC prior to the business daily ACH (Automated Clearing House) transfer deposited to the account the MERCHANT has designated. USC reserves the right to change the Transaction Fee by providing the MERCHANT at least thirty (30) days prior written notice. MERCHANT will have the option of continuing or terminating participation in the USC CarolinaCard Program in the event of a change in the Fee. MERCHANT shall notify the University of closing and opening of settlement banking account and complete new documentation with information. MERCHANT agrees to pay \$30.00 for each rejected ACH transaction from merchant’s financial institution. MERCHANT will be responsible for maintenance agreement on leased or bought equipment.

C. Merchant Payments.

USC will pay MERCHANT on a business daily basis by way of an ACH (Automated Clearing House) transfer for the USC CarolinaCard Program transactions (Debits and Credits) attributable to MERCHANT business, less any Transaction Fees, Equipment Rental Fees (if any), and Commission previously agreed upon. Each day’s transactions will be settled the next business day morning. Payment Date will occur approximately 48 hours (business days) after the day following settlement. USC will be responsible for providing payment to the merchant and provide the MERCHANT with the ability to check sales and supporting documentation for review. The MERCHANT will be responsible to supply a valid bank account and routing information to process ACH transfer upon initiation of contract. Further, the MERCHANT is responsible to notify USC immediately of any changes to such banking information in order to

avoid delays in such processing. Merchant is required to notify USC if depository account is changed thirty days prior to effective date of change so proper pre noting can be completed per NOCHA guidelines.

The MERCHANT can request the CarolinaCard Office accountant to run a more in-depth transaction report for review on an "as needed" basis.

III. **TERM.**

This Agreement shall commence as of the date first written above and shall, unless earlier terminated in accordance with the Section IV, continue until the end of the fiscal year as deemed by USC as 5:00 pm on June 30. Thereafter, the Agreement shall automatically renew for additional one-year terms on July 1 of each year until the expiration of the Term Contract under which this Merchant Agreement is entered.

IV. **TERMINATION.**

A. Either party may terminate this Agreement, with or without cause, upon sixty (60) days prior written notice.

B. Upon material breach of any term of this Agreement by a party hereto (the "Breaching Party"); the other party (the "Non-Breaching Party") may give written notice to the Breaching Party describing in detail such breach. If the Breaching Party shall not have cured such breach within thirty (30) days of receiving notice thereof, the Non-Breaching Party may give written notice to the Breaching Party that it elects to terminate this Agreement and shall specify a date upon which such termination shall take effect, which date shall not be less than thirty (30) days from the date of such notice.

C. Each party shall have the right to immediately terminate this Agreement upon the insolvency or bankruptcy of the other party. If the MERCHANT is found to have sold alcohol or tobacco products or prescription drugs, or illegal products to USC faculty, staff or students, then USC may, at its discretion, terminate this agreement.

D. Notwithstanding any other provision of this Agreement, violation by a MERCHANT of paragraph I (C), (H), or (I) or any provision of State of South Carolina law shall constitute a material breach of this Agreement and shall be sufficient to warrant immediate termination by USC.

E. In the event of termination for any reason, USC shall have no responsibility or liability for any loss, costs or damage, whether direct, indirect or consequential, incurred by MERCHANT resulting from termination.

V. **INDEMNIFICATION.**

The MERCHANT shall defend, indemnify and save and hold harmless USC and its trustees, officers, employees and students from and against any loss or liability, damage, cost and expense, including but not limited to reasonable attorneys' fees and costs, for injury, death, loss or damage of whatever nature to any person, property or any other claim by the MERCHANT or its officer, employees, agents, customers, licensees, invitees or any other person, firm or corporation arising out of, or in any way connected with, the MERCHANT participation in the USC CarolinaCard Off Campus Program.

VI. **NOTICES.**

All notices to the parties required hereunder shall be in writing and shall be delivered by messenger or by certified or registered mail, return receipt requested, to:

VII. **RELATIONSHIP OF PARTIES.**

Each of the parties shall perform its obligations hereunder as an independent contractor. Nothing contained in this Agreement shall create any agency, partnership, association or joint venture between the parties hereto. Neither party shall have the right or authority to create any obligation or responsibility, express or implied, on behalf of or in the name of the other party, or to bind the other party contractually in any manner whatsoever. Under no circumstances, as a result of this Agreement, shall any officer, agent, employee or representative of one party be considered an officer, agent, employee or representative of the other party.

VIII. **DISCLAIMERS & LIMITATION OF LIABILITY.**

A. USC is a state institution of higher learning and provides services hereunder in such capacity. As such, USC makes no representations or warranties whatsoever, expressed or implied, with respect to the equipment or services provided hereunder including, but not limited to, any implied warranties of fitness for a particular purpose, merchantability, non-infringement or otherwise. In no event shall USC be liable for indirect, special, consequential, incidental or punitive loss, damage or expenses arising out of or in connection with this agreement, whether based on breach of contract or tort (including negligence).

B. The sole liability of USC to MERCHANT for any claims arising out of or in connection with this Agreement, whether based on breach of contract or tort (including negligence), shall be to furnish correct payments (as identified under section II B of this agreement), and to correct such payments as necessary.

IX. **ASSIGNMENT.**

The MERCHANT shall not assign or transfer its interest or any obligation or right under this Agreement to any third party without the prior written consent of USC. Any purported assignment without such consent shall be null and void and be grounds for termination of this agreement. If consent is granted, each assignee or transferee shall assume and be deemed to assume all obligations under this Agreement and MERCHANT shall remain jointly and severally liable with its assignee for the payment of all commissions and for the performance of all of the terms and conditions contained herein. Any violations of this section must be resolved in a timely manner or may result in immediate termination to this Agreement.

X. **STATE OF SOUTH CAROLINA LAW.**

This Agreement shall be interpreted in accordance with the laws of the State of South Carolina. By execution of this Agreement, the parties hereby consent that they shall be subject to the exclusive jurisdiction of the state courts located in Richland County, State of South Carolina, for the resolution of any disputes arising from this Agreement, regardless of the place of execution or performance of this Agreement.

XI. **USE OF NAME.**

The MERCHANT shall not use USC's name, insignia or symbol, or any variation thereof, including USC CarolinaCard Off Campus Program, in any publication or advertisement, without the prior and written consent of the USC Office of Trademark and Licensing

XII. **FORCE MAJEURE.**

The parties acknowledge and agree that the provision of services here under may be delayed or prevented due to causes beyond the control and without the fault or negligence of USC. Such causes may include, but shall not be limited to, the failure of any third party to deliver goods or services to USC, fires, strikes, unavailability of energy, communication lines or resources, delay in transportation, acts of God or of the public enemy or acts of civil or military authority.

XIII. **ENTIRE AGREEMENT.**

This Agreement constitutes the entire agreement of the parties regarding its subject matter, and it supersedes any and all prior and collateral negotiations, agreements and understandings between the parties, whether written or oral regarding the subject matter. This Agreement shall be binding on the parties and their respective successors and permitted assigns. Neither this Agreement nor any provision hereof may be modified or waived orally but only by an instrument in writing signed by both parties. Any waiver of any term, provision or condition of this Agreement in any one or more instances shall not be deemed to be or construed as a further or continuing waiver of such term, provision or condition or as a waiver of any other term, provision or condition of this Agreement. If any provision of this Agreement is determined to be invalid, void or unenforceable in any respect, the remaining provisions hereof shall continue in full force and effect. This Agreement is not for the benefit of any third party. This Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts shall together constitute but one and the same instrument. Any Appendices attached hereto are made part of this Agreement as if fully set forth in the text hereof.

Each day's transactions will be settled the next business day morning. Payment Date will occur approximately 48 hours (business days) after the day following settlement. If no transactions were made, there will be no deposit.

ADDENDUM – Data Security

This document constitutes an Addendum to the Agreement between the University of South Carolina (hereinafter “Institution”) and _____ (hereinafter “Service Provider”). If any of the terms of this Addendum conflict with any of the terms of the Agreement, then the terms of this Addendum shall control.

Protection of Confidential Data: Service Provider agrees to abide by the limitations on re-disclosure of personally identifiable information from education records set forth in The Family Educational Rights and Privacy Act and with the terms set forth below. 34 CFR 99.33 (a)(2) provides that the officers, employees and agents of a party that receives education record information from the Institution may use the information, but only for the purposes for which the disclosure of the information was made.

Definition: Covered Data and Information (CDI) includes paper and electronic student education record information supplied by Institution, as well data provided by Institution’s students to the Service Provider, if any.

Acknowledgment of Access to CDI: Service Provider acknowledges that the Agreement allows the Service Provider access to CDI.

Prohibition on Unauthorized Use or Disclosure of CDI: Service Provider agrees to hold CDI in strict confidence. Service Provider shall not use or disclose CDI received from or on behalf of Institution (or its students) except as permitted or required by the Agreement, as required by law, or as otherwise authorized in writing by Institution. Service Provider agrees not to use CDI for any purpose other than the purpose for which the disclosure was made.

Return or Destruction of CDI: Upon termination, cancellation, expiration or other conclusion of the Agreement, Service Provider shall return all CDI to Institution or, if return is not feasible, destroy any and all CDI. If the Service Provider destroys the information, the Service Provider shall provide Institution with a certificate confirming the date of destruction of the data.

Remedies: If Institution reasonably determines in good faith that Service Provider has materially breached any of its obligations under the Agreement, then Institution, in its sole discretion, shall have the right to (1) require Service Provider to submit to a plan of monitoring and reporting, (2) provide Service Provider with a fifteen (15) day period to cure the breach, or (3) terminate the Agreement immediately if cure is not possible. Before exercising any of these options, Institution shall provide written notice to Service Provider describing the violation and the action it intends to take.

Maintenance of the Security of Electronic Information: Service Provider shall develop, implement, maintain and use appropriate administrative, technical and physical security measures to preserve the confidentiality, integrity and availability of all electronically maintained or transmitted CDI received from, or on behalf of Institution or its students. Service Provider shall impose these measures on all subcontractors used by Service Provider.

Reporting Unauthorized Disclosures or Misuse of Covered Data and Information: Service Provider shall, within one (1) day of discovery, report to Institution any use or disclosure of CDI not authorized by the Agreement or in writing by Institution. Service Provider’s report shall identify: (1) the nature of the unauthorized use or disclosure, (2) the CDI used or disclosed, (3) the identity of the individual or entity that received the unauthorized disclosure, (4) the action(s) that Service Provider has taken or shall take to mitigate any potentially negative effects of the unauthorized use or disclosure, and (5) the corrective action(s) Service Provider has taken or shall take to prevent future similar unauthorized uses or disclosures. Service Provider shall provide any additional information in connection with the unauthorized disclosure reasonably requested by Institution.

Compliance with Red Flags Rule: The Federal Trade Commission has promulgated regulations collectively known as the “Red Flags Rule” with which Institution must comply. See 16 CFR 681. Under the Red Flags Rule, if the Service Provider is engaged in activities covered by the Rule (e.g., opening or managing accounts, providing customer service, collecting debts, etc.), then the Institution must ensure that Service Provider either complies with Institution’s identity theft Program or that Service Provider has its own policies and procedures in place to detect and respond to identity theft Red Flags. If the Service Provider is engaged in activities covered by the Red Flags Rule, then the Service Provider represents and warrants that it has reasonable policies and procedures in place to detect, prevent and mitigate identity theft, and Service Provider shall review and comply with all relevant portions of Institution’s identity theft policy, if any, as well as any applicable Institutional identity theft plan. Service Provider shall report any Red Flags that it detects in connection with the Agreement to Institution.

Indemnification: Service Provider shall indemnify, save and hold harmless Institution from any loss, liability, damage, claims, costs or judgments the Institution incurs, including Institution’s costs and attorney fees, which arise from Service Provider’s failure to meet any of its obligations under the Agreement, including but not limited to this Addendum.
