THE FOLLOWING QUESTIONS WERE RECEIVED FROM VENDOR A:

QUESTION NO. 1: How do we insure that we are registered as a non-resident tax payer with the state of South Carolina? We are located in Austin, TX. Does filling out the I-312 form register us?

ANSWER: For purposes of completing the I-312 form (State of South Carolina Department of Revenue Nonresident Taxpayer Registration Affidavit Income Tax Withholding) on page 37 of the solicitation, your firm should contact either The South Carolina Secretary of State's Office or The South Carolina Department of Revenue and get registered or complete the registration process (i.e. registration pending) for purposes of responding to question #6 on the I-312 form. Filling out the I-312 form does not register a vendor with either The South Carolina Secretary of State's Office or The South Carolina Department of Revenue. Please carefully read the Important Tax Notice – Nonresidents Only on page 36 of the solicitation and contact The South Carolina Department of Revenue if you have any further questions regarding the I-312 form or registration questions.

QUESTION NO. 2: I noticed that the request includes Asia Pacific power cords. Is the correct?

ANSWER: This is a mistake. Please quote US cables

QUESTION NO. 3: There is a request for Smartnet. Usually, there is no Smartnet on refurbished gear. Are you looking for Cisco certified refurbished gear or regular refurbished gear?

ANSWER: Please do not quote any SmartNet at this time. The SMARTNET 8x5xNBD Cat 3750 12 SFP Std Multilayer Image Part Number: CON-SNT-3750G12S item has been deleted from the Revised Bidding Schedule in this amendment to the solicitation

THE FOLLOWING QUESTION WAS RECEIVED FROM VENDOR B:

QUESTION NO. 1: In reference to bid USC-IFB-2363-CJ, for The University of South Carolina Upstate-supply to furnish, deliver, install and configure the refurbished Cisco Equipment, I am curious if the University is accepting bids for the equipment only at this time, since there is not a separate line item on the Pricing Sheet for Labor & Install?

If so, our firm can bid the equipment only for the University as requested.

ANSWER: No, the University is not accepting bid for the Refurbished Cisco Equipment only. The University expects bidders to bid each of the forty-two items on the Bidding Schedule (of Section VIII of the solicitation) at a price that include the equipment itself along with the cost to deliver, install, and configure the equipment at the University of South Carolina Upstate campus. Therefore, there is not a separate line item on the Bidding Schedule for the cost to deliver, install, and configure the forty-two items of equipment at the University of South Carolina Upstate campus.

THE FOLLOWING QUESTIONS WERE RECEIVED FROM VENDOR C:

QUESTION NO. 1: Why not use POE cards in the 6500's rather than the power Injectors?

ANSWER: Please quote part numbers we have listed in the solicitation.

QUESTION NO. 2: What Switches are you currently using that the power injectors will plug into?

ANSWER: WS-C3750-48P.

QUESTION NO. 3: Need a network map.

ANSWER:

QUESTION NO. 4: Need a physical layout of the campus. Be sure to include distances between buildings, square footage and location of the equipment within the buildings.

ANSWER: Cabling is already in place. Therefore, distances between buildings, square footage and location of the equipment within the buildings are not included on the physical layout of the campus.

QUESTION NO. 5: How many VLans? private or not and if there will be any inter-vlan routing?

ANSWER: Approximately seventy five (75) VLANs with no inter-vlan routing.

QUESTION NO. 6: How many SSID's and if they are to broadcast or not and type of encryption and what bands they are going to want to use

ANSWER: Four (4) SSIDs with open encryption on all of them.

QUESTION NO. 7: Why do they want a older version of software (SWLC4400K9)?

ANSWER: Please quote part numbers we have listed in the solicitation.

QUESTION NO. 8: What will they be using the DMP-4400G-K9 for? The DMP-4400G-K9 is EOL but there is a replacement part which is DMP-4400G-5.1-K9 will that work?

ANSWER: Please quote part numbers we have listed in the solicitation.

QUESTION NO. 9: Just want to confirm that all wiring is in place or do they need a quote on the wiring?

ANSWER: All wiring is in place.

QUESTION NO. 10: I am showing that the AIR-WLC4404-100-K9 already has the license. Why ask for a quote on WCS-APBASE-50 and DMP-SW5.0-K9?

ANSWER: Please quote part numbers we have listed in the solicitation.

THE FOLLOWING QUESTIONS WERE RECEIVED FROM VENDOR D:

QUESTION NO. 1: How are prices for installation services supposed to be quoted? Do I incorporate the install service prices into the hardware line item prices?

ANSWER: Price bid for each item on the Revised Bidding Schedule in this amendment to the solicitation must include required delivery, installation and configuration services of the item. No additional fees/costs for the item will be paid by the University.

QUESTION NO. 2: Are vendors required to bid on all line items or are partial bids acceptable?

ANSWER: Bidders are required to bid on all items on the Revised Bidding Schedule in this amendment to the solicitation. Bidders bidding on some but not all of the items on the Revised Bidding Schedule in this amendment to the solicitation (i.e. partial bids) will automatically be rejected by the University as “non responsive” and will be removed from further consideration.

QUESTION NO. 3: When is the install services expected to start?

ANSWER: We will start installation once the equipment arrives.

QUESTION NO. 4: Do you want all refurbished quoted?

ANSWER: Yes. Bidders are required to bid on all items on the Revised Bidding Schedule in this amendment to the solicitation. Bidders bidding on some but not all of the items on the Revised Bidding Schedule in this amendment to the solicitation (i.e. partial bids) will automatically be rejected by the University as “non responsive” and will be removed from further consideration.

QUESTION NO. 5: Will the entire opportunity be awarded to one vendor?

ANSWER: Yes, all items on the Revised Bidding Schedule in this amendment to the solicitation will be awarded to one offeror.

THE FOLLOWING QUESTIONS WERE RECEIVED FROM VENDOR E:

QUESTION NO. 1: Will USC be providing the location for the Access Points based on a Wireless Site Survey previously completed?

ANSWER: Yes.

QUESTION NO. 2: Is it possible to get copies of the floor plans and proposed locations for the Access Points?

ANSWER: Floor plans with proposed locations are not available at this time.

QUESTION NO. 3: Would USC be responsible for the wiring/cabling required for the installation of the Access Points or should material/services be included in our response? If the latter can USC provide copies of the floor plans with proposed AP locations and existing IDF/MDF (Wiring Closet) location?

ANSWER: Cabling is already in place.

QUESTION NO. 4: On what type of ceiling/height will the Access Points be mounted?

ANSWER: 2x2 tiles in a drop ceiling with 10ft ceiling height.

QUESTION NO. 5: What type of brackets and mounting gear should be furnished with the Access Points?

ANSWER: No mounting brackets will be necessary.

QUESTION NO. 6: Is release 3.2 on the Wireless LAN Controllers the version of software to be deployed?

ANSWER: The latest code available and supported should be used.

QUESTION NO. 7: Some of the Power Cords requested, item 34 and 35, are for Asia Pacific (APAC) and would not work with standard power in the US. Is this correct or a typo?

ANSWER: That is a mistake. Please quote US cables.

QUESTION NO. 8: What is the version of WCS already deployed in USC's environment?

ANSWER: 5.1.64.0

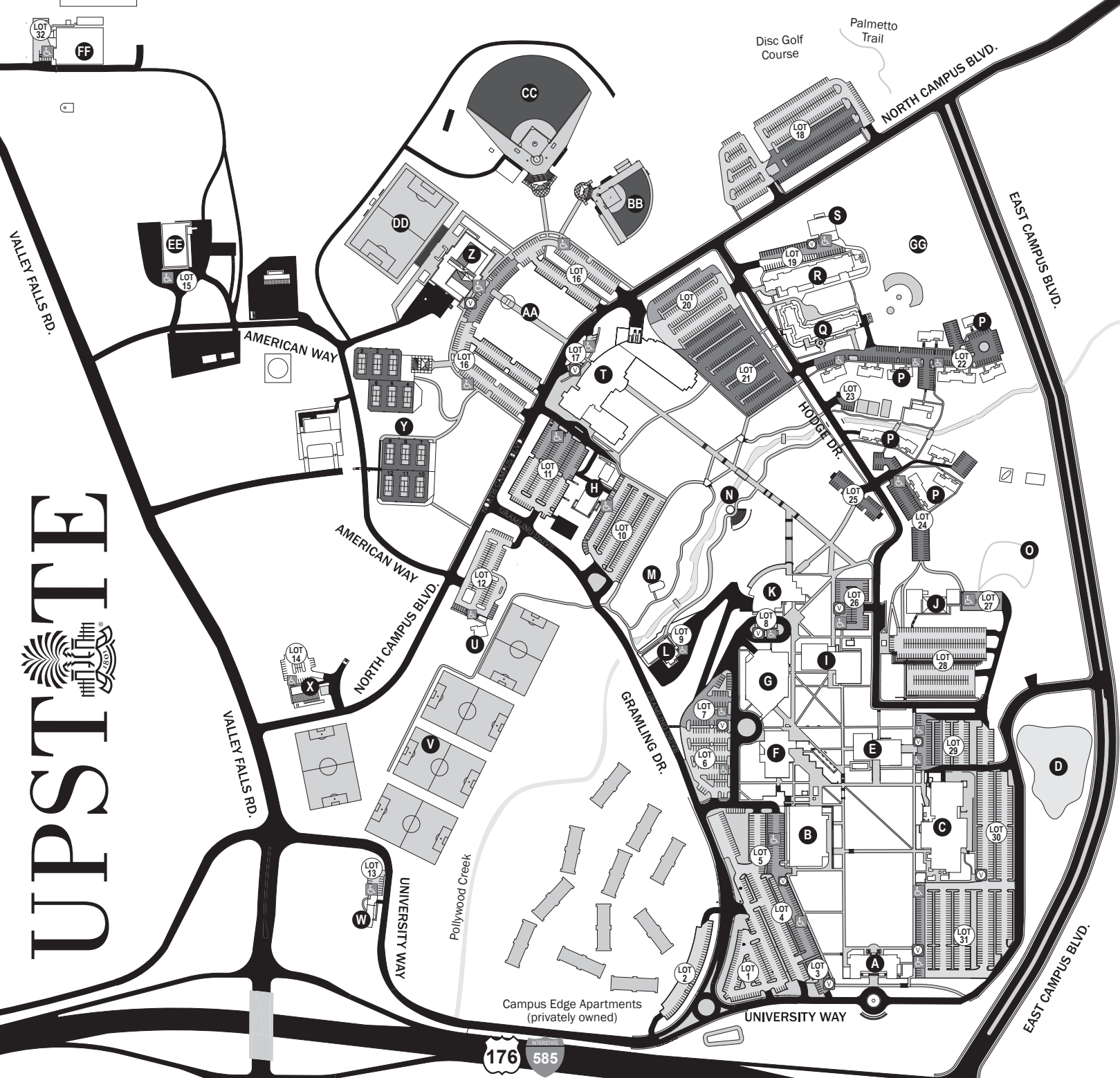
