This Amendment No. 1 modifies the Invitation for Bid only in the manner and to the extent as stated herein.

ITEM ONE: REPLACE THE FOLLOWING TO SECTION III. SCOPE OF WORK / SPECIFICATIONS:
Replace Item A.3 under SCOPE OF SERVICES with the following:
The inspection must be reported on the most current Official South Carolina Wood Infestation Report (Form CL100) as published by the Department of Pesticide Regulation. The form for this report shall be furnished by the licensee.

ITEM TWO: REPLACE THE FOLLOWING TO SECTION III. SCOPE OF WORK / SPECIFICATIONS:
Replace Item B under SCOPE OF SERVICES with the following:

Wood-Damaging Insect Treatment Service, Chemical Treatment for Main Campus Properties

Once per year, the Contractor shall perform a wood-damaging insect treatment service using Termidor® termiticide at specified label rates at sites covered under this agreement. The treatment shall comply with all professional standards and applicable laws. Upon completion of said treatment, the Contractor shall issue a “wood-damaging insect warranty” for that site. The warranty will permit, for one year from date of issuance, re-treatments as necessary at no additional cost to the University.

ITEM THREE: DELETE THE FOLLOWING TO IV. INFORMATION FOR OFFERORS TO SUBMIT, ITEM #B
Delete Item #11 and Item #12.

ITEM FOUR: REVISED BID SCHEDULE, SECTION VIII:
See Attached Revised Bid Schedule.

ITEM FIVE: PRICE PER LINEAR OR PRICE PER SQUARE FOOT
The Price Per Linear and/or Price Per Square Foot is applicable to all or portions of all buildings currently on the contract or to any which may be added to the contract at a later date per change

BIDDER SHALL ACKNOWLEDGE RECEIPT OF AMENDMENT NO. 1 IN THE SPACE PROVIDED
