 Add: Approved changes in scheduled hours of work must be approved in writing.
- Correction to Scope of Work, Section III, Lot II, WORK HOURS
 Add: Approved changes in scheduled hours of work must be approved in writing.
- 4. Correction to Scope of Work, Section III, Lot II, QUALIFICATIONS, Item No. 1
 Delete Item No. 1 in its entirety and replace with the following:

 No subcontracting allowed. All work to be performed by the contractor.

Question: I wanted to clarify what the maximum pressure allowed for the tile & grout cleaning, there was not a specific amount listed. If the grout is weak already then other forms of agitation are going to be a problem as well. Is there room for negotiation on this point (I.e. Different max pressures for those areas?)

Answer: To confirm, the maximum pressure is 250 PSI.

- Question: (a) For the "silicone sealer" by in large the recommended amount usually 1-2 coats per the manufacturers specs and 3 at the most. Is there room for negotiation here and testing after the 2nd coat for proper beading up?
- (b) Also, will the areas being sealed- be able to be shut down for the proper amount of cure time needed usually 24-48 hours to receive moisture? With 3-4 coats the cure time would need to be the maximum recommended.

Answer:(a) Minimum seal coats is 3.

(b) Only the joints are to be sealed. In order to shut down, scheduling must be coordinated with USC Russell House Representative and USC Facilities Representative.
