See Question #11.

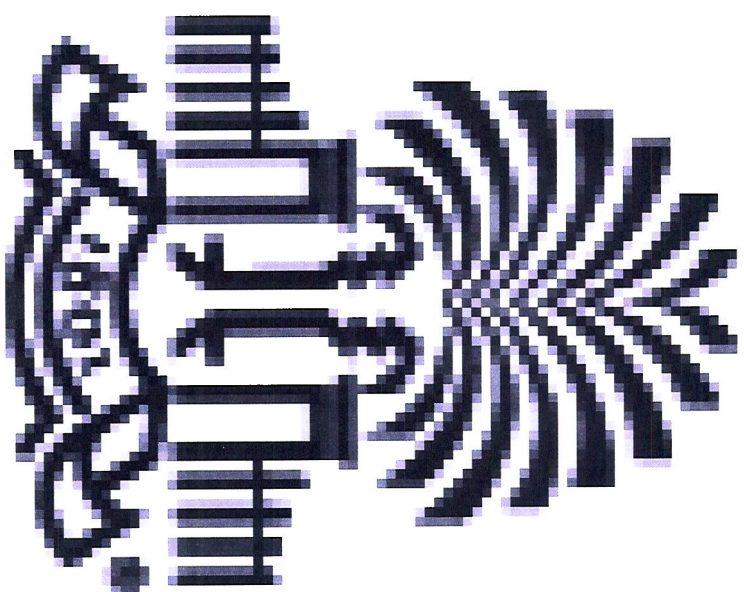
