Additional subscriptions may be purchased by the University at any time during the contract term. Therefore, all subscriptions purchased from the contract (i.e. the subscriptions purchased by the University at the beginning of the contract term and

the subscriptions the University may purchase during the remainder of the contract term) must expire at the same time. The University wants to keep all subscriptions it purchases from the contract coterminous. Therefore, the price of the subscriptions purchased for additional licenses purchased by the University during the remainder of the contract term is going to be prorated by the Contractor.
