VENDOR #1

- 1. What is the internal process for determining the Universities priorities? Answer: The University seeks input from faculty leading toward decisions made by the executive leadership.
- 2. Is the vendor allowed to participate or provide counsel to the University's leadership during those discussions with the academic departments? **Answer: Yes.**
- 3. What is the timeline for the University's decision on priorities; have specific projects for the Appropriations process already been identified by the University for the FY11 Congressional cycle?

Answer: This activity is in process.

- 4. The RFP lists research/Federal funding priorities of: biomedical sciences, life and health sciences, physical sciences and engineering (p. 11).
 - 4a. How do these areas relate to the Centers of Economic Excellence/Endowed Chairs (CoEE)? (Nonocenter, Cardiovascular Health, etc.)
 Answer: The priorities for federal funding and CoEE funding are complementary.
 - 4b. Would the contract include cooperation with Clemson and the Medical University of South Carolina in terms of winning Federal funding for research in the CoEE network?Answer: Yes, when appropriately considered and conflict avoided.
- What is the weighting given for credit to SC companies? Answer: In accordance with the South Carolina Consolidated Procurement Code, Section 11-35-1524 (E)(5), preferences do not apply to a procurement conducted pursuant to Section 11-35-1530 - Request for Proposal.
- 6. Which USC office/individuals will be responsible for managing the contract relationship with the consulting firm?
 Answer: Vice President for Research and Graduate Education in consultation with VP for

In order to prepare a timeline for this contract with benchmarks, please provide USC important calendar events for USC management and the Board meetings with dates of key meetings which would include agenda items pertaining to the contract, e.g. what are the dates of USC Board meetings in 2010, 2011, etc?

Answer: We will work with the winner bidder to set a schedule of important dates.

8a. How do these areas relate to the Federal funding priorities listed in the RFP? **Answer: The priorities for Innovista and federal funding are complementary.**

- How is the new management of Innovista structured and who is responsible for oversight of the consultant winning this contract as it pertains to Innovista?
 Answer: This is in process. For complementary science, oversight is provided by the VP for Research and Graduate Education. For complementary facilities infrastructure, the oversight is provided by the VP for Finance and Planning and the Provost as leaders of the Capital Planning Committee.
- Does the RFP include support for building international cooperation for Innovista, including recruiting non-US firms and institutions as residents and partners? Answer: No.
- 11. To what extent would the contract include representation of USC at the State level? **Answer: None.**
- 12. What is the role of South Carolina Research Authority (SCRA) in the implementation of this contract?Answer: USC enjoys a collaborative relationship with SCRA.
