## **Question & Answers**

1. Is event staff parking provided by the university? If so, is it walking distance to the athletic facilities? If it isn't walking distance, does USC provide shuttle services or is that up the vendor to provide?

Event staffing parking is not provided; however a staging location is available for the **contractor's** event staff to provide shuttle service @ Football. Parking garage and parking lot with USC provided shuttle service are available @ Basketball and baseball respectively. At smaller events, parking is available on site for the contractor's event staff.

- 2. Is selected vendor expected to monitor all breaks of staff during an event, no matter the duration, and no bill USC or is it only breaks over a certain amount of time (30 mins or more for example) need to be no billed. As relates to this section in the RFP: When meals are provided as a courtesy for the Contractor's event staff, a designated period of time will be allotted for the consumption of that meal and the event staff will be "off the clock" during that time. The Department of Athletics will not be billed for that time.
  - No bill only involves rare occasions when USC provides a courtesy meal and the "off the clock" time is 30 minutes or more.
- 3. Are the 2 State of South Carolina Client References a requirement or can those be substituted with other D1 Universities?

- 4. Do all proposers need to be currently staffing in the State of South Carolina or are outside of the state vendors encouraged to submit a bid?
  - Vendors located Outside of the State of South Carolina are encouraged to submit a bid
- 5. What are the current pay and bill rates that the current provider is contracted for?
