<u>General Description</u> – The University of South Carolina (USC) Salkehatchie Campus is accepting bids for the complete removal and replacement of four large (10 ft. X 10 ft. measured @ curb outer edge) Plexiglas skylights in the atrium of the Science and Administration Building in Allendale. USC Salkehatchie would like to replace the 20 year old skylights with a new clear acrylic "Barrel Vault" design which improves watershed performance and holds up much better to ultraviolet deterioration. The existing skylights are developing multiple cracks and periodically leak during heavy rainfall. Pictures of an existing skylight are shown below with another skylight visible in the background.



Skylight Specifications:

- Four 10 ft. X 10 ft. custom barrel vault design skylights with a 10 ft. X 10 ft. constructed curb continuous cast acrylic double dome barrel vault skylight as pictured below.
- Glazing will be cold formed clear cast acrylic with a bronze anodized structural aluminum frame. Extruded acrylic will not be accepted. All acrylic to be continuous cast with a 10 year crazing warranty by the acrylic manufacturer.
