**Question #1:**

**Answer:**

**Question #2:**

Do both of these buildings have elevators? Is so, how many in each building?

**Answer**

Yes, both have elevators.

Bates West has 2 elevators, Interior dimensions: 46"D x 75"W x 88"H

Capstone has 3 elevators, Interior dimensions: 72"D x 76"W x 89"H

**Question #3:**

Will there be other furniture that will stay in the rooms and if so will either the furniture moving out or the furniture staying be marked?

**Answer:**

**Capstone:**

- a) In the student rooms, only the desk chairs will be removed.
- b) In the common areas (studies, Lobby, game room, lounge), all furniture will be removed, per the list.

**Bates West:**

- a) In the student bedrooms, only the desk chairs will be removed.
- b) In the Living Rooms, all furniture will be removed, per the list.

**Question #4**

Will the furniture for trucks or furniture for dumpsters be identified prior to the start of the move?

**Answer**

Yes. A coordination meeting providing this information will be held with the Contractor after issuance of Purchase Order.

**Question #5**

Will we dispose all furniture into the dumpsters, or will we dispose damaged and stack reuseable furniture.

**Answer**

Dispose of damaged furniture and stack on trucks reusable furniture.

**Question #6**

Are we responsible for replacing furniture back into dormitory?

**Answer**

No furniture will be returned; furniture will be permanently removed.
