1. I was at the site visit yesterday at the center for the arts. I did some research on the doors and the hinge cut on those doors I can not find as far as the manufacturer's make. Which is going to make it a special order, which will be more expensive. I can get the doors with frames cheaper than doors without frames. Would you like to change the frames as well?

## Clarifications in Red

### SCOPE OF WORK

Furnish, install, and paint two (2) sets of double fire rated doors and associated hardware in the main corridor –

- The fire rating on new doors should be 90 minutes
- Give price for doors replaced without frames
- Give price for doors replaced with frames

- 1) Remove existing doors and hardware and haul away
- 2) New 3/0x7/0 doors to match existing with fire rated glass lights
- 3) New fire rated exit device hardware, closures, center mullions, hinges and kick plates to match existing
- 4) Paint doors and jambs to match existing
- 5) New panic bars to be installed on all four doors

Furnish, install, and paint exterior door and associated hardware near security office – **the new door should be half glass (upper portion) and half metal (lower portion)**

- 1) Remove existing door and haul away
- 2) New door to match existing with continuous hinge
- 3) New panic bar with locking system
- 4) Paint to match existing door

The base bid is to match all existing hardware for the two (2) sets of double doors. As an alternate, please quote the cost for upgrading to clear, fire rated glass.

All work will be scheduled and coordinated with USCB staff. Work will be performed during normal business hours of 8:00 am through 4:30 pm.
