This Amendment No. 2 modifies the IFB only in the manner and to the extent as stated herein.

**ITEM ONE: CLARIFICATIONS TO QUESTIONS PRESENTED BY VARIOUS VENDORS**

- Historical premium paid

2013-2014 Coverage moves from a fully insured program to a self-insured retention program, with a **PREMIUM** for the August 23, 2013 to August 23, 2014 policy period of \$11,750.00 and an Aggregate Deductible of \$50,000.00. The **ACCIDENT MEDICAL AND DENTAL EXPENSE BENEFIT** plan design is amended as follows:

**Total Benefit Maximum for all Accident Medical \$25,000**

**Loss Period (first Covered Expenses must be incurred within): 180 days after the Covered Accident.**

**Benefit Period: 104 weeks**

**Deductible (Specific, per person): \$0**

**Deductible (Aggregate, per policy): \$50,000 of Covered Expenses Incurred by the Policyholder in the Policy Period**

**Benefit Percentage 100%**

**Terms of Payment Full Excess**

**Dental Benefits 100% of Accident Medical Benefit**
