ITEM ONE: CLARIFICATIONS TO QUESTIONS PRESENTED BY VARIOUS VENDORS

1. Question: Is there an incumbent vendor for these services?

Answer: NO

3. Question: What has been the biggest challenge for fulfilling services under this contract, or if this is a new contract, are there any challenges that you anticipate?

Answer: The anticipated challenges are accommodating a student academic schedule that could begin as early as 8:00am and/or end as late as 8:00pm, and finding an interpreter that can effectively articulate via sign language the academic instruction from a variety of courses.

4. Question: What is the expected volume of this contract per vendor/interpreter? Will there be primary/secondary vendor status?

Answer: Our preference would be to work solely with the primary vendor. A second vendor would only be used when the primary vendor cannot provide the service. We expect to need ASL interpreting service 15 to 20 hours per week for 16 weeks during the Fall and Spring academic terms.

5. Question: Is there any historical data for ASL Interpretation on the Lancaster Campuses (what sorts of courses, how many students, etc.)?

Answer: Historically, only one student per semester has needed ASL Interpretation on the Lancaster Campus. The courses are primarily those needed to meet the education requirements of the Associate in Arts and the Associate in Science degree programs at the University. Potential course offerings include English, Math, History, Biology, Chemistry, Psychology, Sociology, Speech, etc.
