QUESTIONS RECEIVED FROM VENDOR A

QUESTION 1: Will tree/palm pruning be included in the contract? I noticed a lot of the trees need to be elevated. Approximately 35 palms need dead frawns and seed pods removed.

ANSWER: All tree work (i.e. trimmings, disease / pest control) will be done by contracted company. Trees will be pruned as needed to maintain a neat, natural shape and structure. All trees should be pruned and maintained according to industry standards. Trees should be trimmed over walkways maintaining a canopy of shade, but not causing any hindrance to individuals accessing the walkways. Dead palm fronds, loose petioles and seed pods should be removed from all palmetto trees.

QUESTION 2: Property boundary map. When will this be available?

ANSWER: This is to include all trees, shrubs, and vegetation around the facility. This includes anything that borders the facility or the sidewalks surrounding the facility and fields. The border in question was the one between the small field and the Greek Housing. Through discussion with GV staff, we have come to the conclusion that the WFC will be responsible for any bushes or trees down the west side of the fields. It is shown on the plans for the field complex and have attached a map of the field area and Assembly extension to hopefully clear up questions and concerns. Also, all trees and shrubs down Assembly Street to the access drive will be included as well.

QUESTION 3: How many irrigation controllers are onsite and number of zones per controller?

ANSWER: See attached document. This is what we have been able to figure out seeing as changes have been made to the original irrigation set up from several years ago.

QUESTION 4: Is the current annual cost of the contract available to the public?

ANSWER: The current annual cost of the contract is \$23,400.00 annually. (\$1,950.00 per month)


